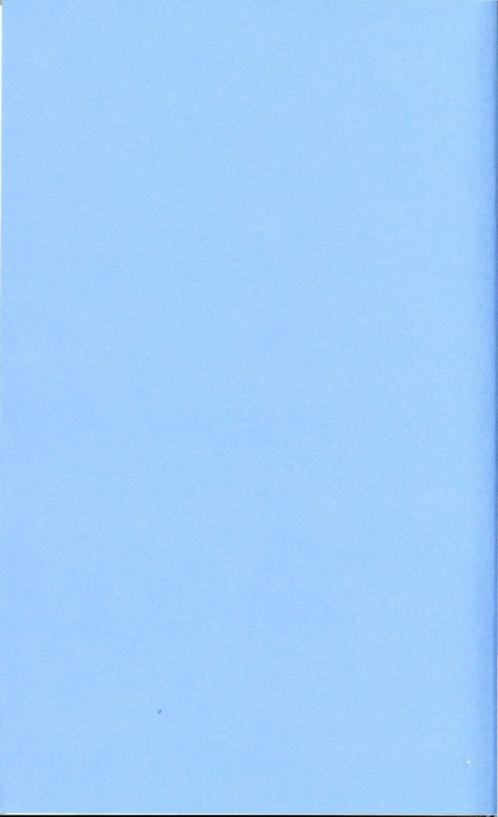
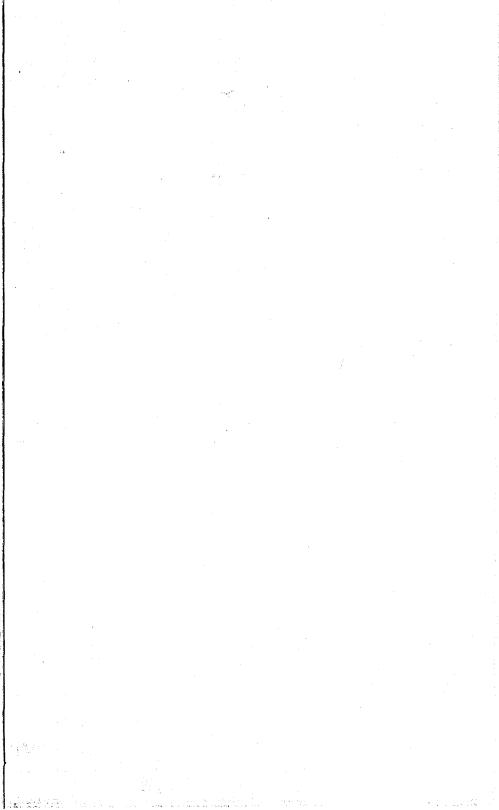

CONSTITUTION OF THE NORTH CAROLINA ASSOCIATION OF FREE WILL BAPTIST

PREAMBLE:

The purpose of this organization shall be the establishment and maintenance of a voluntary association of autonomous Free Will Baptist churches, quarterly meetings (or any other meetings), district associations or conferences or any and all additional organizations - area, district or statewide that may be deemed essential to the prosecution and promotion of the general purpose and program of this association. Included also in the purpose of this association is affiliation with the National Association of Free Will Baptists, the adoption of the Treatise of the Faith and Practices of Free Will Baptists as adopted by the National Association, and cooperation in its world-wide ministry. This association holds unswerving loyalty to the inspired Word of God as our infallible rule of faith and practice.

ARTICLE I. NAME

This association shall be known as the North Carolina Association of Free Will Baptists, however, informally the term "State Association" may be used.

ARTICLE II. COMPOSITION

This association shall be composed of its officers, members of standing boards, ordained and licensed ministers who are in good standing with a conference or association affiliated with this body, together with three (3) delegates elected from each conference or association and one (1) delegate from every fifty (50) members or fraction thereof from each local church which is in good standing with a conference or association affiliated with this body.

ARTICLE III. · MEETINGS

Section 1. This association shall convene in regular annual session Monday and Tuesday after the first Sunday in June and at a place determined by the association in session.

Section 2. In the event of an emergency resulting from a cancellation of the place approved by the association while in annual session, the Executive Board of the association shall have power to make a substitute choice of a suitable location for the annual meeting.

Section 3. Should a called session be deemed essential, the Executive Board shall have authority to issue and publicize a called session of the State Association, said call shall be publicized not less than two (2) weeks in advance of the session.

Session 4. The qualified members in attendance at any regular or called session shall constitute a quorum.

ARTICLE IV. OFFICERS

The officers of this association shall consist of the members of the Executive Board, the Board of Trustees, the Board of Youth Ministry, the Board of Missions Ministry, the Board of Care for the Aged Ministry, the Board of Retirement and Insurance Ministry, and the Board of the Bible Book Store Ministry.

ARTTICLE V. BOARDS

Section 1. This association shall establish the following standing boards:

The Executive Board The Board of Trustees The Board of Youth Ministry The Board of Missions Ministry

The Board of Care For The Aged Ministry The Board of Retirement and Insurance Ministry The Board of the Bible Book Store Ministry

Section 2. The Executive Board shall consist of Moderator, Assistant Moderator, Clerk, Treasurer and three (3) members at large elected by the association.

Section 3. The Board of Trustees shall consist of three (3) members elected by the association.

Section 4. The following boards shall each be composed of five (5) members elected by the association.

The Board of Youth Ministry The Board of Missions Ministry The Board of Care For The Aged Ministry The Board of Retirement and Insurance Ministry The Board of the Bible Book Store Ministry

ARTICLE VI. DISCIPLINE

This association has no judicial or appellate powers conflicting with the independence of the local church or the bodies constituting this association.

ARTICLE VII. AMENDMENTS

This constitution may be amended by two-thirds majority vote of the members present and voting at a session of the association provided the proposed amendment is presented to the body one day in advance.

ARTICLE VIII. DISSOLUTION

In the event of the dissolution of this association any assets of the organization then remaining shall be conveyed to the National Association of Free Will Baptists.

BY-LAWS

ARTICLE I. MEMBERSHIP

Section 1. Membership in this association shall be through application of a duly constituted district association (or conference). A credentials committee shall examine the application and make other investigation it deems appropriate. The credentials committee shall make a recommendation to the association as to the action to take regarding the application. The decision on the application shall be by majority vote of delegates present and voting.

Section 2. Each church holding membership in an affiliated association shall automatically be a member of this association.

ARTICLE II. REPRESENTATION

Section 1. Each district association holding membership in the State Association shall send a report of statistics on a form provided by the association to every annual session of the association. Failure to report for two successive sessions of the association may be the basis for dismissal from the association by a majority vote of members present and voting.

Section 2. Seating of delegates shall be through recommendation of a credentials committee. Any potential delegate whose credentials are not recommended for approval by the Credentials Committee may be seated only by a majority vote of seated delegates who are present and voting.

ARTICLE III. DUTIES OF OFFICERS AND BOARDS

Section 1. The Executive Board shall: (1) arrange the program for the annual sessions of the association, (2) fill vacancies which may occur on any board between sessions of the association, (the

person duly elected by the association), (3) promote the work of the association, (4) review the annual reports and proposed budgets of all boards before they are presented to the State Association, (5) provide for and give general supervision to a church bond program and other similar service ministries and, (6) employ and supervise a promotional director, whose duties shall be as follows:

- A. <u>Administration</u>. To administer the affairs of the Executive Board within the authority delegated by the board. He shall fulfill all duties commensurate with his office and present plans and procedures to the board which he feels would be effective in promoting the work within the association.
 - B. <u>General Promotion</u>. To show through general promotion the correlation and interrelation of all the ministries of the State Association and National Association. It is expected that he will promote impartially the total program of work as devised by all standing boards.
 - C. <u>Public Relations</u>. To keep in close contact with pastors, district associations, and local church leaders. He shall represent the State Association to other bodies when in the interest of the association.
 - D. <u>Publications</u>. To serve as editor-in-chief of the Free Will Baptist Witness. He shall direct the production of other promotional material as may be approved by the Executive Board.
 - E. <u>Stewardship</u>. To provide a stewardship education that will serve to produce increased support for the state ministries through the "State Program" and/or other methods of giving by associations, churches, and individuals.

F. Arranging Annual Association. To expedite

the planning of the annual association program, arrange for the enrolling of ministers and delegates and distribute the printed minutes of the association.

- G. Other Duties. To perform other duties as may be assigned by the Executive Board. It is understood that the Promotional Director is to have no official or ex-officio status on any standing board or committee of the association except as may be specifically provided by action of the association.
- H. The Promotional Director shall serve as historian for the Association. It shall be his responsibility to gather articles and materials for the historical collection. And also shall publish a history of Free Will Baptists, especially as it relates to the history of Free Will Baptists in North Carolina, and shall update the publication periodically.

The Executive Board may advise and assist other boards of the association. The Executive Board is not authorized to act for the association except as provided in the constitution and by-laws of the association or as specifically directed by the association.

Section 2. The Board of Trustees shall be legal custodian of all property belonging to the Association except in the case of the standing boards of the Association which by action of the association are authorized to incorporate.

Section 3. The Board of Missions Ministry, the Board of Care for the Aged Ministry, the Board of Youth Ministry, the Board of Retirement and Insurance Ministry and the Board of the Bible Book Store Ministry each shall promote the work within the State as would generally be recognized as coming within the purview of the respective board. Each board shall: (a) be responsible to the State Association for all their

actions, (b) propose by-laws for the government of their respective work, (the by-laws of each board shall be presented to the association for approval), (c) make an annual report of its accomplishments to the association, and (d) prepare a budget of proposed expenditures which shall be presented to the association for approval.

Section 4. The moderator shall, (1) preside at meetings of the State Association and Executive Board, (2) call meetings of the Executive Board of his own volition or upon request of at least three members of the Executive Board, (3) appoint such committees as are created without provision for their selection, (4) fulfill whatever responsibilities that may be commensurate with the office or that may be delegated by the association.

Section 5. The assistant moderator shall preside at the request of, or in the absence of the moderator and assist the moderator in such manner as may be requested.

Section 6. The clerk shall prepare minutes of the proceedings of all meetings of the association or the Executive Board and preserve an accurate record of said proceedings in a book provided for this purpose and shall handle such official correspondence as may be directed by the association. He shall, through the Executive Board, arrange for the printing of the minutes.

Section 7. The treasurer shall hold in trust all money that belongs to the Executive Board of the association and disburse same by order of the association. The Executive Board, or any standing board or subordinate general organization invested with the authority to authorize the disbursement of funds. He shall keep an account of all funds received and disbursed and make an annual report to the association.

ARTICLE IV. ELECTION OF OFFICERS AND BOARD MEMBERS

Section 1. No person shall hold membership on more than one standing board at the same time.

Section 2. All officers shall be elected by the body. A nominating committee shall be elected at the beginning of each session. After their report is presented, additional nominations for any office may be made from the floor. The General Officers shall be elected for a period of two (2) years. No person shall serve in more than one (1) elected position in the association at the same time, and no one having served a full term shall be elected to succeed himself more than once.

Section 3. The officers of Moderator and Assistant Moderator shall be filled on an alternating basis, from the eastern and western part of the state; Durham shall be the dividing line. When the Moderator is elected from one section, his assistant shall be elected from the other.

ARTICLE V. TERMS OF OFFICE

Section 1. The three (3) members at large elected to the board, shall each have a term of office of three (3) years with their terms arranged so that one (1) member's term expires annually.

Section 2. The members of the Board of Missions Ministry, the Board of Care for the Aged Ministry, the Board of Youth Ministry, the Board of Retirement and Insurance Ministry and the Board of the Bible Book Store Ministry shall each have a term of office of five (5) years with their terms arranged so that one (1) member's term expires annually.

Section 3. The members of the Board of Trustees shall each have a term of office of three (3) years with their terms arranged so that only one member's term expires annually.

ARTICLE VI. COMMITTEES

Section 1. Various committees shall be constituted when need arises, by the State Association or the Executive Board. The number of members of a committee shall be determined by the establishing body (State Association or Executive Board). Committee members shall be appointed by the moderator unless otherwise provided by the action creating the committee. Committee members shall serve for the length of time provided, until their work has been completed, until they are released, or their successors chosen.

Section 2. The following committees shall be appointed annually to serve during the session of the State Association.

- A. The credentials committee of three (3) members. This committee shall examine all letters to the association, applications for membership in the association, and credentials of the various delegates. The committee shall make recommendations to the Association regarding the seating of delegates and the action to take on applications for membership in the association.
- B. The resolutions committee whose duty it shall be to screen resolutions that are presented. Only resolutions determined by this committee to be worthy are to be presented to the association by the committee.
- C. The finance committee which shall receive and account for all funds received with letters or through offerings during the association.

ARTICLE VII. HONORARIUM AND REIMBURSEMENTS

Section 1. The Clerk shall receive as honorarium \$300.00 annually.

Section 2. Members of standing boards, or duly constituted committees, may be reimbursed for expenses in attending board meetings within the state, exclusive of the annual association meeting, at the rate of 20¢ per mile (may claim road distance if traveling by airplane). In addition if over-night travel is required, reimbursements may be made for actual meals and lodging expenses. No employee of any board may be reimbursed for any travel in excess of this amount.

ARTICLE VIII. QUORUM

18

A simple majority of a board or committee shall constitute a quorum.

ARTICLE IX. PROXY

No voting shall be done by proxy in meetings of the State Association. Proxy representation shall be accepted for meetings of the Executive Board provided the proxy is designated in writing by the board member or by oral communication between the member and the moderator.

ARTICLE X. PARLIAMENTARY AUTHORITY

The meetings of the State Association shall be governed by the rules of parliamentary law as set forth in Robert's Rules of Order except in the case of those rules which are superseded by rule of this association.

ARTICLE XI. AMENDMENTS

These by-laws may be amended by (1) majority vote of the members present and voting provided the amendment is presented on day prior to the vote, or (2) by a two-thirds majority of those present and voting if immediate action is to be taken as soon as debate has been completed.

MINUTES TWENTY-THIRD ANNUAL SESSION NORTH CAROLINA ASSOCIATION OF FREE WILL BAPTIST

June 3-4, 1985 ARRINGTON HEIGHTS FREE WILL BAPTIST CHURCH LEXINGTON, NORTH CAROLINA REV. LARRY ABERNATHY, PASTOR

MONDAY MORNING, JUNE 3, 1985, 10:00 A.M.

The twenty-third annual session of the North Carolina Association of Free Will Baptists convened Monday, June 3, 1985 at Arrington Heights Free Will Baptist Church in Lexington, N.C. After registration, the session began at 10:00 A.M. with Rev. E. E. McMillen presiding. Rev. Herman McFaddin led in singing, "Sunlight." Rev. Jack Lassiter read the Scripture, II Corinthians 6:11, spoke concerning the "Spiritually Enlarged Heart" and led in prayer. Host Pastor Rev. Larry Abernathy welcomed the assembly to the Arrington Church and to Lexington.

The session was called to order by the clerk, Rev. E. E. McMillen, and Rev. Robert Durham, the moderator, took charge of the meeting. The delegates were seated and visitors recognized.

The moderator told the assembly that the North Carolina State annual meetings were valuable for the work of Christ. He expressed his thankfulness for the direction the state was presently moving and encouraged the ministers and laymen to give strong support to the work. He spoke briefly on Ephesians 2:6 noting especially the word "together." He stated that more can be accomplished as we work together for the cause of Christ.

The first order of business was the appointment of committees. They were as follows:

Rev. Herman McFaddin led the assembly in singing, "I'd Rather Be An Old-Time Christian." Rev. Randy Sawyer sang the special music. The morning message was brought by Rev. Earl Hanna and his text was taken from Mark 12:28-34. He spoke on the subject, "The Ingredients We Need in the Church."

After the morning message the Executive Board's report was read. MSC to receive the report.

Rev. Tom Lilly, State Promotional Director, reported to the assembly that he had met with representatives of the Woman's Auxiliary relative to their merger with the North Carolina Association's Annual Session. They agreed to consider the proposal tentatively for 1987.

The Specific Recommendations of the Executive Board were read by the Clerk to be considered in the afternoon session.

Dr. Charles A. Thigpen, President of the Free Will Baptist Bible College, Nashville, Tennessee, reported on the college.

Rev. Joe Haas made a report on the Southeastern Free Will Baptist Bible College, Virginia Beach, Virginia.

After prayer, the Association meeting was recessed for lunch.

MONDAY AFTERNOON, JUNE 3, 1985, 1:30 P.M.

The afternoon session convened at 1:30 p.m. with Rev. Herman McFaddin leading the assembly in the "Hallelujah Chorus," and the hymn, "When the Roll is Called Up Yonder." Rev. Leroy Welch led in prayer. Rev. Jack Lassiter and his wife Alane sang a special selection.

The following reports were given:

<u>Promotional Department</u> - Rev. Tom Lilly, State Promotional Director, presented the report. He submitted information concerning the financial support of North Carolina Ministries verses National Ministries. (Copy of this report located in Digest Section under North Carolina Promotional Department). He emphasized that we must continue to develop the 70/30 Plan. The figure of support is presently about 21% to North Carolina and 79% to National Ministries.

Rev. Lilly expressed his appreciation for being allowed to serve as the state's Promotional Director. Pertinent information concerning the Greenville Land Project was presented. He encouraged the association moderators to attend the Coordinating Committee meetings. He concluded by saying we need to:

1. Be more equitable in the distribution of funds to reach our objectives;

2. Get in position where we can accomplish our objectives;

- 3. Gain the potential to do these objectives; and
- 4. Grasp our purpose.

It was MSC that we receive the report of the Promotional Department.

Rev. Sam Truett gave the Financial Report and presented the Promotional Department's Budget for 1985-1986. MSC to receive the report and adopt the budget.

The clerk, Rev. E. E. McMillen, presented specific recommendations from the Executive Board to the body for approval. The following recommendations were acted on by the body:

(1) MSC: "Add an accidental clause for coverage of \$150,000 for Mrs. Loretta Lilly on Rev. Tom Lilly's present 'key man' insurance policy. Such additional premium to be paid for by the North Carolina Association of Free Will Baptists."

(2) MSC: "Due to the possibility of the Woman's Auxiliary combining their annual meeting with the North Carolina State Association meetings commencing in 1987, that invitations to sponsor the site for future State Association meetings be submitted to the Executive Board two years in advance to allow review of adequate accommodations and restaurant facilities."

(3) MSC: "That Article VII, Section 1 of the Constitution be amended to read, 'The Clerk shall receive as honorarium \$300.00 annually,' vice 'The Clerk shall receive as honorarium \$200.00 annually.'"

(4) MSC: "That the North Carolina Association of Free Will Baptists submit an invitation to the Executive Office of the National Association of Free Will Baptists requesting that this state be considered to host the 1995 National Convention."

(5) MSC: "That by the 1986 North Carolina State Annual Meeting that the churches of the state of North Carolina do their best to raise at least \$75,000 toward the Greenville Land Project."

Rev. Cecil Boswell gave a partial report of the Credentials Committee.

Bro. James Stancil reported for the Bible Book Store. MSC to accept this report.

Rev. Randy Sawyer reported for the Board of Youth Relations and presented the proposed budget. MSC to accept the report and adopt the budget.

Rev. Bennie Turner reported for the Board of Missions Ministry and Rev. A. C. Morgan presented the Financial Report and proposed budget. MSC to receive these reports and adopt the budget.

Rev. Milton Hollifield reported for the Board of Care for the Aged Ministry and presented the budget. MSC to receive the report and adopt the budget. Rev. George Lee gave a report for the Board of Retirement and Insurance Ministry and Rev. James Pauley gave the Financial Report. MSC to receive the reports.

The afternoon meeting was adjourned with prayer.

MONDAY EVENING MISSION SERVICE, JUNE 3, 1985

Rev. Bennie Turner presided over the service. The service began by the congregation singing "When the Roll is Called up Yonder," after which Rev. Earl Hanna led in prayer. Then the Sherwood Park Choir, led by Bob Anderson sang, "Only One Life," and "The Old Rugged Cross."

Rev. Randy Stone introduced the following State Missionaries: Rev. James Pittman (Havelock), Rev. Roger Tripp (Hickory), Rev. Johnny Pike (Charlotte) and Rev. Steve Pryor (Henderson).

The congregation sang another hymn, "Victory in Jesus," after which the Minister's Quartet sang the special music.

The evening message was brought by Rev. Richard Hendrix who spoke from Ecclesiastes 11:1. He stated that a man could do an enormous amount for God is he didn't care who got the glory. After the message the Missions offering was taken (\$596.79) and Rev. A. C. Morgan prayed the prayer of benediction.

TUESDAY MORNING, JUNE 4, 1985, 9:00 A.M.

The session reconvened at 9:00 A.M. with Rev. Sam Truett presiding. The congregation sang a hymn and Rev. Bronco West led in prayer. After special music by Johnny Allen, the morning offering was received.

Rev. James Pauley brought the morning message from Galatians 1:6-12 and spoke on the subject, "Old Time Religion."

Following the message the assembly entered into its business session.

Rev. Cecil Boswell gave the final Credentials Committee Report. NSC to receive the report.

Rev. Jack Williams, editor of Contact Magazine, presented a report for the National Executive Department. MSC to receive as information.

A motion was made to recommend Rev. Tom Lilly as a speaker for the next National Association. MSC

No representative was present from the National Sunday School Department, however, a letter providing the department's report was passed out to the assembly. MSC to receive as information. Rev. Johnny Pike gave the Leah Waddell Scholarship Fund Report. MSC to receive this report.

Rev. Jimmy Aldridge gave a report from the National Foreign Missions Department. MSC to receive as information.

Rev. John Gibbs gave a report for the National Home Missions Department. MSC to receive as information.

Jim Vallance gave reports from both the Master's Men and Radio and TV Commission. MSC to receive both reports as information.

Rev. Randy Cox presented the following resolutions from the Resolutions Committee:

RESOLUTION #1

Whereas,

Arrington Heights Church has been gracious in their hospitality and preparation for this Association;

Be it resolved that we give a rising vote of thanks to their Pastor Brother Larry Abernathy and his people.

MSC and the rising vote exhibited by the standing of the assembly.

RESOLUTION #2

Whereas,

concerted efforts are now being made in our state by the Governor and some members of both the House and Senate to end tax-funded abortion on demand;

Be it resolved that we again firmly declare our objection to the murder of the innocent unborn, and;

Be it further resolved that we urge our people to contact both their area legislators and the Governor urging them to pass legislation to stop this holocaust in our state.

RESOLUTION #3

Whereas,

it is highly recognizable that pornography is totally anti-Christian and anti-family, and;

Whereas.

over 300,000 children, ages 10 months to 16 years old are used in the making of pornographic material each year, and;

Whereas,

North Carolina leads the nation in sales and distribution of pornography with the highest number of pornographic outlets per capita of any state, and;

Whereas,

North Carolina, combined with South Carolina, has the greatest number of X-rated movie theaters in our nation, and;

Whereas,

there is an Obscenity Bill (House Bill 1171) pending in our State Legislature;

Be it resolved, that the North Carolina Association of Free Will Baptists go on record once again against pornography and all the wickedness associated with it, and;

Be it further resolved, that the North Carolina Association of Free Will Baptists encourage all of our pastors to lead their churches in the statewide "Day of Prayer to Stop Pornography" on June 9, 1985, and;

Be it therefore further resolved, that the North Carolina Association of Free Will Baptists encourage all of our pastors to encourage their congregations to write and/or phone their state legislators voicing their support of the Obscenity Bill (House Bill 1171).

The Nominating Committee Report was made and MSC to elect according to the report submitted (Report located in the Reports Section of the Minutes).

It was recommended that each year the Nominating Committee of the Association submit names to the Executive Board to forward to the National Association Nominating Committee for consideration for existing vacancies on the National Boards. MSC.

EXECUTIVE BOARD REPORT

During the past year the Executive Committee met three times as authorized by the Constitution and By-Laws or as directed by this body. We endeavored to transact the business of the North Carolina Association of Free Will Baptists.

On October 22, 1984, the Executive Committee and Coordinating Committee met at the Ramada Inn, Durham, N.C. and reconvened on October 23rd, at the Shady Grove Free Will Baptist Church, Durham, N.C.

Several ideas were offered in regard to a more expedious method of liquidating the land payment on the Greenville, North Carolina Land Project. Two projects adopted were:

(1) Churches were to be encouraged to take a special offering on December 16th for the Land Fund. The project was to be called the "State Christmas Project."

(2) Churches were to be encouraged to take a special offering during "Roll Call Sunday," March 31st, 1985.

Various aspects of the Greenville Land Project were discussed and the Committee received a report from the State Promotional Director. The program for the "Claim the Land for Christ" and proposed award certificates were explained to the Committee by the Promotional Director.

Discussion was held concerning the state meeting and it was observed that efficiency in preparation of the departmental reports submitted for the annual Digest of Reports was needed; the committee agreed that the state meetings needed to be promoted and services geared to move efficiently; and consideration of a central location for state meetings needed to be studied. Also the need for one man to be selected to coordinate the music program for the state meetings was considered.

A recommendation was offered to utilize the services of the Promotional Director as a special building consultant to the State Missions Board in future state home mission projects.

The various North Carolina Ministries made their reports and general discussion was conducted.

On February 12th, 1985, the Executive Committee met at the West Calvary Free Will Baptist Church, Smithfield, N.C. The State Promotional Director presented information relative to the progress of the Greenville Land Project. After receiving the information the Committee discussed several options to enhance the Land Project. These options included:

(1) Emphasize the "March Roll Call Sunday," March 31st, whereby each church would be encouraged to raise \$1.00 per person in attendance at Sunday School.

(2) Initiate a Gideon 300 Band--300 people to commit to giving \$10.00 per month for a period of one year or more.

(3) Hold regional banquets, whereby pastors and laymen would be invited, challenged by the State Promotional Director and encouraged to commit themselves to a monthly designated amount. The use of the "checkbook" system could be effectively utilized.

(4) Challenge each church to bring a special offering to the state meeting in June 1985.

(5) Executive Board to write a positive letter of encouragement to each state pastor requesting their comments on the Greenville Land Project and completion of a questionnaire to be returned to the State Moderator.

(6) Executive Board to write a letter to each association moderator to inform them of the need and encourage their personal support.

During the meeting it was discussed concerning the feasibility of forming a committee to investigate future sites for state meetings in order to check on adequate motel and restaurant facilities. The State Promotional Director was requested to meet with the Executive Committee for the North Carolina Ladies' Auxiliary to discuss the possibilities of including the Annual Ladies' Auxiliary Conference with the Annual North Carolina State Association Conference beginning in the year of 1986.

On April 8th, 1985, the Executive Committee and Coordinating Committee met in Durham, N.C., at the Carolina Duke Motel.

The Moderator discussed the recent Questionnaire relative to the Greenville Land Project sent to the Pastors of the state of North Carolina and notified the committee that only 16 of 190 questionnaires had been received.

The State Promotional Director presented to the committee his guarterly and annual financial reports and these reports were reviewed.

The Board discussed reviewing future state meeting sites. Recommendation from this discussion is listed in the Executive Committee's Recommendations at the end of this report.

The Promotional Director informed the committee that he had made an appointment with the Executive Board and Field Workers to discuss coordinating the Annual State Ladies' Auxiliary Meeting with the regular State Meeting of the North Carolina Association.

The State Promotional Director informed the Committee that the response from the "Roll Call Sunday" did not provide much revenue to the Greenville Land Project. The annual fees for the state meeting were discussed. The Moderator informed the committee that our people needed to be better informed concerning the work of the North Carolina State Home Missions, both progress and needs.

The Executive Committee and Coordinating Committee reconvened on April 9th at the Liberty Free Will Baptist Church. The various state boards were dismissed for their separate meetings. After their dismissal the Executive Committee prepared the budget for the State Promotional Department and discussed various aspects of the Greenville Land Project. The schedule for the state meeting was finalized. Rev. Roy Harris was selected to complete the unexpired term of Rev. Eddie Dollar who resigned as Assistant Moderator. It was suggested that the Nominating Committee at the State Meeting be requested to recommend nominees from North Carolina to the General Board of the National Association to fill vacant positions on the National Boards.

The combined committees met together to receive the reports of the various boards of the state and their budgets. Further discussion was held on the Greenville Land Project.

We believe that this report reflects a fair and accurate summation of the endeavors of the Executive Committee during the meetings of the past year.

PROMOTIONAL DIRECTORS REPORT

The CPA's Compilation Report presented in this digest represents the cash receipts and disbursements of the fiscal years ended March 31, 1985, 1984 and 1983. The fiscal year ended March 31, 1985, reflects income transferred from the State Program in it's consolidation with the Promotional Department during that year. With the exception of the funds transferred from the State Program, the receipts fairly represent giving (some designated and some undesignated) to or through the Promotional Department during it's most recent fiscal year.

With receipts to the Promotional Department totalling \$106,106.83 during the past fiscal year, we have reached a 200% increase over a period of three years from 1982. This has been realized by increased support of our churches, "North Carolina Day" services and giving through the "70/30" plan as well as special gifts to the land project for the new office building.

Giving to the land fund has enabled us to apply \$28,687.44 toward the project, and the balance has been reduced to \$91,834.90 as of March 31, 1985. Additional giving to the project since March 31, 1985 amounts to \$7,771.43, making a total of \$36,458.87 by May 30, 1985.

I could not ask for a better spirit of co-operation among the pastors and congregations of our churches throughout the North Carolina Association. I am deeply grateful for the kindness, support, and encouragement everyone has been to me in this ministry as your Promotional Director.

I am committed to our "bottom line," namely; "preaching the gospel, winning the lost, and planting churches throughout North Carolina."

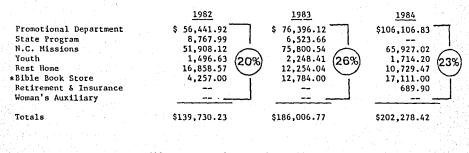

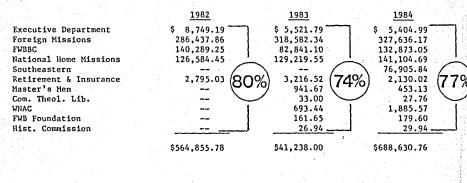

Gifts-Receipts from North Carolina To FWB Ministries OUTSIDE North Carolina



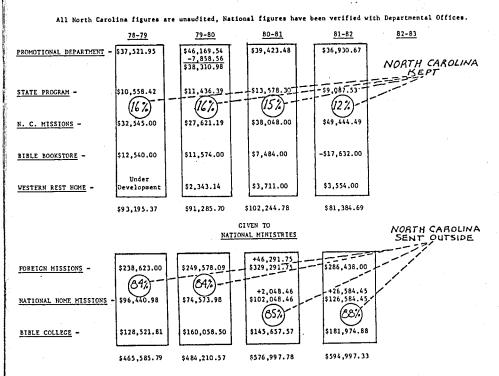

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 1984

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AND OTHER MATTERS

The accompanying financial statements include the accounts of The Bible Book Store of Durham, Inc., a subordinate member organization of the National Association of Free Will Baptists. Accordingly, it is exempt from Federal income taxes under the Internal Revenue Code Section 501(c)(3). The primary function of the Corporation is supplying Sunday School and other Christian literature to the Free Will Baptist Churches in the southeastern states. It also maintains an inventory of Christian literature for sale to the general public. The store accounts for sales and expenses on the accrual method.

Merchandise inventory was taken at retail by seven classifications: Bibles, books, cards, supplies, music, Sunday School literature, and rebound books. A weighted average markup of retail over cost was derived for each classification and then applied to the retail value to derive an inventory value at lower of cost or market.

Bad debts are accounted for by the "direct-charge off" method whereby accounts are charged off as they are determined to be uncollectible.

Other significant accounting policies relate to long-term debt, plant and equipment, lease expense and major sales categories. Their policies are disclosed in Notes 1, 2, 3, 4 and 5, respectively.

NOTE 1

Sinking fund accounts of \$3,778 included in cash are restricted for retirement of long-term debts consisting of bonds and the interest on these bonds as they become due. (See Note 2, below)

The store occupies an outside-the-mall location at the North Duke Mall in Durham, North Carolina. For the lease year, May 1, 1983 to April 30, 1984, the minimum monthly rental rate was \$894. In addition to the minimum rent, the lease requires payment of additional rent of 347 of gross annual sales in excess of \$306,429. For the lease year May 1, 1984 to April 30, 1985, minimum rent payments are \$1,123 per month. Additional rents of $3\frac{1}{2}$ % of gross annual receipts in excess of \$385,000 are required.

NOTE 5

Sales for the year ended December 31, 1984 were \$311,212 of which \$159,277 or 51%, was generated from the service of supplying Sunday School and Vacation Bible School materials to member churches of the Free Will Baptist Association. Sales of \$151,935, or 49%, were generated from the retail sales of Christian literature, paintings, music, cards, and supplies as well as limited services of imprinting and binding of paper products. The classifications of sales comprising the \$151,935 figure are: Books \$42,521; supplies \$46,604; music \$17,992; Bibles \$27,517; cards \$7,174; imprinting and binding \$1,698; and Sunday school literature to non-member churches \$8,429.

NOTES TO FINANCIAL STATEMENTS December 31, 1984

Note 1

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The following is a summary of accounting policies of the organization which are considered to be significant.

CASH BASIS: The accounting records are maintained on the cash basis. While adjustments necessary to prepare an accrual basis could be determined, the accompanying statement has been prepared strictly on the cash basis. Such statement does not purport to show the entire results of operations.

TAX STATUS: The rest home was incorporated October 18, 1976 under the laws of North Carolina as a non-profit corporation.

PROPERTY AND EQUIPMENT: The values of the facilities and furniture and fixtures are recorded at estimated cost. Actual cost figures are not readily available. Transportation equipment is shown at actual cost of \$6,063 for one vehicle and at a market value at the time donated of \$1,000 for the other vehicle. Under generally accepted accounting principles, such property and equipment would have been recorded at cost.

DEPRECIATION: All depreciable assets except transportation equipment are depreciated using straight line method of depreciation. The building and improvements are being depreciated over a 25 year period. The other assets are being depreciated over 10 years. The transportation equipment is being depreciated over 3 years using the ACRS method.

Note 2

BOND ISSUE - Series A

The corporation authorized the issue of \$120,000 in 9% first mortgage development bonds dated August 15, 1978. Funds were used to construct the rest home facilities. Security for the bonds consists of the land and building of the rest home. A sinking fund is maintained to retire these bonds.

BOND ISSUE - Series B

The corporation authorized the issue of \$120,000 10-10.5-11% Second Mortgage Serial Sinking Fund Bonds Series B dated October 1, 1983. A portion of these bonds have been sold and the proceeds are on deposit in the sinking fund. Upon completion of the sale of these bonds, the proceeds will be used to expand rest home facilities.
