### FIRST DAY—MORNING SESSION

The North East Mississippi Association of the Free-Will Baptist met in the Fifth Annual Session with Springdale Church, on Thursday, the 21st day of September, 1939 and continued thru Friday, the 22nd.

The Association came together by singing conducted by Bro. W. G. Prude of East Tupelo. Rev. J. M. Haas, the MD read from Rom. 12 chapter. Prayer by Geo. C. Lee.

The Moderator called for church letters and the following churches represented by letter and delegate, which letters were read to the body by Mrs. Clyde Goodson and Mrs. Lester Duncan, who were appointed by the Moderator as Reading Clerks. Greetings to North East Mississippi Association of Free Will Baptist, when convened with Springdale Church. I have preached 45 sermons, prayed many prayers, visited 15 sick folks, pastored 1 church, conducted 2 revivals, married 4 couples, received \$7.50, had 9 conversions.

I have preached 22 sermons, married 3 couples, hope to do more next year.

G. W. KENNEDY

I have preached 90 sermons, traveled 5656 miles, paid out expense \$112.25, collected as help \$334.37, had 13 funerals, pastored 4 churches, received into church 42 members, baptised 33, had 54 converts, married 2 couples, had many reclaimed, visited and prayed with many sick.

I have preached 30 sermons, prayed many prayers, visited many sick, baptised 7, had 8 converts, conducted 1 revival, married 1 couple, conducted 2 funerals, received \$19.50, traveled 400 miles.

### SUNDAY SCHOOL

Realizing that the Sunday School of today will be the church of tomorrow, we the committee on Sunday Schools, urge that every possible effort be made to build bigger and better schools. If the school is to be made its best the ministers and laymen of the church must lay a foundation on which the youth of today may build an effective teaching of the principles of our Lord and Savior Jesus Christ. If there should be churches who wish to have Sunday Schools organized the Sunday School Association will send some one to help. We suggest the North East Miss. Sunday School Association which meets with the Columbus F. W. Baptist the 5th Sunday in July, 1940, of the 15 churches of this association, only 8 report Sunday Schools. They are East Tupelo, Fawn Grove, Pearces Chapel, Beech Springs, Springdale, Columbus, Union Hill and New Macedonia. We suggest that an interest might be assured in a Sabbath School by having more singing. Just as singing prepares you for God's message, so will it for the Sunday School. Praying that we Christians will listen to the Master's commands and let Him have His way and lead us in this work we feel that the association will find more active Sunday Schools at the next session of our association.

### CHRISTIAN EDUCATION

We, your committee, beg leave to submit the following report: Realizing that we, as Free Will Baptist, have no facility for the higher educational training of our young people, and we of the Northeast Mississippi Association wishing to do our part in the work which is now under way we respectfully recommend:

First—That each church composing our association appoint a committee of young people, interested in giving to a college owned and taught by Free Will Baptist, to solicit funds for the building of same, and that these funds be sent to the next session of our Association so that it may be placed upon the minutes.

Second—That every family subscribe for one or both of the following named denominational publications: Free Will Baptist Weekly published at Ayden, N. C., The Free Will Baptist Gem, published at Monette, Mo. We feel sure that you will take more interest in your church if you will read of the activities in other sections.

Third—That ministers make an effort to teach at least a two weeks Bible course in their respective churches during the coming year.

Fourth—That every man, woman, boy and girl bend every effort to read at least one chapter in the Bible each day during the next year.

Fifth—That our minister and laymen take more interest in all phases of the young peoples work, namely Sunday School, League and Fellowship Activities.

Sixth—That as parents we strive to furnish our young people that type of literature that will stress clean living and Christian character.

Seventh—That our church leaders provide clean wholesome entertainment under the direction of Christian adults, thereby helping them to have the entertainment their young lives crave without having to go elsewhere and perhaps be led in the wrong way.

Third—That expense of association not be paid out of mission funds. We feel that to date a glorious work has been done in the home mission field, and with God's help and your cooperation we can go on and accomplish great good for the association, and God's glory.

We ask that the body authorize committee to insure Tent for (\$300.00) three hundred dollars, provided same can be attained at moderate cost.

## CONSTITUTION .

Section 1.—This organization shall be known as the North-East Mississippi Association of Free Will Baptist and shall be composed of ministers, deacons, clerk, and delegates of the various churches of this Association.

Section 2.—The purpose of the Association shall be to bring together our churches throughout North Mississippi for a closer union among our people and the establishment of new churches in our state.

Section 3.—This Association shall be composed of churches of the above named territory together with like bodies of same Faith and Practice which may be hereafter admitted.

Section 4.—Each church shall be allowed delegated representatives and they must be duly appointed by their church while in conference and bear credentials from the same to this body.

Section 5.—Visiting ministers and delegates may be seated as advisory members in this body.

Section 6.—It shall not be the purpose of this Association to usurp authority over the churches but to recommend such measures as would promote unity of action among the churches, to harmonize the efforts of individual churches to one another in their efforts to accomplish good, and make each other more proficient in their undertakings for good.

Section 7.—This constitution may be altered or amended by a vote of the yearly meeting at any session, notice of such intended alteration having been given in writing, and recorded at the next previous session.

## RULES OF DECORUM

Section 1.—The officers of this Association shall consist of a Moderator, Clerk and Treasurer, who shall be elected at the close of each session by a majority vote of the delegates present.

Section 2.—This Association shall hold its sessions annually beginning on Thursday and continue through Friday before the fourth Sunday in September.

Section 3.—The Moderator shall have the right to appoint all committees.

Section 4.—The Clerk shall have the right to supervise the printing of the minutes and shall be allowed \$10.00 for his service; Treasurer, \$5.00, and Moderator, \$5.00 for their services.

Section 5.—No member shall absent himself from the body without leave of the Moderator.

Section 6.—All members desiring to speak shall arise, address the Moderator, and personal reflections shall be avoided.

Section 7.—All motions made and seconded shall be open for discussion, but debate may be shut off at any time by a majority of the members of the Association.

Section 8.—If any proposition or motion under debate contain two or more points, it shall be divided at the request of any member and the vote taken separately.

Section 9.—Motions made and lost shall not be recorded on the minutes unless so ordered at the time.

Section 10.—No one shall be allowed to speak more than twice on the same subject, and not more than ten minutes at a time; without special leave from the body.

Section 11.—All questions shall be decided by a majority of the members present.



## ARTICLES OF FAITH

Article 1.—THE BIBLE—The Scriptures of the Old and New Testaments were given by inspiration of God and the Scriptures of the New Testament are our infalible rule of Faith and Practice.

Article 2.—GOD—There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe, and in the Scriptures as Father, Son and Holy Spirit, yet as one God, infinitely wise and good, whom all intelligent creatures are to love, adore, and obey.

Article 3.—CHRIST—Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified and is our ever present Savior and Lord.

Article 4.—THE HOLY SPIRIT—The Scriptures assign to the Holy Spirit all attributes of God. He is the reprover, comforter, guide and sanctifier of men.

Article 5.—THE GOVERNMENT OF GOD—God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and the laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.

Article 6.—THE SINFULNESS OF MAN—Man was created innocent but by disobedience fell into a state of sin and condemnation. His posterity therefore inherit a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God.

Article 7.—THE WORK OF CHRIST—The Son of God by His incarnation, life, sufferings, death and resurrection affected for all a redemption from sin that is full and free and is the ground of salvation by faith.

Article 8.—THE TERMS OF SALVATION—The conditions of salvation are: 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Savior and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death.

Article 9.—ELECTION—God determined from the beginning to save all who should comply with the condition of salvation. Hence by faith in Christ men become His elect.

Article 10.—FREEDOM OF THE WILL—The human will is free and self-controlled, having power to yield to the influence of the truth and the Spirit, or to resist them and perish.

Article 11.—SALVATION FREE—God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take the water of life freely.

Article 12.—PERSEVERENCE—All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal salvation.

Article 13.—GOSPEL ORDINANCES—Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel. Feet Washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers.

Article 14.—THE CHRISTIAN SABBATH—The divine law requires that one day in seven be set apart from peculiar employments and amusements, for rest, worship, holy works and activities, and for personal communion with God.

Article 15—RESURRECTION, JUDGEMENT AND FINAL RETRIBUTION—The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done ill unto the resurrection of judgement; then the wicked will “go away into eternal punishment but the righteous into eternal life.”
