FIRST DAY—MORNING SESSION

The North-East Mississippi Association of the Free Will Baptist met in the Sixth Annual Session with Damascus Church, on Thursday, the 19th day of September, 1940, at 9:30 a. m., and continued through Friday the 20th.

The Association came together by singing, Rev. Geo. C. Lee leading. The Moderator, Rev. R. V. Guyton, took the stand and read 33rd Psalm, followed by prayer by Rev. M. L. Hollis.

The Moderator called the pastor of the church to make a talk after which Brother Hollis was called to the floor and made a short talk and had an old-time heartfelt testamony and experience meeting all of which was very appropriate and full of Spirituality.

Rev. D. W. Jones was present and given the floor for two songs. Then Brother W. G. Prude took the floor and sang The Old Time Religion.

The following church letters were presented to the Clerk and read: Beech Springs, Priceville, Bethlehem, Antioch, Gauley, Damascus, Stetson Chapel, East Tupelo, Columbus, Fawn Grove. Reading Clerks were Mrs. L. E. Duncan and Miss Hilma Stone.

These letters were read and the delegation seated after there had been the usual hand-shaking in a fellowship meeting. Thus the body was duly organized and ready for business. The Association adjourned for preaching.

Rev. Fondren being absent the Program Committee called Rev. J. M. Haas to the stand and Bro. Haas preached an inspiring message, using Isa. 9-6 as text, "Wonderful."

Adjourned for lunch.

FIRST DAY—EVENING SESSION

The Association was called together by singing led by W. G. Prude. Scripture reading by Rev. D. M. Smitherman, Heb. 12th Chapter.

Rev. D. W. Jones, a representative from The Little Brown Creek Association of North Mississippi, was present and given a seat with us as corresponding delegate from said Association.

At this time Union Hill and Pleasant Grove letters were received, read and received and delegates given seats with us.

Believing that no church can successfully carry on the Lord's work without a live Sunday School, we ask that each church not at present having a school, organize and support same. Statistics show that 90 per cent of church members come from Sunday Schools. We ask that every Sunday School adopt and carry out as near as possible the standard of efficiencies as adopted by the National Association.

One of the greatest tasks of the church today is to save the youth of tomorrow. That there is an awakening to this self-evident fact, is indicated by the new interest being taken in religeous education by our ministers and church workers who are really interested in seeing our work put upon a higher plane of efficiency, and also by the fact that leaders and students of Christian Education are finding in the new work a fitting field in which to give themselves in Christian service to the cause of humanity.

Of course the church cannot take the place of the school. The home cannot, even in Christian teaching, for there is twelve or fifteen years in the life of the children of our country that is spent in the school room and are under the influence of the school. Hence we need religeous instructions included in our educational system, but not having that we must, as a body of Christian people, pool our resources in order to build and equip a place of higher learning to which we can look forward to as a source of denominational strength. One of our greatest needs today is to educate our evangelistic forces, and if we expect to balance, sustain, and empower our

spiritual energies and aid in bringing in the reign of Jesus Christ in all the world we must be doing whatever we can to establish a training center.

First, that we observe October as Christian Education Month.

Second, that each church appoint a committee to solicit funds during October for the purpose of aiding financially in the building and equipping of a Free Will Baptist School for the training of our clergy and Christian workers.

Third, that these funds be kept in the treasury of North-East Mississippi Association until such time as the National Association begins work on the school.

Fourth, that the secretary for the National Board of Education be sent a report of the funds collected and retained for building of same.

Fifth, that all our churches make an effort to have some of their workers or leaders attend the Bible School and Training course that will be held at Natchez Trace Recreational Project August 10-16, 1941.

God has created us to live by Him, so let us all pray as if everything depended upon God and work as if everything depended upon us. Psalmist says, "Thy word is a lamp unto my feet, and a light unto my path." So let us remember that without this lamp, education fails to save the youth of tomorrow.

HOME MISSION REPORT

As your Associational Evangelist, I beg leave to make the following report of my year's work. Having nine churches to look after as pastor I have not had time to do the work that should have been done, however, I have taken time out to hold the following meetings with the tent in places where we have no church. I was in the midst of a meeting in Mantachie, Miss., during the setting of the last Association and carried on for a week after the Association closed. We felt that much good was accomplised in this meeting. Great crowds attended each service and a fine spirit of interest was shown, so much that they have asked for another meet-

ing this fall. Many confessed Christ as their Savior, seven of this number taking membership in our Fawn Grove Church. From there we moved the tent to Vernon, Ala., where we once had a church but it had died and many of the members had joined other churches. The weather became so bad that we were not able to continue services under the tent, so the Missionary Baptist people tendered the use of their church to us for the rest of the week and God blessed in a very great way. We got several of the old members back and made an effort to re-organize the church. Tore the old delapidated building down and cleaned off the lot to start the new building. The bad weather came on and we were not able to do any more until two weeks ago we went back and started another tent meeting in which God showed His mighty power in saving of souls and renewing back-sliders. We secured a deed to a lot right in the heart of town, 111x196 feet, raised \$1285.00 cash with many more pledges to be paid in sixty days. We bought and paid for thirty-five thousand brick, had ten thousand on the yard Wednesday when I left and the walls up to bottom story windows, with five men working laying brick, and three making window and door casing.

In April I went to Sulligent, Ala] (and held a two-week's meeting which resulted in a great awakening to the whole town. Having something over a hundred to confess faith in Christ and many of the old residents said that there was the largest crowds that had ever attended a religious service in Sulligent. We have fine prospects for a good church there. From there we moved to Fulton, Miss., where we had fine crowds and good interest, with twenty-three confessing Christ as their Savior during this two-week's meeting.

I have had many calls for tent meetings that I was not able to arrange for. Truly the fields are white to harvest, and how we need to go out and possess the land. I have received for my services as evangelist from the Home Mission Board the sum of \$50.00.

Jones and Sister Elzey Johnson prayed the dismissing prayer, and thus closed one of the best and most soul stiring sessions of the North-East Mississippi Association of Free Will Baptist. The Association sang "God Be With You 'Til We Meet Again." All met in altar and had an old-time Christian hand shaking, then we were dismissed by Bro. M. L. Hollis.

CONSTITUTION

Section 1.—This organization shall be known as the North-East Mississippi Association of Free Will Baptist and shall be composed of ministers, deacons, clerk, and delegates of the various churches of this Association.

Section 2.—The purpose of the Association shall be to bring together our churches throughout North Mississippi for a closer union among our people and the establishment of new churches in our state.

Section3.—This Association shall be composed of churches of the above named territory together with like bodies of same Faith and Practice which may be hereafter admitted.

Section 4.—Each church shall be allowed delegated representatives and they must be duly appointed by their church while in conference and bear credentials from the same to this body.

Section 5.—Visiting ministers and delegates my be seated as advisory members in this body.

Section 6.—It shall not be the purpose of this Association to usurp authority over the churches but to recommend such measures as would promote unity of action among the churches, to harmonize the efforts of individual churches to one another in their efforts to accomplish good, and make each other more proficient in their undertakings for good.

Section 7.—This constitution may be altered or amended by a vote of the yearly meeting at any session, notice of such intended alteration having been given in writing, and recorded at the next previous session.

RULES OF DECORUM

Section 1.—The officers of this Association shall consist of a Moderator, Clerk and Treasurer, who shall be elected at the close of each session by a majority vote of the delegates present.

Section 2.—This Association shall hold its sessions annually beginning on Thursday and continue through Friday before the fourth Sunday in September.

Section 3.—The Moderator shall have the right to appoint all committees.

Section 4.—The Clerk shall have the right to supervise the printing of the minutes and shall be allowed \$10.00 for his service; Treasurer, \$5.00; and Moderator, \$5.00 for their services.

Section 5.—No member shall absent himself from the body without leave of the Moderator.

Section 6.—All members desiring to speak shall arise, address the Moderator, and personal reflections shall be avoided.

Section 7.—All motions made and seconded shall be open for discussion, but debate may be shut off at any time by a majority of the members of the Association.

Section 8.—If any proposition or motion under debate contain two or more points, it shall be divided at the request of any member and the vote taken separately.

Section 9.—Motions made and lost shall not be recorded on the minutes unless so ordered at the time.

Section 10.—No one shall be allowed to speak more than twice on the same subject, and not more than ten minutes at a time; without special leave from the body.

Section 11.—All questions shall be decided by a majority of the members present.

ARTICLES OF FAITH

Article 1.—THE BIBLE—The Scriptures of the Old and New Testaments were given by inspiration of God and the Scriptures of the New Testament are our infalible rule of Faith and Practice.

Article 2.—GOD—There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe, and in the Scriptures as Father Son and Holy Spirit, yet as one God, infinitely wise and good, whom all intelligent creatures are to love, adore, and obey.

Article 3.—CHRIST—Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified and is our ever present Savior and Lord.

Article 4.—THE HOLY SPIRIT—The Scriptures assign to the Holy Spirit all attributes of God. He is the reprover, comforter, guide and sanctifier of men.

Article 5.—THE GOVERNMENT OF GOD—God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and the laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.

Article 6.—THE SINFULNESS OF MAN—Man was created innocent but by disobedience fell into a state of sin and condemnation. His posterity therefore inherit a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God.

Article 7-THE WORK OF CHRIST-The Son of God by His incarnation, life, sufferings, death and resurrection affected for all a

redemption from sin that is full and free and is the ground of salvation by faith.

Article 8.—THE TERMS OF SALVATION—The conditions of salvation are: 1. Repentence or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Savior and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the domination of sin and becomes a child of God. 3. Continuance in faith and obedience until death.

Article 9.—ELECTION—God determined from the beginning to save all who should comply with the condition of salvation. Hence by faith in Christ men become His elect.

Article 10.—FREEDOM OF THE WILL—The human will is free and self-controlled, having power to yield to the influence of the truth and the Spirit, or to resist them and perish.

Article 11.—SALVATION FREE—God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take the water of life freely.

Article 12.—PERSEVERENCE—All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal salvation.

Article 13.—GOSPEL ORDINANCES—Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel. Feet Washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers.

Article 14.—THE CHRISTIAN SABBATH—The divine law requires that one day in seven be set apart from peculiar employments and amusements, for rest, worship, holy works and activities, and for personal communion with God.

Article 15.—RESURRECTION, JUDGMENT AND FINAL RETRIBUTION—The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done ill unto the resurrection of punishment but the righteous into eternal life."
