#### THURSDAY MORNING SESSION

The Northeast Mississippi Association of Free Will Baptist met in the Eleventh Annual Session with Depriest Chapel Church, near Gattman, Miss., on Thursday September 20, 1945 at 10:00 a.m.

Called together by song service after which Rev. M. L. Hollis, Assistant Moderator took charge in the absence of the Moderator. Rev. J. M. Haas who was sick. Rev. George C. Lee. clerk and Bro. W. G. Prude. Treasurer were present. Rev. E. W. Graves and Mrs. Larue Marcy were appointed as reading clerks and letters were read from the following churches; Amory, Antioch, Beech Springs, Bethlehem, Columbus. #### COMMITTEE REPORTS

#### Sunday School:

We recommend that all churches that do not have Sunday School organize at once. We realize that the youth of today are the grown-ups tomorrow and that if we have better churches and better people that this phase of Christian training is badly needed.

We further recommend that Free Will Baptist literature be used in our Sunday Schools and that Spiritually led men and women of our own denomination be used as teachers and officers.

We also recommend the advertising of our Sunday School by invisiting those with whom we come in contact with day by day that do not attend, by so doing we feel that our enrollments will show a decided increase. To those we are not able to give a personal invitation by word we feel that they should be contacted by mail. We feel that if these recommendations are followed that we will have a larger attendance in our Sunday Schools another year. We find fourteen churches reporting Sunday Schools this time, and we trust that we may have 100 per cent report another year.

We, your Committee on League make the following report: We urge that each church which has not a League organize one as soon as possible. We feel that if we make our programs more interesting that we can draw more of the youth to the church. We urge that each leaguer work wholeheartedly toward getting more into the work. This is a work in which we can be, if our lives are yielded to Him, a soul winner for our Master. If we will get them into our League we are helping to bring them into the church as Christian workers. We find eight Leagues reported.

We noticed from the reading of church letters that very few of the churches have Ladies' Aid Society. We feel that a Ladies Aid Society is one of the best assets to any church and sincerely hope that more of our churches will report an organization of this type by next association. We find that only four churches reported a Ladies Aid. Several talks were made by those who have this work and gave oral reports of work accomplished.

#### CONSTITUTION

Section 1.—This organization shall be known as the North East Mississippi Association of Free Will Baptist and shall be composed of ministers, deacons, clerks, and delegates of the various churches of this Association.

Section 2.—The purpose of the Association shall be to bring together our churches throughout North Mississippi for a closer union among our people and the establishment of new churches in our state.

Section 3.—This Association shall be composed of churches of the above named territory together with like bodies of same Faith and Practice which may be hereafter admitted.

Section 4.—Each church shall be allowed three delegated representatives and they must be duly appointed by their church while in conference and bear credentials from the same to this body.

Section 5.—Visiting ministers and delegates may be seated as advisory members in this body.

Section 6.—It shall not be the purpose of this Association to usurp authority over the churches but to recommend such measures as would promote unity of action among the churches, to harmonize the efforts of individual churches to one another in their efforts to accomplish good, and make each other more proficient in their undertakings for good.

Section 7.—This constitution may be altered or amended by a vote of the yearly meeting at any session, notice of such intended alterations having been given in writing and recorded at the next previous session.

Section 8.—There shall be an ordaining council, elected by the Association, to inquire into, and examine each applicant for ordination to preach the Gospel of the Lord and Savior Jesus Christ, and make recommendations to the Association for the ordination of said applicant. This council shall be composed of three ministers and two laymen.

#### RULES OF DECORUM

Section 1.—The officers of this Association shall consist of a Moderator, Clerk and Treasurer, who shall be elected at the close of each session by a majority of the delegates present.

Section 2.—This Association shall hold its session annually beginning on Thursday and continue through Friday before the first Sunday in October.

Section 3.—The Moderator shall have the right to appoint all committees.

Section 4.—The Clerk shall have the right to supervise the printing of the minutes and shall be allowed \$10.00 for his service; Treasure, \$5.00; and Moderator, \$5.00, for their services.

Section 5.—No member shall absent himself from the body without leave of the Moderator.

Section 6.—All members desiring to speak shall arise, address the Moderator, and personal reflection shall be avoided.

Section 7.—All motions made and seconded shall be open for discussion, but debate may be shut off at any time by a majority of the members of the Association.

Section 8.—If any proposition or motion under debate contain two or more points, it shall be divided at the request of any member and the vote taken separately.

Section 9.—Motions made and lost shall not be recorded on the minutes unless so ordered at the time.

Section 10.—No one shall be allowed to speak more than twice on the same subject, and not more than ten minutes at a time; without special leave from the body.

Section 11.—All questions shall be decided by a majority of the members present.

#### ARTICLES OF FAITH

Article 1.—THE BIBLE—The Scriptures of the Old and New Testaments were given by inspiration of God and are our infallible rule of Faith and Practice.

Article 2.—GOD—There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe, and in the Scriptures as Father, Son and Holy Spirit, yet as one God, infinitely wise and good, whom all intelligent creatures are to supremely love, adore, and obey.

Article 3.—CHRIST—Is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified and is our ever present Saviour and Lord.

Article 4.—THE HOLY SPIRIT—The Scripture assigns to the Holy Spirit all attributes of God. He is the reprover, comforter, guide and sanctifier of men.

Article 5.—THE GOVERNMENT OF GOD—God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and the laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.

Article 6.—THE SINFULNESS OF MAN—Man was created innocent but by disobedience fell into a state of sin and condemnation. His posterity therefore inherit a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God.

Article 7.—THE WORK OF CHRIST—The Son of God by His incarnation, life, suffering, death and resurrection affected for all a redemption from sin that is full and free and is the ground of salvation by faith.

Article 8.—THE TERMS OF SALVATION—The conditions of salvation are: 1. Repentence or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to live and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death.

Article 9.—ELECTION—God determined from the beginning to save all who should comply with the condition of salvation. Hence by faith in Christ men become His elect.

Article 10.—FREEDOM OF THE WILL—The human will is free and self-controlled, having power to yield to the influence of the truth and the spirit, or to resist them and perish.

Article 11.—SALVATION FREE—God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will come and take the water of life freely.

Article 12.—PERSEVERENCE—All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal salvation.

Article 13.—GOSPEL ORDINANCES—Baptism, or the immersion of believers in water, and the Lord's supper, are ordinances to be perpetuated under the Gospel. Feet washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers.

Article 14.—TITHING—God commanded tithes and offerings in the Old Testament; Jesus Christ indorsed it in the Gospel (Matt. 23-23), and the Apostle Paul said, "Upon the first day of he week let every one of you lay by him in store as God as prospered him." (1 Cor. 16:2)

Article 15—THE CHRISTIAN SABBATH—The divine law requires that one day in seven be set apart from peculiar employments and amusements, for rest, worship, holy works and activities, and for personal communion with God.

Article 16—RESURRECTION, JUDGMENT AND FINAL RETRIBUTION—The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done ill unto the resurrection of damnation, then the wicked will go away into eternal punishment, but the righteous into eternal life.
