MINUTES OF THE SIXTEENTH SESSION OF NORTHEAST MISSISSIPP FREE WILL BAPTIST ASSOCIATION WHICH CONVENED WITH WHITE HILL CHURCH ON SEPTEMBER 28-29, 1950.

THURSDAY MORNING SESSION

Session opened with Rev. George C. Lee presiding. Devotions by Rev. G. P. Perkins. Moderator called body to order. Reading clerks appointed as follows: Mrs. J. O. Sherman and Mrs. W. C. Robison. Letters were read from 20 out of 22 churches making up the body.

Welcomed and seated as Corresponding delegates were the following: Rev. J. L. Lavender from Vernon Association, Rev. J. D. O'Donnell from Liberty Association, Rev. O. L. Fields from Mt. Moriah Association. All of the above from Alabama. Bro. D. C. Lambert from Little Brown Creek Association of Mississippi.

Rev. W. O. Knight led the congregation in singing, "Where the Soul Never Dies". Prayer led by Rev. Luther Gibson. Committees were appointed by Moderator. (See Committee Appointments.) After a short recess the body reassembled for the morning worship service. Rev. Knight led "Standing on the Promises" and "Won't it be Wonderful there. Rev. Lavender led in Prayer. "Leaning on the Everlasting Arms" was sung and Rev. Lee led in Prayer. Rev. J. D. O'Donnell, pastor of Columbus Church, brought the Introductory Message using as a basis for his message several verses from the 12th Chapter of Hebrews. The message was timely and encouraging to those who want to go forward for the Lord Jesus regardless of the cost. Rev. O'Donnell was selected by the Program Committee for this message since Rev. T. L. Walker failed to attend the session.

Following the message the congregation stood and sang "We'll Work till Jesus Comes" and were dismissed for lunch by Rev. M. H. Hollis.

The entire congregation enjoyed an hour of fellowship and feasting.

THURSDAY AFTERNOON SESSION

Afternoon session was opened as Rev. Gibson led the Congregation in singing, "The Lily of the Valley" and "Rescue the Perishing." Prayer led by Rev. Grover Price.

Rev. M. H. Hollis brought a brief but challenging message from Rev. 3:15-16, followed with prayer led by Bro. J. E. Smith.

Rev. L. E. Winter, host pastor, gave a very hearty welcome in behalf of the White Hill Church and community. Rev. Grover Price

responded on behalf of the delegates and visitors.

The following Committee's reports were read and adopted. (See Committee Reports): Credentials, F.W.B. League, Christian Literature, Sunday Schools and Auxiliary. Rev. Gibson led in the singing of "Tis so Sweet to Trust in Jesus." Prayer led by Mrs. L. D. Gibson. Rev. O. L. Fields brought a short message from 1 Kings 18:16-18. Subject: "Who is troubling the World?" This was a pointed message and a warning to those out of God's will. Rev. Lee led in singing "Watching You." Recessed with prayer.

Congregation called together in a short song service.

Minister's reports read and accepted for publication in Minutes. Partial report of Resolution Committee read and adopted. Report of Finance Committee read and adopted. Rev. Knight led congregation in singing, "Home of the Soul". Afternoon session closed with prayer.

THURSDAY EVENING SESSION

Evening session opened with singing of many hymns of the Church. Bro. Lee presided in the testimonial service. "Let the Redeemed of the Lord Say So." How it thrills our souls as we hear Christians tell of their love for Him who saved them.

The evangelistic message of the Association was preached by Rev. M. L. Hollis from Prov. 14:12, "There is a way which seemeth right unto a man, but the end thereof are the ways of death." Would that we would accept God's way for our lives and thus avoid eternal death.

Rev. L. E. Winter led the closing service of the evening. Many enjoyed the Lord's Supper and Feetwashing which followed.

FRIDAY MORNING SESSION

"We'll Work till Jesus Comes" led by Rev. Knight. Prayer by Bro. D. D. Hollis. Rev. Price read from Paul's letter to the Romans and brought a short devotional message on the "Power of the Gospel," ready to preach it and ready to die.

Minutes of the first day's session were read and accepted. Temperance Committee made its report and was discharged. Treasurer's' report read and adopted. Oral report on Christian Education made by Rev. Gibson with short talks by Bro. L. E. Duncan and Rev Paul Long. Report by Sec'ty-Treasurer of Board of Superannuation. Board to bring to next Session of Association, for its approval or rejection, Rules and regulations governing the disbursements of Superannuation funds.

In answer to many prayer requests the association paused for

a session of prayer with Rev. M. L. Hollis and Mrs. L. D. Gibson leading.

Oral reports were made by the Clerk on Unified Program Funds and Morganwood F.W.B. Camp.

Moderator read Church Covenant and Articles of Faith and offered prayer that we might live according to same.

Rev. Henry Melvin of Free Will Bible College spoke to the body in behalf of our college, its founding, its growth, its purpose, its present, and plans for the future. He closed with a plea for our continued support in prayers, funds and work that it might attain the goal for which founded.

Association selected Amory as the host for 1951 session. Officers elected for ensuing year as follows:

Final report of Resolution Committee read and adopted. Report of Obituary Committee read and adopted. "In Memoriam" read by Clerk. Minute of silent prayer observed by Body and closed with Rev. George Lee, leading.

Rev. M. L. Hollis, assisted by Revs. G. C. Lee, L. D. Gibson and W. O. Knight, administered Ordination to Ministry to Rev. M. H. Hollis. Charge was given by Rev. M. L. Hollis, who is related to the new Minister. Let us pray that others will accept the call to full time ministry as the "fields are white unto harvest and the laborers are few."

Business session was adjourned to meet with Amory church on Thursday before the First Sunday in October, 1951.

Rev. Luther Gibson preached the closing message. Reading Matt. 28:16-20 and using as a subject: The Place of the Church in God's service. A very challenging message. With parting hand-clasps and singing, "Till we meet Again" another Session of N. E. Miss. Free Will Baptist Association closed to meet again in 1951, should the Lord tarry.

COMMITTEE REPORTS

CREDENTIAL: We recommend that Rev. M. H. Hollis be ordained to full time ministry during this sitting of the Northeast Miss. F. W. B. Association. We also recommend that Rev. J. D. O'Donnell, a member in good standing of the Liberty Association of Alabama, be received as a member of our Association.

RESOLUTIONS: Resolved, that we organize a Sunday School Convention within our Association, same to convene once a year for the purpose of exchanging ideas and instigating plans whereby our Sunday Schools may be improved.

Resolved, That Moderator appoint a Committee composed of three persons interested in Sunday Schools to draw up a Constitution and By-Laws governing a Sunday School Convention and also to set a date for the meeting of the first session.

Resolved, That we give a rising vote of thanks to White Hill Church, their Pastor and the entire community in appreciation for their friendship and generosity in caring for us during this Session of the Association.

SUNDAY SCHOOLS: We recommend and urge that each Church in our Association have Sunday School every Sunday since we are informed that 85 per cent of our Church membership comes by way of our Sunday Schools. We suggest that only consecrated Christians be chosen as officers and teachers in our Sunday Schools. We urge each Superintendent demand reverence and order in the Sunday School. We further recommend that each Church refuse to use as a Superintendent or teacher any one who patronizes the Movie Industry or other worldly and sinful places.

LADIES AUXILIARY:

We recommend that each church have a Ladies Auxiliary. We find that only seven of our churches have reported Auxiliaries. We

find that from the reports of Churches having Auxiliaries there is a greater interest in the Lord's work, and so much that they can accomplish that is left undone if there is no Ladies work in action.

F. W. B. LEAGUE: We find that only ten of our Churches report a League, which is less than 50 per cent. We feel sure that we would have more Leagues if our Pastors would get behind the organization of same in their churches. The League is the Training Service of our Denomination and since the young people of today are the Churches of tomorrow we should do all we could to train our youth for service in Christ's kingdom. Let us strive to have a League in each Church in our Association by the next Session.

CHRISTIAN LITERATURE: We realize more and more the need for Christian Education and urge that all parents strive to furnish their children the best of Christian literature possible. There is no greater way of giving our children the Christian training than by having a careful and prayerful study of the Bible in our homes, our Sunday Schools and our Leagues. We urge that all subscribe for as many Christian papers as they can afford and especially that we support our own F.W. Baptist Church and denominational papers.

CHURCH COVENANT

Having given ourselves to God, by faith in Christ and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligation in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith, and good works endeavor to "grow in the grace and the knowledge of our Lord and Savior Jesus Christ.

We will not forget the assembling of ourselves together for church conferences; public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the week, encourage the afflicted, admonish the erring, and as far as we are able to promote the success of the church and of the Gospel.

We will everywhere hold Christian principles sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of Missions, the success of Sunday schools, and evangelstic efforts for the salvation of the world. And may the God of peace sanctify us wholly and preserve us blameless unto the coming of our Lord Jesus Christ.

CONSTITUTION

Section 1.--This organization shall be known as the Northeast Mississippi Association of Free Will Baptist and shall be composed of ministers, deacons, clerks, and delegates of the various churches of this Association.

Section2.--The purpose of the Association shall be to bring together our churches throughout North Mississippi for a closer union among our people and the establishment of new churches in our state.

Section 3.--This assoction shall be composed of Churches of the above named territory together with the like bodies of same Faith and practice which may be hereafter admited.

Section 4.--Each church shall be allowed three delegated representatives and they must be duly appointed by their church while in conference and bear credentials from the same to this body.

Section 5.--Visiting ministers and delegates may be seated as advisory members of this body.

Section 6.--It shall not be the purpose of this Association to usurp authority over the churches but to recommend such measures as would promote unity of action among the churches, to harmonize the efforts of individual churches to one another in their efforts to accomplish good, and make each other more proficient in their undertakings for good.

Section 7.--This constitution may be altered or amended by a vote of the yearly meeting at any session, notice of such intended amendment or alterations having been given in writing and recorded at the previous session.

Section 8.--There shall be an ordaining council, elected by the Association, to inquire into, and examine each applicant for ordination to preach the Gospel of the Lord and Savior Jesus Christ, and make recommendations to the Assoction for the ordination of said applicant. This council shall be composed of three ministers and two laymen.

Section 9.--There shall be a board of missions, a Board of Superannuation, and a Board of Christian Education.

RULES OF DECORUM

Section 1.—The officers of this Association shall consist of a Moderator, Assistant Moderator, Clerk, Assistant Clerk, and Treasurer, who shall be elected at the close of each session by a majority of the delegates present.

Section 2.—This Association shall hold its session annually beginning on Thursday and continue through Friday before the first Sunday in October.

Section 3.—The Moderator shall have the right to appoint all committees.

Section 4.—The clerk shall have the right to supervise the printing of the minutes and shall be allowed \$10.00 for his services; Treasurer, \$5.00; and Moderator, \$5.00, for their service.

Section 5.—No member shall be absent from the body without leave of the Moderator.

Section 6.—All members desiring to speak shall arise, address the Moderator, and personal reflection shall be avoid.

Section 7.—All motions made and seconded shall be open for

discussion, but debate may be shut off any time by a majority of the members of the Association.

Section 8.—If any proposition or motion under debate contain two or more points, it shall be divided at the request of any member and the vote taken separately.

Section 9.—Motions made and lost shall not be recorded on the minutes unless so ordered at the time.

Section 10.—No one shall be allowed to speak more than twice on the same subject, and not more than ten minutes at a time; without special leave from the body.

Section 11.—All questions shall be decided by a majority of the members present.

ARTICLES OF FAITH

Article 1.—THE BIBLE—The Scriptures of the OLD and NEW Testaments were given by inspiration of God and are our infallible Rule of Faith and Practice. I Cor. 1:21; Matt. 28:19-20; Rom. 1:16.

Article 2.—GOD—There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe, and in the Scriptures as Father Son and Holy Spirit, yet as one God, infinitely wise and good, whom all intelligent creatures are to supremely love, adore, and obey. I Cor. 8:6; Isa. 40:28.

Article 3.—CHRIST—Is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified and is our ever present Saviour and Lord. I Tim. 2:5-6; Heb. 2:9; St. John 3:16.

Article 4.—THE HOLY SPIRIT—The Scripture assigns to the Holy Spirit all attributes of God. He is the reprover, comforter, guide and sanctifier of men. St. John 16:7-8; Acts 2:45; Eph. 2:1.

Article 5.—THE GOVERNMENT OF GOD—God exercises a wise and benevolent providence over all being and all things by maintaining the constitution and the laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires. Mark 16:15; Luke 24:47; I Tim. 2:4.

Article 6.—THE SINFULNESS OF MAN—Man was created innocent but by disobedience fell into a state of sin and condemnation. His posterity therefore inherit a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God. Gen. 2:17; Gen. 3:19.

Article 7.— THE WORK OF CHRIST—The Son of God by His

incarnation, life, suffering, death and resurrection affected for all a redemption from sin that is full and free and is the ground of salvation by faith. Acts 3:19; Matt. 28:19-20; Eph. 2:5-10.

Article 8.—THE TERMS OF SALVATION—The conditions of salvation are: 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to live and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the domination of sin and becomes a child of God. 3. Continuance in faith and obedience until death. Luke 13:3; Acts 17:30; Rom. 10:10.

Article 9.—ELECTION—God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect. Matt. 28:20; I Cor. 1:21; Matt. 25:31-46.

Article 10.—FREEDOM OF THE WILL—The human will is free and self-controlled, having power to yield to the influence of the truth and the spirit ,or to resist them and perish. Tit. 2nd chp.t; Rev. 2:10-15.

Article 11.—SALVATION FREE—God desires salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will come and take the water of life freely. Gal. 1:13-14; Rev. 22:17.

Article 12.—PERSEVERENCE—All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal salvation. Rom. 16:18-22; Rom. 5:21.

Article 13.—GOSPEL OBEDIENCE—Baptism, or the immersion of believers in water, and the Lord's supper, are ordinances to be perpetuated under the Gospel. Feet washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers. Acts 8 Chpt.; I Tim. 5:10; Luke 22:49.

Article 14.—TITHING—God commanded tithes and offerings in the Old Testament; Jesus Christ indorsed it in the Gospel (Matt. 23-23), and the Apostle Paul said, "Upon the first day of the week let every one of you lay by him in store as God has prospered him."

Article 15.—THE CHRISTIAN SABBATH—The divine law requires that one day in seven be set apart from secular employmetrs and amusements, for rest, worship, holy work, and activities and for personal communion with God. Deut. 5:12-14; Heb. 4:4.

Article 6.—RESURRECTION, JUDGMENT AND FINAL RE-

TRIBUTION—The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they have done ill unto the resurrection of damnation, then the wicked will go away into eternal punishment, but the righteous into eternal Life. Jno. 5:28-29; II Cor. 5:10; I Cor. 15:23.
