MINUTES OF THE 26th ANNUAL SESSION OF THE NORTHEAST MISSISSIPPI FREE WILL BAPTIST ASSOCIATION

The 26th Annual Session of the Northeast Mississippi Free Will Baptist Association met with the Amory Free Will Baptist Church on Thursday and Friday before the 1st Sunday in October 1960. The Association was declared opened by the Moderator, Rev. Wilburn Beasley, presiding. The Rev. Luther Gibson, clerk of the Association at his place of service.

The meeting was opened by the singing of the Hymn, "Love Lifted Me", led by Rev. W. O. Knight. The Devotional was conducted by Bro. Knight using as a Scripture for his remarks, Mark 2:1-12.

The morning Worship was begun by singing the Hymn, "Bring Them In". The Moderator introduced to the Association the Rev. Billy Melvin, the Executive Secretary of the National Association

of Free Will Baptist. Bro. Melvin delivered the morning message using as a Scripture, Matt. 28:19, 20; Acts. 1:8; II Tim. 3:1. He brought a wonderful message on the need of reaching the lost with the message of the Gospel. Rev. M. L. Hollis led in the closing prayer.

An hour of Christian fellowship was enjoyed by those who were attending the Association. The ladies of Amory Free Will Baptist Church served a bountiful lunch which was enjoyed by all.

AFTERNOON SESSION

The afternoon session was opened by singing the Hymn, "At Calvary". The devotional was conducted by Rev. George C. Lee, who read from Exodus 4; "What is that in Thine Hand".

REPORT ON ALABAMA CHILDREN'S HOME

Rev. Carlton Lambert gave a report of the Children's Home and its work in Eldridge, Ala. He presented their needs of the Home to the people of our Association and State.

RESOLUTIONS COMMITTEE

The resolutions committee made its partial report to the Association. Motion made and carried that the report be accepted. The following resolutions were presented and adopted.

RESOUTIONS

Believing that any properties being used and financed by the churches of the Northeast Mississippi Association of Free Will Baptist, and within the confines of said Association should be owned, operated and maintained by said body. We the trustees, of Morganwood Camp and League Rally Resolutions Committee, do hereby offer the following resolutions:

Be it resolved, That the Northeast Mississippi Association of Free Will Baptist, hereby accept full responsibility of ownership, supervision, and maintenance of Morganwood Camp. That all Properties, cash on hand, indebtedness, and approved building plans be transferred to said association as early as convenient.

Be IT RESOLVED, That a committee consisting of five members be appointed, or elected, at this session of association, four members to be from Laity of Association. This committee to be known henceforth as Morganwood Camp Committee.

This committee will be held responsible to the association for the upkeep, direction, and promotion of Morganwood Camp, and they shall see to it that it is used for the Glory of God and for the promotion of Christ's Kingdom here among men. This committee shall bring to each annual session of the association a written report of their stewardship, and any recommendations they believe for the betterment of the Camp and its facilities.

The original committee to be appointed, or elected, to serve terms as follows: One year — Two Years — Three Years — Four Years — and Five Years, then one member shall be elected annually for a term of five years. Members may succeed themselves in office if deemed worthy by the association. It will be the duty of this committee to select a general director for camp sessions as the need arises, and to work in harmony with him, with one another, and under the direction of the Lord Jesus Christ at all times.

RESOLUTIONS: FOR MANAGEMENT OF STAFF AND CAMPERS AT MORGANWOOD CAMP SITUATED ON ROUTE 4, TUPELO, MISSISSIPPI

Be It Resolved by the Morganwood Camp Committee of the Northeast Mississippi Association of Free Will Baptists and its Auxiliaries, that these resolutions be drafted and enacted for the best interests for the promotion and welfare of Morganwood Camp, and that these resolutions be effective for all sessions of youth and others who may attend this Camp. All campers to be nine years of age or older and members of the Caucasian (White) race.

- 1. There shall be a general director, whose duties shall be to carry out these resolutions. All campers and assistants shall render fair and due respect unto him. He must see that the rules for discipline and religious conduct be executed. The camp director shall be subject to the camp committee for his conduct and duties rendered, and it shall be his duties further to see that proper religious exercises be held regularly, each day of camp, in accordance with the Free Will Baptist Treatise and according to New Testament teachings.
- 2. The general director may appoint as many assistant directors as he deems necessary; these may be determined as directors of music, director of Sunday School, director of League, director of Missions, etc. He may also appoint a dietician and a steward, if necessary.
- 3. The dietician shall assume the supervision of the preparation, cooking and serving of meals, and shall exercise the right to supervise all kitchen assistants. The meals shall be served as fitting in the program of the camp activities, namely breakfast, lunch and dinner. Meals to be wholesome and each one well fed.
- 4. It shall be the duties of the steward to see that the camp is kept clean and sanitary, that garbage is disposed of each day. When necessary, he shall purchase commodities. Also he shall see that mail is delivered to and from camp each day, preferbly in the morning. He may help in serving of meals and other refreshments when called upon.

5. The use of tobacco and the use of profanity or other unchristian language shall not be tolerated, and any camper so doing shall be properly admonished, and if correction is not attained the party

shall be dismissed from the camp.

6. The director shall call his assistants all his assistants for the disciplining of any camper. The campers' parents may appeal the case to the camp committee for any discipline which may cause a grievance and which is not thought properly adjusted. In the case of an appeal the camp committee's decision shall be final.

7. The director shall conduct or appoint someone to conduct proper religious services twice a day, which may be determined as

Vespers, evangelistic and morning devotions.

8. The director shall have, with the assistance of all his assistants, a proper and fitting athletic program each afternoon, and no director or camp attendant shall be excused from these exercises, unless unable to participate because of illness. The exercises shall be of such nature as to maintain a healthful program for the exercising of the body.

9. All programs must have the consent of the director before

the program is staged.

10. The time for retiring and rising shall be at the discretion of the camp staff and be properly placarded about the camp premises.

Registration fees and any other financial matters will be determined by the camp committee. The camp committee will also publish leaflets advising those interested in attending camp the necessary articles of clothing, bed linins, toilet articles to be brought for their comfort during stay at camp.

These resolutions may be amended or others added as needful.

CHURCH COVENANT

Having given ourselves to God by Faith in Christ and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn convenant.

We promise by His grace to love and obey Him in all things. To avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of

the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship and by self denial faith, and good works endeavor to "grow in the grace and the knowledge of our Lord and Saviour Jesus Christ."

We will not forget the assembling of ourselves together for church conferences; public worship and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able to promote the success of the church and of the Gospel.

We will everywhere, hold Christian principles sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the Kingdom of God may come and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of Missions, the success of Sunday schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly and preserve us blameless unto the coming of our Lord Jesus Christ.

CONSTITUTION

Section 1.—This organization shall be known as the Northeast Mississippi Association of Free Will Baptist and shall be composed of ministers, deacons, clerks, and delegates of the various churches of this association.

Section 2.—The purpose of the Association shall be to bring together our churches throughout North Mississippi for the closer union among our people and the establishment of new churches in our state.

Section 3.—This Association shall be composed of Churches of the above named territory together with like bodies of same Faith and practice which may be hereafter admitted.

Section 4.—Each church shall be allowed five delegated representatives and they must be duly appointed by their church while in conference and bear credentials from the same to this body.

Section 5.—Visiting ministers and delegates may be seated as advisory members of this body.

Section 6.—It shall not be the purpose of this Association to usurp authority over the churches but to recommend such measures as would promote unity of action among the churches, to harmonize the efforts of individual churches to one another in their efforts to accomplish good, and make each other more proficient in their undertaking for good.

Section 7.—This constitution may be altered or amended by a vote of the yearly meeting at any session, notice of such intended alterations having been given in writing and recorded at the next previous session.

Section 8.—There shall be an ordaining council, elected by the Association, to inquire into, and examine each applicant for ordination to preach the Gospel of the Lord and Saviour Jesus Christ, and make recommendations to the Association for the ordination of said applicant. This council shall be composed of three ministers, and two Laymen.

RULES OF DECORUM

Section 1.—The officers of this association shall consist of a Moderator, Assistant Moderator, Clerk, assistant Clerk, and Treasurer, who shall be elected at the close of each session by a majority of the delegates present.

Section 2.—This Association shall hold its session annually beginning on Thursday and continue through Friday before the first Sunday in October.

Section 3.—The Moderator shall have the right to appoint all committees.

Section 4.—The Clerk shall have the right to supervise the printing of the minutes and shall be allowed \$10.00 for his services; Treasurer \$5.00; and Moderator, \$5.00, for their services.

Section 5.—No member shall be absent from the body without

leave of the Moderator.

Section 6.—All members desiring to speak shall arise, address the Moderator, and personal reflection shall be avoided.

Section 7.—All motions made and seconded shall be open for discussion, but debate may be shut off any time by a majority of the members of the Association.

Section 8.—If any proposition or motion under debate contain two or more points, it shall be divided at the request of any member and the vote taken separately.

Section 9.—Motions made and lost shall be recorded on the

minutes unless so ordered at the time.

Section 10.—No one shall be allowed to speak more than twice on the same subject and not more than ten minutes at a time; without special leave from the body.

Section 11.—All questions shall be decided by a majority of the

members present.

ARTICLES OF FAITH

Article 1.—THE BIBLE—The Scriptures of the Old and New Testaments were given by inspiration of God and our infallible Rule of Faith and Practice. I Cor. 1:21; Matt. 28:19-20. Rom. 1:16.

Article 2.—GOD—There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe and in the Scriptures as Father, Son and Holy Spirit, yet as one God, infinitely wise and good, whom all intelligent creatures are to supremely love, adore and obey. 1 Cor. 8:6; Isa. 40:28.

Article 3.—CHRIST—Is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified and is our ever present Saviour and Lord. I Tim. 2:5-6; Heb. 2:9; St. John 3:16.

Article 4.—THE HOLY SPIRIT — The Scripture assigns to the Holy Spirit all attributes of God. He is the reprover, comforter, guide and sanctifier of men. St. John 16:7-8; Acts 2:45; Eph. 2:1.

Article 5.—THE GOVERNMENT OF GOD—God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and the laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires. Mark 16:15; Luke 24:47; I Tim. 2:4.

Article 6.—THE SINFULNESS OF MAN—Man was created innocent but by disobedience fell into a state of sin and condemnation. His posterity therefore inherit a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God. Gen. 2:17; Gen. 3:19.

Article 7.—THE WORK OF CHRIST—The Son of God by His incarnation, life, suffering, death and resurrection affected for all a redemption from sin that is full and free and is the ground of salvation by faith. Acts 3:19; Matt. 28:19-20; Eph. 2:5-10.

Article 8.—THE TERMS OF SALVATION — The conditions of salvation are: 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to live and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the domination of sin and becomes a child of God. 3. Continuance in faith and obedience until death. Luke 13:3; Acts 17:30; Rom. 10:10.

Article 9.—ELECTION—God determined from the beginning to save all whom should comply with the condition of salvation. Hence by faith in Christ men become His elect. Matt. 28:20; I Cor. 1:21; Matt. 25:31-46.

Article 10.—FREEDOM OF THE WILL—The human will is free and self controlled, having power to yield to the influence of the truth and the spirit, or to resist them and perish. Tit. 2nd chapt; Rev. 2:10-15.

Article 11.—SALVATION FREE—God desires salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will come and take the water of life freely. Gal. 1:13-14; Rev. 22:17.

Article 12.—PERSEVERANCE — All believers in Christ, who through grace perserver in holiness to the end of life, have promise of eternal salvation. Rom. 5:21.

Article 13.—GOSPEL ORDINANCES—Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel. Feet washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers. Acts 8th chapt.; I Fim. 5:10; Luke 22:49.

Article 14.—TITHING—God commanded tithes and offerings in the Old Testament; Jesus Christ endorsed it in the Gospel (Matt. 23:23), and the Apostle Paul said, "Upon the first day of the week let every one of you lay by him in store as God has prospered him."

Article 15.—THE CHRISTIAN SABBATH—The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy work, and activities and for personal communication with God, Deut. 5:12-14; Heb. 4:4.

Article 16.—RESURRECTION, JUDGEMENT AND FINAL RETRIBUTION—The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done ill unto the resurrection of damnation, then the wicked will go away into eternal punishment, but the righteous into eternal life. Jno. 5:28-29; II Cor. 5:10; I Cor. 15:23.
