The 28th Annual Session of the Northeast Mississippi Free Will Baptist Association met with the Beech Springs Free Will Baptist Church on Friday, October 12, 1962. The Association was declared opened by the Moderator, Rev. M. H. Hollis, presiding. The Rev. Gordon Hart, Clerk of the Association was at his place of service.

The session was opened by the singing of the hymn, "To The Work", followed by prayer led by Bro. L. D. Gibson and the singing of another hymn, "What A Friend", after which Bro. Tillis Walley brought the devotional. Bro. Walley used Romans 12:1-2 and spoke on the subject, "YOU".

The Rev. Wilburn Beasley extended to us a warm welcome and Bro. Gibson gave the response.

Mrs. L. D. Gibson and Mrs. G. W. Hart were appointed as reading clerks. The letters of the churches were read and motion was made and carried to accept them and seat the delegates.

A petition for membership into the Association was made by the Main Street F.W.B. Church in Amory. After the letter had been examined, motion was made and carried to accept the church.

The following were visiting from other Associations and states: Rev. J. L. Gore, Booneville, Mississippi, Rev. J. P. Bowman, West Memphis, Arkansas, and Rev. Grover L. See, Denmark, Mississippi.

The Rev. M. H. Hollis gave his moderator's message and appointed the following Committee on Committees: Bros. L. D. Gibson, Grover Perkins and C. J. Ard. We were then adjourned for a short recess.

The Morning Worship Service was begun by singing the hymn, "Jesus Saves", followed with prayer by Bro. W. F. Clark. After singing "Send the Light", Bro. Jerry Ballard from the Foreign Mission Board in Nashville, Tennessee, delivered an inspiring message from I Tim. 1:6-9 and 15. Bro. Ballard pointed out that we are living in a world of rush and speed. He spoke on The Problem, The Reasons for The Problem, and The Answers to The Problem.

An hour of Christian fellowship was enjoyed by those attending the Association. The ladies of Beech Springs F.W.B. Church served a bountiful lunch which was thoroughly enjoyed by all.

AFTERNOON SESSION

The afternoon session was opened by singing the hymn, "Jesus Saves" after which Rev. Paul Long conducted the devotional using I Kings 19:1-6 as his scripture.

REPORT ON ALABAMA CHILDREN'S HOME

The Rev. Carlton Lambert, Supt., gave a good report of the Children's Home and its work in Eldridge, Alabama. He reported that this had been the best year in the history of the home. He told us that the Main emphasis in the home was upon Spiritual things and secondly they tried to encourage all the children to get an education. All fifty of the children are in school this year. He also presented the needs of the home and thanked the churches for what they had done for the home.

Bro. Paul Ketteman gave a good report on the Free Will Baptist Bible College. He showed a picture of the new property that has been purchased and presented the needs of the school.

We urge our pastors to use the power of the pulpit and the power of the Word of God to fight evils of alcohol.

We recommend that each teacher of the younger classes teach a more powerful lesson on temperance. Let us be temperate in all acts of life, forgetting not that we are the Temples of God.

CREDENTIALS COMMITTEE

We, your Credentials Committee, report the following:

We find that all our ministers are in good standing with their churches and thereby recommend that they be given a certificate of good standing in the Association. We recommend that Rev. Tillis Walley, Rev. James P. Bowman, Rev. Grover L. See and Rev. Bob Rogers be accepted into the Association as ordained Ministers upon a letter of good standing from their present Association.

We also recommend that the Seventh Street F.W.B. Church of West Memphis, Arkansas be accepted as a member church into this Association.

We further recommend that a letter of good standing be granted Bro. Paul Ketteman to the Cumberland Association, Nashville, Tenn. Signed your committee

LEAGUE

Upon finding only eleven of the twenty-two churches reporting having Leagues, we, your committee, recommend that each church who has a League make an effort to go to one of our churches without a league and help them organize one this year.

Since our National League Board is to print its own literature, we strongly urge each League to send 10% of their offerings to the National League Board each quarter. If we want better material to train our leaders of our churches tomorrow we must give this 10%.

Furthermore, since our League work is weak in Mississippi, we recommend to the Nominating Committee that Bro. W. C. Robison be elected as a League Promotional man to help strengthen our Leagues in Mississippi.

Our prayer is that there will be many more Leagues organized and that our League work may grow stronger.

SUNDAY SCHOOL

We, your Sunday School Committee submit the following report: We urge (again) that every church have a visitation program. Unless we go we cannot grow.

We urge a teachers training program for each church.

We ask that each S. S. be represented at the Sunday School Convention to be held with Tupelo Church on the fourth Sunday of October.

WOMAN'S AUXILIARY

Realizing that the purpose of the Auxiliary is to teach and support Missions we urge each woman of our churches to keenly feel their responsibility to be an active member of our auxiliary and to participate in the Mission activities of this organization. We recommend to our Pastors that they publicize from the Pulpit each

meeting of the Auxiliary. We urge our women to support each youth organization by prayer and earnest concern for our young people. We invite all auxiliaries to affiliate with our District Auxiliary Convention. Thereby an accurate record of the work done by our women can be kept and reported. Six of the nine auxiliaries reported today are members of the District Convention. We invite all the others to join with us in this worthy work. We urge all churches who do not have Auxiliaries to organize one and be Co-Laborers with us for the glory of God.

MORGANWOOD YOUTH CAMP COMMITTEE

We are happy to make this report to you concerning the year's work at Morganwood Camp.

Rev. Jack Paramore of Greenville, N. C., brought the messages for our Youth Camp and Revival. Three fine young people found Christ as their Saviour, this being all of those who attended that had not already professed Him as Saviour. Night after night many came to the altar for prayer and rededication. The services were plain gospel messages that were from God's Holy Word.

Seventy nine Campers enrolled for the week, including faculty members. One mother who came for her children on Friday night asked, "What have you done to our children, they don't want to go home?" Many gave warm glowing testimonies of how they had enjoyed the week of play, work and Christian counseling, and all said they were looking forward to another camping time.

Campus and buildings are looking much better as the buildings were given another coat of paint and quite a bit of work was done on the campus, sowing grass and leveling. An addition of 8×42 feet was made to the eating area, this giving 50% more space. The entire area was screened also in the dining hall.

There is much work yet to be done and we are praying that more of our people will become interested in this Christian project.

We must have additional bath and toilet facilities for the girls, also more bedding space is needed.

Some of our leagues sponsored the buying a deepfreeze that will help in a great way for storing of meats and vegetables and save money on groceries.

We trust that all our churches in this association will rally to the support of this work, that we may be able to reach more of our young people for Christian service.

Alabama, Mississippi, North Carolina, South Carolina and Tennessee were represented at camp this year.

We recommend the reelection of Rev. Luther Gibson for a five year term on the committee and recommend that Mr. Bill Vanderford be elected to fill the unexpired term of Mr. Trice Kingsley, who has tendered his resignation.

CHURCH COVENANT

Having given ourselves to God by Faith in Christ and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things. To avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship and by self denial faith, and good works endeavor to "grow in the grace and the knowledge of our Lord and Saviour Jesus Christ."

We will not forget the assembling of ourselves together for church conferences; public worship and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring and as far as we are able to promote the success of the church and of the Gospel.

We will everywhere, hold Christian principles sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the Kingdom of God may come and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of Missions, the success of Sunday schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly and preserve us blameless unto the coming of our Lord Jesus Christ.

CONSTITUTION

Section 1.—This organization shall be known as the Northeast Mississippi Association of Free Will Baptist and shall be composed of ministers, deacons, clerks, and delegates of the various churches of this association.

Section 2.—The purpose of the Association shall be to bring together our churches throughout North Mississippi for the closer union among our people and the establishment of new churches in our state.

Section 3.—This Association shall be composed of Churches of the above named territory together with like bodies of same Faith and practice which may be hereafter admitted.

Section 4.—Each church shall be allowed five delegated representatives and they must be duly appointed by their church while in conference and bear credentials from the same to this body.

Section 5.—Visiting ministers and delegates may be seated as advisory members of this body.

Section 6.—It shall not be the purpose of this Association to usurp authority over the churches but to recommend such measures as would promote unity of action among the churches, to harmonize the efforts of individual churches to one another in their efforts to accomplish good, and make each other more proficient in their undertaking for good.

Section 7.—This constitution may be altered or amended by a vote of the yearly meeting at any session, notice of such intended alterations having been given in writing and recorded at the next previous session.

Section 8.—There shall be an ordaining council, elected by the Association to inquire into, and examine each applicant for ordination to preach the Gospel of the Lord and Saviour Jesus Christ and make recommendations to the Association for the ordination of said applicant. This council shall be composed of three ministers, and two Laymen.

RULES OF DECORUM

Section 1.—The officers of this association shall consist of a Moderator, Assistant Moderator, Clerk, assistant Clerk, and Treasurer, who shall be elected at the close of each session by a majority of the delegates present.

Section 2.—This Association shall hold its session annually beginning on Thursday and continue through Friday before the first Sunday in October.

Section 3.—The Moderator shall have the right to appoint all committees.

Section 4.—The Clerk shall have the right to supervise the printing of the minutes and shall be allowed \$10.00 for his services; Treasurer \$5.00; and Moderator, \$5.00, for their services.

Section 5.—No member shall be absent from the body without leave of the Moderator.

Section 6.—All members desiring to speak shall arise, address the Moderator, and personal reflection shall be avoided.

Section 7.—All motions made and seconded shall be open for discussion, but debate may be shut off any time by a majority of the members of the Association.

Section 8.—If any proposition or motion under debate contain two or more points, it shall be divided at the request of any member and the vote taken separately.

Section 9.—Motions made and lost shall be recorded on the minutes unless so ordered at the time.

Section 10.—No one shall be allowed to speak more than twice

on the same subject and not more than ten minues at a time; without special leave from the body.

Section 11.—All questions shall be decided by a majority of the members present.

ARTICLES OF FAITH

Article 1.—THE BIBLE—The Scriptures of the Old and New Testaments were given by inspiration of God and our infallible Rule of Faith and Practice. I Cor. 1:21; Matt. 28:19-20. Rom. 1:16.

Article 2.—GOD—There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe and in the Scriptures as Father, Son and Holy Spirit, yet as one God, infinitely wise and good, whom all intelligent creatures are to supremely love, adore and obey. 1 Cor. 8:6; Isa. 40:28.

Article 3.—CHRIST—Is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified and is our ever present Saviour and Lord. I Tim. 2:5-6; Heb. 2:9; St. John 3:16.

Article 4.—THE HOLY SPIRIT — The Scripture assigns to the Holy Spirit all attributes of God. He is the reprover, comforter, guide and sanctifier of men. St. John 16:7-8; Acts 2:45; Eph. 2:1,

Article 5.—THE GOVERNMENT OF GOD—God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and the laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires. Mark 16:15; Luke 24:47; I Tim. 2:4.

Article 6.—THE SINFULNESS OF MAN—Man was created innocent but by disobedience fell into a state of sin and condemnation. His posterity therefore inherit a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God. Gen. 2:17; Gen. 3:19.

Article 7.—THE WORK OF CHRIST—The Son of God by His incarnation, life, suffering, death and resurrection affected for all a redemption from sin that is full and free and is the ground of salvation by faith. Acts 3:19; Matt. 28:19-20; Eph. 2:5-10.

Article 8.—THE TERMS OF SALVATION — The conditions of salvation are: 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to live and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the domination of sin and becomes a child of God. 3. Continuance in faith and obedience until death. Luke 13:3; Acts 17:30; Rom. 10:10.

Article 9.—ELECTION—God determined from the beginning to save all whom should comply with the condition of salvation. Hence by faith in Christ men become His elect. Matt. 28:20; I Cor. 1:21; Matt. 25:31-46.

Article 10.—FREEDOM OF THE WILL—The human will is free and self controlled, having power to yield to the influence of the

trust and the spirit, or to resist them and perish. Tit. 2nd chapt; Rev. 2:10-15.

Article 11.—SALVATION FREE—God desires salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will come and take the water of life freely. Gal. 1:13-14; Rev. 22:17.

Article 12.—PERSEVERANCE — All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal salvation. Rom. 5:21.

Article 13.—GOSPEL ORDINANCES — Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel. Feet washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers. Acts 8th chapt.; I Tim. 5:10; Luke 22:49.

Article 14.—TITHING—God commanded tithes and offerings in the Old Testament; Jesus Christ endorsed it in the Gospel (Matt. 23:23), and the Apostle Paul said, "Upon the first day of the week let every one of you lay by him in store as God has prospered him."

Article 15.—THE CHRISTIAN SABBATH—The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy work, and activities and for personal communication with God, Deut. 5:12-14; Heb. 4:4.

Article 16.—RESURRECTION, JUDGEMENT AND FINAL RETRIBUTION—The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done ill unto the resurrection of damnation, then the wicked will go away into eternal punishment, but the righteous into eternal life. Jno. 5:28-29; II Cor. 5:10; I Cor. 15:23.
