BY-LAWS

- The Moderator or Assistant Moderator, or in their absence, the oldest ordained Free Will Baptist minister or deacon in good standing in the Northeast Association present, shall call Association into conference.
- 2. Each session shall be opened and closed with prayer.
- Five members from two or more churches shall constitute a quorum. A lesser number may adjourn until such quorum is present.
- Visiting brethren are invited to seat as advisory members.
- Those who speak shall rise and address the moderator.
 Personal reflections shall be avoided in all debates.
- If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.
- 7. The Association may be called together by the Moderator by giving the churches ten days notice of such meeting.
- 8. No one shall speak more than twice on the same subject without special leave of the Moderator.
- 9. The Moderator shall not allow discussion when not carried on in the Christian spirit.
- 10. The ruling of the Moderator may be overruled by a two-thirds majority of the members voting.
- No question from any church shall come under the consideration of the Association unless it has first been discussed in its own church.
- At each Association session, arrangements shall be made to insure two or more sermons or their equivalent in devotional exercises each day.
- 13. This body shall be governed by the Roberts Rules of Order.

CONSTITUTION

From long experience we are convinced of the necessity of a combination of churches to perpetuate our nation and to maintain a correspondence among our churches.

Therefore, we have adopted the following constitution and bylaws for our government:

- 1. The association shall be called the Northeast Oklahoma association
- 2. This association shall be composed of such well regulated Free Will Baptist Churches maintaining gospel order, agreeing with the denomination in doctrine and practices, favoring the enterprises that have been endorsed by this association.
- 3. The acting members of this association shall be the Ordained Ministers in good standing and their wives, Ordained Deacons, in good standing, and Church Clerks belonging to any church composing this body. Also, three (3) delegates from each church chosen by members of the respective churches.
- 4. The officers of this association shall be: a Moderator, an Assistant Moderator; a Clerk, an Assistant Clerk, and an Executive Board of five (5) members consisting of at least three (3) Ordained Ministers, the other two (2) being Ordained Deacons. They shall be elected by and subject to the association; they shall act as a committee to promote peace and harmony among the ministers and churches belonging to this association; they shall also act between sessions of the association to carry out the program of the association.

Also, a Board of Trustees, consisting of five (5) members. The Trustees shall be elected and subject to the association and sign all legal papers when authorized by the association to do so.

Also, a Christian Education Board. The Christian Education Board shall consist of at least five (5) members elected by the body of this association, the Moderator being an ex-officio member of the Board. Members of this Board shall rotate their term of service with one member being elected annually at the yearly meeting. This shall not be a standing Board. This Board shall be concerned with all areas of Christian Education that concerns the churches of the Northeast Oklahoma Association of Free Will Baptists, such as: Sunday School conferences, workshops, seminars, revivals, etc. and youth camps, retreats, etc. This Board shall be responsible for: a) The selecting of the youth camp director and the

assistant director for the youth camp each year, and b) In cooperation with the camp director and assistant director, the selection and securing of the camp evangelist, the alternate evangelist, camp teachers, sponsors, cooks, workers, and all personnel necessary to operate an effective youth camp each year, and c) Assisting the youth camp director and the assistant director in the selection of camp literature and formulating of the camp program, goals, and activities each year. This Board shall be responsible for setting the amount of remuneration for the services of special speakers for all Christian Education programs or projects, camp evangelists, cooks, etc. that are normally or routinely remunerated by this Northeast Association. All officers shall hold office until their successors are elected.

 The property of any church in this Association that should go down until they cannot transact business because they are disorganized shall become the property of this Association.

6. This Association shall meet annually at such time and place as shall be decided upon by the Association, also meet in regular quarterly meetings and at such quarterly meeting, shall have power to transact all business of the Association except to change the Constitution.

Upon dissolution of the Northeast Oklahoma Association of Free Will Baptists, the trustees shall, after paying or making provision for payment of all liabilities of the Northeast Oklahoma Association of Free Will Baptists, dispose of all the assets of the Northeast Oklahoma Association of Free Will Baptists to such organization (the Free Will Baptist Association to which the Northeast Oklahoma Association of Free Will Baptists belongs) or organization formed and operated exclusively for religious purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) as the trustees shall determine. Assets may be distributed only to organizations which agree with Northeast Oklahoma Association of Free Will Baptists statement of faith.

FREE WILL BAPTIST CHURCH COVENANT

Having given ourselves to God, by faith in Christ, and adopted the word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant. We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and "provide things honest in the sight of all men".

We agree faithfully to discharge our obligation in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith and good works, endeavor to "grow in grace and the knowledge of our Lord and Saviour Jesus Christ".

We will not forget the assembling of ourselves together for church conferences, public worship, and the observance of the ordinance of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of education and denominational enterprises, the support of Missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly and preserve us blameless until the coming of our Lord Jesus Christ.

ARTICLES OF FAITH

Article I
The Bible

We believe the scriptures of the Old and New Testaments were given by the inspiration of God, and are our infallible rule of faith and practice.

We believe that God created Man innocent, but by disobedience he fell into a state of sin and death. His posterity therefore inherited a fallen nature of such tendencies that all who come to the years of accountability sin and become guilty before God.

Article IV Children Saved

We believe that all children dying in infancy, having not actually transgressed against the law of God in their own persons, are only subject to the first death, which was brought on by the fall of the first Adam, and not that any one of them dying in that state shall suffer punishment in hell by the guilt of Adam's sin for of such is the Kingdom of God.

Article V General Atonement

We believe that Christ died for all and whosoever will may be saved.

We believe that a Church of God is an organized body of believers in Christ who statedly assemble to worship God and keep the Ordinances of the Gospel according to the scriptures.

Services opened with prayer by Bro. Max Campbell. Singing led by Bro. Don Thomason with Sissy Swift at the piano. Song:" When We All Get To Heaven"

Devotion by Bro. David Bilby. He read from Judges 4. Deborah had imparted God's word to Barack. They faced 10,000 soldiers, 900 chariots of iron. It was like foot soldiers going against nuclear weapons, but God was on their side. The iron chariots sank in the mud. It seems, at times, we face insurmountable odds. God knows how to handle all situations at the right time. We only have to trust Him.

Services turned to Bro. Mike Wade. He gave a brief report on the state meeting. It was a good meeting. The theme was "Still Standing". We must always stand for the truth of God's word. Also, Bro. Brad Ransom had taken a position with the National Association, leaving his position with the State Mission Board open. The state association is taking time to find out how best to plant churches and to help others.

Pray for the State Mission Board that they would have wisdom to make good decisions. He engaged the churches to support TSP, and Home Missions. He desires God's blessing on each church.

Service turned to Bro. Bob Thompson speaking on the behalf of Hillsdale. He thanked the association for our support of all parts of the state work at Hillsdale, the professors, staff and everyone involved in teaching our people. Gods view is not the worlds view. Fifteen students are going to Equator for practical training as teachers and some will help in building. The school needs faithful supporters. He asked that we give generously. Bro. Bob asked us to pray for strength as he takes care of his wife who is seriously ill.

Service turned to Bro. and Sis. George Hyatt. Sister Judy talked about when they first joined Harvest Child Care Ministries in 2005. They have always lived close to the home in Virginia. Oklahoma is a long way from Virginia. On a visit back, they met a family with the dad in trouble. The older daughter had to take care of the family. When she went to the home she was relieved from those adult duties. The younger children are afraid of their dad. They went to stay with an aunt away from all the abuse. When we help Harvest we help families like this. Bro. George spoke about Harvest/Mexico. When a child reaches the age of 14 or 15 years they think they are grown up. One boy, 8 or 9 years old was left alone to take care of himself. He is in the home now and in school. He wants to be an engineer. Bro. Hyatt is willing to come visit any of our churches. All he needs is an invitation.

Treasurers report by Sis. Bonita Hanes. Motion made and properly sustained to accept this report as given. Carried. Motion made and properly sustained to give Hillsdale \$1000. Carried. To be taken from the general fund.

Recessed for 15 min.

Business resumed.

Resolution Committee Report.

- Be it resolved that churches fill shoe boxes and back packs for Mexico.
- 2. Be it resolved we give \$500 to Harvest/Mexico.

Motion made and properly sustained to accept Resolution 1. Carried Motion made and properly sustained to accept Resolution 2. Carried.

Bro. Everett Peace talked about the break in at the camp ground. Everything is gone out of the rock building. The building needs to be better secured.

We had prayer for Bro. Bob Thompson's wife. Bro Jack Metcalf needs our prayers also.

Long time credential board member, Bro. Dale Long has passed away. This leaves the 2 year position on the board vacant. Nominations were Bro. Bill Adcock (declined), Bro. Everett Peace and Bro. Wayne Peace nominated. Moderator declared nominations cease. Bro. Everett Peace 10 votes, Bro. Wayne Peace 9 votes. Bro. Everett Peace elected.

Motion made and properly sustained to adjourn business session. Carried.

Dismissed from session with prayer for Sis. Thompson and Bro. Jack Metcalf.

Worship Service

Services lead by Bro. Everett Peace.

Singing led by Bro. Don Thomason, with Sissy Swift at the piano. Songs-"The Glory Land Way" and "Living In Canaan Now" Special by Bonita Hanes "Why Did Jesus Have to Die".
