Saturday Morning Session

The meeting opened with congregational singing led by Rev. Jay Constant. James Ellis led in prayer, asking the Lord's blessings on the service.

Following the song "Amazing Grace," all ordained ministers and deacons were called into the altar for prayer which was led by Rev. H. D. Gentry.

A motion carried that the session adopt into the by-laws that the Executive Board members be ordained ministers and ordained deacons.

The treasurer's report was accepted, with a balance of \$83.20.

Each pastor was given an opportunity to report on his church and its progress.

A motion carried that the session adjourn. Rev. Wm. L. Brown dismissed the session in prayer.

Worship Hour

The service was opened with congregational singing led by Rev. Harvey Helms.

Special songs included "Precious Memories" sang by Lois Mize, Iva Ussery, and Clark Ussery, and "In the Garden" sang by the young people from Dorris.

The morning message was brought by Rev. Jay Constant, who used Matthew 27: 45-46 as his text.

Rev. Zimmerman, pastor of the Assembly of God Church of Capay, California, led the closing prayer. Rev. Jay Hamilton asked the blessing on the noon meal.

Saturday Afternoon Session

The session was opened with congregational singing led by Jim Punkett, accompanied by Ellen Rutledge.

The Winters Church shared a poem with the congregation. It was presented by Marie Rutledge of that church.

The Finance Committee presented the following recommendations:

Recommendation #1: We recommend that the finances of 50¢ per member be continued.  
A motion carried to accept this recommendation.

Recommendation # 2: We recommend that each church give \$10.00 per month for two months and that this money be set aside for the Dorris Church. This money shall be used for an evangelist for at least a ten-night revival. The evangelist is to be of their choosing. A motion carried to accept this recommendation.

The Resolution Committee recommended that this quarterly meeting give the Right Rev. Dr. W. H. Smith a vote of thanks for the fellowship and the wonderful meal. A motion carried to accept this recommendation.

The Executive Board reported that it had examined James Ellis and had issued to him a license to preach the Gospel for one year.

The Obituary Committee reported the death of Lorene Ellis from the Dorris Church. The congregation stood in memory of her while Rev. H. D. Gentry led in prayer.

A motion carried that an offering be taken for the Gridley Mission. The offering totaled \$ 18.05.

Rev. H.D. Gentry brought the message from Hebrews 3:7.

The congregation sang "Just As I Am" in closing, and Rev. John Clifton dismissed the session in prayer.


The congregation was asked to stand for a moment of silent prayer and Rev. Jay Hamilton prayed the prayer of remembrance.
