Saturday Morning Session

The annual statistical report of the churches was read by the clerk. A motion carried to accept the letters and seat the delegates.

When convened with the Olivehurst Free Will Baptist Church, August 3, 1968.

SATURDAY MORNING SESSION

Services were opened with congregational singing, led by Bro. Sanford Massengale. Rev. Chester Burgess led the congregation in united altar of prayer.
