THE OGEECHEE ASSOCIATION OF FREE WILL BAPTISTS CONVENING AT DEEP CREEK FREE WILL BAPTIST CHURCH MIDVILLE, GEORGIA

JANUARY 15, 2005

Buck Taylor began the meeting by leading the congregation in singing *Brethren, We Have Met to Worship.* Reverend Rick Wilson led the congregation in prayer.

On behalf of Deep Creek Free Will Baptist Church, Buck Taylor extended a warm welcome to all those in attendance.

Before calling the meeting to order Moderator Reverend Bobby Taylor, Jr. led the congregation in singing the charus *Isn't He Wonderful*.

MORNING BUSINESS SESSION

Moderator Reverend Bobby Taylor, Jr. called the meeting to order, then recognized the standing delegates. Church delegates were presented, Reverend Johnny Beasley made a motion to seat church delegates; the motion was seconded by Carlis Wilson. The motion carried. The Moderator welcomed visitors to the association, and introduced Charles Sumner, Georgia State Representative for Alabama Free Will Baptist Children's Home.

The moderator made the following committee appointments:

Buck Taylor gave the offertory prayer. The meeting recessed briefly following the offering.

Following a brief recess, Moderator Reverend Bobby Taylor, Jr. reconvened the meeting, calling for the following committee reports:

Georgia State Mission Board

Reverend Rick Wilson reported that there are many good things happening with the state mission board. As of December 1, 2004 the Valdosta work is once again active. A missionary has been hired to serve in the Valdosta work and the board is excited about the work, Rev. Wilson also noted that other churches have shown an interest in bringing their churches under the mission board for assistance. Rev. Wilson also reported that after a diligent search, the Mission Board has hired Rev. William Crank. This selection was carefully and prayerfully made after reviewing sixteen candidates. Rev. Crank is available to begin work with the mission board March 2005. The Mission Board is considering three areas for Rev. Crank to begin his mission work. Rev. Wilson pointed out that these newly hired men were interviewed and gareed to all conditions in the Georgia State Missions Handbook. According to Rev. Wilson, several states have approached the mission board about their Mission Handbook; the handbook is very comprehensive and other states are using it as a guideline to write their own manuals. The Moderator ask for an update on the Hampton work. Rev. Wilson reported that they had a buyer for the property. The buyer is trying to secure financing. Reverend Harris Nix inquired as to the three areas being considered by the mission board. Rev. Wilson stated that the three areas are Cartersville, Richmond Hill/Ricon, and Bonair. The moderator received the report as information.

Mark Findley polled the congregation to determine how many churches plan to participate in youth competition. There was no response. Findley stated that State Youth Competition will be held at Baxley Free Will Baptist Church, on May 6 & 7.

Reverend Irvin Murphy reported that the terms of a number of association representatives on state boards would be expiring. The nominating committee made the following nominations for those positions:

Rev. Murphy made a motion to accept nominations and proceed to elect by acclamation. Reverend Johnny Beasley seconded the motion and the motion was carried.

Member -at-Large

The moderator, Reverend Bobby Taylor, Jr. reminded the attendees that a change in the state constitution has created a new position on the state executive committee. Each association moderator now serves as a memberat-large on the state executive committee. Rev. Taylor reported that the state executive board will be presenting a proposal to change the Laura Belle Banard State Missions Offering to the Damon ${\it C.}$ Dodd State Missions Offering. This change will help to alleviate confusion with the National Laura Belle Banard Missions Offering. Rev. Taylor also reported that the

executive committee will propose state guidelines to determine who qualifies as a Georgia Missionary under the Acts 1:8 plan. Rev. Taylor also commented that the state camp board plans to continue the practice of giving each association a \$1500.00 grant for summer camp. In reference to our association summer youth camp, Rev. Taylor stated that the camp would be held at Camp Tattnall again this year; the dates for camp are June 12 - 17. Rev. Taylor added that he plans to use a number of young people who have previously participated as campers as camp workers. Reverend Rick Wilson interjected that he had received some indication from the camp director at Camp Tattnall that there may be a possibility of our association building a dormitory on their property. Wilson suggested the possibility of building a 50x100ft. building which could be divided to serve fifty boys on one side and fifty girls on the other side. There was some discussion as to the wisdom of building on someone else's property. The moderator commented that this possibility would have to be pursued further so that the association could consider the stipulations of such an agreement. Rev. Tim Brantley also added that we need to consider the fact that Camp Tattnall already has facilities available and if we built our own camp it would be extremely costly. Reverend Alan Carter shared that a Christian couple in Appling County have started a facility for camping, Cross Ties. Carter stated that we may be able to work out an agreement to use this camp. Reverend Harris Nix added that a committee needed to be appointed to investigate our camp options and come up with a long term plan. The moderator appointed a committee to investigate camping options. The appointees are Reverend Rick Wilson, Reverend Bobby Taylor, Jr., and Reverend Alan Carter.

Alabama Free Will Baptist Children's Home

The moderator asked Charles Sumner to share information concerning the children's home in Alabama. Charles Sumner serves along with Arthur Smith as Georgia's representative for the children's home in Alabama. Sumner thanked the association for their previous financial help and commented that the children's home received \$22,000.00 from the state of Georgia last year. However, Sumner pointed out that all of the monies received from Georgia were designated: the home was once included in the state budget but is no longer included. Sumner set forth his desire to see the state add the home back to its budget. Sumner discussed the home's mission at

Following a moment of silence Reverend Tim Brantley led in prayer.

Financial Report

Mark Findley, treasurer stated that he had no report due to computer problems, but promised to get reports to the churches. Mr. Findley stated that church dues for the meeting totaled \$600.00 and the days offering was \$90.63. Adding this income to the current balance gives a total balance in all accounts of \$14,099.63. Findley made a motion to accept this report, and Reverend Johnny Beasley seconded the motion. The motion was carried.

New Business

Reverend Rick Wilson made a motion for the association to make a donation to the Alabama Free Will Baptist Children's Home. Reverend Johnny Beasley seconded the motion. There was some discussion over how much to donate. Reverend Irvin Murphy asked the treasurer for the total in the general fund. Treasurer, Mark Findley stated that he was unsure of the general fund balance since he failed to retain a financial report from the previous association meeting, but estimated the balance to be approximately

\$4000.00. Reverend Tim Brantley stated that he felt we should always try to give more than we did before. The previous offering was \$2000.00. Reverend Johnny Beasley suggested donating \$1000.00 and encourage our churches to add the home in their budgets as well. The moderator suggested matching our previous gift of \$2,000.00, and encouraging our churches to give additionally. Wilson agreed to amend his motion to set the donation amount at \$2,000.00. Reverend Johnny Beasley added his second to the amendment and the motion was carried.

Terry Carter asked attendees to give a rising vote of thanks to Deep Creek Free Will Baptist Church for their hospitality and the meal which they prepared.

Bro. Aaron Taylor gave the offertory prayer. The offering was received.

Rev. Bobby Taylor dismissed the group for the committees to have time to meet.

Rev. Bobby Taylor called the business session back to order. He asked for the committee reports at this time.

State Mission Board Committee

Rev. Rick Wilson being absent, no committee report was received. Rev. Bobby Taylor informed the Ogeechee Association that the State Mission Board has hired two Missionaries for the works in Cartersville and Valdosta. He requested prayer for these two missionaries and works in these two cities.

State Trustee Board

Rev. Charles Beasley informed the Association that the State Trustee Board had voted to purchase the current building in which the Executive Secretary is located in.

State Christian Education Board

Bro. Mark Findley informed the Association that the state youth competitions were being moved from Baxley to the Church in Albany.

Ogeechee Camp Board

Rev. Bobby Taylor stated that the Ogeechee Association did not have made a formal request to the state association to receive the \$1500 grant for summer camp. He also stated that the registration forms should be mailed to pastors in the next few weeks. The deadline for registering for camp will be the middle of May. He reminded that summer camp was for children ages 7 to 18 years old.

Rev. Taylor informed the association that summer camp would be held at Camp Tattnall June 12th through June 17th. The cost will be \$25 per camper.

Rev. Taylor announced that the Metter Freewill Baptist church had donated \$600 to the Ogeochee Association Summer camping program.

Rev. Taylor requested pastors to explain the dress code for camp with their children. The male campers are required to wear long pants and female campers are required to wear a dress or shirt to worship services. Girls are required to wear one-piece swimsuit.

Rev. Taylor stated that he is planning allow teens that are too old attend camp to be workers during the week of camp.

Rev. Michael Moore with Walk on Ministries will be at summer camp and giving his testimony and his real life experiences with drugs.

Camp registration forms should be filled out completely including social security numbers.

Rev. Taylor expressed a need for workers during the week of camp.

Rev. Bobby Taylor dismissed for the morning worship service.

The morning worship service was open with the choir of Friendship Church sing "Heavens Jubilee" Rev. Charles Beasley asked Rev. Bobby Taylor to lead the congregation in special prayer for Bro. Leon Findley.

Rev. Harris Nix brought the morning message from 1st Corinthians, chapter 10, verses 1-10. He also referred back to the book of Numbers Chapter 11, verse 1. Rev. Nix gave an invitation and closed the service with prayer at the Alter. Rev. Nix turned the meeting back over to Rev. Taylor.

Bro. Mark Findley gave the financial report (see the attached report) and made the motion to accept the financial report. Bro. W. J. Wimberly seconded the motion and the motion passed.

Rev. Bobby Taylor, Jr. showed a copy of the National Freewill Baptist Magazine and explained that it would be mailed to all Freewill Baptist members.

Alabama Children's Home Report

Rev. Bobby Taylor, Jr. talked about some of the needs of the children at the home. He read a testimony of one of the children.

Bro. Mark Findley made a motion to add children's home as a part of the Ogeochee Association's budget. Rev. Irvin Murphy seconded the motion. The motion passed.

Bro. Mark Findley asked for any suggestions into the direction the association needed to go in budgeting the money for the children's home. Rev. Taylor suggested that he look at the current budget and some suggestions at the next quarterly meeting.
