Rev. Rick Wilson brought greetings from the State Mission Board. We feel that everything looks good in our mission sites. The Mission Board is in good financial shape. We have two missionaries in the field. They are Bro. Crank in Cartersville, and Bro. Lewis in Valdosta. We are looking to sale the building in Valdosta and move to another building across town. We are also looking for a missionary to start a works in Harris County. The Mission Board has sold the property in Hampton, Georgia,

Following a brief recess Rev. Taylor called the meeting back to order.

Rev. Taylor asked for standing committee reports:

Ogeechee Camp Board

Rev. Bobby Taylor informed the association that the Ogeechee Camping Program would receive a \$1600 grant from the State Youth Camp Board to help with cost of our camping

program. He announced that camp would be during the week of June 4th thru June 9th and that he would be sending a letter to the Pastors with the information for camp along with a registration form. He reminded the association that the camp registration form must be filled out completely and returned back to him by May 17th to give time to prepare for the number to be at camp. He also reminded the group that he needed their help in getting helpers for the week of camp. He stated that no children should arrive before 3:30pm, no bulling will be allowed, and the dress code will be followed. He stated that the cost for the week of camp would remain at \$25 per camper. He also stated that the State Teen Camp would be held the last week of May and that it would cost \$125 for those who registered early and \$150 for regular registration.

Financial Report

Rev. Irvin Murphy reported that he received \$625 in the morning offering and quarterly dues from the church dues; this brought the balance in the Ogeechee Association General Fund to \$1302.05. The balance in the Ogeechee Mission Board Account is \$10,774.70. The balance in Christian Education Board Account is 2241.33. Rev. Murphy made a motion to accept his report. Rev. Johnny Beasley seconded the motion. The motion passed.
