They have Japanese students enrolled in the FWB Bible College. He also stated that in Asia since 1986 there Eighteen FWB Churches with Ordained Pastors and 350 FWB Churches with 188 licensed Preachers. In Korea there is 15 FWB Churches. He asked that the churches support Mission Works World Wide and pray for the missionaries and their families as they carry the word of God to all parts of the world.
