Fields, text, Isa. 1:18, which was enjoyed by all present. Dismissed by Bro. W. E. Dearmore, to meet at nine o'clock Thursday.

Met according to adjournment. Called to order by moderator, Bro. M. M. McKee. Song No. 111. Prayer by Bro. Jack Hopkins. Called for election of moderator. Rev. M. M. McKee was elected moderator, Rev. W. E. Dearmore ass't moderator, C. L. Hudson clerk. Called for letters of various associations. Letters from Dibble, Washitaw, first Oklahoma association, were received. Motion and second that delegates be seated, after which the hand of Christian fellowship was extended to all present. Rules of order was read. The moderator appointed the following committees: committee on divine service, Jack Hopkins, J. Q. Moore, Tom Priest; committee on education, Rev. W. E. Dearmore. Rev. W. G. Fields, Si Huddleston; committee on publication, Rev. O'Donnell, Rev. M. M. McKee, Jack Hopkins: committee on resolutions, J. Q. Moore, J. E. Bean, G. W. Wright; committee on obituaries, Sisters Fields, O'Donnel, and Vance. Dismissed for committee work.

Called to order for divine service by song, "Tell It to Jesus Alone." Message brought by Rev. W. E. Dearmore, text—Romans 12:1. Adjourned to meet at 2 p. m.

Thursday evening session called together by singing at two o'clock, after which ass't moderator, Rev. W. E. Dearmore read Acts, 15th chapter. Prayer by W. G. Fields, after which Rev. W. E. Dearmore turned in his report. Motion and second to receive it. Motion carried

(report given elsewhere), after which Rev. E. A. O'Donnel turned in his report as editor of the Mission Publishing Co. Motion and second to accept his report; motion carried (report given elsewhere). Motion and second that there be an investigating committee appointed. The following committee was appointed: Bros. Jack Hopkins, J. Q. Moore, Rev. M. M. McKee.

REPORT OF STATE SECRETARY REPORT OF RETIRING CLERK

As your clerk for the past two years I beg leave to submit the following report. The state did not do very much business last year. The state conceded its time to the executive board of the Mission Publishing Co. We received \$23.25 for minutes last year. Paid out \$2.25 for leaflets, 25c for stamps to mail these to the different parts of the state. Total received for minutes \$23.25. Total paid out \$2.50. Total in treasury \$20.75. Motion and second to receive the report carried.

Motion and second that we elect Bro. G. W. Wright, J. E. Bean, Bro. Abbott, A. B. Tolbert, Bingham, as delegates to the Missouri state association.

Motion and second that we have our emblems printed

on silk ribbon of our state association. Carried.

Motion and second that our clerk be made treasurer also and he receive five dollars for his work.

Motion and second that we print the minutes of the First Oklahoma Association.

Motion and second that the state minutes have the same Articles of faith found in the treaties adopted by the cooperative association.

Motion and second that all associations have their minutes printed together.

FRIDAY, 2 P. M.

Called to order by moderator, Bro. M. M. McKee. Prayer by C. L. Hudson.

Motion and second that we elect officers for the preachers' and deacons' organization. Rev. W. E. Dearmore was elected emissary; W. G. Fields, assistant; A. E. O'Donnell clerk and treasurer.

Motion and second that we meet Rev. Dearmore, Fields, O'Donnell in the altar and anoint them for this special work.

Motion and second that the range 6 east be the evangelist dividing line, and that any church in four miles of the line have their preference of evangelists.

Motion and second to adjourn until 9 o'clock Saturday was elected.

Meet pursuant to adjournment. Motion and second that we elect member of executive board. Bro. A. B. Epperson morning. Dismissed by Bro. Epperson.
