# COMMITTEE REPORTS

Resolutions—We your committee on resolutions, beg to submit our report: We the state association want to thank the Pastor of the Drumright church and its respective members for the bountiful table spread, and the hospitable reception into the many good homes of Drumright, also for the spiritual blessings received in the church.

Resolution No. 1—Resolved that we the state association of Freewill Baptist go on record as being opposed to the modern teaching of Pre-Millennialism as taught by Seventh Day Adventis, Pastor Russell, Judge Rutherford, Modern Holliness, Fundamentalist Baptist, many other denominations and some Freewill Baptist. That if any one be found teaching that Christ will reign personally, materially and literally on Davids throne on this earth for one thousand years. That they be charged with attempting to divert the meaning of the scriptures, and that they be represented as a heretic, and if after they have been reproved they refuse to conform to the teaching of the scriptures, they be ex-communicated from the church as a heretic.

Ministerial Standing—We your committee beg leave to submit, the following. We find that Rev. Everette Wilson Pastor of the Denison Church is teaching a personal reign of Christ on the earth for 1000 years. Therefore we request a personal reproval for his unscriptural teaching, and that if he fails to adhere to the doctrine of the church he be ask to resign his pastorate.

Sunday School—We your committee beg leave to submit the following. We believe the Sunday School is the training school of the Church. We urge the parents to take their children to Sunday School rather than send them. We should encourage children of an accountable age to remain for church services. All Sunday School tachers and officers should be christians. All cur churches report a Sunday School.

Prayer Meeting—We feel the great need of more Prayer-Meetings, and we urge that every church give one night at least to Church Prayer-Meetings and cottage Prayer Meetings, if possible. As financial affairs will not permit some to come to services we might reach out in the highways and hedges and bring the lost to Christ. Also that we have more grove meetings in our revivals and that Gods children will always pray and not faint and that we might pray for the conversion of the world.

Obituary—We find that God in his infinite wisdom has called from our midst the following: 4 from Center Association; 13 from Gaines Creek Association; 5 from Payden; 6 from 1st Mission; 5 from Dibble; 1 from Hopwell; 3 from Hopewell No. 2; 17 from Grand River. We extend our deepest sympathy to the bereaved ones, yet we know that our loss is heaven's gain. We ask that this body stand for a moment of silent prayer in memory of those gone on.

Temperance—We your committee on temperance beg leave to report the following. After a careful study of the Prohibitory laws, and the impending laws about to be submitted to the voters of the State of Oklahoma, we find that the 18th ammendment has failed for lack of co-operation of the churches and enforcement of the law. Therefore we urge every member of the Freewill Baptist churches to abstain from the use of 3.2 Beer, intoxicating wines, whiskey or any other intoxicating beverages. We further recommend that our ministers co-operate with the officials of the law in their endeavors to destroy them, and that all Pastors and Evangelists condemn the use and possession of any intoxicants.

Publication—We your committee submit the following. We recommend that all our Freewill Baptist Sunday Schools use Freewill Baptist Literature, and that we put forth some effort to have a publishing house in our own state.

Mission—We beg to make the following report. We recommend that each mission circle arrange a program and go out to some new place at least once each month that we may advertise the mission department of the church work with the hope that we may reach lost souls and advance the kingdom of Christ.

Music—We beg leave to submit the following. After visiting many churches we find that music is at a very low ebb in them. Therefore we recommend that each church sponsor a school of music to train church choirs. We further recommend that we make choir practice a regular weekly meeting of the church.

League—We recommend that our leagues use Freewill Baptist Literature exclusively. Furthermore that each league set as their goal the conversion of the Young People in their respective communities. We further recommend that all Pastors and Parents get behind the young people with the league work and encourage them to go forward.

Education—We your committee on education beg leave to report. That whereas we the state association have written in the records a resolution setting apart ten days each associational year for the purpose of a Bible School for our young ministers. As therefore this present session of the association was petitioned separate and apart from the Bible training school. We therefore now request the association to entertain petitions for the placing of our annual Bible School in connection with an old time revival to run jointly with the school and furthermore that the teachers be selected at this session as a Faculty to teach in this school. We furthermore recommend a training course for Sunday School Superintendents and teachers under an experienced instructor.

Finance—We your committee on finance beg leave to report as follows, money received: First Mission Association, \$5.00; Gains Creek, \$2.50; Center, \$5.00; Hopwell, \$2.00; Hopewell No. 2, \$2.00; Dibble, \$3.00; Canadian, \$4.00; Grand River, \$3.00; total, \$26.50.

# CHURCH COVENANT

Having given ourselves to God by faith in Christ and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant. We promise by His grace to love and obey Him in all things, to avoid the appearance of evil, to abstain from all sinful amusements and unholy conformity to the world; from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit," in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strenghen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gos-

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our cheif business in life to extend the influence of Christ in society; constantly praying and toiling that the kingdom of God may come, and His will be done on earth as it is in heaven.

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith, and good works endeavor to "grow in grace and the knowledge of our Lord and Savior Jesus Christ." We will not forget the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

To this end, we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday school, and evangelitic efforts for the salvation of souls, and the conversion of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the

coming of our Lord Jesus Christ.

#### BY-LAWS

- 1. The moderator or assistant moderator, or in their absence, the oldest minister present shall call the Association in conference.
  - 2. Each session shall be opened and closed with prayer.
- 3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.
  - 4. Visiting brethren are invited to seats as advisory members.
- 5. Those who speak shall arise and address the moderator. Personal reflections shall be avioded in all debates.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken separately.
  - 7. Motions made and lost shall not be recorded.
- 8. No one shall speak more than twice on the same subject without leave of the moderator.
- 9. The moderator shall not allow discussion when not carried on in a Christian spirit.
- 10. The ruling of the Moderator may be overruled by a two-thirds vote of the members voting.
- 11. Any minister opposed to any of the enterprises endorsed by the Association will not be entitled to a seat in conference and we will not seat any minister in this Association that teaches the baptism of the Holy Ghost separate from regeneration or the birth of the Spirit.
- 12. No question from any church shall come under the consideration of the Association unless it has first been discussed in its own church.
- 13. At each Association arrangements shall be made to insure two or more sermons or their equivalent devotional exercises each day.
