- 3. Those who speak shall arise and address the Moderator Personal reflections shall be avoided in all delates.

Any member who personates, reflects, or causes a personal reflection on any other member of the association shall at the very instant of reflection be seated by the Moderator and shall not be allowed recognition again in that immediate session.

- 4. No motion shall be discussed without a second.
- 5. When a motion has been made and seconded, and a member opposes its discussion, the Moderator shall put the question, 'Shall it be discussed?" If negative, the question shall be dismissed.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member, and the vote taken separately.
 - 7. Motions made and lost shall not be recorded
- 8. No one shall speak more than twice on the same subject without special leave of the Moderator.
- 9. All questions shall be decided by a majority vote of all members present.
- 10. No member shall absent himself without special leave of the Moderator.
- 11. Minutes shall be leisurely read and corrected before the close of the Association, if necessary.

COMMITTEE REPORTS

RESOLUTIONS: No. 1—Be it Resolved, That every paster of each church collect at the rate of one dollar each month to be paid into the state treasury for the support of the State Evangelist. Be it further resolved that each pay their quota, if possible, on or before Jan. 1, 1940. Be it further resolved that the evangelist labor where there are no churches or churches without pasters. Be it further resolved, that the salary of the evangelist shall not exceed one hundred dollars (\$100.00) a month and that the evangelist be authorized to use all offerings independently of his salary for personal expenses.

- No. 2-Be it Resolved, That each subordinate Association send \$1.25 to the clerk of the State Association to pay for National minutes to be sent in by May 1, 1940.
- No .3—Be it Resolved, That at each sitting of the State Association that all preachers, deacons, delegates, and visitors register and pay \$1.00 which is to be used to defray the expenses of accommodating of all delegates, deacons, preachers, and adult visitors. Out of state visitors excepted.
- No. 4—Be it Resolved, That each subordinate Association send \$5.00 each year or the expense of printing minutes and paying clerk.
- No. 5.—Be it Resolved, That the State Association instruct the State Executive Board to make proper negotiation for the incorporation of the State Association of Free Will Baptist and proceed to do the same.
 - No. 6 Be it Resolved, That the Moderator of this Association appoint a member of this body to serve with himself and with the Executive Board, to arrange a code of parliamentary rules to govern the transaction of the business sessions of the State Association.
- No. 7—Be it Resolved, That Rule No. 3 of Rules of Order, be amended to read, "Any member who personates, reflects, or causes a personal reflection on any other member of the Association shall at the very instant of reflection be seated by the Moderator and shall not be allowed recognition again in that immediate session."

MINISTERIAL STANDING—We, your Committee on Ministerial Standing, beg to report as far as we know all ministers are in good standing with the Association.

EDUCATION — We, your Committee on Education, recommend that a Bible school be maintained in each subordinate Association and urge all ministers, especially our young ministers, to attend said school. We further recommend that God's people everywhere devote more time to the study of God's Word and scriptural literature. We also recommend and urge our ministers and pastors of the churches in each subordinate association to endeavor to stimulate an interest in our National Educational Program.

FOREIGN RELATIONSHIP — Since War lowers the standard of morals, destroys the lives of our youth, encourages crime, forces us into a state of intemperance, clouds our hearts with sorrow, and trends toward universal insanity, We your Committee on Foreign Relationship submit the following report for your earnest consideration:

Be it Resolved, That we the Church of God denominated Free Free Will Baptist, worshipping in the great soverign State of Oklahoma, oppose any form of aggressive warfare involving the political and economic conditions of Eurpoe now or hereafter. We will, however, defend our freedom to worship God according to the dictates of our conscience, which we, as citizens of the United States of America, claim as our God giver right. However, we are not opposed to any form of defence within the bounds of the United States. Futhermore, we will not only co-operate with, but will make the extreme sacrifice if necessary in defence of our civil and religious rights as provided for its by the Constitution of the United States.

PUBLICATION — We, your Committee on Publication, recommend that our minutes be printed at Monett, Missouri. Also we would like to have printed in the minutes the work of the State Executive Board of the past year concerning the printing press, and these resolutions which were as follows:

That the State Association elect a president and a Secretary treasurer who must be bonded to the amount of \$2,000.00 and said amount to be raised in three years by sub-ordinate associations, churches, and subscribers, and that contributors be issued a certificate for the amount given, and if the amount is not raised in three years, all money will be refunded. This money to be used to purchase a printing press and building to be controlled by the state Executive Board of the Free Will Baptisis of the state of Oklahoma.

The State Executive Board met October 21, 1938, and in our presence was Bro. Jack Hopkins, our state Sec'y-Treas., of Blanchard, R4, and we, the state Executive Board, have accepted his bond made by mortgage of 86 acres of real estate valued at \$3500.00 located in section 4 N. W. 1/4 of the N. W. 1/4 of Colbert Township, McClain County. This mortgage is securing all money paid by contributors to Jack Hopkins to be placed in the First National Bank of Blanchard, Okla. on time deposit not to be used by him until authorized by said Executive Board.

Bro Jack Hopkins reported that \$90.00 had been paid.

TEMPERANCE — We, your Committee on Temperance, report that we believe that the majority of crimes are caused, either directly or indirectly, by the use of intoxicating liquors. We as a body of Free Will Baptists, stand against it, and we do not patronize any business who handle it unless forced to, for we feel it is an enemy to men, women and children. It deprives them of the necessities of life. We pray earnestly that the good people of our country will consider the danger and work against its very appearance.

OBITUARY—We, your Committee on Obituary, find that God, in His infinite wisdom has called from our midst the following: 2 from the First Mission, 4 from the Gaines Creek, 4 from the Center, 3 from Hopewell No. 2, and 10 from the Canadian Associations.

We express our deepest sympathy to the bereaved, for we believe our loss was heavens gain. We know He does all things well.

FINANCE — We, your Committee on Finance, beg to report as follows: Amount paid in for minutes — First Mission \$3.00; Center \$5.00; First Oklahoma \$5.00; Hopewell No. 2 \$5.00; Dibble \$3.00; Canadain \$4.00; Eureka \$2.00; Gaines Creek \$5.00; Hopewell \$3.00; Total \$35.00.

SUNDAY SCHOOL — We, your Committee on Sunday School, wish to report as follows:

We recommend that our pastors and deacons, together with all ministers who have no churches give more attention to our Sunday School work, for in our youth lies the hope for more peaceful co-operation among our church leaders. Therefore, we urge that careful and prayerful consideration be given our youth. We advise that our more advanced leaders condescend to the simple truths of our Saviour more often and that they give much attention to our young preachers who have started out for God.

HOME MISSIONS—We, your Committee on Home Missions, recommend that each subordinate Association shall elect or appoint a mission president of their respective Association whose duty it shall be to organize and advise in the mission work, and to arrange a Mission Rally to meet once each month or as often as they deem necessary; seeing the great need of the Mission spirit in the various churches and seeing, also the great things that have been done in other churches that have Missions. We also recommend that all of our preachers and deacons take active part in helping to carry on this great work.

We have 49 missions in the state and 210 churches.

STATISTICAL REPORT — I wish to report as follows: We have 14 local associations; 210 churches; 10,500 members; 242 ministers; 600 deacons; property valued at \$127,000.00; paid pastors \$18,000.00; paid evangelists \$2,700.00; and we have 49 home missions.

FREE WILL BAPTIST ARTICLES OF FAITH

- 1. THE BIBLE. The Scriptures of the Old and New Testaments were given by inspiration of God, and are our infallible rule of faith and practice.
- 2. Gov. There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe, and in the Scriptures as the Father, Son and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore and obey.
- 3. CHRIST. Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified and is our ever present Savior and Lord.
- 4. THE HOLY SPIRIT. The Scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men.
- 5. THE GOVERNMENT OF GOD: God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.

- 6. THE SINFULNESS OF MAN. Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore, inherited a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God.
- 7. THE WORK OF CHRIST. The Son of God, by His incarnation, life, sufferings, death and resurrection effected for all a redemption from sin that is full and free and is the ground of salvation by faith.
- 8. THE TERMS OF SALVATION. The conditions of salvation are: 1. Repentance or sincere sorrow for sin and the hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Savior and Lord, with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death.
- 9. Election. God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect.
- 10. FREEDOM OF WILL. The human will is free and self-controlled, having power to yield to the influence of the truth and the Spirit and live, or to resist them and perish.
- 11. SALVATION FREE. God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosever will may come and take of the water of Life freely.
- 12. PERSEVERANCE. All believers in Christ, who through grace, persevere in holiness to the end of life, have the promise of eternal salvation.
- 13. Gospel Ordinances. BAPTISM, or the immersion of believers in water, and the LORD'S SUPPER, are ordinances to be perpetuated under the Gospel: FEET WASHING, an ordinance teaching humility, of universal obligation, and to be administered to all true believers.
- 14. THE CHRISTIAN SABBATH. The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works, and activities, and for personal communion with God.
- 15. Wan. War destroys the lives or the innocent, and is contrary to the New Testament, therefore, we are opposed to war.
- 16. RESURRECTION, JUDGMENT, AND FINAL RETRIBUTION. The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of dampaticn; then the wicked shall "go away into eternal punishment, but the righteous into eternal life."
