# **CONSTITUTION**

#### ARTICLE 1

This conference shall be called the Ministers Conference of the Grand River Association of Free Will Baptist. It shall be composed of Ministers of the Grand River Association who are in good standing with their respective Churches.

## ARTICLE 2

Officers of this Conference shall be composed of a chairman, Assistant Chairman, Clerk and Assistant Clerk, who shall be elected annually at the last session of each calendar year.

## ARTICLE 3

This Conference reserves the right to discipline its membership. All members of this conference should carry credentials of identification endorsed by the Chairman and Clerk.

## ARTICLE 4

This Conference shall meet quarterly. Place and date to be designated by the body in session.

#### ARTICLE 5

This Constitution may be amended at any regular session by a two-third majority vote of members present.

# **BY-LAWS**

## ARTICLE I

It shall be the duty of the clerk of this conference to ascertain is a quorum is present. If a quorum is present the clerk, or assistant clerk, or if neither is present the senior minister shall then take charge. If neither are present the senior minister shall moderate until the arrival of the presiding officers.

#### ARTICLE II

Ministers wishing to become members of this conference shall present themselves with letters of recommendation from their respective church of which they are a member, which shall be accepted by this body, after which the clerk shall enroll them.

## ARTICLE III

At each session the ministers of the conference shall present themselves with proper evidence of their right to seats therein. In case of questionable representation the case under question shall be referred to a credential committee.

## ARTICLE IV

This conference shall have the power at any sitting, by motion and second, and vote of two-thirds majority of members present, to seat our deacon brethren, of the Grand River Association, and give them a right to vote.

## ARTICLE V

Those who wish to speak in this conference shall obtain the floor by first addressing the chair as brother chairman. No one shall be allowed to proceed further until properly recognized by the chairman. (Chairman shall respond by repeating the name of the speaker; if the speaker's name is unknown, he may reply in the following manner: "proceed," "continue," or "you are at liberty."

## ARTICLE VI

Subject matter in all motions must be clearly stated before discussions are allowed to proceed.

Motions containing two or more points shall be divided at the request of any member present.

ARTICLE VII

When any member of this conference becomes heretical or corrupt in doctrine or practice; this conference, on being appraised of the fact, according the First Timothy, Chapter Five, and Verse Nineteen: (Against an elder receive not an accusation but before two or three witnesses). Investigates the matter and after suitable labor and gospel steps have been taken, if unsuccessful, withdraws fellowship, and reports same to his respective church. (Tim. 6-3,4,5.)

ARTICLE VIII

Each conference shall be opened by reading a portion of God's word and prayer, and each session shall be closed with prayer.

ARTICLE IX

By two-thirds vote of the members present a ruling of the chairman may be overruled.

ARTICLE X

This conference shall sit with open doors except when it shall go into a committee as a whole.

ARTICLE XI

No member shall absent himself from the conference during its meetings without permission from the chairman.

ARTICLE XII

All items of business shall be brought before the body by motion and second.

(Subjects For Discussion)

All questions presented to this conference for discussion must first pass through the Resolution committee and must refer to subjects as set forth in Free Will Baptist treaties. (Page 50, section 2.)

ARTICLE XIII

This conference shall elect ministers to bring the introductory message on Wednesday at the 11:00 o'clock service.

## **COVENANT**

Having given ourselves to God by faith in Christ, and being called and chosen to the Ministry, we give ourselves to one another, by the will of God in this solemn covenant.

We promise by the grace of God to love and support our brother minister to the advancement of the Gospel and the Glory of God.

We will not be partakers of any sinful amusement, neither shall we conduct ourselves in any manner at any time that will bring reproach on the ministry or hinder God's cause.

We agree to faithfully discharge our obligations and duties, to study to show ourselves approved, unto God a workman that needeth not to be ashamed, rightly dividing the Word of Truth.

We are willing by self denial, to promote the Gospel, and by faith, endeavor to "Grow in Grace and in the knowledge of our Lord and Saviour Jesus Christ." We agree to reprove with meekness and to watch over one another in love and affection, endeavor to keep the unity of the "Spirit" in the bonds of peace. To be careful of one another's happiness, reputation, and ministerial success. Seek to strengthen and encourage one another, and at all times promote the success of the church and the Gospel of our Lord and Saviour. We will at all times hold Christian principles sacred, and Christian obligations and enterprises supreme, counting it our chief mission in life to carry God's eternal message to those who are dead in sin, that they may be resurrected by "Saving Grace."

To this end we agree to labor for the promotion of Educational and Denominational Enterprises, constantly praying and toiling for greater achievements for Christ. May the God of Peace sanctify us blameless unto the coming of our Lord and Saviour Jesus Christ.
