By-Laws Of Minister's Conference

ARTICLE 1

The clerk or assistant clerk, or in their absence the senior minister in years, shall call the ministers into conference. If a quorum is present the President or in his absence the Vice president shall moderate the meeting. If neither of these are present, the senior minister in years shall be in charge.

ARTICLE 2

It shall be the duty of the clerk to enroll the ministers of the conference. Ministers shall present themselves with proper

evidence of their rights to seats therein, and those enrolled by the clerk shall compose the conference. In case of questionable representation the case under question shall be referred to the Credential Committee.

ARTICLE 3

It shall be the duty of each minister belonging to this conference, to be active in pastoral or evangelistic services (disabled and retired ministers excepted). Any minister belonging to this conference shall report in each session in person or by letter, and failing to do so for two successive sessions shall be subject to discipline.

ARTICLE 4

Each conference shall be opened by reading a portion of God's word and prayer, and each session shall be closed with prayer.

ARTICLE 5

By a two-thirds vote of the members present a ruling of the President may be overruled.

ARTICLE 6

This conference shall sit with open doors, except when it shall go into a committee as a whole.

ARTICLE 7

No member shall absent himself from the conference during its meeting without permission from the President.

ARTICLE 8

No person shall be allowed to nominate more than one member of a committee, unless person nominated is not elected.

ARTICLE 9

The President shall not allow discussions when not carried on in a Christian spirit, or when he thinks it will cause discord.

ARTICLE 10

Anyone desiring to speak shall rise and address the President by the appellation, "Brother President", but shall not speak further until recognized.

ARTICLE 11

No member of this conference shall be allowed to speak more than five minutes, nor twice on the same subject without permission from the President.

ARTICLE 12

These By-Laws may be altered or amended at any regular or adjourned session of this conference by a two-thirds vote of the members present.

Constitution Of Minister's Conference

ARTICLE 1

This Minister's Conference shall be called The Oklahoma State Free Will Baptist Minister's Conference, and shall be composed of Ordained Free Will Baptist Ministers who are regular members of some Orthodox Free Will Baptist church in the state of Oklahoma.

ARTICLE 2

The officers of this conference shall be President, Vice-President, Clerk, Asst. Clerk and Treasurer, who shall be elected annually.

ARTICLE 3

This conference shall have the power to discipline its members.

ARTICLE 4

Every ordained minister in the State of Oklahoma should be a member of this conference and is required to report in each session in person or by a letter. Every member shall be required to carry a card of identification, and recommendation from this conference, and said card to be issued annually.

ARTICLE 5

This conference shall meet Semi-Annually.

ARTICLE 6

This Constitution may be amended by a two-thirds vote of the members present at any regular session.

Articles Of Faith Of State Association

ARTICLES OF FAITH OF STATE ASSOCIATION

1. **THE BIBLE** The Scriptures of the Old and New Testament were given by the inspiration of God, and are our infallible rule of faith and practice.

2. **GOD** — There is one living and true God, revealed in nature as the Creator, Preserver and Righteous Governor of the Universe, and in the Scriptures as the Father, Son and Holy Ghost, yet, as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore and obey.

3. **CHRIST** — Christ is God manifest in the flesh: in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified. He is now risen and glorified and is our ever - present Saviour and Lord.

4. **THE HOLY SPIRIT** — The Scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men.

5. **THE GOVERNMENT OF GOD** — God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of Grace, not otherwise provided for as highest welfare of man requires.

6. **THE SINFULNESS OF MAN** — Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore, inherited a fallen nature of such tendencies that all who come to years of accountability, sin and become guilty before God.

7. **THE WORK OF CHRIST** — The Son of God, by His incarnation, life, sufferings, death, and resurrection effected for all a redemption from sin that is full and free and is the ground of salvation by faith.

8. **THE TERMS OF SALVATION** — The conditions of salvation are: 1. Repentance or sincere sorrow for sin and the hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord, with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit; freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death.

9. **ELECTION** — God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ, men become His elect.

10. **FREEDOM OF WILL** — The Human will is free and self controlled, having power to yield to the influence of the truth and the Spirit and live, or to resist them and perish.

11. **SALVATION FREE** — God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of Life freely.

12. **PERSEVERANCE** — All believers in Christ, who through grace persevere in holiness to the end of life, have the promise of eternal salvation.

13. **GOSPEL ORDINANCE** — Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel; Feet Washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers.

14. **TITHING** — God commanded tithes and offerings in the Old Testament: Jesus Christ endorsed it in the Gospel (Matt. 23: 23) and the Apostle Paul said, "Upon the first day of the week

let every one of you lay by him in store as God hath prospered him." I Cor. 16:2.

15. THE CHRISTIAN SABBATH — The divine law requires that one day in seven be set apart from secular employment and amusements for rest, worship, holy works and activities, and for personal communion with God.

16. RESURRECTION, JUDGMENT AND FINAL RETRIBUTION — The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation: then the wicked shall "go-away into eternal punishment but the righteous into eternal life."

RULES OF ORDER

1. At every sitting of the Association, business shall be opened and concluded by prayer by the Moderator or whomsoever he may request.

2. Ministers and deacons present are invited to seats, allowed to take part in debates on all subjects, and to vote.

3. Those who speak shall arise and address the Moderator. Personal reflections shall be avoided in all debates.

4. No motion may be discussed until made and seconded.

5. When a motion has been made and seconded, and a member opposes its discussion, the Moderator shall put the question, "Shall it be discussed?" If negative, the question shall not be discussed.

6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member, and the vote taken separately.

7. Motions made and lost shall not be recorded.

8. No one shall speak more than twice on the same subject without special leave of the Moderator.

9. All questions shall be decided by a majority vote of all Members present.

By Laws Of State Association

1. The clerk or assistant clerk, or in their absence, the senior ministers in years shall call the Association into conference, and if a quorum is present the moderator, or in his absence, the assistant moderator shall take charge; and if neither of them is present the senior minister in years shall act as Moderator.

2. It shall be the duty of the clerk to enroll the delegates to the Association, who shall present themselves with proper evidence of their rights to seats therein, and those enrolled by the clerk shall compose the Association.

3. It shall be the duty of every District belonging to this Association to send a letter to every annual session of this Association, reporting in the same, spiritual condition, benevolent work, and its statistics. Any District belonging to this Association, which shall fail to report itself for two successive sessions, may be dismissed from the Association by a two-thirds vote of all members present.

4. Each meeting shall be opened by reading a portion of the Bible and with prayer, and shall be closed with prayer.

5. By a two-thirds vote of all members present, a ruling of the moderator can be overruled.

6. This Association may correspond by messenger or otherwise with other religious bodies.

7. This Association shall sit with open doors except when it shall go into a committee of the whole.

8. Any person not a member of this Association may be allowed to take part in its discussions by obtaining permission from the moderator.

9. It shall be the duty of all of the Association to be present at the time appointed for each meeting, and anyone wishing to retire shall first obtain leave of the moderator.

10. No person shall be allowed to nominate more than one member of any committee, provided the person nominated be elected

11. The moderator shall not allow discussions when not carried on in a Christian spirit or when he thinks it will cause discord or division.

12. Anyone desiring to speak shall rise to his feet and address the moderator by the appellation, "Brother Moderator," but shall not speak further until recognized by the moderator.

13. No member of this association shall be allowed to speak more than ten minutes nor twice on the same subject without permission from the moderator.

14. These By-Laws may be altered or amended at any regular or adjourned session of this Association by a two-thirds vote of the members present.

Constitution Of State Association

PERAMBLE: From long experience, we the members of the Free Will Baptist denominations, being regularly baptised upon a profession of our faith in Jesus Christ, and realizing the necessity of a bond of union and fellowship among us as a church: and to preserve and maintain correspondence and co-ordination with us, do therefore ordain this Constitution for our better denominational government.

ARTICLE I

Name: This organization shall be known as the OKLAHOMA STATE ASSOCIATION OF FREE WILL BAPTIST.

ARTICLE II

PURPOSE: the object and purpose of this organization shall be to unify the work of the various bodies composing this State Association, and to devise and execute measures for the extension of the Kingdom of God in connection with the various bodies in the Association, or that may hereafter be represented therein.

ARTICLE III

REPRESENTATION: Section 1: This Association shall be composed of all ordained ministers and deacons with membership in some local church which is a member of a district association with membership in the State Association.

Section 2: Each District Association shall be entitled to a number of elected delegates equal with the number of churches composing said association. These delegates may be recommended by the local churches and shall be endorsed by their district association. Five delegates from the league, Woman's Auxiliary, and Master's Men

ARTICLE IV

FINANCE: Each elected delegate shall be represented with a fee of Five dollars.

ARTICLE V

DISCIPLINE: This State Association shall have the right to settle any question of discipline, doctrine or practices that may properly come before it from any of the bodies composing said organization, furthermore if there be any question of discipline, doctrine or practices on the part of a subordinate association, delegates of that association shall not be seated until these questions have been settled to the satisfaction of the Credential Committee.

Section 2: Decisions of the Credential Committee may be appealed. All Appeals coming before the State Association when sitting in a Committee as a whole. (2) by a special committee whose report shall be voted on without discussion.

ARTICLE VI

OFFICERS: The officers of the state association shall consist of a Moderator, Assistant Moderator, Clerk and Assistant Clerk, Parliamentarian, and an Executive Secretary, each of whom shall be elected at the close of each regular session, except

the Executive Secretary, who shall be elected every two years.

Section 2: Committees, as necessary, shall be appointed by the moderator, unless otherwise provided for, and shall hold office until their work is completed, or until their successors are elected.

ARTICLE VII

BOARDS: All standing boards shall be composed of five members who shall serve terms of 5, 4, 3, 2, 1 years, exclusive of the College Board of Trustees. The General Board shall be composed of one member from each subordinate association and the chairman of each standing board and the state officers. The College Board of Trustees shall be composed of seven members who shall serve terms of 5, 4, 3, 2, 2, 1 and 1 years. The standing boards shall include the Executive Board, Mission Board, College Board of Trustees, Superannuation Board, Sunday School Board, League Board and Church Loan Extension Service Board. The Coordinating Board shall be composed of the Executive Secretary and the chairman from each standing board.

ARTICLE VIII

DUTIES AND RULES OF STANDING BOARDS: 1 Executive Board. To this board is delegated the power to act in behalf of and for the State Association from one meeting to another for said Association, and shall have power and authority to select such officers as might be deemed best for its own government and to carry out the plans and undertakings of the State Association. The board shall have power to fill vacancies that may occur in its own body. To this Executive Board is further designated power to collect funds and employ and superintend such work for the field as may seem best, and the means on hand may warrant. They shall deliver Oil and Gas leases upon any real property owned by the association, for such bonuses and rentals as in the discretion of the said board.

This Executive Board shall keep a record of all work done, money raised, meetings held, and make a full and complete report to the regular meeting of the association and shall further receive, hold, manage, use, control, and convey any property entrusted to said State Association.

The chairman and secretary of said Executive Board shall sign all deeds, bonds and notes, etc., and any other papers by which the State Association is to become legally responsible, exclusive of those documents pertaining to Oklahoma Free Will Baptist Bible College which shall be signed by the College Board of Trustees.

The board shall have the power to call the association in conference by notifying each subordinate association at least ten (10) days prior to conference.

2. General Board: It shall be the duty of this board to meet with the executive board one day preceding the State Association to hear the reports of the standing boards and to make recommendations to the state associations. They also serve as credential committee.

3. Mission Board: It shall be the duty of this board to work in connection with the national foreign and home mission boards, and to promote an active missionary program in and for the state of Oklahoma. They shall elect a treasurer who shall handle all mission money.

It will also be their responsibility to investigate and assist, if necessary any new church. This board should thoroughly investigate the ability of a church to support an organization before assistance is pledged.

4. College Board of Trustees: It shall be the duty of this board to supervise and promote the Oklahoma Free Will Baptist Bible College.

5. League Board. It shall be the duty of the state league board to plan and assist in every way possible the League work throughout the state. It will also be their responsibility to promote an active league work in each subordinate association and to encourage League Rallies.

6. Sunday School Board: Their duties shall include the planning and operation of the State Sunday School Conventions, and the encouragement of the organization of district conventions. They may carry through any plans they think wise to actively promote Sunday school work in the state, and publishing any literature deemed advisable.

7. Superannuation Board. This board, workin in cooperation with the National superannuation board and district boards, shall provide a definite program of support for ministers.

8. Publication Board. This board shall have under their direction the printing of tracts, papers, books, pamphlets, etc., and shall encourage proper advertising in the local church.

9. Co-ordinating Board: This board shall be charged with the responsibility of co-ordinating and promoting the work of the other standing boards, and shall also act as Budget Committee. The Executive Secretary shall serve as chairman and the board shall meet at his discretion.

10. Working agreement between the state association and the Executive Secretary of the State association: That the Executive Secretary be paid a set salary and mileage and a two week paid vacation and all money received by him for speaking engagements, revivals and etc., shall be turned in by him to the Executive Office for the support of this office. He shall be ex-officio member of all standing boards.

ARTICLE IX

This constitution may be amended or altered at any regular session of the State Association by a two-thirds vote of members present, provided proposed amendment or alteration be presented in writing to the body one day in advance.

ARTICLE X

Elected delegates to State Association shall be retained as standing delegates for special called meetings.

Mission Board Report

The Mission Board submits the following report on its activities for the year 1960-61.

We have held 12 meetings since our last report and travelled a total of 12,337 miles in all phases of the work. Our Board meets regularly in the Headquarters Building in Oklahoma City on the third Tuesday of each month, unless it is otherwise deemed advisable for the convenience of the work to meet elsewhere. Anyone who has business to discuss with the Board may feel free to attend these meetings. Contact should be made with the Chairman or clerk previous to the meeting to make certain of the meeting place.

A ruling was passed in August of this year requiring any group or individual wishing to receive financial assistance from the board to file a written application with the Board stating the information concerning the work to be aided and giving all names of those involved, including individuals, churches, or associations. The main purpose of this ruling is to help keep a more accurate record of our work that is done where other parties are involved.

We have sponsored five organizations the past year including Bartlesville, Weatherford, Madill, Vian, and Stuart. Of these five, only Bartlesville has not yet been organized into a Church, but is still a Mission.

The Mission at Bartlesville was started on September 25, 1960 under the direction of Rev. Harry Beatty, who was employed by the Board as a full time mission worker. Bro. Beatty has served in this capacity with a full time salary up to the second Sunday of September. During this period the Board has worked to get an organized church, but circumstances have not made such action advisable. Rev. L. A. Yandell conducted a five night meeting in June of 1961 with plans to organize at the close, but because of the inability of those interested in membership to support an organized church, the Board felt it best to delay organization at that time. The mission has averaged 20 in Sunday school, 21 in morning worship, and 18 in evening worship for the year. The average weekly income has been around \$30.00. It is hoped by the Board to organize the mission into a church very soon.

The Weatherford Church was a result of the joint efforts with Union Association Mission Board. Rev. Clyde Hamar was the first to meet with the Board concerning services there and was endorsed by the Board as a mission worker to conduct the first services. The first meeting was held in Oct. 1960. The mission was organized on Dec. 16, 1960 with 20 charter members. Brother Hamar was called as the first pastor and

has since served as such. The church received assistance from the "New Church Club" for the purchase of property, but has not as yet bought and the Board has been asked to hold the money in the treasury until called for. The amount is \$930.00. The group is worshipping in a rented building at present.

The Vian Church was organized on Jan. 17, 1961 with 10 charter members and called Rev. Julian Hawkins as the first pastor. The group was organized out of a General Baptist Church which was disbanded to unite with the Free Will Baptists. The property formerly owned by the General Baptists was purchased by the new church, and has been used for services since the beginning. The group has united with the S. Grand River Association.

The Madill Church was a joint effort with the Center Association. The group first met on Feb. 2, 1961 in a home. The Odd Fellows lodge hall was later obtained to worship in and here following a five night meeting the group was organized on April 25th with 8 charter members. Bro. J. L. Vanwinkle was called as the first Pastor. He moved to Madill soon after the organization and has been serving the Church since. The progress has been slow, but the Board feels the Lord will bless the work and cause it to grow. There has never been a Free Will Baptist Church in this town before. The New Church Club was also used to assist the group and money is on hand to purchase property when a suitable location can be found and the Church is ready.

The Stuart Church was organized on July 28, 1961 with ten charter members and has united with the Gaines Creek Association. A mission was first established in June at the close of a revival effort sponsored by the Gaines Creek Master's men and held by Rev. Wade Jernigan and Rev. Gilbert Pixley. Rev. Muril Wilson served the mission until its organization as pastor, at which time Rev. Jimmy Ray Nichols was called as first Pastor. The church applied for assistance from the New

Church Club but due to previous commitments to other work, no funds were available through this source, however a gift was made by the Board from the General fund.

Other new organizations which have been given financial assistance from the Board, but were not sponsored by it, include Porter, and East Tulsa Churches.

There have been numerous inquiries about the New Church Club policies. In answer to these inquiries and perhaps to others who do not understand, the following statement of policy is made: Only those churches sponsored by the Board are eligible for assistance. The Board has sought to sponsor work in towns and cities where Free Will Baptist Churches were not located. The amount of assistance given to any church spon-

sored by the Board is left solely to the discretion of the Board. The amount of members contacted may vary in accord with the needs of the group to be assisted. We are indeed grateful to those who have contributed to the cause of Missions through the New Church Club. The members are only contacted once each calendar year for a \$10.00 contribution. Rev. Lonnie Davault 2715 S.W. 33rd St. Oklahoma City is the secretary of the club. At the present time there are approximately 505 members. We invite any individual, group, or church who wishes to join this effort, to send your name and address to our Secretary and you will in turn be notified when you are to send your contribution. The Board would like to have at least 1000 members in this club.

The Board has made surveys and done ground work in the cities of Altus and El Reno the past year. At the meeting in Sept. a motion was passed to sponsor a mission work in El Reno in conjunction with the First Oklahoma Association Mission Board. Services are to be started as soon as possible and efforts will be made to organize a church in the near future.

Our efforts in the coming year will be concentrated on projected organizations in El Reno, Altus, Woodward, Anadarko, and Ponca City. Bartlesville of course will be in the program as a carry over work. Also, we stand ready to give assistance and help wherever the need and conditions demand in so far as it is within our power and jurisdiction to so do.

We have been contacted concerning help for mission churches in Ulysses and Wellington, Kansas, but have felt that we are bound to the borders of Oklahoma so far as financial help is concerned. The group at Ulysses Kansas is a mission sponsored by the church at Guymon, Oklahoma and the group at Wellington, Kansas has been a result of efforts started from the church at Blackwell, Okla. We are praying that these works will grow and prosper and that soon a new State Association will come into being in our neighbor State of Kansas.

In regard to mission giving the past calendar year of 1960 we have much for which to praise the Lord. The State over subscribed its quota in both the Foreign and Home Mission Departments of our National work, giving a combined total of \$15,552.60. Add to this a total of over \$6000.00 given to all phases of the State mission program and this is a record amount. If we continue as of now there will be a larger amount recorded this year. The Board has sponsored itinerants for the Roy Thomas family, Lonnie Palmer family, and John Moelhman family this past year.

The Board wishes to express its appreciation to the churches over the State that participated in the State Missions month program last December. The special offerings received

totaled near \$1000.00. This special Missions month program will be sponsored again this year in the month of December. December 24th is to be designated as State Missions Sunday. Each church in the State is asked to receive an offering for State Home Missions on this date or some other Sunday in Dec.

We are asking for the same budget this year as last including 8% of the Cooperative Budget.

Co-ordinating Board Report

The Co-ordinating Board met in Oklahoma City on September 19, at 10:00 A. M. The meeting opened with prayer by Rev. Wade Jernigan, State Moderator. Rev. E. M. Kennedy was chairman by virtue of his office; Waldo Young was elected clerk.

The Board passes to you the following recommendations:

1. We recommend the adoption of the League Board Report with their budget of \$750.00, and grant them 1% of the co-operative receipts.

2. We recommend the adoption of the Superannuation Board report with their budget of \$3,500.00, and grant their request for 5% of the co-operative receipts.

3. We recommend that the Christian Education Board budget of \$7,000.00 be adopted, and their co-operative budget allocation be raised to 13%.

4. We recommend the adoption of the Executive Board budget of \$15,740.00 and their co-operative receipts be 35%.

5. We recommend the adoption of the Sunday School Board budget of \$75,000.00, and that they not be included in the co-operative receipts.

6. We recommend that the report of the State Mission Board be received, and grant them 8% of the co-operative receipts.

7. We recommend that the allocation to the National Association be 38%.

8. We recommend that the co-operative budget be set at \$27,500.00.

9. We recommend that the total budgets of each board be printed in the minutes the coming year.

The Loan Commission Chairman reported that their planned budget was \$50,000.00. This was for information only. The chairman ruled that only written reports could be received.

The Superannuation Board met four times during the year of 1960 and 1961, and history was made in Oklahoma Free Will Baptist. With the blessings of God upon our Work, an insurance program was started for our ministers that would pay their beneficiary \$2,000.00 in case of their death.

The following sixty-two ministers enrolled in this plan that they might receive these benefits. Name of the ministers are: Rev. Harry H. Beatty, Rev. Ralph B. Brown, Rev. Marion L. Caton, Rev. We regret to report that Rev. Clay Richey of Blanchard, Oklahoma was the first minister of this group to pass on to his reward. Rev. Richey died of a heart attack September 3, 1961. We extend our deepest sympathy to the family.

In the meeting of the Superannuation Board at Tulsa, October 21, 1961, Bro. Doyle Dipboye was elected as chairman of this board, and Bro. Jerry Rhoades was elected clerk.

A meeting was called by Bro. Doyle Dipboye 11-4-60 to set up the books for the coming year and to authorize the refund of the checks of those who had applied for this insurance, but because of age were unable to qualify. A meeting was set up with N. Y. L. I. C. representatives to formulate claim and correspondence policies.

On November 16, 1960 a meeting was held in the Northwest Free Will Baptist Church, Oklahoma City, with the representatives of the New York Life Insurance Company, and the details of the policy handling were worked out.

We urgently ask each minister who is an active member of the Oklahoma State Association of Free Will Baptist to prayerfully consider this insurance program. We do not feel that this program we now have is the ultimate in our aim, but we do feel that it is certainly a step in the right direction toward bigger and better coverage for our ministers. This program can only go forward if you, the ministers, pastors, evangelists, take part.

On September 11, 1961, the board met at the Northwest Free Will Baptist Church in Oklahoma City to close the books for the year. We recommend that our allocation be set at 5%, and we are setting our budget at \$3,500.00.

Report Of The Executive Board Of The Oklahoma State Association Of Free Will Baptists

The Executive Board had eleven official meetings during the year:

November 21, 1960 — State Headquarters

The Chairman presented items of business. The possibility of purchasing the Capitol Hill Book and Bible Supply at 29th South Agnew was discussed. A group visited the store and decision was deferred until owner of the store gives more detailed information of the operation of the business. The possibility of renting or buying other property was discussed.

As advised by the State Association, the executive board authorized the chairman and the state moderator to meet with Brother Richey regarding the circulation of a paper opposed to the state work.

November 29, 1960—State Headquarters

The chairman reported that he and Brother Jernigan had visited Brother Richey and that he was in accord with the work of the state association and had been misrepresented in a circulated letter.

Motion sustained that we borrow \$30,000.00 to purchase property at 4801 South Walker for state headquarters' office and book store.

Motion sustained that we borrow \$2,000.00 to pay the escrow on the purchasing of the property.

Motion sustained that the chairman and the executive secretary make necessary arrangements for house rent of present office and moving equipment to new location.

The headquarters property was purchased for \$27,500.00 which was \$2,500.00 less than the asking price with the owner also making several improvements. It was necessary to borrow \$30,000.00 in order to negotiate the loan and equip the store and office. Out of this amount was also paid the loan of \$2,000.00 for the escrow payment.

December 12, 1960—State Headquarters

At this meeting a service of dedication and the opening of the book store were discussed and planned. A motion was sustained to purchase a sign for the property. Motion was sustained that the chairman and executive secretary be authorized the minor expenditures necessary for opening the new store.

Plans were made and quotas suggested for the district associations to contribute to the purchasing of the property.

January 4, 1961—State Headquarters

The executive secretary gave financial report. Motion sustained that two of the upstairs rooms be rented to the Home Mission and Sunday School Departments at \$25.00 per month.

Motion sustained that the chairman, Robert Duncan, the secretary, J. Reford Wilson and Gilbert Pixley meet at Ringling to investigate the selling of oil royalty.

On January 9 the committee visited with Mr. Pogue, owner of the farm, and discussed with him the possibility of selling some royalty. At the time a well was being drilled just west of the property, indications were that it would be a producing well which would require an offset well on our lease. Motion sustained that we make available for sale 50 acres at \$400.00 an acre or 40 acres at \$500.00 an acre.

The well was not brought into production and no market was found for the royalty.

Motion sustained that we retain \$1,000.00 in the loan commission and use the balance for stock in the store.

January 16, 1961—Northwest Free Will Baptist Church, Oklahoma City

Mr. Charles Hinsley, representing board of Christian Education, presented the deed to the property which the Christian Education Board had purchased for a college site. The board attended the opening session of the second semester which was at the new location.

The executive secretary gave financial report to the board. Motion sustained that cancellation notices be sent on all insurance policies at 35 days if no down payment or arrangements have been made for paying. Motion sustained that a 10% interest be charged on all accounts 90 days past due beginning February 1, 1961.

January 24, 1961—Free Will Baptist Church, Broken Arrow.

The chairman, Robert Duncan, served as moderator of this meeting for the purpose of organizing a new district association. Letters were received from Liberty Church of Broken Arrow, Haskell Church and Barnsdall Church and delegates from these churches were seated.

The Free Will Baptist Treatise of Faith and Practice of The Original Free Will Baptists was presented and standing

vote was given to accept the doctrine of the treatise. Rev. John West prayed the prayer of consecration.

The delegates elected Rev. Oran Estes moderator of the association and Rosa Estes was elected clerk-treasurer. The delegates voted to name the district the Arkansas Valley Association of Free Will Baptists. Brother Marvin Mann directed the singing and Joan Richmon was the pianist for the service.

February 21, 1961—State Headquarters

Rev. E. M. Kennedy, executive secretary gave report on the state office and bookstore.

Whereas, funds are presently limited for increasing the bookstore stock, be it resolved that until money can be appropriated for increasing the stock that the stock be maintained at \$12,000.00 retail value and that orders be made upon customer request. Motion sustained to adopt.

Motion sustained that monies received on headquarters campaign be placed in savings account until January, 1962, at which time the money can be applied to the principal.

April 10, 1961—State Headquarters

Discussion of work of secretary and bookkeeper. Motion sustained that executive secretary be authorized to hire additional worker at not more than \$50.00 per week. Motion sustained that gravel be purchased for approach on south side of building. Motion sustained that an air conditioner be purchased for state office and book store.

A season of prayer for divine wisdom in discussing with the Capitol Hill Chamber of Commerce plans for building hospital. The board met with the special project's committee of the Capitol Hill Chamber of Commerce and discussed with them the possibility of building a hospital in the Capitol Hill area. It was found that they were looking for a sponsoring agency to administer the institution. Details of securing the money, size of hospital and working agreements were not available. No definite decisions were made regarding this matter and board is waiting for further developments.

August 15, 1961—First Mission Camp ground

The Executive Board and Sunday School Board met in joint session and adopted a resolution requesting the Executive Committee of the National Association of Free Will Baptists to approve the Sunday School literature published by the Sunday School Board of Oklahoma.

Motion sustained that chairman and secretary of the board

investigate the possibility of employing an account to audit and keep the books of the state office.

September 4, 1961—State Headquarters

A report on the cost of having a professional audit made of the books was given and it was decided that the cost was too much. A brief financial report was given by the executive secretary.

The board planned the budget for the executive office, bookstore and insurance business. Motion sustained that \$1200.00 of the amount being paid the executive secretary as salary be listed as housing allowance and \$4800.00 as salary. Motion sustained that we authorize executive secretary to withdraw money as needed from loan commission to set up payment plan for customer credit at 10% interest on the unpaid balance. Motion sustained that 2500 badges be printed for state association (a 2 year supply); 400 ministers; 600 delegates; 1100 visitors. Motion sustained that roof on mailing room be repaired. Motion sustained that 1200 programs be printed for state convention.

September 19, 1961—State Headquarters

Discussion of secretarial help. Motion sustained that the executive secretary be authorized to employ Mrs. Barnett as secretary-bookkeeper when needed at \$1.60 per hour.

Motion sustained that audit of Home Mission and Christian Education books be approved.

The chairman and secretary were authorized to complete audit of other books. This special committee met September 25 and audited the books of the Woman's Auxiliary, Superannuation, Sunday School and Executive office.

The Executive Board recommends that any department handling \$15,000.00 or more have a professional audit made of their books.

Report Of Executive Secretary Of The State Of Oklahoma

To the fifty third session of the Oklahoma State Association of Free Will Baptists while convened at Duncan, Oklahoma.

As we look back this has been a wonderful year. We have gone over our cooperative budget for the first time in the history of our state. We exceeded our budget some \$4,000.00. It was through the help and cooperation of both pastor and people that enabled us to do this.

More of our time is being consumed in the office. We take care of all the money coming in for Missions, Sunday School, College and Loan Commission, besides the allocations and book store and insurance business. I am teaching one hour per week in our College. I am not complaining, for this is as it should be, but we are just pointing out the pull on our time in the office. Nevertheless this being true, we have conserved our time and made more important meetings than ever before. I have been able to visit every District. God has given me some good results in revivals. I have attended many youth encampments and helped out in some. You will see that the Book Store business is growing each year, yet we are taking care of the work with the same amount of help that we had last year. If it were not for the interest and willingness of the workers at the Book Store and office to put forth extra effort in keeping up the work it

would be impossible for us to make it. Our increase in business is due to the moving into a better location and the efforts being made by our leaders throughout the State in boosting for our people to buy from our own book store. The pastors and people of Oklahoma City are to be commended in the help given us in moving to our new location.

There are a few observations I would like to make. Let me say first that had it not been for the fine cooperation given by our pastors and people throughout the State it would be a different story today. First let me say that since we are moving forward with such speed, we need to take time and check up on our forward progress in spiritual things. At such a time as this Satan will make a desperate effort to get in our midst and separate us as a people. The unity that now prevails must continue. We can agree to disagree and yet love each other. Second, although we have given more to outside causes than at any time in the history of our denomination, we must not be satisfied. The time is short, the day is at hand, if we ever get into many countries or even states in our union, we must do it soon. More of our Districts are becoming conscious of the need of sending the Gospel to others, but an added emphasis is needed to speed up this program.

Third, our Promoter subscriptions have suffered this year. There has been a let down on the part of our pastors in boosting the subscriptions. We should have a distribution of at least 3,000; we have less than 2,000.

Let me express my appreciation to each Church, Pastor and People that have supported the work this past year. My appreciation to each board of the State that has been so considerate of the office and the work. May God bless each of you and may the work grow under your supervision this coming year. There is no job, or phase of work that is unimportant in God's cause.

Constitution

ARTICLE (1)

This shall be called the Arkansas River Valley Association.

ARTICLE (2)

This Association shall be composed of such well regulated Free Will Baptist Churches maintaining Gospel order, agreeing with the denomination in doctrine and practices, favoring the enterprises that have been endorsed by this association.

ARTICLE (3)

The acting members of this association shall be Ordained Ministers and their wives and Church Clerks, Ordained Deacons, and their wives, belonging to any church composing the body, also three delegates from each church chosen by the members of their respective churches.

ARTICLE (4)

The officers of this Association shall be a Moderator and Assistant Moderator and a Clerk and an Assistant Clerk and an Executive Board composed of 5 members, elected so as to require one member to be elected each year and a Trustee Board composed of 3 members elected so as to require one member to be elected each year. The Trustee Board shall act as custodians of all property belonging to the Association, and shall sign legal papers when authorized by the Association to do so.

ARTICLE (5)

The property of any church in this Association that should degenerate until they cannot transact business because they are disorganized shall become the property of the Association and the Executive Board shall have power to execute legal papers for the property.

ARTICLE (6)

This Association shall meet annually at such time and places as shall be decided upon by the Association, also shall meet in regular Quarterly Meetings, and shall at such quarterly meetings have power to transact business of the Association except to change the Constitution.

ARTICLE (7)

This Association may be called together by the Moderator by giving the churches ten days notice of such meeting.

ARTICLE (8)

This Constitution may be changed at any yearly Meeting by a two-thirds majority of members voting.

ARTICLE (9)

The Officials of the Association shall be elected at the close of each regular session.

We your committee on Temperance wish to present the following report. In noting the ever increasing scenes of intemperance among church people of moral character, in the appearance of dress, habits, time, activities and service; we recommend the following items be taught, preached, and practiced as well as be dealt with to a greater degree by our local churches and pastors in the receiving of members and the various fields of service or auxiliaries within the church. In as much as we are taught to let our light so shine before men that they might see our good works and glorify our Father which is in heaven.

1. We recommend the temperate use of all things good, and the total abstinence from all things harmful.

2. That our churches cooperate with the Sooner alcohol and Narcotic Education Inc.

3. The total abstinence from the use of alcoholic beverages.

4. That our State body recognize and uphold the standard which has been passed by the National Convention of F. W. B. (that we go on record as being opposed to the use of tobacco in any form among Christians everywhere.)

5. That a more modest dress be observed both by women and men.

6. A more temperate use be made of television, in view of a greater need for home and family devotion with encouragement for more family altars.

7. That we be more temperate in our outside activities especially during spare time and more so, the appointed time of worship. That we may live, walk, and be led in and by the Holy Spirit, and not just to satisfy the lust of the flesh. That we may devote more earnest time to the work of our Lord and Saviour Jesus Christ. In as much as we as Christians should be lovers of God more than lovers of pleasure.

8. We recommend that our state association go on record in favor of the uniform petition in circulation being sponsored by the Retail Grocer's Association to provide a uniform day of worship and rest for all people, and that our pastors and laymen give this program support.

Obituary Committee

We the obituary committee report 121 deceased. Our loss is heaven's gain. Listed among this number is one of our pioneer ministers, Rev. Clay Richey.

Placement Committee

At the invitation of the Mayor and Chamber of Commerce, we recommend that the association meet in Oklahoma City for the 1963 session.

Special Committee Report

We recommend that a special committee be appointed by this association to go to the next quarterly meeting of the Arkansas River Valley Association to discuss Free Will Baptist doctrine and practices with them.

Constitutional Changes Committee

Recommendation No. 1 - That article VII of the constitution be changed to read: All standing boards shall be composed of five members who shall serve terms of 5,4,3,2,1 years, exclusive of the College Board of Trustees. The General Board shall be composed of one member from each subordinate association and the chairman of each standing board and the state officers. The college board of trustees shall be composed of seven members who shall serve terms of 5,4,3,2,2,1 and 1 years. The standing boards shall include the Executive Board, Mission Board, College Board of Trustees, Superannuation Board, Sunday School Board, League Board, and Church Loan Extension Service Board. The Coordinating Board shall be composed of the Executive Secretary and the chairman from each standing board.

Recommendation No. 2 - That article VIII, paragraph No. 3 be changed to read:

The chairman and secretary of said Executive Board shall sign all deeds and bonds, notes, etc., and any other papers by which the state association is to become legally responsible, exclusive of those documents pertaining to Oklahoma Free Will Baptist Bible College which shall be signed by the college board of trustees.

Recommendation No. 3 - That article VIII, item No. 4 be changed to read:

College Board of Trustees: It shall be the duty of this board to supervise and promote the Oklahoma Free Will Baptist Bible College.

Recommendation No. 4 - Add to article III, item 2: Five delegates from the League, Woman's Auxialary, and Master's Men.

Recommendation No. 5 - Change article IV to read: Each elected delegate shall be represented with a fee of five dollars.

Recommendation No. 6 - Article X shall read that delegates to state association be retained for standing delegates for special called meetings.
