MONDAY, OCTOBER 12, 1964

The meeting of the General Board was called to order by Rev. Clarence Shepherd, chairman. Prayer was led by Rev. Lynn Wood.

The chairman called the roll of the General Board.

Motion made and carried to seat Rev. Joe Payne to represent the Superannuation board.

Letters were read and accepted from the following associations; Center, First Mission, Gaines Creek, Progressive, Dibble, Arkansas River Valley, South Grand River, First Oklahoma, Eureka, Canadian, Southeastern, Hopewell #1, and Hopewell #2.

The Sunday School Board report was read. Motion made and seconded to accept the report. Motion made and sustained to amend the report by changing the 3% to 1%.

The report was accepted with the amendment.

Motion sustained to adjourn for lunch. Prayer by Rev. James Cearley.

The afternoon session opened with prayer by Rev. Ernest Harrison.

The Mission Board report was read by Rev. James Murray. Motion sustained to accept the report. The chairman requested the Mission Board to prepare a proposed budget to be presented at the convention.

The report of the Executive Board was read and accepted.

The League Board report was read and accepted.

The Coordinating Board report was read by the Executive Secretary. Motion sustained to accept the report item by item. Item No. 1 accepted. No. 2 accepted. No. 3 accepted. No. 4 accepted.

The report of the Superannuation Board was read by Rev. Joe Payne. Motion sustained to accept the report item by item. Item No. 1 accepted. No. 2 accepted. No. 3 accepted. No. 4 accepted. No. 5 accepted.

The Executive Secretary read his report. Motion sustained to accept the report.

The Book store financial report was read and motion sustained to accept the report.

An oral report of the Oklahoma Bible College Board of Trustees was given by Rev. J. B. Fletcher. Motion sustained that this report be received as information.

The financial report and the budget of the Oklahoma Bible College was read. Motion made and seconded to accept the report. Motion sustained to table the report until after the "Future Perspective of OBC" is given.

The Future Perspective of OBC was given by Rev. Paul Inbody. Rev. Kenneth Seikman, architect, spoke to the board concerning the proposed buildings. Motion sustained to table the perspective until after we view the proposed charter. The proposed charter was distributed in mimeographed form.

The motion was made and seconded that we adjourn until tomorrow. Carried.

The Session of the General Board continued Tuesday afternoon.

Motion sustained that the Chairman appoint a committee to receive late letters. Ernest Harrison, Jack Richey, and James Murray were appointed.

The letter from the Union Association was read and accepted.

The Charter of Oklahoma Bible College was accepted in amended form.

Motion sustained to adopt the report with the amendment of the corrected overall budget figure of \$144,600.00.

Motion sustained to remove the perspective from the table.

Motion sustained to accept the perspective.

Motion sustained to adjourn. The meeting was adjourned.

The 56th Annual Session of the Oklahoma State Association was opened by singing "Glory to His Name," directed by Mr. Kenneth Beatty, with Mrs. Doyle Cox, pianist. The theme of the convention was, "Unto God Be Glory," taken from Phil. 4:20.

Prayer by Rev. Roma Stewart.

Song, "Praise Him, Praise Him."

Rev. Berton Perry, who was presiding, introduced the Clerk of the Association, Rev. Howard Gage, who called the session to order and introduced the other officers.

Rev. Lonnie DaVoult, the Moderator, was introduced and brought the Moderator's message reading Colossians 1:3-5.

Rev. Ernest Harrison, pastor of the host Church, gave the convention a welcome to the city and the area.

The response to the welcome was given by the Clerk.

An offering was received for the expense of the convention.

The State Minister's Quartet sang, "I've Been To Calvary."

Rev. Paul Inbody was introduced as the introductory speaker. He brought the message on, "The Work of the Word," reading Hebrews 4:12.

Rev. Bill Ketchum led the closing prayer.

The Wednesday morning session opened by singing, "I Will Sing

the Wondrous Story." Prayer by Rev. Sherman Webb.

Song, "O How I Love Jesus."

The devotional was brought by Rev. Tommy Roberts who read from I Peter 4:10-11 and led in prayer.

The Moderator read Psalm 133, delivered the Moderator's admonition, and declared the meeting in order.

A partial report of the General Board was read and motion sustained to accept the partial report of this board acting as credential committee.

Visiting ministers were recognized.

Rev. Ernest Harrison was introduced and he introduced Mr. Al Pruksa who gave the welcome address.

Motion sustained to adopt the program and leave the time flexible.

Obituary Committee: Rev. A. A. Williams, Rev. Connie Cariker, Rev. Don Jones, Rev. E. E. Morris, and Rev. George McLain.

Placement Committee: Rev. Clarence Campbell, Rev. Jack Richey, Rev. DeArthur Yandell, Rev. Myrl Wilson, and Rev. V. B. True.

Rev. Paul Kettelman was introduced to give us information concerning the Free Will Baptist Bible College in Nashville, Tennessee.

Rev. Billy Melyin, National Executive Secretary, brought greetings and information from the National Headquarters.

Mr. Samuel Johnson, Church Training Service Director, gave information concerning this work, its literature and program.

The meeting was adjourned for recess.

The Wednesday Morning Worship Service opened by singing the Doxology. Prayer by Rev. L. A. Yandell. The song director then led in a medley of songs, and the song, "Jesus Saves."

Rev. Paul Inbody sang, "I Know I'm Saved by Grace Divine."

Rev. John H. West led the congregation in prayer.

The Morning Message was delivered by Rev. Ray Gwartney on "The Work of Christ," reading John 12:27-28.

The benediction was prayed by Rev. Curtis Hogue.

The afternoon session opened by singing, "There Is A Fountain," and prayer by Mr. Jim Martin.

The State Minister's Quartet sang, "Hide Me, Rock of Ages."

Rev. Arvil Arnold brought the devotion reading from Psalms 22:23-26. He called on Rev. E. E. Morris to lead in prayer.

Two representatives from the Travelers Insurance were introduced. Rev. Gerald Herd and Mr. Radclif, who briefly explained a Hospitalization insurance for ministers.

The names of the delegates from the different associations were read by the clerk.

The Polity Committee report was read. Motion made and seconded to accept the report. Motion sustained to table the report until tomorrow.

The report of the Special Committee on Standing Boards was distributed. Motion made and seconded to accept this report. Motion sustained to table the report until tomorrow.

The Oklahoma Bible College financial report, budget, charter, and Future Perspective of OBC, were read. Motion made and seconded to accept the report. Motion sustained to table the report until tomorrow.

The remainder of the General Board report was read. Motion sustained to accept the report.

The report of the State Sunday School Board was read. Motion sustained to accept the report and adopt the budget.

Rev. Roger Reeds was recognized to report on the National Sunday School Program. Motion sustained to adopt the report.

The Oklahoma State Mission Board report was read. Motion sustained that the State Mission Board contact the National Home Mission Board to see about securing qualified personnel.

Rev. Homer Willis gave a report of the National Home Missions and Church Extension. He called on Rev. H. E. Staires to lead in prayer.

Rev. Rufus Coffey gave a report of the work of Foreign Missions of the National Association.

The report of the Loan Commission was read and motion sustained to accept the report.

The Coordinating Board report was read and Motion made and seconded to accept the report and adopt the recommendations item by item. Item No. 1 accepted. No. 2 accepted. No. 3 accepted. No. 4 accepted.

The League Board report was read. Motion made and seconded to adopt the report. Motion sustained to table the report due to a Constitutional change.

Rev. N. R. Smith gave the report of the Executive Secretary and the Book Store. Motion sustained to accept the report.

Motion sustained to adjourn.

The Wednesday evening service opened by singing "There is Power in the Blood." Prayer by Rev. Bob Ketchum.

Song, "Stand Up, Stand Up for Jesus."

The First Oklahoma Youth Choir sang several numbers.

An offering was received for missions.

Rev. Rufus Coffey was introduced to bring the message on "The Work of the Holy Spirit." He read Acts 13:1-3.

Rev. Joe Blair prayed the benediction.

The Thursday Morning service opened by singing, "Tis So Sweet to Trust in Jesus." Prayer by Mr. Henry Braisher.

Song, "Blessed Assurance."

Rev. E. E. Jenkins brought the devotion reading from Acts 4:18-21, and leading in prayer.

Motion sustained to take from the table the report of the College Board of Trustees.

The financial report and budget were read. Motion made and seconded to adopt this part of the report. Motion sustained this part of the report.

The Future Perspective was read. Motion made and seconded to accept this part of the report. After discussion, the Previous Question was moved. The Future Perspective was adopted.

Motion sustained to bring the financial report and budget from the table. The financial report and budget of the College Board of Trustees were adopted.

The Oklahoma Bible College Charter was reviewed.

Motion made and seconded to amend the charter by adding to item five of Section B these words, "At least five of these trustees be from Oklahoma." Motion made and seconded to amend the amendment by substituting "All" in place of "five." The amendment to the amendment carried. The amendment carried as amended.

Motion sustained to insert as item five these words: "Each Trustee shall be a resident member of a regular Free Will Baptist Church that is in good standing with the Oklahoma State Association."

Motion sustained to adopt the Charter and By-Laws as amended.

Motion sustained to adopt the entire report of the College Board of Trustees.

Motion sustained to adjourn. Dismissed in prayer by Rev. A. F. Ferguson.

The Thursday morning worship service opened with singing, Rev. Lynn Wood presiding.

The Obituary report was given by Rev. E. E. Morris reporting 120 members had expired during the past year. Mention was made of Mrs. Lizzie McAdams who was with us many years, and deceased the past year. She was buried in Texas. A moment of silent prayer followed by Rev. Kenneth Brandon.

The song, "Follow Me," was sung by Rev. and Mrs. Don Jones.

Prayer by Rev. Homer Young.

Rev. Bill Ketchum brought the morning message on "The Wonder of the Transformed Life." He read Romans 12:1-2.

The service was dismissed with prayer by Rev. Doyle Cox.

Thursday afternoon the session opened by singing, "How Firm a Foundation," and prayer by Rev. Don Cox.

Song, "When I Survey the Wondrous Cross."

The moderator introduced Rev. H. Z. Cox from Dallas, Texas, who brought the afternoon devotion and greetings from the state of Texas. Rev. Cox read from Isaiah 6:1-7, and lead in prayer.

Motion sustained to take the report of the League Board from the table.

Motion sustained to take from the table the report of the Committee on the duties of Standing Boards.

Motion sustained to amend item No. 3 of the report to read, "A chairman, clerk, and/or treasurer."

The question was put to the body by the moderator, "Does this wording mean the chairman and clerk or treasurer may be the same persons?" The body voted that these offices shall be filled by separate persons.

Motion sustained to amend paragraph 3, Article VIII, by adding, "Exclusive of the College Board of Trustees."

Motion sustained to accept the report of this committee in its amended form.

Motion sustained to have Resolution No. 3 read before the election of board members, since it pertains to this election.

Motion sustained to amend Resolution No. 3 by inserting the words, "Full time employees."

Board members were elected as follows:

EXECUTIVE BOARD: 7 years Rev. John H. West, 6 years Rev. H. E.

Staires, and 5 years Rev. Howard Gage.

CHURCH TRAINING SERVICE: 7 years Rev. Roma Stewart, 6 years Rev. Don Jones, and 5 years Rev. Lewis Wickham.

MISSION AND CHURCH EXTENSION BOARD: The Resignations of Rev. Lónnie DaVoult and Rev. Jerry Rhoades were accepted. Elected to the board for 2 years Rev. Joe Blair, 1 year Rev. Lynn Wood, 7 years Rev. James Murray, 6 years Rev. Bob Duncan, 5 years Rev. Adrain Condit.

Motion sustained to declare the offices of the two two year men vacant from the College Board of Trustees. Members of this board were elected as follows:

The Master's Men report was given by Mr. Howard Gwartney.

The Obituary Committee report was accepted.

The report of the Temperance Committee was read and accepted.

The Placement Committee report was read recommending that we meet in Pryor in 1966. The recommendation was adopted.

The Resolution Committee report was read and motion sustained to adopt it item by item. Resolution No. 1 adopted. Resolution No. 2 adopted. Resolution No. 4 adopted. Motion sustained to amend Resolution No. 5 to read, "We send our Executive Secretary with a letter." Resolution No. 6 adopted.

Motion sustained to take the report of the Polity Committee from the table.

Motion sustained to refer the report of the Polity Committee back to the committee until next year.

Motion sustained to pay the expenses of the Polity Committee.

Motion sustained to accept the resignation of Rev. DeArthur Yandell on the Polity Committee. Motion sustained the moderator appoint

a member of fill his vacancy. Rev. Jerry Rhoades was appointed.

The election of officers was as follows:

BY-LAWS OF MINISTER'S CONFERENCE

Article 1

The clerk or assistant clerk, or in their absence the senior minister in years, shall call the ministers into conference. If a quorum is present the President or in his absence the Vice President shall moderate the meeting. If neither of these are present, the senior minister in years shall be in charge.

Article 2

It shall be the duty of the clerk to enroll the ministers of the conference. Ministers shall present themselves with proper evidence of their rights to seats therein, and those enrolled by the clerk shall compose the conference. In case of questionable representation the case under question shall be referred to the Credential Committee.

Article 3

It shall be the duty of each minister belonging to this conference, to be active in pastoral or evangelistic services (disabled and retired ministers excepted). Any minister belonging to this conference shall report in each session in person or by letter, and failing to do so for two successive sessions shall be subject to discipline.

Article 4

Each conference shall be opened by reading a portion of God's word and prayer, and each session shall be closed with prayer.

Article 5

By a two-thirds vote of the members present a ruling of the Presi-

dent may be overruled.

Article 6

This conference shall sit with open doors, except when it shall go into a committee as a whole.

Article 7

No member shall absent himself from the conference during its meeting without permission from the President.

Article 8

No person shall be allowed to nominate more than one member of a committee, unless person nominated is not elected.

Article 9

The President shall not allow discussions when not carried on in a Christian Spirit, or when he thinks it will cause discord.

Article 10

Anyone desiring to speak shall rise and address the President by the appellation, "Brother President," but shall not speak further until recognized.

Article 11

No member of this conference shall be allowed to speak more than five minutes, nor twice on the same subject without permission from the President.

Article 12

These By-Laws may be altered or amended at any regular or adjourned session of this conference by a two-thirds vote of the members present.

CONSTITUTION OF MINISTER'S CONFERENCE

Article 1

This Minister's Conference shall be called the Oklahoma State Free Will Baptist Minister's Conference, and shall be composed of Ordained Free Will Baptist Ministers who are regular members of some Orthodox Free Will Baptist church in the State of Oklahoma who have paid their \$1.00 dues.

Article 2

The officers for this conference shall be President, Vice-President, Clerk, Asst. Clerk and Treasurer, who shall be elected annually.

Article 3

This conference shall have the power to discipline its members.

Article 4

Every ordained minister in the State of Oklahoma should be a member of this conference and is required to report in each session in person or by letter. Every member shall be required to carry a card

of identification, and recommendation from this conference, and said card to be issued annually.

Article 5

This conference shall meet Semi-Annually.

Article 6

This constitution may be amended by a two-thirds vote of the members present at any regular session.

ARTICLES OF FAITH OF STATE ASSOCIATION

1. **THE BIBLE** — The Scriptures of the Old and New Testament were given by the inspiration of God, and are our infallible rule of faith and practice.

2. **GOD** — There is one living and true God, revealed in nature as the Creator, Preserver and Righteous Governor of the Universe, and in the Scriptures as the Father, Son and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore and obey.

3. **CHRIST** — Christ is God manifest in the flesh: in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified. He is now risen and glorified is our ever-present Saviour and Lord.

4. **THE HOLY SPIRIT** — The Scriptures assigns to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men.

5. **THE GOVERNMENT OF GOD** — God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of Grace, not otherwise provided for as highest welfare of man requires.

6. **THE SINFULNESS OF MAN** — Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore, inherited a fallen nature of such tendencies that all who come to years of accountability, sin and become guilty before God.

7. **THE WORK OF CHRIST** — The Son of God, by His incarnation, life, sufferings, death, and resurrection effected for all a redemption from sin that is full and free and is the ground of salvation by faith.

8. **THE TERMS OF SALVATION** — The conditions of salvation are: 1. Repentance or sincere sorrow for sin and the hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord, with purpose to love and obey Him in all things.

In the exercise of saving faith the soul is renewed by the Holy Spirit; freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death.

9. **ELECTION** — God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ, men become His elect.

10. **FREEDOM OF WILL** — The Human will is free and self controlled, having power to yield to the influence of the truth and the Spirit and live, or to resist them and perish.

11. **SALVATION FREE** — God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of Life freely.

12. **PERSERVANCE** — All believers in Christ, who through grace persevere in holiness to the end of life, have the promise of eternal salvation.

13. **GOSPEL ORDINANCE** — Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel: Feet Washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers.

14. **TITHING** — God commanded tithes and offerings in the Old Testament: Jesus Christ endorsed it in the Gospel (Matt. 23:23) and the Apostle Paul said, "Upon the first day of the week let every one of you lay by him in store as God hath prospered him." I Cor. 16:2.

15. **THE CHRISTIAN SABBATH** — The divine law requires that one day in seven be set apart from secular employment and amusements for rest, worship, holy works and activities, and for personal communion with God.

16. **RESURRECTION, JUDGMENT AND FINAL RETRIBUTION** — The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation: then the wicked shall "go-away into eternal punishment but the righteous into eternal life."

RULES OF ORDER

1. At every sitting of the Association, business shall be opened and concluded by prayer by the Moderator or whomsoever he may request.

2. Ministers and deacons present are invited to seats, allowed to take part in debates on all subjects, and to vote.

3. Those who speak shall rise and address the Moderator. Personal reflections shall be avoided in all debates.

4. No motion may be discussed until made and seconded.

5. When a motion has been made and seconded, and a member opposes its discussion, the Moderator shall put the question, "Shall it be discussed?" If negative, the question shall not be discussed.

6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member, and the vote taken separately.

7. Motions made and lost shall not be recorded.

8. No one shall speak more than twice on the same subject without special leave of the Moderator.

9. All questions shall be decided by a majority vote of all Members present.

BY LAWS OF STATE ASSOCIATION

1. The clerk or assistant clerk, or in their absence, the senior minister in years shall call the Association into conference, and if a quorum is present the moderator, or in his absence, the assistant moderator shall take charge; and if neither of them is present the senior ministers in years shall act as Moderator.

2. It shall be the duty of the clerk to enroll the delegates to the Association, who shall present themselves with proper evidence of their rights to seats therein, and those enrolled by the clerk shall compose the Association.

3. It shall be the duty of every District belonging to this Association to send a letter to every annual session of this Association, reporting in the same, spiritual condition, benevolent work, and its statistics. Any District belonging to this Association, which shall fail to report itself for two successive session, may be dismissed from the Association by a two thirds vote of all members present.

4. Each meeting shall be opened by reading a portion of the Bible and with prayer, and shall be closed with prayer.

5. By a two-thirds vote of all members present, a ruling of the moderator can be overruled.

6. This Association may correspond by messenger or otherwise with other religious bodies.

7. This Association shall sit with open doors except when it shall go into a committee of the whole.

8. Any person not a member of this Association may be allowed to take part in its discussions by obtaining permission from the moderator.

9. It shall be the duty of all the Association to be present at the time appointed for each meeting, and anyone wishing to retire shall

first obtain leave of the moderator.

10. No person shall be allowed to nominate more than one member of any committee, provided the person nominated be elected.

11. The moderator shall not allow discussions when not carried on in a Christian spirit or when he thinks it will cause discord or division.

12. Anyone desiring to speak shall rise to his feet and address the moderator by the appellation, "Brother Moderator," but shall not speak further until recognized by the moderator.

13. No member of this association shall be allowed to speak more than ten minutes nor twice on the same subject without permission from the moderator.

14. These By-Laws may be altered or amended at any regular or adjourned session of this Association by a two-thirds vote of the members present.

CONSTITUTION OF STATE ASSOCIATION

PERAMBLE: From long experience, we the members of the Free Will Baptist denominations, being regularly baptised upon a profession of our faith in Jesus Christ, and realizing the necessity of a bond of union and fellowship among us as a church; and to preserve and maintain correspondence and co-ordination with us, do therefore ordain this Constitution for our better denominational government.

Article I

Name: This organization shall be known as the OKLAHOMA STATE ASSOCIATION OF FREE WILL BAPTIST.

Article II

PURPOSE: the object and purpose of this organization shall be to unify the work of the various bodies composing this State Association, and to devise and execute measures for the extension of the Kingdom of God in connection with the various bodies in the Association, or that may hereafter be represented therein.

Article III

REPRESENTATION: Section 1: This Association shall be composed of all ordained ministers and deacons with membership in some local church which is a member of a district Association with membership in the State Association.

Section 2: Each District Association shall be entitled to a number of elected delegates equal with the number of churches composing said Association. These delegates may be recommended by the local churches and shall be endorsed by their district association. Five delegates

from the League, Women's Auxiliary, and Master's Men.

Article IV

FINANCE: Each elected delegate shall be represented with a fee of Five dollars.

The Twenty-first Semi-annual Oklahoma State Free Will Baptist Ministers Conference was called to order at 9:30 A. M., Tuesday the 14th day of October, 1964, at the First Free Will Baptist Church of McAlester, Oklahoma, by the president, Delbert Akin.

Brother Jack Richey led in congregational singing, and Brother Floyd Vulgamore brought the morning devotion from Col. 3:1-4.

Visiting ministers were recognized and invited to sit with us. The minutes of the previous meeting were read and approved. A letter from the Superannuation Board was read and received. Motion and second passed to lay the letter on the table until the afternoon business session.

Brother Homer Willis, Director of National Home Missions, gave a challenging report on the nation wide church membership. Less than 50% of American population belong to all churches.

Brother Roger Reeds, National Sunday School Board, outlined the duty of the Sunday School, reading Acts 5:42.

Conference was called to order, after a short recess. Brother Homer Young directed congregational singing, and the State Ministers Quartet sang, "Lovest Thou Me."

Brother Billy Melvin, National Executive Secretary, brought the morning message from Gal. 6:17, theme: The Marks of Christ.

Lunch

Brother Lynn Wood led congregation in song. Followed by the afternoon devotion by Brother Le Roy Corbit, president of State Masters Men.

Brother Sam Johnson, Director of the National Church Training Service, presented the new CTS material and explained the long range program of the CTS material and its desired effect upon the local church.

Brother Rufus Coffey of the National and Foreign Missions brought greetings from the missionaries and shared the burdens and joy of his heart with us.

Brother Paul Kettelman, Public Relations Director for the Free Will Baptist Bible College, Nashville, Tenn., informed us of the purpose, intent, need and condition, of the college. His theme: "The Trained to Train Others to Train Others."

The Business session was declared in order by Brother Delbert

Akin, president.

Motion made, second and carried to adopt the recommendations of the Superannuation Board item by item. Items 1, 2 and 3 were adopted as follows:

1. That all ministers belonging to the insurance group be required to be a member of the State Ministers Conference, and that their dues be set at \$1.00 (one dollar) annually.
2. That all ministers belonging to the insurance plan who are a member of another State Association other than Oklahoma be listed as Honorary members of the Oklahoma State Ministers Conference, and their dues be set at \$1.00 (one dollar) per year.
3. That all ministers past the age of 65 years and are holding down a full time job, or pastoring a church be required to pay their half of their Insurance premium. And that all dues be in the hands of the treasurer by the 15th day of April of each year.

Motion made, second and carried that Article I of the Constitution be amended by addition of the words, Who have paid their one dollar dues.

Motion made, second and carried to grant a \$50.00 (fifty dollar) scholarship to a student of Oklahoma Bible College. Student to be selected by the faculty.

Next conference to be at the First Free Will Baptist Church of Duncan, Oklahoma, Tuesday, May 11, 1965.

Article V

DISCIPLINE: This State Association shall have the right to settle any question of discipline, doctrine or practices that may properly come before it from any of the bodies composing said organization, furthermore if there be any question of discipline, doctrine or practices on the part of a subordinate association, delegates of that association shall not be seated until these questions have been settled to the satisfaction of the Credential Committee.

Section 2: Decisions of the Credential Committee may be appealed.

All appeals coming before the State Association when sitting in a Committee as a whole. (2) by a Special committee whose report shall be voted on without discussion.

Article VI

OFFICERS: The officers of the State Association shall consist of a Moderator, Assistant Moderator, Clerk and Assistant Clerk, Parliamentarian, and an Executive Secretary, each of whom shall be elected at the close of each regular session, except the Executive Secretary, who shall be elected every two years.

Section 2: Committees, as necessary, shall be appointed by the moderator, unless otherwise provided for, and shall hold office until their work is completed, or until their successors are elected.

Article VII

BOARDS: All standing boards shall be composed of seven members who shall serve terms of 7, 6, 5, 4, 3, 2, and 1 years. The general board shall be composed of one member from each subordinate association, chairman of each standing board, and the state officers. The standing boards shall include the Executive Board, the Church Extension and Mission Board, College Board of Trustees, Superannuation Board, Sunday School Board, and Church Training Service Board. Each board shall elect a chairman and clerk-treasurer to act for one year and to be elected at the close of each annual state association. The Co-ordinating Board shall be composed of the executive secretary and the chairman from each standing board.

Article VIII

DUTIES AND RULES OF STANDING BOARDS: The Executive Board is elected at the discretion of the State Association of Free Will Baptists and shall act in behalf of the association when not in session, and shall have power and authority to elect such officers as might be deemed best for its own government and to carry out the plans and undertakings of the state association. To this Executive Board is further delegated power to collect funds and report and superintend such work for the field as may seem best and the means on hand may warrant, exclusive of College Board of Trustees.

This Executive Board shall keep a record of all work done, money raised, meetings held, and make a full and complete report to the regular meeting of the association and shall further receive and convey any property entrusted to said state association. **They shall not have the power to purchase or sell any real estate property without the voice of the association.**

The chairman and the secretary of said Executive Board shall sign

all deeds, bonds, and notes, etc., and any other papers by which the State Association is to become legally responsible, exclusive of College Board of Trustees.

The board shall have the power to call the association in conference by notifying each Subordinating Association at least ten (10) days prior to conference.

(2) GENERAL BOARD: It shall be the duty of this board to meet with the Executive Board one day preceeding the State Association to hear reports of the standing boards and to make recommendations to the State Association. They shall also serve as Credential Committee.

(3) CHURCH EXTENSION AND MISSION BOARD: It shall be the duty of this board to work to promote an active missionary program in and for the State of Oklahoma.

It will also be their responsibility to investigate and assist, if necessary, any new church and, or, a church that cannot maintain itself. This board should thoroughly investigate the ability of a church to support an organization before assistance is pledged.

(4) COLLEGE BOARD OF TRUSTEES: It shall be the duty of this board to supervise and promote Oklahoma Bible College and the function of this board shall be governed by the charter as adopted by the State Association of Free Will Baptists, which shall be presented at this the 1964 session.

(5) CHURCH TRAINING SERVICE BOARD: It shall be the duty of this board to plan and assist in every way possible the C.T.S. work throughout the state. It will also be their responsibility to promote an active C.T.S. work in each Subordinate Association and to encourage C.T.S. institutes. It shall also be the duty of this board to plan and direct a State Youth Camp or Camps.

(6) SUNDAY SCHCOL BOARD: Their duties shall include the planning and operation of the State Sunday School Conventions, Institutes, and the encouragement of the organization of district conventions. They may carry through plans they think wise to actively promote Sunday School work in the state, and the publishing of literature deemed advisable by the State Association of Free Will Baptists.

(7) SUPERANNUATION BOARD: This board working in cooperation with the National Superannuation Board and district boards, shall provide a definite program of superannuation for ministers.

(8) CO-ORDINATION BOARD: This board shall be charged with the responsibility of co-ordination the work of the standing boards, and shall also act as Budget Committee. The Executive Secretary shall serve as chairman and the board shall meet at his discretion.

[9] **FILLING OF VACANCIES:** All boards shall have power to fill vacancies that may arise between sessions of the association. Such appointment valid only until next session of association.

[10] **Working agreement between the state association and the Executive Secretary of the State Association:** That the Executive Secretary be paid a set salary and mileage and a two week paid vacation and all money received by him for speaking engagements, revivals and etc. shall be turned in by him to the Executive Office for the support of this office. He shall be ex-officio member of all standing boards.

Article IX

This constitution may be amended or altered at any regular session of the State Association by a two-thirds vote of members present, provided proposed amendment or alteration be presented in writing to the body one day in advance.

Article X

Elected delegates to State Association shall be retained as standing delegates for special called meetings.

STATE SUNDAY SCHOOL BOARD REPORT

The State Board has purchased a film strip projector and a fine catalog of film strips. They have proved a great aid in the teaching of our institutes.

We feel that the State sponsored Sunday School contest was a great success. The award going to the Cincinnati Church in Tulsa. We plan to have another contest this coming year in March with divisions in the size of Sunday Schools as follows:

- 0 - 85 Class A
- 86 - 175 Class B
- 176 - up Class C

We hope that each Sunday School in our state will enter in this contest.

We still have plenty of the books written by Rev. E. E. Morris, "Message of the Cross". Get them from the bookstore or from any member of the Board.

We are asking to be included in the Coop plan this year. We are asking for 1%. We desire your prayers and cooperation for this coming year.

MISSION BOARD REPORT

The State Mission Board has met twelve times in the past year and traveled a total of 7,602 miles.

Two new churches have been organized. These were in the cities of Tahlequah and Marietta.

Tahlequah Church was organized on November 8, 1963 with 17 charter members. Rev. James Murray, chairman of the Board, conducted the organizational revival. Three souls were saved in the meeting and united with the church. The work was promoted and organized jointly by the South Grand River Association and the State Mission Board. Rev. Gerald Chester was employed in June of 1963 as the Mission worker and was elected as first pastor serving until May, 1964. The church has recently voted to purchase one half acre of property in a good location in the town. The New Church Club funds received by the Board, for Tahlequah, totaled \$600.00 and has been sent to the church to help purchase the new property.

The Marietta Church was organized on November 13, 1963 with eight charter members. The Hopewell No. 2 Association co-sponsored this organization. Rev. Jerry Rhoades, of Ardmore, conducted the organizational revival. Funds totaling \$580.00, from the New Church Club, were paid to Marietta in May, 1964 to be used in construction of a church building.

A trip was made to Hugo, by the Board, in July to investigate possibilities of starting a mission there. Since that time reports have

been received of two new families moving into this area and has increased possibilities of starting a work soon. Hugo is a town about 8,000 population, is in the Southeastern section of the State.

The Board hopes to continue to promote new organizations through joint efforts with local associations. Such effort has been suggested in connection with churches in Woodward, Edmond, Guthrie, Midwest City, Skiatook, Atoka and Coalgate.

In February the Board voted to support a full time worker in Ponca City in cooperation with the First Mission Association. This is an effort to put the church organized there in February, 1963 on a more solid foundation. Rev. E. B. Condit moved to Ponca City in August and is now working there with the church in this effort. Continuation of the support is on an indefinite basis.

The Durant Church, which was organized in 1960 by the Board, voted in February to disband as an organized church and come back under the direction of the Board as a Mission. Rev. Noah H. Smith was employed in May to direct the work and has since continued to serve there. The Church wasn't able to continue as an organization and it was considered best that the Board would take charge to protect the interest of the State Association as well as further attempt to bring the group to a self supporting basis. The group is very small in number, but is engaged in regular services each week. Services are held at 12th and Arkansas streets. The property was purchased in 1960 with money received from the New Church Club funds.

The funds received for the New Church Club have decreased the past year, however, more than \$1,100.00 was received and paid to churches at Tahlequah and Marietta. A motion was adopted in August to revise the New Church Club program. Under the revised plan a permanent fund will be established by the Board and all members will contribute \$10.00 per calendar year, as in the past, but will give it at the time of joining or at any time in the year the member chooses to do. The money will not be designated to any particular church organization but will go into the permanent fund. The fund will continue to be used to aid newly organized churches which are sponsored by the State Board. The amount of aid given to any church will depend upon the need presented and shall be decided by the Board. The money will only be available for purchase of land or property for church buildings.

The Sparks Vehicle Project was successfully completed and funds were used to purchase a Chevy II station wagon which the Sparks family took to Africa in November, 1963.

The State of Oklahoma again over subscribed its mission quotas

to Foreign and National Home Missions in 1963 by large amounts. Foreign Missions giving was \$30,312.84 and National Home Missions received \$15,127.14 making a grand total of \$45,439.98. The combined quotas for the year of 1963 were \$24,500.00. Quotas for 1964 are \$37,500.00 (Foreign Missions \$25,000.00 and National Home Missions \$12,500.00). Gifts so far in 1964 are substantially ahead of subscribed quotas. The quotas for 1965 total \$65,000.00, with Foreign Missions at \$45,000.00 and National Home Missions at \$20,000.00. The increase in giving continues as interest increases in missionary itinerants and conferences. Local churches and associations all over the State are sponsoring annual conferences and allowing more itinerant work. The Board expresses its appreciation to these churches and associations as well as to the National departments for Foreign and Home Missions which give valuable assistance in this field. Missionary itinerant services have been arranged the past year for Ken Eagleton, Archie Mayhew, Jim Combs, Bill Phipps, Herbert Waid, Dan Cronk, Earnie Deeds, Kirby Jo Godwin, Wade Jernigan, Lewis Perry and Roger Harwell.

CHARTER of OKLAHOMA BIBLE COLLEGE

ARTICLE I

NAME

Be it known that; Wade Jernigan, Paul Inbody, J. B. Fletcher, Walter Mantooth, Bob Followwill, Howard Gwartney, and Charles Hinesley and their successors chosen under the provision and terms of this charter, are hereby constituted a body politic by the name of Oklahoma Bible College, which shall be governed and controlled by the State Association of Free Will Baptists of Oklahoma.

ARTICLE II

PURPOSE

The purpose of this Body Politic is the establishment and maintenance of a college devoted to the promotion and impartation of higher christian education and such other education, instruction, and training as may be deemed essential; for the cause of Christ and to that end prescribe courses of study, charge and collect tuition; employ professors, instructors, and other subordinate employees as may be necessary for the proper conduct of the institution; to conduct courses of training for both resident and correspondence students; to institute and carry on missions and commissions for missionary purposes or investigations; to publish and distribute such pamphlets, literature, or books as may be required in the conduct of such work and the general promotion of the Bible College; to solicit support, receive, collect, hold, and apply all properties-real, personal, or mixed-acquired by gift, bequest, purchase, devise, or otherwise, for the purposes of the College; and to purchase, construct, rent and equip such buildings as may be required for the accommodation, work, and welfare of the institution in all of its departments.

ARTICLE III

DOCTRINAL POSITION

As this institution is fostered by and controlled of the Oklahoma State Association of Free Will Baptists the theological position of Oklahoma Bible College shall be that of the state body, as the state endorses the Treaties of the National Association of Free Will Baptists so shall Oklahoma Bible College's theological position be.

ARTICLE IV

BOARD OF TRUSTEES

The persons named in this charter shall be members and constitute the present named Board of Trustees, of Oklahoma Bible College and shall hold office until their elected terms expire or removal from office and their successors have been chosen by the Oklahoma State Association of Free Will Baptists.

SECTION A. NAME The governing board of Oklahoma Bible College shall be designated as the Board of Trustees.

SECTION B. MEMBERSHIP: Election to office by the State Association when convened shall constitute membership. The tenure of office on the Board of Trustees shall be governed by the following items:

ITEM ONE: Officers:

The said members of the Board of Trustees shall have power to elect a slate of officers to regulate its actions in affairs of business, said officers to consist of Chairman, Vice-chairman and Secretary, said officers shall also serve as an Executive Committee to expedite the extra matters of business.

ITEM TWO: ELECTION:

The members of the Board of Trustees shall be elected to terms of 7, years 6, 5, 4, 3, 2, and 1 respectively, said elected to take place during the annual association of Oklahoma Free Will Baptists.

ITEM THREE: REPLACEMENT:

The Board of Trustees shall have authority to replace vacancies that may occur ad interim among its members by resignation and death. The terms of office of such members, however, shall be considered temporary, and they shall continue only until the first session of the Oklahoma State Association following their election.

ITEM FOUR: REMOVAL:

The Oklahoma State Association shall have the power and right to remove from office at will any and all trustees of the Oklahoma Bible College for any cause, reason, or condition deemed valid or expedient to the interests, purposes, and progress of the said Bible College, and to elect successors to those who may thus be removed from office.

ITEM FIVE: QUALIFICATIONS:

Each trustee shall be a resident member of a regular Free Will Baptist Church that is in good standing with the Oklahoma State Association.

SECTION C. COMMITTEE'S: This charter shall give power to and through its board of trustees to make all by-laws necessary for the creation of an executive committee and the determination of the powers to be exercised by such executive committee when the Board of Trustees is not in session; to prescribe also in said by-laws for the creation of all other committees, officers, or agents deemed essential or expedient to the administration of th College and the management of its corporate affairs; determine the powers, duties, and functions of such committees, officers, or agent; fix their terms of office and the method of their election or appointment.

SECTION D. ELECTIONS: In all elections held by the Board of Trus-

tees each member shall be entitled to one vote, either in person or by proxy, and the result shall be determined by a majority of the votes cast. Due notice of any election must be personal notice to the members, or a day stated on the minutes of the Board not less than one week preceding the election.

SECTION E. RECORDS: The Board of Trustees shall keep record of all its preceedings, which shall be at all time subject to the inspection of any member of the Board.

SECTION F. EX-OFFICIO MEMBERS: Due to their position and office president of Oklahoma Bible College and the Executive Secretary of the State Association FWB of Oklahoma compose the ex-officio membership of the Board of Trustees. When setting with open doors other persons may be invited to set in session as deemed advisable by the Board of Trustees.

SECTION G. AMENDMENTS: The Board of Trustees shall have power to alter at will, revise or amend the by-laws of Oklahoma Bible College provided that the proposed alteration, revision, or amendment shall not be contrary to the terms and conditions of this charter, the constitution, rules and regulations of the Oklahoma State Association.

ARTICLE V POWERS

SECTION A. GENERAL: The general powers of this Body Politic shall be to contract and be contracted with; to grant degrees and other literary honors as are usually conferred by like institutions, including the conference of graduate, post-graduate, and honorary degrees.

This Body Politic shall have power also to purchase and hold and receive by gift or bequest, personal property in any amount, real estate in any amount, money, or other things of value; held, or received by this Body Politic, it may purchase and hold all real estate that may be given, devised, or bequeathed to the group—the same to be held and used for carrying on the purposes of the College; to purchase or accept real estate in payment of any debt due the college, and sell the same; to borrow money to be used in payment for property bought by the group, for erecting buildings and making improvements, and for any other purposes germane to the objects of the college; and to secure by mortgage, pledge, or deed of trust upon the property and funds owned by it, the repayment of money borrowed; to accept, hold and manage, as trustee, any property, money, of effects bequeathed or devised

to it for any special purpose germane to the objects of the Body Politic, said business not to occur without the approval of the Oklahoma Association of F.W.B.

SECTION B. GENERAL BUSINESS: Power is hereby granted through the Board of Trustees to the Administration officers to carry out the duty recognized business affairs of the College. Said Administration shall operate within its annual budget approved by the Board of Trustees and the State Association. All business functions of the college shall be in accordance with good business ethics.

ARTICLE VI ORGANIZATION

The college known as Oklahoma Bible College shall be structured in such a manner to carry out the philosophy of education endorsed by the sponsoring body. Said school shall contain a Jr. College Division and a Bible College Division. Specifically stated such educational content shall provide for General Education in the Arts, Christian Ministries for Service, and Biblical studies for wisdom.

ARTICLE VII DEGREES

The degrees awarded shall be in accordance with sound educational practices upon completion of an academic program. Oklahoma laws of higher education shall be considered for validity of program.

ARTICLE VIII ASSETS AND INCOME

The means, assets, income, or other property of the Body Politic shall not be employed, directly or indirectly, for any other purpose whatever than to accomplish the legitimate objects of its creation, any by no implication shall it engage in any kind of trade operation, or hold any more real estate than is necessary for its legitimate purposes.

OKLAHOMA BIBLE COLLEGE

By-Laws

Section I

The Board of Trustees

The Board of Trustees of Oklahoma Bible College shall be composed of seven members, as provided in the charter of the College:

ARTICLE A. OFFICERS: The officers of the Board of Trustees shall be a Chairman, an Assistant Chairman, and a Secretary, each of whom shall be elected by the Board for a term of one year. They shall continue in office until their successors have been chosen.

An Executive Committee, composed of three members, shall be

elected annually by the Board of Trustees.

ITEM ONE CHAIRMAN:

The Chairman of the Board of Trustees or his assistant shall preside at all meetings of the Board. The Chairman shall sign, or execute, all deed, conveyances, and other legal papers involving the Board's authority, unless otherwise provided for by the Board.

ITEM TWO SECRETARY:

The Secretary shall record and preserve minutes of all meetings and acts of the Board of Trustees and counter-sign all deeds, conveyances, and other papers authorized by the Board.

He shall have authority to call special meetings of the Trustees of the College upon the written request of two-thirds of the members of the Board; he shall mail notice of said meeting to the trustees ten (10) days in advance.

ITEM THREE EXECUTIVE COMMITTEE:

The Executive Committee shall have authority to consider and act upon all questions affecting the interests of the Bible College which may be brought before it between the stated meetings of the Board, or whenever it is deemed impractical to convene the entire Board, or a quorum of the Board fails to attend a called or regular meeting. It shall transact such business as may be committed to it by the Board and shall act as an advisory council to the President of the College on such matters as he may submit to it. The Committee shall meet at the call of the Chairman or the President of the College.

ARTICLE B MEETINGS: The Board of Trustees shall meet each year at a time and place agreed upon by the Board. It shall, also, hold special meetings whenever called in accordance with the By-Laws of the Board.

ARTICLE C. QUORUM: A majority of the qualified members of the Board of Trustees of Oklahoma Bible College in attendance at any called or regular meeting, written notice of which has been mailed by the Secretary to each trustee, shall constitute a quorum. Proxy representation shall be restricted to a minority of the trustees.

ARTICLE D. ELECTIONS: In all elections held by the Board of Trustees each member shall be entitled to one vote, either in person or by proxy, and the result shall be determined by a majority of the votes cast. Due notice of any election must be personal notice to the members, or a day started on the minutes of the Board not less than one week preceding the election.

SECTION II

OFFICERS of the BIBLE COLLEGE

The officers of Oklahoma Bible College shall be a President, Vice-President, Dean, and a Business Manager, each of whom shall be elected by the Board of Trustees to hold office for two years, exclusive of the President whose term of office shall be indefinite. It is provided, however, that retirement of anyone of the officers herein named may occur at any time upon the resignation of the officer or the request of the Board. In either case, notice shall be given six weeks before the date of the proposed retirement unless otherwise agreed upon by the concerned parties.

ITEM ONE PRESIDENT:

The President shall be executive officer of the Board of Trustees and shall have general control of the College including its officers, teachers, students, and business. He shall render to the Board complete annual reports and to its Chairman, Executive Committee or other committees such information as may be deemed essential to a thorough knowledge of the operation of the College and its promotion. He shall be a member of the Board of Trustees ex-officio and shall have all the rights and privileges of a member of the Board exclusive of voting. Duties of the president and working relationship shall be further detailed in a format approved by the Board of Trustees.

ITEM TWO VICE PRESIDENT:

The Vice-President shall perform all the duties of the President in the absence of the latter.

ITEM THREE DEAN:

The Academic Dean of the Bible College shall, under the President, fix the hours of recitation, govern, control, and regulate the conduct of the student, have general oversight of curriculum, students records, and such other internal details and administrative duties as may be delegated to him by the president of the College.

ITEM FOUR BUSINESS MANAGER:

The Treasurer shall keep an accurate record of all accounts of the College and shall receive and expend, as directed by the Board of Trustees and the President, all money for the expenses of the institution. He shall make an annual report to the Board and furnish the Chairman of the Executive Committee with such information pertaining to his office as may be requested. He shall provide bond in whatever amount the Board may require.

Until such time as the Board of Trustees may deem different the Treasurer's office shall be contained within the Business Managers Office. The Business Manager may at the direction of the administration designate this duty to a subordinate officer. The Business Manager shall have general supervision of the financial business of the College, and shall, at the direction of the President, be responsible for the upkeep of all the physical facilities and premises of the College. His detailed duties are directed in a format approved by the Board of Trustees.

SECTION III FACULTY

The faculty shall consist of the President, the Dean, and all teachers of Oklahoma Bible College. Instructors and assistant teachers shall have the privilege of sitting with the faculty in stated meetings but shall not have the right of voting.

It shall be the policy of Oklahoma Bible College to employ on its faculty those who are members of Free Will Baptist churches that are affiliated with the National Association. Emergencies, however, arising from the resignation, illness, death, or approved leaves of absence of faculty members may be relieved by the temporary employment of instructors who are affiliated with any evangelical denomination. Part-time or short-term instructors, deemed essential to the successful prosecution of a consistent educational program, may be employed at the discretion of the President and the Board of Trustees without respect of denominational affiliation.

The faculty, under the authority and jurisdiction of the President, shall have general charge of instruction, attendance of students, examinations, administration of curriculum, discipline, and all matters involving the spiritual, physical, and social welfare of the Bible College. The Board of Trustees, however, shall have full and final authority over all faculty members when the interests of the College may require. The faculty shall be hired upon recommendation of the president.

In the selection of the faculty qualitative factors shall be kept in mind. All faculty members shall be urged to pursue graduate programs in their respective fields. Except in special cases no faculty member will be required to teach courses outside of his field.

ACADEMIC COUNCIL SECTION IV

The Academic Council shall consist of the President, the Dean and the heads of the departments of Oklahoma Bible College. It shall determine the curriculum and academic policy of the College, prescribe require-

ments for admission, certificates, diplomas, and degrees, and supervise the courses of instruction offered by the various departments of the College.

SECTION V CONTRACTS

The Board of Trustees shall have full and final authority in all obligations involving the execution of contracts, deeds of conveyance, the determination of salaries, and the employment of all officers, representatives, faculty members, and essential domestic and maintenance employees. It is provided, however, that the Executive Committee or the President of the College may be directed, the option of the Board of Trustees, to negotiate agreements, execute contracts, employ representatives, and supply vacancies incurred by the termination of contracts, resignations, or death of any essential employees.

SECTION VI ADVISORY COUNCIL

An advisory council shall be formed which is to be composed of interested, qualified persons in the various fields which will be of value in building and maintaining a strong academic program to carry out the educational program stated in the charter.

SECTION VII AMENDMENT

These By-Laws may be amended by a favorable vote of two-thirds of the qualified members of the Board of Trustees of the Oklahoma Bible College at any meeting of the Board, provided that the proposed amendment has been submitted in writing to each Trustee one month in advance. This change to be subject to the Oklahoma State Association of Free Will Baptists.

ARTICLE VIII ADMINISTRATIVE FUNCTIONS

The president of the Oklahoma Bible College shall be elected by the Board of Trustees, and he shall act for and on behalf of the Board in the conduct and management of the institution. He shall also be a member of the Board of Trustees ex officio, and his duties, powers, and term of office shall be prescribed in the by-laws of the College and a format approved by the Board of Trustees.

ARTICLE IX AMENDMENTS

This charter may be here after amended subject to the provisions contained herein and the laws of the State of Oklahoma. It is provided, however, that the trustees of the Bible College shall not purpose or

apply for any amendment which has not been previously authorized by an act of the Oklahoma State Association.

THE COORDLINATING BOARD REPORT

The Coordinating Board met at the Headquarters building on September 8, 1964. Members present were Clarence Shepherd, James Murray, Ernest Harrison, Berton Perry and N. R. Smith.

Motion was made, seconded and carried to seat Bro. Joe Payne for the Superannuation Board and Bro. Don Payne for the College Board of Trustees.

1. We recommend the subscription price of the PROMOTER be raised and improve the quality of the paper. We recommend the following rates; Individual subscriptions \$2.00 per year; 12 copies \$1.75 per month; 25 copies \$3.50 per month; 37 copies \$5.00 per month; 50 copies \$6.50 per month. These rates to be effective January 1, 1965.
2. We recommend that each Board discuss means to improve the PROMOTER and each Board Chairman bring this to the October 23, 1964 meeting.
3. We recommend that the Cooperative Budget be disbursed with the following per cents:

SUPERANNUATION BOARD REPORT

The Board held several meetings and visited most of the Associations in the State. We feel that great progress has been made by our

insurance plan for our ministers. We had 70 ministers insured June 30, 1963. Since that time our membership has grown to 128 members. Rev. C. C. Cain one of our members and a member of the Board departed this life April 25, 1964. Eleven of these ministers have reached the age of 65 or older.

The ministers insurance program for Oklahoma Free Will Baptist Ministers was first started in 1960 as an auxiliary to the State Ministers Conference. We were required to have at least 75% of our total enrollment insured in order to qualify with the insurance program offered by New York Life Insurance Co. However, at the present time our plan has 128 members of which 7 members have passed the age of 70 and 5 more have passed 65. While the State Ministers Conference has only 60 members. We feel that this problem should be met with a workable solution. Therefore, we are offering the following recommendations.

1. That all Ministers belonging to the Insurance Group be required to be a member of the State Ministers Conference and that their dues be set at \$1.00 annually.
2. That all Ministers belonging to the insurance plan who are a member of an Association in another State Association other than Oklahoma be listed as Honorary members of the Oklahoma State Ministers Conference and their annual dues be set at \$1.00
3. That all Ministers past the age of 65 years and are holding down a full time job or pastoring a church be required to pay their half of their insurance premiums and that all dues be in the hands of the treasurer by April 15th of each year.
4. We recommend that our allocation from the Coop Program be set at 5% for the coming year.
5. We recommend that our budget be set at \$3,500.00 and that \$12.00 for each member of the plan belonging to the State Association and \$24.00 for each auxiliary member be paid by the membership of the plan.

EXECUTIVE SECRETARY REPORT

Report of the Executive Secretary to the Fifty-Sixth Annual Session of the Oklahoma State Association when convened at McAlester, Oklahoma.

As we end another year, we are thankful that our giving is up over the previous year. REPORT OF SPECIAL COMMITTEE CONCERNING DUTIES OF STANDING BOARDS

Purpose for committee is as is found in 1963 State Minutes Page 10. Chairman, Bro. Harry Stairs and secretary, Bro. Lonnie E. DaVoult.

The committee met September 22nd at 10:00 A.M. at the Capitol Hill Free Will Baptist Church to formulate the report to this state association. All members were present and the duty of each board was designated to different members. We correlated our findings and submit the following recommendations and changes.

(1) Motion and second that all standing boards be composed of seven members.

(2) Motion and second to change the name of the Free Will Baptist League to Church Training Service in order that we might be in harmony with the National Association, and that the name of the State Mission Board be changed to Church Extension and Mission Board.

(3) Each board shall be composed of a chairman, clerk or treasurer, and any other office that the particular board shall so deem necessary. These offices shall be elected annually at the close of each state association.

CHANGES TO BE MADE IN THE CONSTITUTION:

ARTICLE VII

BOARDS: All standing boards shall be composed of seven members who shall serve terms of 7, 6, 5, 4, 3, 2, 1 years. The general board shall be composed of one member from each subordinate association, chairman of each standing board, and the state officers. The standing boards shall include the Executive Board, the Church Extension and Mission Board, College Board of Trustees, Superannuation Board, Sunday School Board, and Church Training Service Board. Each board shall elect a chairman and clerk-treasurer to act for one year and to be elected at the close of each annual state association. The Coordinating Board shall be composed of the executive secretary and the chairman from each standing board.

ARTICLE VIII

DUTIES AND RULES OF STANDING BOARDS: The Executive Board is elected at the discretion of the State Association of Free Will Baptists and shall act in behalf of the association when not in session, and shall have power and authority to elect such officers as might be deemed best for its own government and to carry out the plans and undertakings of the state association. To this Executive Board is further delegated power to collect funds and report and superintend such work for the field as may seem best and the means on hand may warrant. Exclusive of the College Board of Trustees.

This Executive Board shall keep a record of all work done, money raised, meetings held, and make a full and complete report to the regular meeting of the association and shall further receive and convey any property entrusted to said state association. They shall not have the power to purchase or sell any real estate property without the voice of the association.

The chairman and the secretary of said Executive Board shall sign all deeds, bonds, and notes, etc., and any other papers by which the State Association is to become legally responsible, exclusive of the College Board of Trustees.

The board shall have the power to call the association in conference by notifying each Subordinating Association at least ten (10) days prior to conference.

(2) **GENERAL BOARD:** It shall be the duty of this board to meet with the Executive Board one day preceeding the State Association to hear reports of the standing boards and to make recommendations to the State Association. They shall also serve as Credential Committee.

(3) **CHURCH EXTENSION AND MISSION BOARD:** It shall be the duty of this board to work in connection with the National Foreign and Home Mission Boards and to promote an active missionary program in and for the State of Oklahoma.

It will also be their responsibility to investigate and assist, if necessary, any new church and, or, a church that cannot maintain itself. This board should thoroughly investigate the ability of a church to support an organization before assistance is pledged.

(4) **COLLEGE BOARD OF TRUSTEES:** It shall be the duty of this board to supervise and promote Oklahoma Bible College and the function of this board shall be governed by the charter as adopted by the State Association of Free Will Baptists, which shall be presented at this the 1964 session.

(5) **CHURCH TRAINING SERVICE BOARD:** It shall be the duty of this board to plan and assist in every way possible the C. T. S. work throughout the state. It will also be their responsibility to promote an active C. T. S. work in each Subordinate Association and to encourage C. T. S. institutes. It shall also be the duty of this board to plan and direct a State Youth Camp or Camps.

(6) **SUNDAY SCHOOL BOARD:** Their duties shall include the planning and operation of the State Sunday School Conventions, Institutes, and the encouragement of the organization of district conventions. They may carry through plans they think wise to actively promote Sunday School work in the state, and the publishing of literature deemed advisable by the State Association of Free Will Baptists.

(7) **SUPERANNAUTION BOARD:** This board working in cooperation with the National Superannuation Board and district boards, shall provide a definite program of superannuation for ministers.

(8) **CO-ORDINATION BOARD:** This board shall be charged with the responsibility of co-ordination the work of the standing boards, and shall also act as Budget Committee. The Executive Secretary shall serve as chairman and the board shall meet at his discretion.

(9) **FILLING OF VACANCIES:** All boards shall have power to fill vacancies that may arise between sessions of the association. Such appointment valid only until next session of association.

(10) **Working agreement between the state association and the Executive Secretary of the State Association:** That the Executive Secretary be paid a set salary and mileage and a two week paid vacation and all money received by him for speaking engagements, revivals and etc. shall be turned in by him to the Executive Office for the support of this office. He shall be ex-officio member of all standing boards.

TEMPERANCE COMMITTEE

We your committee on temperance wish to present the following report:

No. 1 The temperance use of all things good and total abstinence from all things harmful according to the scripture in Matt. 5-16 to let your lights so shine before men that they might see our good works and glorify our Father which is in Heaven.

No. 2. That our churches cooperate with the Sooner Alcoholic and Narcotic Education Inc.

No. 3. In the light of public interest we reaffirm our stand on the total abstinence from the use of alcoholic beverages.

No. 4. That our state body recognize the standard which has been

passed by the National Convention of Free Will Baptist. That we go on record as being opposed to the use of tobacco in any form.

No. 5. That a more modest dress be observed by both men and women.

OBITUARY COMMITTEE

We the obituary committee report 120 deceased from our State Association. We wish to mention two of our co-laborers, Sister Lizzie McAdams, a pioneer in the State work in Oklahoma, and Reverend Clyde Cain, who was faithful in the ministry. We ask this convention to pause for prayer in memory of the Brothers and Sisters who have departed this life during the past year.

PLACEMENT COMMITTEE

We the placement committee wish to thank each request for the 1966 State Association, and after due consideration, we wish to recommend that the State Association meet with the Pryor Free Will Baptist Church in 1966.

RESOLUTIONS COMMITTEE

Resolution No. 1. Be it resolved that the Oklahoma State Association of Free Will Baptist take as a special project a goal of \$1000.00 to help furnish the conference rooms of the National Headquarters building, Nashville, Tenn.

We further recommend that this money be raised through a love offering in each church in the state, and sent in by Jan. 1, 1965.

Resolution No. 2. Be it resolved that when reports are being given they are in the delegation's hands, in printed form, that only the highlights be given.

Resolution No. 3. Be it resolved that no one who is employed full time by the State Association, or any of its agencies be permitted to serve on any of the standing boards of the State Association.

Resolutions No. 4. Be it resolved that the treasures of all standing boards be bonded for at least \$10,000.00.

Resolution No. 5. Be it resolved that the clerk write a letter to the State Legislature, that the State Association of Free Will Baptist stand opposed to parimutuel betting.

Resolution No. 6. As Oklahoma Bible College must liquidate its land indebtedness prior to the launching of its Bible Program, we recommend that Sunday Dec. 6 be set as a date for a statewide effort

in each church to remove this indebtedness, to be known as Operation Liquidation.
