### PROCEEDINGS OF THE STATE ASSOCIATION

The 58th annual session of the Oklahoma State Association of Free Will Baptists convened at Pryor, Oklahoma, October 18-20, 1966. The convention theme was "I Delivered Unto You," taken from I Corinthians 15:3. The Music Director was Mr. Bob Followwill, with Mrs. Bob Followwill as pianist.

"Jesus Saves," was the opening song. Rev. Jerry Dudley led the opening prayer followed by the congregation singing "Amazing Grace," and "Blessed Assurance."

The Association was called into the 58th annual session and the officers introduced by Rev. Waldo Young, Clerk.

Rev. Lonnie DaVoult made recognition of visiting missionaries and representatives of the National Departments. He then delivered the Moderator's Message using Philippians 2:5-9, with the thought of "Let The Mind of Christ be in You."

Rev. Ray Gwartney welcomed the State Association to Pryor, representing the Pryor Church and the South Grand River Association.

Rev. Jerry Rhoades gave the response to the welcome and was in charge of the evening offering. He led the congregation in prayer.

The Messengers Quartet of Tulsa sang two numbers, "The Wonder," and "He's Everything to Me."

Rev. Joe Blair, pastor of the Moore First Church, brought the introductory message. He read from II Timothy 3:16-17, and used for the subject, "I Delivered Unto You the Ministry of the Scripture."

The Benediction was given by Rev. Ray Gwartney

The Wednesday Morning session was called to order by the Moderator. "I Love to Tell the Story," was the opening hymn. Rev. Roma Stewart led in prayer followed by the hymns "Rock of Ages," and "All Hail the Power."

Rev. Fred McCoy brought the devotional, reading Deuteronomy 6:3-5 and 6:1-2, and 12.

The Moderator's admonition was from Philippians 1:12-16, "Do All Things Without Murmuring and Disputing."

The Business session was called to order by the Moderator. A partial report of the General Board was given by the Clerk. Motion sustained to accept the partial report and seat the delegates.

Visitors recognized were: Samuel Johnson from the National C.T.S. Department, Paul Kettelman from the Free Will Baptist College, Rufus Coffey from the Foreign Mission Department, Johnnie Postlewaite, Home Missionary in Portland, Oregon, Gene Whittaker also from Portland, Harvey Aguirre, Missionary appointee to Mexico, John Staggs and Doyle Terry from Wichita, Kansas, Mr. and Mrs. Arthur Billows from Mexico, and Wade Jernigan from Jerome, Idaho.

Rev. Ray Gwartney, host pastor, introduced Mr. Stewart Robertson, Mayor of Pryor, who gave the welcome address.

Motion sustained to adopt the program leaving the time element flexible.

The Moderator announced the appointment of committees as follows: Resolution Committee: Rev. Connie Cariker, Rev. Doyle Cox, Rev. James Murray, Rev. Roma Stewart, and Rev. Bailey Thompson. Obituary Committee; Rev. Kenneth Elledge, Rev. Buddy Biggs, Rev. Arvil Arnold, Rev. Robert Duncan, and Rev. Ralph Hampton. Temperance Committee; Rev. Bill Ketchum, Mr. Marvin Hawkins, Mr. Bob Followwill, Rev. Adrain Condit, and Rev. Casey Adams. Placement Committee; Rev. Eugene Hawkins, Rev. Clarence Shepherd, Rev. Lynn Wood, Rev. Earl Judd, and Rev. Joe Blair.

The rest of the General Board report was read by the Clerk. Motion carried to receive the report and adopt it item by item. Item No. 1 was tabled. Item No. 2 adopted, as amended.

Rev. Wade Jernigan, Field Secretary of the Western States, gave a report for the National Home Mission Department.

Rev. Johnnie Postlewaite gave a report of the work in Portland, Oregon, and the Northwest.

The Business meeting adjourned for the morning.

The Wednesday Morning Worship service opened with the congregation singing "All the Way My Savior Leads Me," and "At The Cross". Rev. John H. West presided. Rev. Clarence Shepherd led in prayer followed by the song, "Praise Him, Praise Him."

The report of the Oklahoma Bible College Harvest Day Offering was given by Rev. West. He reported that 60 churches gave and pledged \$11,388.65 for O.B.C.

Rev. Delbert Akin sang, "He Touched Me."

The message was delivered by Rev. Bob Ketchum, using II Timothy 2:2 and the subject "I Delivered Unto You the Ministry of Education."

The Benediction was by Rev. E. E. Morris.

The afternoon session opened with the song "At the Cross." Rev. Joe Grizzle sang, "I'm Nearer Home." The congregation then sang, "There is a Fountain."

Rev. Wayne Patton brought the devotional on "Obedience." He read Psalm 119: 1-8 and Genesis 22: 1-6. Mrs. Fern Ray then sang, "God did a Wonderful Thing for Me."

The State Sunday School Board report was given by Rev. Joe Haas. Motion sustained to accept the report except the budget items.

Rev. Harold Harrison spoke concerning the National Sunday School Department.

The report of the State Mission and Church Extension Board was given by Rev. James Murray. Motion carried to accept the report except the budget items.

Rev. Arthur Billows brought greetings from Mexico during the report.

Rev. Rufus Coffey spoke representing the Foreign Missions Department.

Rev. Howard Gage, Missionary appointee to Africa, spoke to the congregation.

Special prayer was given by the Moderator for Mrs. Lennie Sparks, mother of Missionary Lonnie Sparks.

Mr. and Mrs. Harvey Aguirre, appointees to Old Mexico, spoke to the congregation.

Mrs. Arthur Billows gave greetings and her testimony.

Rev. Clarence Shepherd gave the report of the State Executive Board. Motion sustained to accept the report except the budget items.

The clerk read Resolution No. 1. Motion made to accept the Resolution. Motion sustained to table the resolution because of the constitutional change involved.

Rev. N. R. Smith gave the report of the Executive Secretary and the Bookstore. Motion carried to accept the report except the budget items.

Motion made that our state send the promoter to all missionaries, both foreign and home. Motion made to amend that the promoter be sent to the national offices for distribution. Motion sustained as amended.

Rev. Connie Cariker and Mr. Earl Collings gave the report of the Superannuation board. Motion made that the report be adopted including the budget. Motion made to amend the motion by deleting 'including the budget.' The motion carried as amended.

Motion sustained to adjourn. The congregation sang "Amazing Grace."

Rev. James Murray presided over the Wednesday evening service. Mr. Bob Followwill led the congregation in singing "Jesus Saves." He then recognized all present by the association they represented. "Stand Up for Jesus" was sung, followed with the prayer by Rev. Lynn Wood. The congregation then sang "Near the Cross."

Special music was presented by the New Home Youth Choir directed by Marguerite Hinesley. The choir sang, "He Belongs to Me," "Sound the Battle Cry," and "How Great Thou Art."

Also presenting special music was the Tulsa Radio Choir directed by Mr. Kenneth Beatty. This choir sang numbers from the cantata, "The Greatest Story Yet Untold."

Rev. Howard Gage gave his testimony of the work he is called to do in Africa followed by a missionary offering to go to his account. The amount of the offering was reported as \$538.40.

The Hinesley sisters sang, "Win the Lost at Any Cost."

Rev. Kenneth Walker was the evening speaker. He read from II Timothy 4; 16-17, and delivered the message on, "I Delivered Unto You the Ministry of Missions." "Have Thine Own Way" was sung for an invitation hymn.

At the close of the service 15 ministers pledged \$100.00 each for the Howard Gage account to make it possible for the Gages to go to the field immediately.

The Benediction and prayer of Thanksgiving for the offering was led by Rev. James Murray.

The Thursday morning session was called to order by the Moderator. The congregation sang, "Tis so Sweet to Trust in Jesus," and "Glory to His Name."

Rev. Odell Nunley gave the devotional, reading Proverbs 3:1-6.

Rev. Roma Stewart gave the report of the State Church Training Service Board. Motion sustained to accept the report except the budget items. The report was followed by the report of the National CTS Department given by Mr. Samuel Johnson, General Director.

Rev. Jerry Rhoades led the congregation in prayer, and gave the report of the College Board of Trustees. Motion made to give the Capitol Hill Free Will Baptist Church a standing vote of thanks for being host to Oklahoma Bible College. Motion sustained that the motion be amended to include the Board of Trustees in the vote of thanks and that the clerk write the Capital Hill Church expressing appreciation for their hospitality. The motion carried as amended. Motion sustained to accept the report of the College Board of Trustees. Motion sustained to give the Building Committee a standing vote of thanks.

Rev. Paul Kettelman read Amos 8:11-12, and gave a report of Free Will Baptist Bible College, Nashville, Tennessee.

Dr. J. D. O'Donnell, OBC President, reported on the work of the school. Rev. Paul Inbody led in prayer.

The Thursday Morning Worship Service opened with the congregation singing, "I am Thine, O Lord," and "Saved, Saved." Rev. Floyd Vulgarmore presided.

Rev. James Cearley led in prayer followed by a special in song, "He's the Master of Blue Galilee," by Rev. Bailey Thompson.

The congregation sang, "Blest Be the Tie," followed by a special number by Ricky Duncan. He sang, "Ten Thousand Angels."

Rev. J. C. Morgan brought the morning message, using II Timothy 4:5 for his text, and preaching on "I Delivered Unto You the Ministry of Evangelism."

After the announcements, Rev. Joe Haas prayed the benediction.

The Thursday afternoon session opened with singing, "There is a Fountain." The devotion was given by Rev. Jerry Dudley who read Jeremiah 29:10-14, and led in prayer.

Mrs. Edna DaVoult gave the oral report of the State Woman's Auxiliary.

Rev. Billy Melvin, National Executive Secretary, reported on the work of the National Association.

The meeting was turned to Mr. Bob Followwill who surprisingly honored the Moderator, Rev. Lonnie DaVoult, on his birthday. Mrs. Nadine Followwill sang "Take My Life and Let It Be," while the congregation expressed appreciation to Rev. and Mrs. DaVoult with a hand shake.

The report of the Co-ordinating Board was read by Rev. N. R. Smith. Motion sustained to accept the report and adopt it item by item. Item No. 1 carried. Item No. 2 carried. Item No. 3 carried. The Co-ordinating Board report was accepted as a whole.

Motion sustained to adjust all budgets to correspond with the Co-ordinating Board report.

Rev. O. T. Dixon, Moderator of Missouri State Association, gave greetings.

Mr. Howard Gwartney gave the report of the Master's Men.

The election of Board members was held. Those elected were as follows: Executive Board 7 year man, Rev. Ray Gwartney; 3 year man Rev. Waldo Young; and 6 year man, Rev. Fred McCoy.

Church Training Service Board 7 year man Rev. Jerry Dudley, and 1 year man Rev. Rudell Smith.

Elected to the Church Extension and Mission Board as 7 Year man was Rev. Joe Blair.

Mr. Howard Gwartney was elected as 7 year man to the College Board of Trustees.

To the Sunday School Board Mr. Orville Ray was elected as 7 year man and Mr. Ed Warner was elected as 2 year man.

Mr. Charlie Christian was elected for 7 years to the Superannuation Board.

Members of the General Board for 1967 were elected. (See Board listed page 2).

Motion sustained to take Resolution No. 1 from the table. Motion sustained to refer Resolution No. 1 to the College Board of Trustees to be reported on at the next State Meeting.

Resolution No. 2 was read. Motion made to adopt it. Motion made to amend the resolution that the action begin next year. Motion carried as amended.

Resolution No. 3 was read and motion sustained to adopt it.

The Temperance Committee report was read and motion sustained to adopt it.

The report of the Obituary Committee was read and motion sustained to adopt it. The Moderator, Rev. Lonnie DeVault, led in prayer.

Motion sustained to take from the table the constitutional change recommended by the general board. Motion sustained to adopt the recommendation.

After raising pledges for the Howard Gage account in the amount of \$2,000.00, a motion was made and carried that our state Association guarantee this amount to this account.

After pledges in the amount of \$1100.00 were raised, a motion was sustained that our state guarantee this amount to the Harvey Aguirre account.

The moderator led in a prayer of praise and thanksgiving for this response.

The report of the Placement Committee was read. Motion sustained to accept the report and go to Guymon in 1968.

The Election of officers was held. Rev. N. R. Smith was re-elected as Executive Secretary. Rev. Don Payne was re-elected as Parliamentarian. Rev. C. E. Campbell was re-elected as Assistant Clerk. Rev. Waldo Young was re-elected as Clerk. Rev. Jerry Rhoades was re-elected as Assistant Moderator. Rev. Lonnie DeVault was re-elected as Moderator.

Motion sustained to give the officers, host church, and city of Pryor a rising vote of thanks. Motion sustained to adjourn. "Blest Be the Tie that Binds" was sung. Rev. Don Payne led in the closing prayer.

#### **REPORT OF THE GENERAL BOARD**

The General Board of the Oklahoma State Association met at Pryor, Oklahoma October 17, 1966.

The board was called to order by the assistant chairman, Rev. James Cearley. Rev. James Murray led in prayer.

Letters from fifteen Associations were read. Motion sustained to accept the letters and seat the delegates.

Motion sustained that we receive two delegates from the Arkansas River Valley Association with the understanding that the Associational letter would follow.

Recommendation No. 1. We recommend that the last sentence of Article III, Section 2, of our Constitution be deleted. (Page 47 of 1965 Minutes).

The reports of the Sunday School Board, State Church Extension and Home Mission Board, and the Executive Board were given by the chairmen of these boards.

The report of the Executive Secretary and the Oklahoma Free Will Baptist Bookstore was given by Rev. N. R. Smith.

Motion sustained to adjourn for lunch.

Rev. N. R. Smith led the opening prayer of the afternoon session of the meeting.

The report of the Superannuation Board was read by Rev. Clarence Shepherd.

The State Church Training Service Board report was given by Rev. Roma Stewart.

Rev. Jerry Rhoades gave the report of the Oklahoma Bible College Board of Trustees.

The Coordinating Board report was given by Rev. N. R. Smith. Motion sustained to adopt the report of the Coordinating Board.

Motion sustained that all reports be received and all budgets be corrected according to the Coordinating Board Report.

Recommendation No. 2. We recommend that mileage be increased for all standing Boards, and those employed by these boards, from 5¢ per mile to 7¢ per mile.

Motion sustained to adjourn. Rev. Roma Stewart led the closing prayer.

**STATE MISSION BOARD REPORT**

The Board has held 13 meetings since the last report given. Our regular meetings are held monthly, however, necessity causes us to meet more often on occasions.

Mission giving continued to increase in Oklahoma. Foreign Mission receipts for 1965 were \$34,042.66. National Home receipts were \$20,041.94. This is an increase of \$5,766.33 over 1964. Quotas for these departments are as follows: Foreign Missions 1965, \$45,000.00; Foreign Missions 1966, \$45,000.00; National Home Missions 1965, \$20,000.00; and National Home Missions 1966, \$21,000.00.

The Board has helped arrange some itinerant services for missionaries the past year. We are happy to help in this area when called upon to do so.

A National Home Missions project was sponsored by the Board this year to raise money for a vehicle for Old Mexico. A goal of \$3,500.00 was set by the Board. We were not able to reach this goal, however, a check for \$2,000.00 was sent to the National Home Missions office and with help from other sources the vehicle was purchased.

Some assistance was given this year to the church in Ponca City. This was done in cooperation with the First Mission Association. Rev. E. M. Kennedy was the pastor of the church in Ponca City. A motion carried in our October meeting to withdraw support from Ponca City.

The Enid Church has also been helped some this year in cooperation with the First Mission Association. Rev. Carl Hembree was pastor of Enid. The Board withdrew support until further notice in September 1965. In our November meeting the Board accepted the request of the First Mission General Board to accept the Enid work back as a mission since the Church had voted to disband. A meeting of the Board was held in Enid on November 29, 1965, with some members of the Enid Mission to discuss the future of the work there. A revival was held December 12-17 by Rev. James Murray. Approximately 10 people from Enid attended plus other out of town visitors. The property at Enid was listed for sale. The Board was able to sell the property for enough to cover the loans and the expense the Board was out on the church. We are praying that God will open the doors at Enid and Ponca City and in some future date we can have a strong Free Will Baptist work in these two cities.

A joint effort of the State Mission Board and the First Oklahoma Mission Board has resulted in a new church at Edmond. The church was organized on January 26, 1966 with 24 charter members, under the direction of the First Oklahoma Mission Board. A check for \$1,500.00 was given to the church from the State Board to apply to the purchase of two acres of land. Rev. Bob Duncan, member of the State Board, brought the message. At a previous meeting we voted to match the gift from First Oklahoma Association of \$250.00 that was needed for the option. Through the efforts of the Edmond church, First Oklahoma Association and State Missions Board the

land was purchased. The Church now has completed the first unit of their building program. Rev. Milburn Wilson is the pastor. Money from the New Church Club members was used on the Edmond land.

Another joint effort of the Board this year has been with the First Mission Association in Southeast Tulsa. We are paying \$35.00 per week of a \$100. per week salary to Rev. Kenneth Walker, pastor. The Southeast Church is paying \$100.00 per month and the churches of First Mission Association are responsible for the rest of this salary. Southeast Tulsa was organized on February 6, 1966 under the direction of the Tulsa Area Quarterly Meeting Executive Board, with 44 charter members. Rev. James Murray, chairman of the State Mission Board, brought the message. They are meeting in the McArthur Elementary School until a permanent building site is located. The Church is in the process of buying a 10 acre piece of property, 1801 S. Garnett Road, at the cost of \$40,000.00. At a later time 5 acres of this land will be sold. A letter will be sent to New Church Club Members for funds for this project.

State Missions Month is December. State Missions Sunday is December 18th this year. We encourage each church to receive an offering for State Missions on this Sunday. We would also like to express appreciation to the churches and individuals for your past response and encourage you to cooperate with us again this year.

Our plans are to continue to work in areas such as the work in Edmond and Southeast Tulsa. Not that we wish to move away from any given area where we may be able to establish a Church, but we realize that much of the American population is moving to the areas surrounding the larger cities. Will you help us pray that God will open doors in these places.

We request 7% of the Cooperative receipts.

### EXECUTIVE BOARD REPORT

The Executive Board had four meetings this past year and are grateful to God for a good year in His service. We do regret the resignation of two of our Board members, Rev. L. A. Yandell who moved to another state and Rev. Howard Gage who was employed by our National Foreign Mission Board in Ivory Coast, West Africa.

We are still urging the "Every Family Plan" PROMOTER subscription whereby every active family in the church can have the PROMOTER sent to their home for the cost of \$1.40 per year.

We also extend to you as an individual or as a Church the privileges of your Oklahoma Bible and Bookstore, 4801 South Walker, Oklahoma City, for all of your home, Sunday School and Church needs (Bibles, books, awards and supplies) visit the Bookstore when in the City or make your order by mail or phone.

On January 18, 1966 we met with Rev. Connie Cariker and Bro. Earl Collings of the Superannuation Board. Rev. Connie Cariker gave an oral report concerning the insurance program for Oklahoma State Ministers. Stated Superannuation treasurers balance as of December 20, 1965 was \$779.00. Premium to New York Life Insurance Company was \$329.00 per month.

We decided in this meeting that the Executive Board loan needed funds to the Board of Superannuation to pay insurance premium until May 1,

1966. At such date we recommended to the Board of Superannuation that the present ministers insurance program be terminated.

On January 18, 1966 we met with the Board of Trustees of Oklahoma Bible College. At this meeting the Trustee Board presented their plan for pursuing the building program of Oklahoma Bible College.

The plan was to hire a building superintendent and for the College Board of Trustees to act as a general contractor rather than let the building program to a general contractor.

We adopted a budget for Oklahoma Free Will Baptist Bookstore of \$40,000.00 for the year of July 1, 1966 to June 30, 1967 also a budget of \$45,000.00 for the year July 1, 1967 to June 30, 1968.

We also adopted a budget of \$17,200.00 for the Executive Office for the year of July 1, 1966 to June 30, 1967 and a budget of \$17,200.00 for the year of July 1, 1967 to June 30, 1968.

We recommend to the State Association that 31% of the Cooperative Plan receipts be to the Executive Office.

The Board of Trustees of Oklahoma Bible College, Inc. met seven times the past fiscal year, 1965-1966.

On September 17, 1965, we met at the Lewis Avenue Church in Tulsa and voted to issue \$140,000 in first mortgage bonds to finance the building of the College plant. We employed Executive Church Bonds, Inc. of Nashville, Tennessee, to issue the bonds and guide us in this program. We voted to "Incorporate" the College.

On October 14, 1965, following the State Association in Ardmore, Oklahoma we met and organized as follows:

Mail service for O B C will be through the Moore, Oklahoma Post Office.

On November 19, 1965 we met again at the College in Oklahoma City and selected a three man mediating board to serve between the contractor and the architect. (Dr. J. D. O'Donnell, Rev. Jerry Rhoades and Bob Followwill.)

On December 3, 1965, the board met again at the College and elected Rev. Jerry Rhoades, chairman to set up a selling procedure for the bonds which would be strictly adhered to.

On January 14, 1966, at the Lewis Avenue Church in Tulsa, the Board learned that the contractor, Mr. Russell, did not wish to post bond, therefore, we could not contract him as builder. We voted to hire a building superintendent to supervise the construction of the College plant.

January 18, 1966, we met in joint session with the Executive Board of State Association and requested approval of the hiring of a building superintendent and that the Trustee Board act as general contractor rather than letting a contract to an individual general contractor. The Executive Board met and gave their consent to our request.

On April 22, 1966, authority was given to the College Administration to negotiate and hire the faculty for the school year, 1966-67.

We request 16% of the Cooperative receipts.

### OKLAHOMA BIBLE COLLEGE, INC.

#### BY-LAWS

#### BOARD OF TRUSTEES

The Board of Trustees of Oklahoma Bible College shall be composed of nine members, as provided in the charter of the College:

ARTICLE A—OFFICERS: The officers of the board of Trustees shall be a Chairman, an Assistant Chairman, and a Secretary, each of whom shall be elected by the Board for a term of one year. They shall continue in office until their successors have been chosen:

Item 1—CHAIRMAN: The chairman of the Board of Trustees or his assistant shall preside at all meetings of the Board. He shall be an ex-officio member of the Executive Committee.

Item 2—**SECRETARY**: The Secretary shall record and preserve minutes of all meetings and acts of the Board of Trustees and countersign all deeds, conveyances, and other papers authorized by the Board. He shall have authority to call special meetings of the Trustees of the College upon the written request of two-thirds of the members of the Board; he shall mail notice of said meeting to the trustees ten (10) days in advance.

Item 3—**EXECUTIVE COMMITTEE**: The Executive Committee shall consist of the Chairman of the Board of Trustees, the Vice-Chairman of the Board, the Secretary of the Board. The Executive Committee shall have authority to consider and act upon all questions affecting the Bible College which may be brought before it between the stated meetings of the Board, or whenever it is deemed impractical to convene the entire Board, or a quorum of the Board fails to attend a called or regular meeting. It shall transact such business as may be committed to it by the Board and shall act for the College on such matters as it may submit to it. The Committee shall meet at the call of the Chairman or the President of the College.

**ARTICLE B—MEETINGS**: The Board of Trustees shall meet each year at a time and place agreed upon by the Board. It shall, also, hold special meetings whenever called in accordance with the By-Laws of the Board. Such special meetings may be called by either the chairman of the Board, or the President of the College.

**ARTICLE C—QUORUM**: A majority of the members of the Board of Trustees of Oklahoma Bible College in attendance at any called or regular meeting, written notice of which has been mailed by the Secretary to each trustee, shall constitute a quorum. No proxy votes shall be permitted. No ex-officio member shall be entitled to vote at meetings of the Board of Trustees.

**ARTICLE D—ELECTIONS**: In all elections held by the Board of Trustees each member present except ex-officio members shall be entitled to one vote, and the result shall be determined by a majority of the votes cast. Due notice of any election must be personal notice to the members, or a day on the minutes of the Board not less than one week preceding the election.

## **SECTION II OFFICERS OF THE BIBLE COLLEGE**

The officers of Oklahoma Bible College shall be a President, Vice-President, Dean, and a Business Manager, each of whom shall be elected by the Board of Trustees to hold office for two years, exclusive of the President whose term of office shall be indefinite. It is provided, however, that retirement of any one of the officers herein named may occur at any time upon the resignation of the officer or the request of the Board. In either case, notice shall be given six weeks before the date of the proposed retirement unless otherwise agreed upon by the concerned parties.

**ITEM ONE—PRESIDENT**: The President shall be executive officer of the Board of Trustees and shall have general control of the College including its officers, teachers, students, and business. He shall render to the Board complete annual reports and to its chairman, Executive Committee or other committees such information as may be deemed essential to a thorough knowledge of the operation of the College and its promotion. He shall be a member of the Board of Trustees ex-officio and of the Executive Committee ex-officio and shall have all the rights and privileges of a member of the Board except voting. The President shall execute all

documents, instruments, and conveyances on behalf of the College. Duties of the president and working relationship shall be further detailed in a format approved by the Board of Trustees.

**ITEM TWO—VICE PRESIDENT:** The Vice-President shall perform all the duties of the President in the absence of the latter.

**ITEM THREE—DEAN:** The Academic Dean of the Bible College shall, under the President, fix the hours of recitation, govern, control, and regulate the conduct of the students, have general oversight of curriculum, student's records, and such other internal details and administrative duties as may be delegated to him by the President of the College.

**ITEM FOUR—BUSINESS MANAGER:** The Treasurer shall keep an accurate record of all accounts of the College and shall receive and expend, as directed by the Board of Trustees and President, all money for the expenses of the institution. He shall make an annual report to the Board and furnish the Executive Committee with such information pertaining to his office as may be requested. He shall provide bond in whatever amount the Board may require. Until such times as the Board of Trustees may deem different the Treasurer's office shall be contained within the Business Manager's Office. The Business Manager may at the direction of the administration designate this duty to a subordinate officer. The Business Manager shall have general supervision of the financial business of the College, and shall, at the direction of the President, be responsible for the upkeep of all the physical facilities and premises of the College. His detailed duties are directed in a format approved by the Board of Trustees.

### **SECTION III FACULTY**

The faculty shall consist of the President, the Dean, and all teachers of Oklahoma Bible College. Instructors & assistant teachers shall have the privilege of sitting with the faculty in stated meetings but shall not have the right of voting.

It shall be the policy of the Oklahoma Bible College to employ on its faculty those who are members of Free Will Baptist churches that are affiliated with the National Association. Emergencies, however, arising from the resignation, illness, death, or approved leaves of absence of faculty members may be relieved by the temporary employment of instructors who are affiliated with any evangelical denomination. Part-time or short-term instructors, deemed essential to the successful prosecution of a consistent education program, may be employed at the discretion of the President without respect of denominational affiliation.

The faculty, under the authority and jurisdiction of the President, shall have general charge of instruction, attendance of students, examinations, administration of curriculum, discipline, and all matters involving the spiritual, physical, and social welfare of the Bible College. The faculty shall be hired upon recommendation of the President.

In the selection of the faculty qualitative factors shall be kept in mind. All faculty members shall be urged to pursue graduate programs in their respective fields. Except in special cases no faculty member will be required to teach courses outside of his field.

### **SECTION IV ACADEMIC COUNCIL**

The Academic Council shall consist of the President, the Dean and the

heads of the departments of Oklahoma Bible College. It shall determine the curriculum and academic policy of the College, prescribe requirements for admission, certificates, diplomas, and degrees, and supervise the courses of instruction offered by the various departments of the College.

#### **SECTION V CONTRACTS**

The Board of Trustees shall establish the College policy involving the execution of contracts, deeds of conveyance, the determination of salaries, and employment of all officers, representatives, faculty members and essential domestic and maintenance employees. The President of the College shall negotiate agreements, execute contracts, employ representatives, and supply vacancies incurred by the termination of contracts, resignations, or death of any essential employees. All contracts for building construction shall be let only to persons or corporations posting a valid performance bond and recording the same in the Office of the County Clerk of Cleveland County, Oklahoma.

#### **SECTION VI ADVISORY COUNCIL**

An advisory council shall be formed which is to be composed of interested, qualified persons in the various fields which will be of value in building and maintaining a strong academic program to carry out the educational program stated in the charter.

#### **SECTION VII AMENDMENT**

These By-Laws may be amended by a favorable vote of two-thirds of the qualified members of the Board of Trustees of Oklahoma Bible College at any meeting of the Board, provided that the proposed amendment has been submitted in writing to each Trustee one month in advance. This change to be subject to the Oklahoma State Association of Free Will Baptists.

#### **SECTION VIII ADMINISTRATIVE FUNCTIONS**

The President of the Oklahoma Bible College shall be elected by the Board of Trustees, and he shall act for and on behalf of the Board in the conduct and management of the institution. He shall also be a member of the Board of Trustees ex-officio and of the Executive committee ex-officio, and his duties, powers and term of office shall be prescribed in the by-laws of the College and a format approved by the Board of Trustees.

#### **ARTICLES OF INCORPORATION OF THE OKLAHOMA BIBLE COLLEGE, INC.**

Know all men by these presents, that, we, whose names are hereunto subscribed, do hereby associate ourselves together for the purpose of forming a corporation under the provisions of the corporation laws of the State of Oklahoma, and for that purpose state:

#### **ARTICLE ONE**

The name of this corporation shall be OKLAHOMA BIBLE COLLEGE, INC.

#### **ARTICLE TWO**

The purpose of this corporation shall be the creation, establishment and maintenance of a college and institution of higher learning devoted to the promotion and impartation of higher learning, Christian education and such

other education, instruction, learning, training and research as may be deemed essential for the cause of Christ and to that end prescribable courses of study and grant degrees. The doctrinal and theological position of this institution shall be that of the sponsoring denomination, Oklahoma State Association of Free Will Baptists and the treatise of the National Association of Free Will Baptists as endorsed by the state body, and in connection therewith, in accordance with the stipulation of the Constitution and By-Laws of the State Association of Free Will Baptists, Inc.

(a) To prescribe courses of study for both resident and correspondence students, which shall include general education in the arts, Christian Ministries of Service and Biblical studies for wisdom; said courses to be taught in both a Junior College Division and a Bible College Division, and to award degrees, either graduate or post-graduate, to those persons satisfactorily completing the prescribed courses of study and to grant such other literary honors, including honorary degrees, as shall be deemed advisable.

(b) To charge and collect tuition as determined by the Board of Trustees and to create scholarships.

(c) To employ professors, instructors and other subordinate employees as may be necessary for the proper conduct of the college under the direction and control of the President of the College, with the advice and consent of the majority of the Board of Trustees.

(d) To institute and carry on missions and commissions for missionary purposes and investigations.

(e) To publish and distribute such pamphlets, literature or books as may be required in the conduct of such work and the general promotion of the Bible College.

(f) To sue and be sued in its corporate name and to enter into contracts of every type and nature.

(g) To solicit support, receive, collect, hold and receive by gift or bequest personal property in any amount, money or other thing of value; to purchase real estate, to receive real estate that may be given, or devised to the college for achieving the legitimate ends of the college and to sell or mortgage the same as the need arises.

(h) To borrow money in payment of property; for erecting buildings and making improvements and for any other purpose germane to the objectives and purposes of the college.

(i) To issue notes, bonds, debentures and other evidences of indebtedness and execute mortgages, liens and other incumbrances upon the property of the corporation, real or otherwise, to secure the payment of any such evidences of indebtedness.

(j) To transact any and all business connected with said College as may be necessary to achieve the purposes of said College.

(k) To obtain under Internal Revenue Laws of the United States and of the Revenue Laws of the State of Oklahoma exemption from income property and other forms of taxation.

### ARTICLE THREE

The location of this corporation shall be in Norman, Oklahoma.

### ARTICLE FOUR

The duration of this corporation shall be perpetual.

### ARTICLE FIVE

The general control of this corporation shall be vested in a Board of Trustees consisting of nine members, seven of which shall be elected by the delegates to the annual association of the Oklahoma Free Will Baptists;

the elected members of said Board shall be elected to terms of seven years, six, five, four, three, two and one year respectively, provided, that each elected Trustee shall be a resident of a regular Free Will Baptist church that is in good standing with the state association. The remaining two members, which are ex-officio, shall be the president of the College and the Executive Secretary of the State Association of Free Will Baptist of Oklahoma.

**ARTICLE SIX**

An executive committee consisting of the Chairman, Vice Chairman, and Secretary of the Board of Trustees shall possess all powers of the Board of Trustees between the stated meetings of the Board of Trustees.

**ARTICLE SEVEN**

All contracts for building construction shall be let only to persons or corporations posting a valid performance bond and recording the same in the office of the County Clerk of Cleveland County, Oklahoma.

**ARTICLE EIGHT**

The College Board of Trustees shall be empowered to call special or extraordinary meetings of the State Association of Free Will Baptists of Oklahoma by mailing written notice to each delegate to the previous meeting of said Association or to the delegate's sponsoring church. Such notice shall be mailed not less than ten (10) days prior to the date of said meeting. At such meetings, any matter stipulated in the notice, concerning the welfare of the College may be considered, including, but not limited to, finances, new bond issues, vacancies on the Board of Trustees and approval of new construction.

**SECTION IX  
AMENDMENTS**

This charter may be hereafter amended subject to the provisions contained herein and the laws of the State of Oklahoma. It is provided, however, that the trustees of the Bible College shall not propose or apply for any amendment which has not been previously authorized by an act of the Oklahoma State Association.

## CONSTITUTION OF MINISTER'S CONFERENCE

### Article 1

This Minister's Conference shall be called the Oklahoma State Free Will Baptist Minister's Conference, and shall be composed of Ordained Free Will Baptist Ministers who are regular members of some Orthodox Free Will Baptist church in the State of Oklahoma who have paid their \$1.00 dues.

### Article 2

The officers for this conference shall be President, Vice-President, Clerk, Assist. Clerk and Treasurer, who shall be elected annually.

### Article 3

This conference shall have the power to discipline its members.

### Article 4

Every ordained minister in the State of Oklahoma should be a member of this conference and is required to report in each session in person or by letter. Every member shall be required to carry a card of identification, and recommendation from this conference, and said card to be issued annually.

### Article 5

This conference shall meet Semi-Annually.

### Article 6

This constitution may be amended by a two-thirds vote of the members present at any regular session.

## BY-LAWS OF MINISTER'S CONFERENCE

### ARTICLE 1

The clerk or assistant clerk, or in their absence the senior ministers in years shall call the ministers into conference. If a quorum is present the President or in his absence the Vice President shall moderate the meeting. If neither of these are present, the senior minister in years shall be in charge.

### ARTICLE 2

It shall be the duty of the clerk to enroll the ministers of the conference. Ministers shall present themselves with proper evidence of their rights to seats therein, and those enrolled by the clerk shall compose the conference. In case of questionable representation the case under question shall be referred to the Credential Committee.

### ARTICLE 3

It shall be the duty of each minister belonging to this conference, to be active in pastoral or evangelistic services (disabled and retired ministers excepted.) Any minister belonging to this conference shall report in each session in person or by letter, and failing to do so for two successive sessions shall be subject to discipline.

#### ARTICLE 4

Each conference shall be opened by reading a portion of God's word and prayer, and each session shall be closed with prayer.

#### ARTICLE 5

By a two-thirds vote of the members present ruling of the President may be overruled.

#### ARTICLE 6

This conference shall sit with open doors, except when it shall go into a committee as a whole.

#### ARTICLE 7

No member shall absent himself from the conference during its meeting without permission from the President.

#### ARTICLE 8

No person shall be allowed to nominate more than one member of a committee, unless person nominated is not elected.

#### ARTICLE 9

The President shall not allow discussion when not carried on in a Christian Spirit, or when he thinks it will cause discord.

#### ARTICLE 10

Anyone desiring to speak shall rise and address the President by the appellation "Brother President," But shall not speak further until recognized.

#### ARTICLE 11

No member of this conference shall be allowed to speak more than five minutes, nor twice on the same subject without permission from the President.

#### ARTICLE 12

These By-Laws may be altered or amended at any regular or adjourned session of this conference by a two-thirds vote of the members present.

2. GOD — There is one living and true God, revealed in nature as the Creator, Preserver and Righteous Governor of the Universe, and in the Scriptures as the Father, Son and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore and obey.

3. CHRIST — Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified. He is now risen and glorified is our ever-present Saviour and Lord.

4. THE HOLY SPIRIT — The Scriptures assigns to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of all men.

5. THE GOVERNMENT OF GOD — God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of Grace, not otherwise provided for as highest welfare of man requires.

6. THE SINFULNESS OF MAN — Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore, inherited a fallen nature of such tendencies that all who come to years of accountability, sin and become guilty before God.

7. THE WORK OF CHRIST — The Son of God, by His incarnation, life, sufferings, death, and resurrection effected for all a redemption from sin that is full and free and is the ground of salvation by faith.

8. THE TERMS OF SALVATION — The conditions of salvation are: 1. Repentance or sincere sorrow for sin and the hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord, with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit; freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death.

9. **ELECTION** — God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ, men become His elect.

10. **FREEDOM OF WILL**—The Human will is free and self controlled, having power to yield to the influence of the truth and the Spirit and live, or to resist them and perish.

11. **SALVATION FREE** — God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of Life freely.

12. **PERSEVERANCE** — All believers in Christ, who through grace persevere in holiness to the end of life, have the promise of eternal salvation.

13. **GOSPEL ORDINANCE** — Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel: Feet Washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers.

14. **TITHING**—God commanded tithes and offerings in the Old Testament: Jesus Christ endorsed it in the Gospel (Matt. 23:23) and the Apostle Paul said, "Upon the first day of the week let every one of you lay by him in store as God hath prospered him." I Cor. 16:2.

15. **THE CHRISTIAN SABBATH**—The divine law requires that one day in seven be set apart from secular employment and amusements for rest, worship, holy works and activities, and for personal communion with God.

16. **RESURRECTION, JUDGMENT AND FINAL RETRIBUTION** — The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation: then the wicked shall "go away into eternal punishment but the righteous into eternal life."

#### **RULES OF ORDER**

1. At every sitting of the Association, business shall be opened and concluded by prayer by the Moderator or whomsoever he may request.

2. Ministers and deacons present are invited to seats, allowed to take part in debates on all subjects, and to vote.

3. Those who speak shall rise and address the Moderator. Personal reflections shall be avoided in all debates.

4. No motion may be discussed until made and seconded.

5. When a motion has been made and seconded, and a member opposes its discussion, the Moderator shall put the question, "Shall it be discussed?" if negative, the question shall not be discussed.

6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member, and the vote taken separately.

7. Motions made and lost shall not be recorded.

8. No one shall speak more than twice on the same subject without special leave of the Moderator.

9. All questions shall be decided by a majority vote of all Members present.

#### **BY LAWS OF STATE ASSOCIATION**

1. The Clerk or assistant clerk, or in their absence, the senior minister in years shall call the Association into conference, and if a quorum is present the moderator, or in his absence, the assistant moderator shall

take charge; and if neither of them is present the senior minister in years shall act as Moderator.

2. It shall be the duty of the clerk to enroll the delegates to the Association, who shall present themselves with proper evidence of their rights to seats therein, and those enrolled by the clerk shall compose the Association.

3. It shall be the duty of every District belonging to this Association to send a letter to every annual session of this Association reporting in the same, spiritual condition, benevolent work, and its statistics. Any District belonging to this Association, which shall fail to report itself for two successive sessions, may be dismissed from the Association by a two-thirds vote of all members present.

4. Each meeting shall be opened by reading a portion of the Bible and with prayer, and shall be closed with prayer.

5. By a two-thirds vote of members present, a ruling of the moderator can be overruled.

6. This Association may correspond by messenger or otherwise with other religious bodies.

7. This Association shall sit with open doors except when it shall go into a committee of the whole.

8. Any person not a member of this Association may be allowed to take part in its discussions by obtaining permission from the moderator.

9. It shall be the duty of all the Association to be present at the time appointed for each meeting, and anyone wishing to retire shall first obtain leave of the moderator.

10. No person shall be allowed to nominate more than one member of any committee, provided the person nominated be elected.

11. The moderator shall not allow discussions when not carried on in a Christian spirit or when he thinks it will cause discord or division.

12. Anyone desiring to speak shall rise to his feet and address the moderator by the appellation "Brother Moderator," but shall not speak further until recognized by the moderator.

13. No member of this association shall be allowed to speak more than ten minutes nor twice on the same subject without permission from the moderator.

14. These By-Laws may be altered or amended at any regular or adjourned session of this Association by a two-thirds vote of the members present.

## CONSTITUTION OF STATE ASSOCIATION

**PREAMBLE:** From long experience, we the members of the Free Will Baptist denomination, being regularly baptised upon a profession of our faith in Jesus Christ, and realizing the necessity of a bond of union and fellowship among us as a church; and to preserve and maintain correspondence and co-ordination with us, do therefore ordain this Constitution for our better denominational government.

### Article I

**NAME:** This organization shall be known as the OKLAHOMA STATE ASSOCIATION OF FREE WILL BAPTISTS.

### Article II

**PURPOSE:** The object and purpose of this organization shall be to unify the work of the various bodies composing this State Association, and to devise and execute measures for the extension of the Kingdom of God in connection with the various bodies in the Association, or that may here-

after be represented therein.

#### Article III

**REPRESENTATION:** Section 1: This Association shall be composed of all ordained ministers and deacons with membership in some local church which is a member of a district Association with membership in the State Association.

Section 2: Each District Association shall be entitled to a number of elected delegates equal with the number of churches composing said Association. These delegates may be recommended by the local churches and shall be endorsed by their district association.

#### Article IV

**FINANCE:** Each elected delegate shall be represented with a fee of Five dollars.

#### Article V

**DISCIPLINE:** This State Association shall have the right to settle any question of discipline, doctrine or practices that may properly come before it from any of the bodies composing said organization, furthermore if there be any question of discipline, doctrine or practices on the part of a subordinate association, delegates of that association shall not be seated until these questions have been settled to the satisfaction of the Credential Committee

Section 2: Decisions of the Credential Committee may be appealed. (1) All appeals coming before the State Association when sitting in a Committee as a whole. (2) by special committee whose report shall be voted on without discussion.

#### Article VI

**OFFICERS:** The officers of the State Association shall consist of a Moderator, Assistant Moderator, Clerk and Assistant Clerk, Parliamentarian, and an Executive Secretary, each of whom shall be elected at the close of each regular session, except the Executive Secretary, who shall be elected every two years.

Section 2: Committees, as necessary, shall be appointed by the moderator, unless otherwise provided for, and shall hold office until their work is completed or until their successors are elected.

#### Article VII

**BOARDS:** All standing boards shall be composed of seven elected members who shall serve terms of 7, 6, 5, 4, 3, 2, and 1 years, and any ex-officio members provided for elsewhere. Ex-officio members shall not have vote. The general board shall be composed of one member from each subordinate association, chairman of each standing board, and the state officers. The standing boards shall include the Executive Board, the Church Extension and Mission Board, College Board of Trustees, Superannuation Board, Sunday School Board, and Church Training Service Board. Each board shall elect a chairman and clerk-treasurer to act for one year and to be elected at the close of each annual state association. The Co-ordinating Board shall be composed of the executive secretary and the chairman from each standing board.

#### Article VIII

**DUTIES AND RULES OF STANDING BOARDS:** The Executive Board is elected at the discretion of the State Association of Free Will Baptists and shall act in behalf of the association when not in session, and shall have power and authority to elect such officers as might be deemed best

for its own government and to carry out the plans and undertakings of the state association. To this Executive Board is further delegated power to collect funds and report and superintend such work for the field as may seem best and the means on hand may warrant, exclusive of College Board of Trustees.

This Executive Board shall keep a record of all work done, money raised, meetings held, and make a full and complete report to the regular meeting of the association and shall further receive and convey any property entrusted to said state association. They shall not have the power to purchase or sell any real estate property without the voice of the association.

The chairman and the secretary of said Executive Board shall sign all deeds, bonds, and notes, etc., and any other papers by which the State Association is to become legally responsible, exclusive of College Board of Trustees.

The board shall have the power to call the association in conference by notifying each Subordinating Association at least ten (10) days prior to conference.

(2) **GENERAL BOARD:** It shall be the duty of this board to meet with the Executive Board one day preceding the State Association to hear reports of the standing boards and to make recommendations to the State Association. They shall also serve as Credential Committee.

(3) **CHURCH EXTENSION AND MISSION BOARD:** It shall be the duty of this board to work to promote an active missionary program in and for the State of Oklahoma.

It will also be their responsibility to investigate and assist, if necessary, any new church and, or, a church that cannot maintain itself. This board should thoroughly investigate the ability of a church to support an organization before assistance is pledged.

(4) **COLLEGE BOARD OF TRUSTEES:** It shall be the duty of this board to supervise and promote Oklahoma Bible College, Inc. and the function of this board shall be governed by the Articles of Incorporation and By-laws as adopted by the State Association of Free Will Baptists, adopted at the 1965 session.

(5) **CHURCH TRAINING SERVICE BOARD:** It shall be the duty of this board to plan and assist in every way possible the C.T.S. work throughout the state. It will also be their responsibility to promote an active C.T.S. work in each Subordinate Association and to encourage C.T.S. institutes. It shall also be the duty of this board to plan and direct a State Youth Camp or Camps.

(6) **SUNDAY SCHOOL BOARD:** Their duties shall include the planning and operation of the State Sunday School Conventions, Institutes, and the encouragement of the organization of district conventions. They may carry through plans they think wise to actively promote Sunday School work in the state, and the publishing of literature deemed advisable by the State Association of Free Will Baptists.

(7) **SUPERANNUATION BOARD:** This board working in cooperation with the National Superannuation Board and district boards, shall provide a definite program of superannuation for ministers.

(8) **CO-ORDINATION BOARD:** This board shall be charged with the responsibility of co-ordinating the work of the standing boards, and shall also act as Budget Committee. The Executive Secretary shall serve as chairman and the board shall meet at his discretion.

(9) **FILLING OF VACANCIES:** All boards shall have power to fill vacancies that may arise between sessions of the association. Such appointment valid only until next session of association.

(10) **Working agreement between the state association and the Executive Secretary of the State Association:** That the Executive Secretary be paid a set salary and mileage and a two week paid vacation and all money received by him for speaking engagements, revivals and etc. shall be turned in by him to the Executive Office for the support of this office. He shall be ex-officio member of all standing boards.

#### Article IX

This constitution may be amended or altered at any regular session of the State Association by a two-thirds vote of members present, provided proposed amendment or alteration be presented in writing to the body one day in advance.

#### Article X

Elected delegates to State Association shall be retained as standing delegates for special called meetings.
