PROCEEDINGS

TUESDAY EVENING, OCTOBER 16, 1984

The Seventy-Sixth (76th) Annual Session of the Oklahoma State Association of Free Will Baptists meeting in the Civic Center of Muskogee, Oklahoma began with the opening service music presented by the New Life Singers of Hillsdale Free Will Baptist College.

The service was called to order with singing led by Phil Akin singing "Victory In Jesus." Earl Scroggins, the Assistant Moderator, then led the Association in a season of prayer.

Glen Hood, presiding, welcomed all of the people present and called attention to the convention theme, "In Remembrance of These Things" (I Timothy 4:6).

Associational Clerk, Jerry Dudley, called the Association into official session and introduced the officers who are to serve through this session: Lonnie DaVoult, Executive Secretary; Earl Scroggins, Assistant Moderator; David Sutton, Moderator.

Moderator, David Sutton delivered the Moderator's message from Deuteronomy 8, noting: (1) God's Patience (2) God's Provision (3) God's Promise (4) God's Protection and (5) God's Power.

The Scott Sisters of Stigler, Oklahoma brought special music which glad-

dened the hearts of all present in singing "Canaan's Land Is Just Ahead" -"Step Into the Water" and "Beulah Land."

Glen Hood then came and introduced Orville Hood for the evening message. From the theme "In Remembrance of These Things" his message, "Purity of the Doctrine" was delivered. A truly outstanding message was received by the Association. His major emphasis was: (1) Man's inability (2) God's availability and (3) Our Responsibility. Without doubt a classic sermon was delivered.

THE WEDNESDAY MORNING SESSION

The Assistant Clerk having moved from the State, a motion and second carried that Waldo Young be elected to serve as Assistant Clerk for this session.

The Clerk read Item 2 of the General Board Report. A motion and second carried to receive the report. (See General Board Report)

David McDougal, Chairman, gave the report of the Executive Board. Motion and second carried to receive the report. (See Board Reports)

Lonnie DaVoult, Executive Secretary, gave the report of the Executive Office. A motion and second carried to receive the report. (See Board Reports)

Melvin Worthington, Executive Secretary of the National Association of Free Will Baptists gave a report of that department and answered questions concerning receiving and dispensing funds through that office.

Ray Martin, Manager, gave the report of the Free Wil Baptist Book Store. A motion and second carried to receive the report.

Jack Richey was elected to serve as the seven (7) year member of the Executive Board.

David Joslin, Executive Secretary of Arkansas Free Will Baptist State Association, brought greetings from our Arkansas brethren. A warm report of their work and fellowship was received.

Keith Burden, Chairman, gave the report of the State Sunday School Board. A motion and second carried to receive the report. (See Board Reports)

Harold Harrison gave a report of the National Sunday School Department.

James Puckett was elected as the seven (7) year member of the Sunday School Board.

Jim Vallance, Director, gave a report of the National Master's Men.

The Moderator declared a recess for morning worship.

WEDNESDAY MORNING WORSHIP SERVICE

David Archer led the congregation in singing "Oh, How I Love Jesus" to open the Wednesday morning worship service.

Francis Berka, presiding, led in prayer.

The congregation then sang the chorus "God Is So Good."

The Watchmen Quartet sang "His Grace is Sufficient: and "Love Grew Where the Blood Fell."

Francis Berka then introduced Earl Scroggins for the Morning Message. From the Theme "In Remembrance of These Things" he then read 1 Corinthians 11:2, 23-26 as his text scripture and presented the sermon "Participation in the Body." He closed the message with prayer.

Following announcements, the service was dismissed for lunch.

WEDNESDAY AFTERNOON SESSION

David Archer led the Association in singing "Amazing Grace" to open the Wednesday afternoon session.

The Moderator led in prayer for Holy Spirit guidance through the afternoon business session.

Allen Moore read Psalms 1:1-3 as a basis for the afternoon devotional thoughts.

Keith Burden completed the report of the Sunday School Board by recognizing churches who had won awards in the campaigns and conventions sponsored by the Board.

The Clerk clarified the issue of employees of State Boards serving standing boards by reading rules adopted by this Association in previous years.

The place of Danny Hester on the Sunday School was declared vacant. Ernest Harrison, Jr. was elected to this position as a three (3) year member of the State Sunday School Board.

Ron Carner, Chairman, and Berton Perry, Director, gave the report of the State Missions Board.

Motion and second carried to receive the report.

Berton Perry recognized J. B. Chism for his sixteen (16) years of service to the State Mission Board.

Connie Cariker gave a report of the National Home Missions Board.

Eugene Waddell gave a report of the National Foreign Missions Department.

Buddy Drake was elected to serve a seven (7) year term on the State Mission Board.

Kent Hubbard, Chairman, gave the report of the Church Training Service Board. A motion and second carried to receive the report. (See Board Reports)

Dean Stone was elected to serve a seven (7) year term on the Church Training Service Board.

Earl Scroggins was elected to a one (1) year term on the Church Training

Service Board to fill out the unexpired term of Leroy Welch who moved from the State.

Ray Gwartney, Chairman of the Board of Trustees, gave the Trustees report of Hillsdale Free Will Baptist College.

Edwin Wade, President, and Richard Gallant, Public Relations Director, gave a report of the operation and status of Hillsdale. A motion and second carried to receive the report and consider the recommendations individually.

Recommendation number one (1) to permit use of non-Free Will Baptist instructors in non-biblical courses. A motion and second carried to table recommendation #1. (See Board Reports)

Recommendation number two (2) giving Hillsdale all funds received to date from the royalty from the Ringling property was read. A motion and second carried to adopt recommendation #2.

Recommendation number three (3) requesting clarification of future use of these funds was read. A motion and second carried to table this item until after the General Board report is made.

Charles Thigpen, President, gave a report of Free Will Baptist Bible College, Nashville, Tennessee.

Orville Hood was elected to serve as a five (5) year member on the Hillsdale Free Will Baptist College Board of Trustees.

David Sutton was elected to serve as a five (5) year member on the Hillsdale Free Will Baptist College Board of Trustees.

Jack Richey resigned from the Hillsdale Board of Trustees.

Ron Barber was elected to serve as a one (1) year member on the Hillsdale Free Will Baptist College Board of Trustees to fill the unexpired term of Jack Richey.

Following announcements, a motion and second carried to recess for the day.

WEDNESDAY EVENING WORSHIP SERVICE, OCTOBER 17, 1984

A pre-service inspirational singing time was provided by the "Harvesters", an all men singing group from Hillsdale Free Will Baptist College. They sang "I'm Yours, Lord"; "It's A Great Morning"; and "Sweet Beulah Land."

The evening service was called to order with singing led by Doug Little. The congregation sang "At Calvary."

A convention choir composed of volunteer vocalists from all of the churches and directed by Doug Little sang "King of Kings."

John Ballard presided over the service. He called on Lonnie DaVoult to lead in prayer and requested special prayer for one of our ministers, Kenneth Brandon, a patient in Veteran's Hospital.

Jim Vallance, Director of the National Master's Men, presented a book of remembrance to Jack and Lillie Metcalf containing the names of contributors to a 'Metcalf Memorial Dormitory' built in Brazil by the Master's Men and named in memory of John and Kay Metcalf.

An offering for Hillsdale Free Will Baptist College was received. The congregation sang "Power In the Blood."

The Locust Grove Trio blessed all hearts in singing "Hallelujah, He's Coming Again" and "He Cared that Much for Me."

Bailey Thompson was introduced to bring the evening message. Using the theme "In Remembrance of These Things" he delivered the message "The Practice of the Duties." An excellent sermon of Christian stewardship was received. He closed the message with prayer.

The service was dismissed.

THURSDAY MORNING SESSION, OCTOBER 18, 1984

The Thursday morning session was opened with Delbert Akin leading the congregation in singing "He Keeps Me Singing."

James Deatherage read from Col. 1:9-17 and from these scriptures led in morning devotions.

Ernest Harrison, Sr. gave the report of the National Retirement and Insurance Department.

A motion and second carried to remove from the table Recommendation number one (1) of Hillsdale Free Will Baptist College report. Following discussion the previous question was moved and the recommendation lost.

The final report of the General Board was read by the Clerk. A motion and second carried to receive the report and adopt it item by item.

Part one (1) of Item three (III) was considered.

A substitute motion and second was made that 10% of all funds received from the Ringling property go into the cooperative plan fund beginning with the check now in hand.

Since Item #2 of the Hillsdale Free Will Baptist College report has already been adopted and the essence of this motion are identical, the Moderator ruled the motion out of order.

Part two (2) of Item three (III) was considered. A motion and second carried to adopt.

A motion and second carried that beginning January 1, 1985, ten per-cent(10)% of all funds received from the royalty from the Ringling property go into the coop fund and the remainder be divided 90% to Hillsdale Free Will Baptist College and ten percent (10)% to the State Mission Board.

A motion and second made to reconsider Part 3 of Item III. The motion lost.

Part four (4) of Item three (III) was considered. A motion and second carried to adopt.

Part five (5) of Item three (III) was considered. A motion and second made to adopt.

A motion and second made to amend part 5 of Item III to read 19% to State Missions and 28% to the National Association. The amendment lost.

Part 5 of Item III was adopted.

Part six (6) of Item three (III) was considered. A motion was made and seconded to adopt.

A motion and second carried to amend part 6 of Item III by adding "and three members at large."

Part 6 of Item III was adopted.

J. B. Chism, Waldo Young and Charles Wilson were elected to serve as members at large of this committee.

A motion and second carried that the Executive Secretary set the meeting

with each board to pay mileage and cost for its chairman and the Executive Department to pay mileage and cost for the at large members. (See General Board Report)

The report of the Study commission on ordination was read. A motion and second carried to adopt the report.

A motion and second carried to recess for worship.

THURSDAY MORNING WORSHIP

Delbert Akin led the Association in singing "He Lives."

Bob Ketchum led participants to the throne of grace in prayer.

Delbert Akin led in singing "Brethren, We Have Met for Worship."

The Minister's Quartet then came and sang "More About Jesus" and "What A Beautiful Day."

Howard Gage, presiding, introduced Jerry Pilgrim as the speaker of the hour. He spoke from the theme "In Remembrance of These Things" a sermon entitled "Perpetuation of the Burial." Using Romans 6:1-12 as a text he emphasized (1) The Person of Baptism (2) The Purpose of Baptism (3) Perpetuating the Practice of Baptism and (4) The Prerequisite of Baptism.

Upon query by the Moderator, a motion and second carried to conclude business without recess.

Resolution No. Three - Adopted (See Committee Reports)

The report of the Public Morals Committee was read. A motion and second carried to adopt the report. (See Committee Reports)

The Obituary Committee report was read by the Clerk. A motion and second carried to receive the report. The Association stood and after a period of silent prayer, Ralph Hampton, Sr. lead the Association in a prayer of dedication of ourselves that we might be faithful until we too are called home. (See Committee Reports)

A motion and second carried that the Oklahoma State Association meet in Oklahoma City in 1986.

A motion and second carried to invert the usual order of electing officers with the moderator being elected first.

Jerry Dudley was elected as Moderator.

Earl Scroggins was elected as Assistant Moderator.

His election created a vacancy on the Church Training Service Board.

Phil Akin was elected as the one (1) year member of the C.T.S. Board.

Waldo Young was elected as Clerk.

J. B. Chism was elected as Assistant Clerk.

Jerry Dudley assumed the position of Moderator to conclude the session.

Following announcements, a motion and second carried to adjourn.

David Sutton led in the prayer of benediction.

THE GENERAL BOARD REPORT

The General Board of the Oklahoma State Association of Free Will Baptists met October 15, 1984 at the Civic Center of Muskogee, Oklahoma. As a result of that meeting, we offer the following items for your consideration.

- I. We received communication from twenty-two of the twenty-three Associations comprising the membership of this body. We recommend their letters be received and their delegates seated. (NOTE: The only Association who failed to report is Green Country.) (Adopted)
- II. We heard the reports of the Executive Board; the Executive Secretary; Free Will Baptist Book Store; the Sunday School Board; the Church Training Service Board; the State Mission Board; and Hillsdale Free Will Baptist College Board of Trustees.

We forward the report of the departments and recommend the reports for adoption with one exception. We recommend that Hillsdale Free Will Baptist College Board of Trustees recommendation no. 1 be forwarded with a negative recommendation. (Received)

III. Serving as Budget Committee, we offer the following:

- (1) That all funds received from the oil revenue from the Ringling property to date be dispersed by the Hillsdale Board of Trustees. (Adopted)
(2) That from the funds received from the oil revenue from the Ringling property a one time gift of \$30,000.00 be given to the Executive Department to pay off the State Office property. (Adopted)

- (3) That effective January 1, 1985, the oil revenue from the Ringling property be divided with 10% to the State Mission Board and 90% to Hillsdale F. W. B. College for a period of one year.

(Amended by the Association to read:) That effective January 1, 1985 the oil revenue from the Ringling property be divided with 10% of all funds received from the royalty from the Ringling property go into the coop fund and the remainder be divided 90% to Hillsdale F. W. B. College and 10% to State Mission Board. (Adopted)

- (4) That effective January 1, 1985 the cooperative fund be changed allocating an additional 1% to Hillsdale F. W. B. College; Church Training Service Board and Sunday School Board. (Adopted)

- (5) That we adopt a Cooperative Budget of Three Hundred Fifteen Thousand dollars for 1985-6 and that it be distributed as follows:

NOTES TO FINANCIAL STATEMENTS
JUNE 30, 1984 AND 1983

(1) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

GENERAL - The State Association of Free Will Baptists is a non-profit organization designed to provide central leadership and representation for the Free Will Baptists of Oklahoma and to handle certain receipts and disbursements of the Free Will Baptist Churches. The Association uses the fund method of accounting, whereby the fund balance represents the equity the Association has in its assets. This accounting method is generally accepted among non-profit organizations as the most feasible way of reflecting their financial activity and position.

PROPERTY AND EQUIPMENT - Property and equipment are recorded at cost. Depreciation is computed based on the estimated useful lives of the related assets. Expenditures for repairs and maintenance are charged to operations when incurred while major betterments and renewals are capitalized.

(2) MORTGAGE RECEIVABLE

The executive residence was sold on May 30, 1974 for \$20,500. The buyer assumed the mortgage on the property and gave the Association a second mortgage in the amount of \$10,300. Payments began on July 1, 1974. The rate of interest is 8% and the mortgage is for thirty years.

(3) OFFICE BUILDING

Construction of the new office building located in Moore, Oklahoma, began in March, 1983. As of June 30, 1984 and 1983, the capitalized costs were \$103,726 and \$101,467, respectively. Financing for the building came from:

- (a) Contributions from churches and individuals;
- (b) \$500 monthly payments from the Free Will Baptist Bookstore;
- (c) Current operating fund of the State Association; and
- (d) Acquisition of long-term debt as described in Note 4.

(4) LONG-TERM DEBT

As of June 30, 1984, the Association had the following long-term notes payable:

NOTES TO FINANCIAL STATEMENTS
JUNE 30, 1984 AND 1983

(1) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

GENERAL - The financial statements of the Bookstore have been prepared

on the accrual basis of accounting, wherein income and expense are recorded as they are earned or incurred.

INVENTORIES - Inventories are recorded using the first-in, first-out method of accounting and are further reduced to the lower of cost or market.

PROPERTY AND EQUIPMENT - Property and equipment are recorded at cost. Depreciation is computed based on the estimated useful lives of the related assets. Expenditures for repairs and maintenance are charged to operations when incurred while major betterments and renewals are capitalized.

INCOME TAXES - No provision for income taxes has been made due to the fact that the Bookstore is a non-profit organization exempt from income tax under Section 501 (c) (3) of the Internal Revenue Code.

- (2) The Bookstore has an agreement with the State Association of Free Will Baptists, whereby the Bookstore makes monthly payments in the amount of \$500 to the Association. The first monthly payment was made in July, 1983 and the last payment is to be made in June, 1986. During the current fiscal year, the Bookstore incurred \$6,000 of payments. In addition, during the fiscal year ended June 30, 1983, the Bookstore paid a lump sum in the amount of \$5,000 to the Association.

FOR IMMEDIATE RELEASE

The Board of Randall House Publications voted during the Fall meeting to publish a ten volume set of commentaries on the Bible, according to Dr. Roger C. Reeds, General Director.

Dr. Robert Picirilli, Academic Dean at Free Will Baptist Bible College, will serve as the General Editor of this project.

The first volume to be produced will cover the books of Romans, 1 and 2 Corinthians. Reverend Leroy Forlines, Professor of Bible and Theology at Free Will Baptist Bible College will write the commentary on the book of

Romans. Dr. Picirilli will do the writing on the two Corinthian epistles. The book of Second Corinthians will be the adult Sunday School study for the Summer Quarter, 1986. This first volume is scheduled to be released by the National Association meeting in July, 1986. Volumes covering all of the New Testament books will be completed first. Tentative plans call for the release of one volume each year until the set is completed.

In order to fund a project of this magnitude we need your commitment and cash in advance of the publication date. The prepublication price of this first volume is \$29.95 postage paid. The average number of pages in each volume is estimated to be about 700. The trim size of the pages will be 6"x9" and each volume will be encased in a hard bound cover.

The commentary may be characterized as follows. It will be analytical, exegetical, and homiletical. The major portion will be given to analyzing the text. Key words, phrases, and idioms will be exegeted. Attention will be given to homiletical possibilities in Scripture passages. This format will allow pastors, teachers, church leaders, and any serious student of the Bible to benefit from this new commentary.

Maps, charts, and diagrams will be used where appropriate.

MISSION BOARD REPORT FOR 1984

The mission board has met three times during the year. We have utilized the services of our missions director and in so doing we have been able to cut down on the number of meetings which was necessary. Too, this has enabled us to cut down on expenses.

We are supporting four full-time missionaries and a missions director at the present time. They are as follows: Jim Smith-Weatherford; Curtis Linton-Lawton; David Archer-Glenpool; and Danny Hester-Bartlesville. Berton Perry was hired as our state missions director just before our last year's meeting.

Our churches are doing very well. The first services were held in the new church at Glenpool in March of this year. Attendance and finances have been good. Danny Hester was hired in February as our new missionary in Bartlesville. He is on location and attendance is climbing. Jim Smith hopes to be able to go self-supporting by the end of this year. Curtis Linton continues to do well in Lawton. His family has been beset with personal problems this year, but in spite of this, the Lawton work is progressing.

We have had some financial difficulties this year. We were not able to send our missionaries to the National Association of Free Will Baptists in Little Rock because of our lack of funds. As you are aware, supporting four full-time missionaries and a missions director requires a great deal of money. We do not feel there is a person in our state that would be willing for us to curtail our missions outreach. In order for us to operate effectively we must have the added support of our people in Oklahoma. It has been nothing short of wonderful the way you have responded to the Church Establishment Program

(C.E.P.), but if we are to continue we must have your help. We are trusting that the Lord will help you to increase your giving to this urgent need.

OKLAHOMA STATE ASSOCIATION
OCTOBER 15-18, 1984

Greetings to Free Will Baptists of Oklahoma. Nineteen hundred and eighty-four has been a year of triumphs and tragedies.

God has moved in an unusual way in the Ivory Coast. During August, 11,000 people heard the gospel in Agnibilekrou where ARILLA WODE is working. Approximately 170 people prayed to receive Christ as saviour. Thirty new people are now in the church.

LONNIE and ANITA SPARKS are continuing to see people saved in Alcala, Spain. They rejoice in several young people who have answered God's call to service.

LYNN MIDGETT arrived in Mostoles, Spain this summer. She is doing quite well in her studies of the Spanish language and culture.

EDDIE PAYNE rejoices in what God is doing in Bouna, Ivory Coast. The church building is nearing completion. Sandra teaches 80 children in Junior Church. More than 50 are attending services in nearby Panzarani. Eddie taught 34 students in a short-term Bible institute. This fall these young men will assist Eddie in distributing 15,000 evangelistic magazines among the school children. They also plan to have Bible classes in several primary schools. Eddie also supervises the Koulango radio ministry.

DAVE and SHARON FILKINS are involved in deputation as they prepare to go to the Ivory Coast.

DENNIS and CAROL TEAGUE are returning to France. Dennis is also available for conferences and missionary services.

JERRY and JANICE BANKS have enjoyed a summer of blessings, so much that they are planning a formal organizational service soon. They are asking the Lord to provide a more suitable building for their congregation at Kita Hiroshima, Japan.

JIM and SHIRLEY COMBS are raising support in preparation to return to their ministry in Brazil.

MIKE and DELEEN COUSINEAU have returned to the Ivory Coast. This fall they are serving as dormitory parents at the school for missionary children in Bouake. In January they will move to Bouna and continue their ministry with the Paynes at the youth center and church. Last May, ELAINE ALLEN, missionary to Ivory Coast, became MRS. EARNEST HOLLAND. She is temporarily on leave of absence from the department. She and Earnest are working with a church in Texas but hope to return to Doropo, Ivory Coast within the next couple of years. DARREL and LILA NICHOLS have gone to France where they are studying the language in preparation for their ministry in the Ivory Coast.

ROBERT and JUDY BRYAN just recently returned to Abidjan, Ivory Coast. There, Robert will be the director of the Evangelical Literature Center. His ministry will benefit Free Will Baptists as well as other gospel preaching missionaries in West Africa.

EARNIE and JEAN DEEDS are now in their fifth term of service in Brazil. They are teaching, preaching and ministering to the people of Lafaiete. This city is steeped in Roman Catholic tradition and spiritism. For more than ten years, Earnie has conducted a daily radio program. Souls have been saved, a church organized and building erected for God's glory.

God has called DR. KENNETH EAGLETON, JR. to relieve human suffering and preach the gospel in the Ivory Coast. I am appealing to Free Will Baptist health care professionals to become financial partners in Dr. Eagleton's ministry. Since he was reared in Brazil he has no home base to support him. Will you share this need with the health care professionals in your church?

We are grateful for these triumphs but our hearts are still moved with compassion for the Dudley and Metcalf families. We feel a great sense of loss in the tragic deaths of JOHN and KAY METCALF, February 28. We are convinced that their example has left such a lasting impression that many more will be going to the mission fields as a result.

We really appreciate your faithful support for foreign missions. During 1983 you sent \$272,727. This was 86% of your suggested quota of \$315,000.

Through August you have sent \$211,530 toward your 1984 goal of \$350,000. With a little extra effort your great state can exceed your suggested quota.

Though never satisfied, we're pleased and grateful for what has been accomplished this past year through our board-sponsored activities.

In November of 1983, a statewide Youth Conference was held at the First FWB Church, Ada. It was estimated that 300 young people and youth workers attended this all-day event which included preaching services, a musical concert, a Christian film, a dramatic presentation, etc. We appreciate the hospitality of the Ada First Church and will be using their excellent facilities for our 1984 Youth Conference to be held there on Saturday, November 10th.

Approximately 900 attended and/or participated in the State CTS Competitive Activities and Music and Arts Festival held in May, 1984 at Hillsdale College. Many of the young people who displayed their knowledge and talents at the State meet moved on to and received honors at the national level. We thank Hillsdale for their facilities and hospitality.

Attendance at the State Youth Camps, which had been on the decline for several years, dramatically increased in 1984. Enrollment at this summer's three camps totaled 550. We have tentatively scheduled the 1985 Junior Camp for July 8-12; Junior High Camp for June 10-14; and Senior High Camp for June 3-7, all at First Mission Association's Campgrounds. We are happy to report that the designated half way mark in the acquisition of funds has been reached for beginning construction on the Library/Classroom Building. "Ground breaking" was held on September 7, and construction has begun. A special thanks goes to Free Will Baptists of Oklahoma and our neighboring states for a good response to this project. The cost of the building is \$640,000 plus \$50,000 for promotion and fund raising. The \$320,000 for beginning construction plus the \$150,000 accumulated for the building makes a total of \$470,000 toward the cost. The supplying of the remainder of the needed funds remains a task for which your continued support is vital. The completion of this building will provide an invaluable tool for the ongoing ministry of Hillsdale Free Will Baptist College.

The enrollment for the Fall semester 1984 is 156 plus 1 audit. We Praise God for an excellent student body and the 73 students from Oklahoma. They are making valuable contribution to the life and mission of Hillsdale Free Will Baptist College.

An Office of Admissions Information has been initiated under the supervision of the Director of Public Relations. This office will concentrate on student recruiting for increased enrollment. Lyndon Emberton is working in this office. We feel that good results will be forthcoming from this endeavor.

Hillsdale continues to be blessed by your financial giving. The cooperative fund gifts are greatly appreciated and continue to add to the stability of Hillsdale's financial picture. However, there is a need to raise the level of giving to the general fund. While the level of expenditures has increased, the level of giving to the general fund has not. Special concentration is being focused upon this and you will be hearing from the Promotional Department as plans are unveiled to bring this giving to a level that will meet growing needs. Your positive response to this need will allow Hillsdale to minister more effectively

to our churches. Actually, a small effort on the part of everyone will make a great difference.

We express appreciation for a good working relationship with Brother Lonnie DaVoult. His interest in the college and his promotion of the work here is invaluable.

A special "thanks" goes to each of you for your support as Hillsdale strives to be a servant to the churches.

RECOMMENDATION NO. 1

The Board of Trustees recommends to the State Association that the Bylaws of Hillsdale Free Will Baptist College be amended to allow the employment of full-time Christian faculty members for non-biblical courses only who are not members of a Free Will Baptist Church.

The following matter is respectfully submitted by the Board of Trustees of Hillsdale Free Will Baptist College for confirmation and/or clarification:

WHEREAS the Board of Trustees of Hillsdale F. W. B. College have been operating under the assumption that the royalty income derived from the Ringling Property has been designated by the State Association for use by Hillsdale F. W. B. College for its growth and development, and at the direction and under the supervision of its Board of Trustees; and

WHEREAS the Board of Trustees of Hillsdale F. W. B. College desire (i) to provide for all the various needs within the State Association, (ii) to share and use wisely the blessings which the Lord has bestowed upon the entire State Association, (iii) to preserve and promote harmony and unity of mind and spirit among the constituency of the State Association, and (iv) to carry out and fulfill the desires and objectives of the State Association with respect to the uses applications of all revenues received from the Ringling Property.

NOW, THEREFORE, the Board of Trustees of Hillsdale F. W. B. College hereby respectfully requests that the matter of the uses and applications of all revenues derived from the Ringling Property be submitted to the body of the State Association for:

RECOMMENDATION NO. 2

Confirmation and ratification of all uses and applications of the Ringling Property revenues to date by the Board of Trustees of Hillsdale F. W. B. College; and

RECOMMENDATION NO.3

Clarification and direction regarding the State Association's desires with respect to the future uses and applications of the Ringling Property revenues.

Except as explained in the following paragraph, our examinations were made in accordance with generally accepted auditing standards and, accordingly, included such tests of the accounting records and such other auditing procedures as we considered necessary in the circumstances.

As discussed in Note 5 to the financial statements, the College did not maintain a record of fixed asset additions and retirements prior to June 30, 1975; and, as such, we were unable to obtain sufficient evidence to form an opinion as to the basis on which fixed assets were stated.

In our opinion, except for the effects of such adjustments, if any, as might have been required with respect to the fixed asset accounts, the financial statements referred to in the first paragraph present fairly the financial position of HILLSDALE FREE WILL BAPTIST COLLEGE as of June 30, 1984 and 1983, and the changes in fund balances and the current funds revenues, expenditures and other changes for the years then ended, in conformity with generally accepted accounting principles applied on a basis consistent with that of the preceding year.

NOTES TO FINANCIAL STATEMENTS
JUNE 30, 1984 AND 1983

(1) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

GENERAL - The significant accounting policies followed by the Hillsdale Free Will Baptist College are described below to enhance the usefulness of the financial statements to the reader.

ACCRUAL BASIS - The financial statements of the Hillsdale Free Will Baptist College have been prepared on the accrual basis of accounting except for depreciation. Depreciation is not taken on depreciable assets comprising the physical plant in conformity with the reporting objectives of accounting for resources received and used rather than the determination of net income. The statement of current funds revenues, expenditures and transfers is a statement of financial activities of current funds related to the current reporting period. It does not purport to present the results of operations or the net income or loss for the period as would a statement of income or a statement of revenues and expenses.

FUND ACCOUNTING - In order to ensure observance of limitations and restrictions placed on the use of the resources available to the College, the accounts of the College are maintained in accordance with the principles of "fund accounting." This is the procedure by which resources for various purposes are classified for accounting and reporting purposes into funds that are in accordance with activities or objectives specified. Separate accounts are maintained for each fund; however, in the accompanying financial statements, funds that have similar characteristics have been combined into fund groups. Accordingly, all financial transactions have been recorded and reported by fund group.

RECLASSIFICATIONS - The June 30, 1983, financial statements have been reclassified to conform to current year formats. These reclassifications were not material to the financial statements.

(2) INVESTMENTS

Investments exclusive of physical plant are recorded at cost; investments received by gift are carried at market value at the date of acquisition. As of June 30, 1984 and 1983, investments of the restricted and unrestricted funds were composed of the following:

(3) LOAN FUND

The loan fund reflects activity with respect to the National Direct Student Loan program which is funded primarily by the Department of Education. The College provides matching funds equal to one-ninth of the Federal funds received. This program, along with the College Work-Study, Pell Grant and Supplemental Educational Opportunity Grant programs have been reported under a separate audit report to the Department of Education.

(4) ENDOWMENT FUND

During the current fiscal year, the governing board of the College determined that certain funds were to be retained and invested as an endowment. The board stipulated that the principal is to remain invested and the interest income is to be placed in the current unrestricted fund. On September 16, 1983, an investment in a limited partnership was made in the amount of \$87,000. In addition, as of June 30, 1984, an amount of \$21,199 which was in the current fund was designated to be transferred to the endowment fund.

(5) INVESTMENT IN PLANT

The College did not maintain adequate historical cost accounting records for fixed asset acquisition and retirements in years prior to June 30, 1975. Best available estimates of historical costs were used to record \$871,093 of fixed assets acquired prior to June 30, 1975. However, fixed asset acquisitions made subsequent to that time and through June 30, 1983 totaling \$565,435 were properly accounted for and recorded using the historical cost basis as were current year acquisitions which totaled \$50,957.

NATIONAL ASSOCIATION OF FREE WILL BAPTISTS

Dear Brethren:

Thank you for the privilege of sharing this report in your Annual Associational meeting! It is good to bring you greetings from our department and to express our appreciation for the prayers and financial help from your churches.

This year we have twenty chapters in Oklahoma. Four other chapters need to renew membership now. Our membership is now based on the anniversary date of each chapter. The date for renewal this year will be the date for renewal each year. I pray we will be able to welcome more of you into our membership soon.

Our denomination has from 30,000 to 50,000 men. Eventually, I hope to see a majority of our men involved in active service for the Lord in Master's Men. A total of 2,568 men were members.

Financially, 1983 was a good year also. The Department was able to retire several outstanding debts. Now, we are working on current billings. Thank you for the help your state has given through Co-operative giving and gifts. In 1983 you gave \$9,032.92 to Master's Men Department. Your state gave the largest amount of all the states where Free Will Baptists minister.

Last year Master's Men received \$24,362.06 through Co-op. That was nearly half our spendable income. We couldn't have made it without those funds. Every Free Will Baptist church should support the *entire* work of our denomination through Co-operative giving.

Our 1984 theme has been "Sharing the Load" from Exodus 18:22. Moses was to choose men to help judge his people. They were to be *able* men, such as *fear God* and men of *truth*. I believe we have such men today in our ranks; men who want to be about the Father's business; men who need the sense of achievement from daily service for the Master. Will you allow your men to grow this way?

You are already aware of the results of Master's Men sharing the load this year, but I want to remind you of several accomplishments.

- * Master's Men have raised over \$8,000 to build the Metcalf Memorial Dormitory in Brazil.
- * Two Tennessee laymen volunteered three weeks of labor on that project. Mr. Carroll Poole and Mr. Don Wilbanks labored hard while there.
- * Master's Men Board members chose Mr. R. L. (Bob) Sharp as the Layman of the Year for 1983. You can be proud of your State Senator from the Bethany Free Will Baptist Church in Tulsa.
- * Master's Men handled ushering and security at the National convention in Little Rock, Arkansas. They saved over \$4,000 in convention expenses by performing that task so well.
- * The Sixth National Conference ministered to 177 men from 18 states. Nearly two dozen pastors came with their men for the fellowship and worship. The seventh conference will meet April 25-27, 1985 at Camp Linden

in Tennessee. The guest speaker will be Rev. Keith Burden, pastor of the largest Master's Men chapter in the nation.

- * Project Tool Shed funds purchased a \$900 memory typewriter for use in Ivory Coast, Africa. Mike and Deleen Cousineau carried the typewriter with them in June when they returned for their second tour of service.
- * October 7th was Master's Men Day. Just last Sunday every Free Will Baptist church was asked to share our financial load. Master's Men only ask for one offering a year. Our needs from that appeal are \$10,000.

January 1985 begins the Master's Men DECADE OF DISCIPLESHIP. The theme for the first year is "Committed to Christ's Commission." I pray this will be ten years of spiritual and numerical growth for the churches who participate.

Every man needs to be able to disciple other men. This is a command from our Lord. Pray with us that we will begin to more fully fulfill His command. This is a time that demands great things of God's people to reach a needy world.

The forty-fourth annual convention of the Oklahoma State Woman's Auxiliary convened October 16, 1984, at the Muskogee Civic Center, Muskogee, Oklahoma. The meeting was opened with comments from our President, Judy Puckett, who introduced our song leader, Carole Carner. The congregation sang 'He is Lord,' 'Fill My Cup,' and a theme song taken from Phillippians 4:6 and 7, which was written by Carole Carner for our meeting.

Betty Wells, President of South Grand River District, welcomed approximately 200 ladies who gathered for the occasion. A sextet from the Locust Grove church sang "Jesus is Still the Answer," after which our devotion was given. These Committees were asked to meet for a short time during our recess. We were to reconvene at 11:00 for the worship hour.

As we met to worship, Carole Carner led us in singing "Spend a Little Time with Jesus in Prayer." Ramona Van Winkle brought our special music "There is Peace in the Midst of My Storm," accompanied by Joyce Little.

Our special guest speaker, Lynn Miley, missionary to France, brought us greetings from the Foreign Missions Department. Using the theme, "Everything by Prayer" (Phillipians 4:6), Bro. Miley gave examples of how prayer had been answered in their lives, through His Presence, His Protection

(3) Be it resolved that we give Bro Lynn Miley \$400.00 for a personal love offering and expenses in appreciation for speaking today. (4) In keeping with WNAC Resolution 2A, be it resolved that each local Auxiliary send \$1.00 *per Auxiliary* along with representation fees, beginning in 1985 and each year thereafter. (5) That the State President appoint a 5-member Study Committee to make plans for the 1986 WNAC in Tulsa and report their recommendations to the 1985 State Auxiliary meeting.

THE FREE WILL BAPTIST MASTER'S MEN State of Oklahoma CONSTITUTION

PREAMBLE

The purpose of the Free Will Baptist Master's Men, state of Oklahoma is to provide a means of Christian fellowship and to deepen the spiritual lives of the laymen of the local church. Also, to provide a means of developing the abilities and talents of the laymen, and to promote the cause of Christ through a complete, "total church program," as prescribed by Oklahoma State Association of Free Will Baptists.

ARTICLE I NAME

The name of this organization shall be known as the Free Will Baptist Master's Men, State of Oklahoma.

ARTICLE II MEMBERSHIP

Section 1. The membership of this organization shall be composed of the district associations of Master's Men, and any local chapters where there is only

one chapter in the district, within the state of Oklahoma.

Section 2. Every member in good standing of an affiliated district association of Master's Men, or any local chapter where there is only one chapter in the district, is entitled to the full benefits of membership.

Section 3. Each district association, or any local chapter where there is only one chapter in the district, shall submit an annual, written report to this body, (as a matter of information).

ARTICLE III OFFICERS

The officers of this organization shall consist of a president, vice-president and a secretary-treasurer.

The officers of this organization shall be elected annually and may succeed themselves, at this level.

ARTICLE IV EXECUTIVE COMMITTEE

Section 1. The executive committee shall consist of the elected officers of this organization and they shall serve as the program committee for each annual convention.

Section 2. Ex-officio members of the executive committee shall be the presidents of the district associations of Master's Men, presidents of any local chapter where there is only one chapter in the district, and the state executive secretary of the State Association of Free Will Baptists.

ARTICLE V MEETINGS

This organization shall meet annually at 7:30 P.M. on the Monday night before the Oklahoma State Association of Free Will Baptists convenes.

ARTICLE VI AMENDMENTS

This constitution may be amended by a two-thirds vote of any regular meeting.

BY-LAWS

VOTING RIGHTS

Section 1. Every member of each affiliated district association, or any local chapter where there is only one chapter in the district, is eligible to vote on all questions and matters that might come before the Free Will Baptist Master's Men, State of Oklahoma.

COMMITTEES

Section 2. The executive committee shall transact all routine business and shall act for the organization in the interim between meetings.

Section 3. The executive committee shall meet at the call of the president.

Section 4. A nominating committee, for the annual election of officers, shall be composed of the presidents of each district association, and the president of any local chapter where there is only one chapter in the district.

Section 5. The president shall appoint all other committees, subject to the approval of the body.

FINANCE

Section 6. This organization shall be financed on the basis of offerings, dues and assessments.

QUORUM

Section 7. One-tenth of the members of this organization shall constitute a quorum at any regular meeting.

AMENDMENTS

Section 8. These by-laws may be amended at any regular meeting by a two-thirds vote of the members present.

As adopted by the Free Will Baptist Master's Men, State of Oklahoma annual session, in Muskogee, Oklahoma October 19, 1970.

CONSTITUTION OF MINISTER'S CONFERENCE

ARTICLE 1

The Minister's Conference shall be called the Oklahoma State Free Will Baptist Minister's Conference, and shall be composed of Ordained Free Will Baptist Ministers who are regular members of some Orthodox Free Will Baptist church in the State of Oklahoma who have paid their \$1.00 dues.

ARTICLE 2

The officers for this conference shall be President, Vice-President, and Clerk Treasurer, who shall be elected annually.

ARTICLE 3

This conference shall have the power to discipline its members.

ARTICLE 4

Members of this organization shall be all ordained ministers who participate in the benefits and activities of this body, and associate members who become members by payment of the \$1.00 annual dues.

ARTICLE 5

This conference shall meet Semi-Annually.

ARTICLE 6

This constitution may be amended by a two-thirds vote of the members present at any regular session.

BY-LAWS OF MINISTER'S CONFERENCE

ARTICLE 1

The clerk or assistant clerk, or in their absence the senior minister in years shall call the ministers into conference. If a quorum is present the President or in his absence the Vice-President shall moderate the meeting. If neither of these are present, the senior minister in years shall be in charge.

ARTICLE 2

It shall be the duty of the clerk to enroll the ministers of the conference. Ministers shall present themselves with proper evidence of their rights to seats therein, and those enrolled by the clerk shall compose the conference. In case of questionable representation the case under question shall be referred to the Credential Committee.

ARTICLE 3

It shall be the duty of each minister belonging to this conference, to be active in pastoral or evangelistic services (disabled or retired ministers excepted). Any minister belonging to this conference shall report in each session in person or by letter, and failing to do so for two successive sessions shall be subject to discipline.

ARTICLE 4

Each conference shall be opened by reading a portion of God's word and prayer, and each session shall be closed with prayer.

ARTICLE 5

By a two-thirds vote of the members present ruling of the President may be overruled.

ARTICLE 6

This conference shall sit with open doors, except when it shall go into a committee as a whole.

ARTICLE 7

No member shall absent himself from the conference during its meeting without permission from the President.

ARTICLE 8

No person shall be allowed to nominate more than one member of a committee, unless person nominated is not elected.

ARTICLE 9

The President shall not allow discussion when not carried on in a Christian Spirit, or when he thinks it will cause discord.

ARTICLE 10

Anyone desiring to speak shall rise and address the President by the appellation "Brother President," but shall not speak further until recognized.

ARTICLE 11

No member of this conference shall be allowed to speak more than five minutes, nor twice on the same subject without permission from the President.

ARTICLE 12

These By-Laws may be altered or amended at any regular or adjourned session of this conference by a two-thirds vote of the members present.

HILLSDALE FREE WILL BAPTIST COLLEGE, INC. BY-LAWS BOARD OF TRUSTEES

SECTION I

The Board of Trustees of Hillsdale Free Will Baptist College, Inc., an Oklahoma corporation, shall be composed of fifteen members, elected as provided in the Articles of Incorporation of said College, as amended:

ARTICLE A—OFFICERS: The officers of the Board of Trustees shall be a Chairman, an Assistant Chairman, and a Secretary, each of whom shall be elected by the Board for a term of one year. They shall continue in office until their successors have been chosen:

Item 1—CHAIRMAN: The chairman of the Board of Trustees or his assistant shall preside at all meetings of the Board. He shall be an ex-officio member of the Executive Committee.

Item 2—SECRETARY: The Secretary shall record and preserve minutes of all meetings and acts of the Board of Trustees and countersign all deeds, conveyances, and other papers authorized by the Board. He shall have authority to call special meetings of the Trustees of the College upon the written request of two-thirds of the members of the Board; he shall mail notice of said meeting to the trustees ten (10) days in advance.

Item 3—EXECUTIVE COMMITTEE: The Executive Committee shall consist of the Chairman of the Board of Trustees, the Vice-Chairman of the Board, the Secretary of the Board. The Executive Committee shall have authority to consider and act upon all questions affecting the College which may be brought before it between the stated meetings of the Board, or a quorum of the Board fails to attend a called or regular meeting. It shall transact such business as may be committed to it by the Board and shall act for the College on such matters as it may submit to it. The Committee shall meet at the call of the Chairman or the President of the College.

ARTICLE B—MEETINGS: The Board of Trustees shall meet each year at a time and place agreed upon by the Board. It shall, also, hold special meetings whenever called in accordance with the By-Laws of the Board. Such special meetings may be called by either the chairman of the Board, or the President of the College.

ARTICLE C—QUORUM: A majority of the members or the Board of Trustees of Hillsdale Free Will Baptist College, Inc. in attendance at any called or regular meeting, written notice of which has been mailed by the Secretary to each trustee, shall constitute a quorum. No proxy votes shall be permitted. No ex-officio member shall be entitled to vote at meetings of the Board of Trustees.

ARTICLE D—ELECTIONS: In all elections held by the Board of Trustees each member present except ex-officio members shall be entitled to one vote, and the result shall be determined by a majority of the votes cast. Due notice of any election must be personal notice to the members or a day on the minutes of the Board not less than one week preceding the election.

SECTION II OFFICERS OF HILLSDALE FREE WILL BAPTIST COLLEGE

The officers of Hillsdale Free Will Baptist College shall be a President who is elected by the Board of Trustees for an indefinite term. Other officers shall be a Vice President of Academic Affairs, Vice President of Student Affairs, and a Vice President of Business Affairs, each of whom shall be appointed by the President with the approval of the Board of Trustees.

ITEM ONE—PRESIDENT: The President shall be executive officer of the Board of Trustees and shall have general control of the College including its officers, teachers, students, and business. He shall render to the Board complete annual reports and to its chairman, Executive Committee or other committees such information as may be deemed essential to a thorough knowledge of the operation of the College and its promotion. He shall be a member of the Board of Trustees ex-officio and the Executive Committee ex-officio and shall have the rights and privileges of a member of the Board except voting. The President shall execute all documents, instruments, and conveyances on behalf of the college. Duties of the president and working relationship shall be further detailed in a format approved by the Board of Trustees.

ITEM TWO—VICE PRESIDENT OF ACADEMIC AFFAIRS: The Vice President of Academic affairs of the College shall, under the President, fix the hours of recitation, govern, control, and regulate the conduct of the students, have general oversight of curriculum, student's records, and such other internal details and administrative duties as may be delegated to him by the President of the College.

The Vice President of Academic Affairs shall act as President in the absence of the President.

ITEM THREE—VICE PRESIDENT OF STUDENT AFFAIRS: The Vice President of student affairs shall be responsible for directing the religious activities of the College, serve as counselor to the students, and such other duties as may be delegated to him by the President of the College.

ITEM FOUR—VICE PRESIDENT OF BUSINESS AFFAIRS: The Treasurer shall keep an accurate record of all accounts of the College and shall receive and expend as directed by the Board of Trustees and President, all money for the expenses of the institution. He shall make an annual report to the Board and furnish the Executive Committee with such information pertaining to his office as may be requested. He shall provide bond in whatever amount the Board may require. Until such times as the Board of Trustees may deem different the Treasurer's office shall be contained within the Vice President of Business Affairs office. The Vice President of Business Affairs may at the direction of the administration designate this duty to a subordinate officer. The Vice President of Business Affairs shall have general supervision of the financial business of the College, and shall, at the direction of the President, be responsible for the upkeep of all the physical facilities and premises of the College. His detailed duties are directed in a format approved by the Board of Trustees.

SECTION III FACULTY

The faculty shall consist of the President, the Vice President of Student Affairs, and all teachers of Hillsdale Free Will Baptist College. Instructors and assistant teachers shall have the privilege of sitting with the faculty in stated meetings but shall not have the right of voting.

It shall be the policy of the College to employ on its faculty those who are members of Free Will Baptist churches that are affiliated with the National Association. Emergencies, however arising from the resignation, illness, death, or approved leaves of absence of faculty members may be relieved by the temporary employment of instructors who are affiliated with any evangelical denomination. Part-time or short-term instructors, deemed essential to the successful prosecution of a consistent education program, may be employed at the discretion of the President without respect of denominational affiliation.

The faculty, under the authority and jurisdiction of the President, shall have general charge of instruction, attendance of students, examinations, administration of curriculum, discipline, and all matters involving the spiritual, physical, and social welfare of the College. The faculty shall be hired upon recommendation of the President.

In the selection of the faculty qualitative factors shall be kept in mind. All faculty members shall be urged to pursue graduate programs in their respective fields. Except in special cases no faculty member will be required to teach courses outside of his field.

SECTION IV ACADEMIC COUNCIL

The Academic Council shall consist of the President, the Vice President of Student Affairs and the heads of the departments of Hillsdale Free Will Baptist

College: It shall determine the curriculum and academic policy of the College, prescribe requirements for admissions, certificates, diplomas, and degrees, and supervise the courses of instruction offered by the various departments of the College.

SECTION V CONTRACTS

The Board of Trustees shall establish the College policy involving the execution of contracts, deeds of conveyance, the determination of salaries, and employment of all officers, representatives, faculty members and essential domestic and maintenance employees. The President of the College shall negotiate agreements, executive contracts, employ representatives, and supply vacancies incurred by the termination of contracts, resignations, or death of any essential employees. All contracts for building construction shall be let only to persons or corporations posting a valid performance bond and recording the same in the Office of the County Clerk of Cleveland County, Oklahoma.

SECTION VI ADVISORY COUNCIL

An advisory council shall be formed which is to be composed of interested, qualified persons in the various fields which will be of value in building and maintaining a strong academic program to carry out the educational program stated in the charter.

SECTION VII AMENDMENT

These By-Laws may be amended by a favorable vote of two-thirds of the qualified members of the Board of Trustees of Hillsdale Free Will Baptist College at any meeting of the Board, provided that the proposed amendment has been submitted in writing to each Trustee one month in advance. This change to be subject to the Oklahoma State Association of Free Will Baptists.

SECTION VIII ADMINISTRATIVE FUNCTIONS

The President of the Hillsdale Free Will Baptist College shall be elected by the Board of Trustees, and he shall act for and on behalf of the Board in the conduct and management of the institution. He shall also be a member of the Board of Trustees ex-officio and of the Executive committee, ex-officio, and his duties, powers and term of office shall be prescribed in the by-laws of the College and a format approved by the Board of Trustees.

ARTICLES OF INCORPORATION OF THE HILLSDALE FREE WILL BAPTIST COLLEGE, INC.

Know all men by these presents, that, we whose names are hereunto subscribed, do hereby associate ourselves together for the purpose of forming a cor-

poration under the provisions of the corporation laws of the State of Oklahoma, and for that purpose state:

ARTICLE ONE

The name of this corporation shall be HILLSDALE FREE WILL BAPTIST COLLEGE, INC.

ARTICLE TWO

The purpose of this corporation shall be the creation, establishment and maintenance of a college and institution of higher learning devoted to the promotion and impartation of higher learning, Christian education and such other education, instruction, learning, training and research as may be deemed essential for the cause of Christ and to that end prescribe courses of study and grant degrees. The doctrinal and theological position of this institution shall be that of the sponsoring denomination, Oklahoma State Association of Free Will Baptists and the treatise of the National Association of Free Will Baptist as endorsed by the state body, and in connection therewith, in accordance with the stipulation of the Constitution and By-laws of the State Association of Free Will Baptists, Inc.

(a.) To prescribe courses of study for both resident and correspondence students, which shall include general education in the arts, Christian Ministries of Service and Biblical studies for wisdom; said courses to be taught in both a Junior College Division and a Bible College Division, and to award degrees, either graduate or post-graduate, to those persons satisfactorily completing the prescribed courses of study and to grant such other literary honors, including honorary degrees, as shall be deemed advisable.

(b.) To charge and collect tuition as determined by the Board of Trustees and to create scholarships.

(c.) To employ professors, instructors and other subordinate employees as may be necessary for the proper conduct of the college under the direction and control of the President of the College, with the advice and consent of the majority of the Board of Trustees.

(d.) To institute and carry on missions and commissions for missionary purposes and investigations.

(e.) To publish and distribute such pamphlets, literature or books as may be required in the conduct of such work and the general promotion of the College.

(f.) To sue and be sued in its corporate name and to enter into contracts of every type and nature.

(g.) To solicit support, receive, collect, hold and receive by gift or bequest personal property in any amount, money or other thing of value; to purchase real estate, to receive real estate that may be given, or devised to the college for achieving the legitimate ends of the college and to sell or mortgage the same as the need arises.

(h.) To borrow money in payment of property for erecting buildings and making improvements and for any other purpose germane to the objectives and purposes of the college.

(i.) To issue notes, bonds, debentures and other evidences of indebtedness and execute mortgages, liens and other incumbrances upon the property of the

corporation, real or otherwise, to secure the payment of any such evidences of indebtedness.

(j.) To transact any and all business connected with said College as may be necessary to achieve the purposes of said College.

(k.) To obtain under Internal Revenue Laws of the United States and of the Revenue Laws of the State of Oklahoma exemption from income property and other forms of taxation.

ARTICLE THREE

The location of this corporation shall be in Moore, Oklahoma.

ARTICLE FOUR

The duration of this corporation shall be perpetual.

ARTICLE FIVE

The general control of this corporation shall be vested in a Board of Trustees consisting of 16 members, 10 of which shall be elected by the delegates to the annual Oklahoma State Association of Free Will Baptists—each of which shall serve for a term of 5 years, and until his successor is elected and qualified. Two members shall be elected at each annual sitting of the State Association for the expiring five year term and vacancies that occur on the board. One member each shall be elected by the delegates to the annual meeting of the State Association of Free Will Baptists of the states of Arkansas, Colorado, Kansas, Missouri, New Mexico, and Texas, each of which serve for a term designated by the states they represent.

ARTICLE SIX

An executive committee consisting of the Chairman, Vice Chairman, and Secretary of the Board of Trustees shall possess all powers of the Board of Trustees between the stated meetings of the Board of Trustees.

ARTICLE SEVEN

All contracts for building construction shall be let only to persons or corporations posting a valid performance bond and recording the same in the office of the County Clerk of Cleveland County, Oklahoma.

SECTION IX AMENDMENTS

This charter may be hereafter amended subject to the provisions contained herein and the laws of the State of Oklahoma. It is provided, however, that the Trustees of the College shall not propose or apply for any amendment which has not been previously authorized by an act of the Oklahoma State Association.

OKLAHOMA STATE WOMAN'S AUXILIARY CONVENTION CONSTITUTION AND BY-LAWS

ARTICLE I

NAME

This organization shall be known as the Oklahoma State Woman's Auxiliary Convention.

ARTICLE II

PURPOSE

The purpose of this convention shall be to bring the women of each district convention together for fellowship, sharing information, and encouraging one another in the work of the Lord.

ARTICLE III

OFFICERS

The Officers of this convention shall be a president, vice president, secretary, assistant secretary, treasurer, and field worker. These shall serve on the state executive committee together with three members elected by the convention as desired. These shall serve for a period of 2 years.

ARTICLE IV

MEMBERSHIP

This convention shall be composed of the officers of the convention together with each active auxiliary member of the district or local (duly accredited by the credentials committee).

ARTICLE V

MEETINGS

The annual meeting shall be held each year on the day preceding the Oklahoma State Association of Free Will Baptists and at the place designated by said Association.

ARTICLE VI

AMENDMENTS

This constitution may be amended at any annual meeting of the convention by a two-thirds vote of members present.

BY-LAWS

ARTICLE I

DUTIES OF OFFICERS

Section 1, President. The president shall preside over all meetings, appoint such committees as may be needed, call the executive committee together when necessary, be ex-officio member of all committees, and serve as chairman of the executive committee, see that reports are made promptly to the national secretary and perform all duties usually pertaining to such an office.

Section 2, Vice President. The vice president shall preside in the absence of the president or by her request and otherwise assist her in the overseeing of the work in general.

Section 3, Secretary. The secretary shall keep an accurate record of all proceedings of the convention and executive meetings, preserve all valuable papers and turn same over to her successor in office, and make an annual report to the national secretary on a form available from the NWAC office. She shall compile the districts slates of officers and addresses immediately after the convention. She shall also send a slate of state officers and addresses to the national executive secretary. She is chairman of the Credentials Committee.

The secretary shall also serve as historian keeping an historical record and submitting historical information to the national executive secretary annually.

Section 4, Assistant Secretary. The assistant Secretary shall assist the secretary in recording proceedings of convention and executive committee meetings and shall aid the secretary in all her work as needed.

Section 5, Treasurer. The treasurer shall have charge of all funds belonging to this convention and shall pay out same only when authorized by the convention. The treasurer shall keep an accurate account and shall give a written report of all funds received and disbursed at each annual meeting of the convention. She shall also send an annual report to the WNAC office (executive secretary-treasurer) at least ten days before the end of the fiscal year. She shall encourage support of missions through the WNAC Gift Plan, individual giving and special offerings.

Section 6, Field Worker. The field worker shall have charge of all field work pertaining to, or necessary to, the promotion of the work of the convention and keep the national program before the district officers.

ARTICLE II

ELECTIONS

The general officers shall be nominated by a nominating committee and shall be elected by acclamation, unless there are other nominations. In case of more than one nominee for any particular office, a vote will be taken on each. All elections shall be held at the closing business session of the convention.

ARTICLE III

EXPENSES

Section 1. An appropriation of 18 cents per mile toward the expense of the general officers, when called upon to attend the executive committee meeting to plan program, secretary's expenses, phone calls, postage and stationery for officers will be paid by the convention. All field promotional work is subject to the state executive committee, who should approve all work done by state officers in the interest of state work, as well as expenses of the same.

Section 2. An amount of \$100.00 shall be paid on the expense of the state president to attend WNAC. If the president is unable to go to WNAC that we give the \$100.00 for this purpose to whomever goes in her place providing she is a state officer.

Section 3. The auditing committee shall be paid mileage the same as the executive committee.

ARTICLE IV

COMMITTEES

Section 1. Executive Committee—The executive committee shall be composed of the five officers and three members elected by the convention. Five of these shall compose a quorum. They shall hold meetings for the transaction of business as often as necessary. It shall be the duty of the executive committee to maintain an overseeing of the work at large. They shall act for the convention when necessary. They shall meet with district presidents the night preceding the state auxiliary convention. They will send out a newsletter with expenses paid by the State Treasury.

Section 2. Resolutions Committee—A resolutions committee of five members shall be appointed by the president as needed.

Section 3. Nominating Committee—The nominating committee shall be composed of at least one member from each district convention. Nominations shall be submitted by district with their annual report. These elected by the body at the annual meeting.

Section 4. Credentials Committee—The secretary shall be chairman of the credentials committee, and other members may be appointed by the president. The treasurer shall be a standing member of this committee.

Section 5. Finance Committee—The finance committee shall be appointed by the president. This committee audits the financial records of the year and reports on same to the convention.

Section 6. Registration committee shall be provided by the district convention which is host to state convention.

ARTICLE V

FEES AND REPORTS

Active members shall pay dues of \$1.50 per year. With 25 cents remaining in the district, \$1.25 to be forwarded to state where 25 cents shall be retained, and \$1.00 forwarded to WNAC as required for membership fees. It shall be the duty of each body directly affiliated with the State Auxiliary Convention to send a report to every annual session.

ARTICLE VI

AMENDMENTS

These by-laws may be amended by a two-thirds vote of members present at regular meeting of the state auxiliary convention.

ARTICLE VII

GIFTS

The desired plans for giving in the Woman's Auxiliary are those adopted by WNAC as follows:

1. Mission offerings following each special season of prayer
2. Co-Laborer offering (monthly or quarterly designated to WNAC General Fund)
3. WNAC Emphasis Month in August or other time more convenient to help in support of WNAC General Fund

4. Memorial Student Loan Fund (special program and offering in September to assist worthy and needy students at FWBBC in Nashville)
5. Hillsdale Free Will Baptist College Student Loan Fund. (Special program and offering in September to assist worthy and needy students at Hillsdale Free Will Baptist College)
6. Tithes—Pay tithes on all undesignated money received
7. All offerings are to be forwarded through regular channels.

ARTICLE VIII

WNAC DELEGATE

Each district convention shall submit one nomination for a State delegate to WNAC with their annual report. This nomination (along with others as needed to make up 15 delegates to WNAC) shall be elected by the body at the annual meeting. It shall be the duty of delegates elected to notify president if they cannot attend WNAC. President shall appoint delegates as needed in absence of regular elected delegates.

ARTICLES OF FAITH OF STATE ASSOCIATION

1. **THE BIBLE**—The Scriptures of the Old and New Testament were given by the inspiration of God, and are our infallible rules of faith and practice.

2. **GOD**—There is one living and true God, revealed in nature as the Creator, Preserver and Righteous Governor of the Universe, and in the Scriptures as the Father, Son and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore and obey.

3. **CHRIST**—Christ is God manifest in the flesh: in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified. He is now risen and glorified as our ever-present Saviour and Lord.

4. **THE HOLY SPIRIT**—The Scriptures assigns to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of all men.

5. **THE GOVERNMENT OF GOD**—God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of Grace, not otherwise provided for as highest welfare of man requires.

6. **THE SINFULNESS OF MAN**—Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore inherited a fallen nature of such tendencies that all who come to years of accountability, sin and become guilty before God.

7. **THE WORK OF CHRIST**—The Son of God, by His incarnation, life, suffering, death, and resurrection effected for all a redemption from sin that is full and free and is the ground of salvation by faith.

8. **THE WORK OF SALVATION**—The conditions of salvation are:

1. Repentance or sincere sorrow for sin and the hearty renunciations of it.
2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord, with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit; freed from the dominion of sin and becomes a child of God.
3. Continuance in faith and obedience until death.

9. **ELECTION**—God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ, men become His elect.

10. **FREEDOM OF WILL**—The Human will is free and self controlled, having power to yield to the influence of the truth and the Spirit and live, or to resist them and perish.

11. **SALVATION FREE**—God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take the water of life freely.

12. **PERSEVERENCE**—All believers in Christ, who through grace persevere in holiness to the end of life, have the promise of eternal salvation.

13. **BACKSLIDING AND APOSTASY**—A person who has been regenerated or born again and is living in unconfessed, unforgiven sin, is rebellious to the principles of the Kingdom of God and His righteousness, and therefore is a backslider in a lost condition who must repent and be restored to the right relationship with God or be eternally lost.

We recognize, according to Hebrews 6:4-6, that it is possible for a person to get in the condition that he could never return to Christ. This, we believe, is Apostasy; However, we also recognize that a regenerate person can fall into sin, be in a lost condition and still not be an Apostate. This person, through repentance, can be reconciled to God.

14. **GOSPEL ORDINANCES**—Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel; Feet Washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers.

15. **TITHING**—God commanded tithes and offerings in the Old Testament; Jesus Christ endorsed in the Gospel (Matt. 23:23), and the Apostle Paul said, "Upon the first day of the week let every one of you lay by him in store as God hath prospered him." 1 Cor. 16:2.

16. **THE CHRISTIAN SABBATH**—The divine law requires that one day in seven be set apart from the secular employment and amusements for rest, worship, holy works and activities, and for personal communion with God.

17. **RESURRECTION, JUDGMENT, AND FINAL RETRIBUTION**—The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation: then the wicked shall "Go away into eternal punishment but the righteous into eternal life."

RULES OF ORDER

1. At every sitting of the Association, business shall be opened and concluded by prayer by the Moderator or whomever he may request.

2. Ministers and deacons present are invited to seats, allowed to take part in debates on all subjects, and to vote.
3. Those who speak shall rise and address the Moderator. Personal reflections shall be avoided in all debates.
4. No motion may be discussed until made and seconded.
5. When a motion has been made and seconded, and a member opposes its discussion, the Moderator shall put the question, "Shall it be discussed?" If negative, the question shall not be discussed.
6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member, and the vote taken separately.
7. Motions made and lost shall not be recorded.
8. No one shall speak more than twice on the same subject without special leave of the Moderator.
9. All questions shall be decided by a majority vote of all Members present.

BY-LAWS OF STATE ASSOCIATION

1. The Clerk or assistant clerk, or in their absence, the senior minister in years shall call the Association into conference, and if a quorum is present the moderator, or in his absence, the assistant moderator shall take charge; and if neither of them is present the senior minister in years shall act as Moderator.
2. It shall be the duty of the clerk to enroll the delegates to the Association, who shall present themselves with proper evidence of their rights to seats therein, and those enrolled by the clerk shall compose the Association.
3. It shall be the duty of every District belonging to this Association to send a letter to every annual session of this Association reporting in the same spiritual condition, benevolent work, and its statistics. Any District belonging to this Association, which shall fail to report itself for two successive sessions, may be dismissed from the Association by a two thirds vote of all members present.
4. Each meeting shall be opened by reading a portion of the Bible and with prayer, and shall be closed with prayer.
5. By a two-thirds vote of members present, a ruling of the moderator can be overruled.
6. This Association may correspond by messenger or otherwise with other religious bodies.
7. This Association shall sit with open doors except when it shall go into a committee of the whole.
8. Any person not a member of this Association may be allowed to take part in its discussions by obtaining permission from the moderator.
9. It shall be the duty of all the Association to be present at the time appointed for each meeting, and anyone wishing to retire shall first obtain leave of the moderator.
10. No person shall be allowed to nominate more than one member of any committee, provided the person nominated be elected.
11. The moderator shall not allow discussions when not carried on in a Christian spirit or when he thinks it will cause discord or division.

12. Anyone desiring to speak shall rise to his feet and address the moderator by the appellation "Brother Moderator," but shall not speak further until recognized by the moderator.

13. No member of this association shall be allowed to speak more than ten minutes nor twice on the same subject without permission from the moderator.

14. This association shall meet annually beginning on Tuesday following the second Sunday in October.

15. These By-Laws may be altered or amended at any regular or adjourned session of this Association by a two-thirds vote of the members present.

CONSTITUTION OF STATE ASSOCIATION

PREAMBLE: From long experience, we the members of the Free Will Baptist denomination, being regularly baptized upon a profession of our faith in Jesus Christ, and realizing the necessity of a bond in union and fellowship among us as a church; and to preserve and maintain correspondence and co-ordination with us, do therefore ordain this Constitution for our better denomination government.

ARTICLE I

NAME: This organization shall be known as the OKLAHOMA STATE ASSOCIATION OF FREE WILL BAPTISTS.

ARTICLE II

PURPOSE: The object and purpose of this organization shall be to unify the work of the various bodies composing this State Association, and to devise and execute measures for the extension of the Kingdom of God in connection with the various bodies in the Association, or that may hereafter be represented therein.

ARTICLE III

REPRESENTATION: Section 1. This Association shall be composed of all ordained ministers and deacons with membership in some local church which is a member of a district Association with membership in the State Association.

Section 2: Each District Association shall be entitled to a number of elected delegates equal with the number of churches composing said Association. These delegates may be recommended by the local churches and shall be endorsed by their district association.

ARTICLE IV

FINANCE: Each district association shall be responsible for sending \$35.00 per church to the State Association for State and National Convention fee, of this \$35.00, \$25.00 shall go to the State Association and \$10.00 to the National Association.

ARTICLE V

DISCIPLINE: This State Association shall have the right to settle any question of discipline, doctrine or practices that may properly come before it from any of the bodies composing said organization; furthermore, if there be any question

of discipline, doctrine or practices on the part of an affiliated association, delegates of that association shall not be seated until these questions have been settled to the satisfaction of the General Board.

Section 2: Decisions of the General Board may be appealed in this manner. All appeals shall come before the State Association when sitting in a committee as a whole.

ARTICLE VI

OFFICERS: A. The officers of the State Association shall consist of a Moderator, Assistant Moderator, Clerk, Assistant Clerk, and an Executive Secretary. Each of these shall be elected at the close of each regular session except the Executive Secretary.

B. (1) The Executive Secretary shall be elected for an indefinite term. It shall be the responsibility of the Executive Board to seek out a prospective candidate and make their recommendation to the body at the state association in its regular session, with privilege of nominations from the floor.

(2) In the event of a vacancy occurring during the course of the year, the Executive Board shall fill the vacancy until the annual setting of the association.

(3) Any time a majority of the Executive Board, or seven (7) members of the General Board requests a vote of confidence on the Executive Secretary, a vote shall be taken. If such action results in the termination of the Executive Secretary, he shall be given sixty (60) days severance pay.

In the event of immorality on the part of the Executive Secretary, or of him teaching or preaching doctrine contrary to the Free Will Baptist Treatise, he may be dismissed by a majority vote of the Executive Board with no severance pay.

ARTICLE VII

BOARDS: All standing boards shall be composed of seven (7) elected members who shall serve terms of 7, 6, 5, 4, 3, 2 and 1 years with such ex-officio members as may be provided for elsewhere, with no member serving more than two (2) consecutive terms of office or portion thereof, except: (1) the General Board which shall be composed of one (1) member from each affiliated association, the chairman of each standing board, and the current general officers of this association, and (2) the College Board of Trustees which shall be composed as provided for in the Articles of Incorporation of Hillsdale Free Will Baptist College, Inc.

The standing boards of this association shall be: Executive Board; Board of Church Extension, Missions and Evangelism; Sunday School Board; Church Training Service Board; and College Board of Trustees.

No standing board shall meet in a functional meeting during the session of this association.

ARTICLE VIII

DUTIES, SCOPE OF ENDEAVOR AND QUALIFICATIONS OF STANDING BOARDS

Section 1. **EXECUTIVE BOARD:** The Executive Board shall be composed of seven (7) members who are members of an affiliated association and in good standing with the association of which they are members. They shall be elected at the discretion of this association.

It shall be the duty of this board to act in behalf of the association when it is not in session. It shall be bound to carry out the directions of the association and shall hold itself bound by every consideration of morality and honor to carry out the wishes of this association and to act under its instructions in whatever technical rights, civil laws and the decisions of courts may give it in certain emergencies. It shall be the duty of this board to sign their signatures to any and all papers concerning properties, indebtedness, bonds, or other legal documents

pertaining to the execution of the will of this association, exclusive of the College Board of Trustees.

This board shall have the oversight of the Executive Department of this association. The members shall assist and direct such work for the general promotion of this association as is deemed needful or necessary as the means available shall permit. The Executive Department shall serve as the coordinating agency of this association to correlate the work of all standing boards and agencies.

This board shall have the oversight of Free Will Baptist Book Store and shall endeavor to serve affiliated associations and churches and the community with literature and church supplies. Merchandising procedures shall be those accepted as normal retail procedures with the board being cognizant of the spiritual contribution of the store in distributing Christian literature.

All decisions of this board shall be governed by the general tenets of this association and shall not violate this constitution.

This board shall organize itself and elect such officers as necessary to the orderly conduct of its affairs and labors. This board shall keep an accurate record of all meetings, decisions, and work done and shall make a report in writing at each annual session of this association. All records shall be available to this association at its request.

Whereas this board represents the association when not in session, it and it alone shall have the power to call the association into special conference provided each affiliated association shall be given notice at least ten (10) days prior to the meeting of such special conference.

Section 2. GENERAL BOARD: This board shall be composed of one (1) member from each affiliated association, the chairman of each standing board, and the current general officers of this association. Each member must be a member of an affiliated association and in good standing with the association of which he is a member. The members shall be elected at the discretion of this association.

The duties of this board shall be to meet one (1) day preceding the annual session of this association. This board shall serve as the credential committee with the duties and responsibilities assigned by Article V of this constitution. This board shall hear reports of all standing boards. It shall serve as budget committee and shall make such recommendations as deemed pertinent to this association. A complete and accurate record shall be kept of meetings of this board and a report shall be made in writing to this association in its annual session.

The moderator of the association shall serve as chairman of this board, and the clerk of the association shall serve as its clerk.

Section 3. BOARD OF CHURCH EXTENSION, MISSIONS AND EVANGELISM: This board shall be composed of seven (7) members who are members of affiliated associations and in good standing with the associations of which they are members. They shall be elected at the discretion of this association.

It shall be the duty of this board to labor to further the Gospel of Jesus Christ into the uttermost parts of the earth. In accomplishing this, they are to endeavor to establish missions and churches in communities within the bounds of

this association with whatever moral and financial assistance that may be theirs. In cases of small churches failing to function, whatever assistance deemed appropriate shall be rendered to maintain the effective witness of that church by either direct labor with the church or with an associational board in instances where the affiliated association has a functional board or agency.

This board shall be empowered to receive and convey title to real property in the area of its labors.

The promotion of missionary endeavors from a local, state or national level shall come within the scope of endeavor of this board. This board shall assist in maintaining prayer and financial support of missionary enterprises through whatever channels available.

Whereas missionary and evangelistic labors are so intimately related, this board shall assist through participation or assistance in maintaining a strong evangelistic thrust in the life of affiliated association.

This board shall organize itself and elect such officers as necessary to the orderly conduct of its affairs and labors. This board shall keep an accurate record of all meetings, decisions, work done, funds received and disbursed and shall make a report in writing at each annual session of this association. All records shall be available to this association at its request.

Section 4. COLLEGE BOARD OF TRUSTEES: The College Board of Trustees shall be composed as provided for in the Articles of Incorporation of Hillsdale Free Will Baptist College, Inc.

Hillsdale Free Will Baptist College, Inc. is an agency of the Oklahoma State Association of Free Will Baptists and is incorporated under the corporate laws of the State of Oklahoma. The articles of incorporation are a part of this association's record and delineate the purpose, duty and scope of endeavor of the members of this board.

Section 5. CHURCH TRAINING SERVICE BOARD: This board shall be composed of seven members who are members of affiliated associations and in good standing with the associations of which they are members. They shall be elected at the discretion of this association.

The duties of this board shall be to plan and assist in organizing and sustaining a strong Church Training Service in every church in each association affiliated with this association with every means of promotion and assistance available to them. This board shall plan, coordinate and conduct state-wide youth camps or camp.

This board shall organize itself and elect such officers as necessary to the orderly conduct of its affairs and labors. This board shall keep an accurate record of all meetings, decisions, work done, funds received and disbursed and shall make a report in writing at each annual session of this association. All records shall be available to this association at its request.

Section 6. SUNDAY SCHOOL BOARD: This board shall be composed of seven (7) members who are members of affiliated associations and in good standing with the associations of which they are members. They shall be elected at the discretion of this association.

The duties of this board shall be to plan and promote Sunday schools in every church in each association affiliated with this association. This board shall use every available means to promote Sunday school clinics, seminars, institutes

and conventions on local, district and state-wide basis, working with local agencies to distribute and employ all effective methods and material available.

This board shall organize itself and elect such officers as necessary to the orderly conduct of its affairs and labors. This board shall keep an accurate record of all meetings, decisions, work done, funds received and disbursed and shall make a report in writing at each annual session of this association. All records shall be available to this association at its request.

Section 7. VACANCIES: Vacancies shall occur when a member moves from the territorial bounds of this association, by death, by resignation or by removal from office by this association. In the event of disciplinary action where charges concerning misconduct, doctrine or practice shall have been lodged against a member of any board, his office shall be held in abeyance until such charges shall be concluded or as determined by this association.

All boards shall have power to fill vacancies arising between sessions of this association. Such appointment shall terminate at the next session of the association and shall be filled by this association.

Section 8. EMPLOYEES: All employees of boards or agencies of this association shall be employed by agreement or contract with employing board or agency upon approval of this association except those elected by this association and the conditions of their employment shall be those approved by this association.

The duties of the Executive Secretary of this association shall be:

- (1) He is to represent, or cause to be represented, the association at all affairs of interest to the association.
- (2) He is to promote the work of the association in such a manner so as to unify the efforts of the association.
- (3) He is to serve with all standing boards and committees of the association in an ex-officio capacity.
- (4) He is to aid in planning the work of the association by relating the activities and plans of one board to another.
- (5) He is to report to the association during each annual session.
- (6) He is to communicate to the affiliated members of this association the pressing causes and events before the association. This can be in person or by means of a periodical bulletin or both.
- (7) He shall serve as treasurer of this association. An accurate and complete record of all funds received and disbursed shall be kept and a written report shall be included in his report to this association in its annual session.
- (8) The conditions of employment shall be determined by the Executive Board.

ARTICLE IX

DISSOLUTION: Should this association cease to function, all properties and holdings shall go to the National Association of Free Will Baptists after all creditors are satisfied and indebtedness cleared.

ARTICLE X

AMENDMENTS: This constitution may be amended or altered at any regular session of the association by a two-thirds (2/3) majority vote of members

present and voting, provided proposed amendment or alteration be presented in writing to the body one (1) day in advance.

ARTICLE XI

SPECIAL SESSIONS: Elected delegates to the last session of this association shall be retained as standing delegates for special called sessions.
