PROCEEDINGS THURSDAY EVENING

The 148th annual session of Old Mount Zion Association of Free Will Baptists was called to order by the moderator, Elder Gordon Bradshaw. Elder Loy Counts led in prayer. Elder Bradshaw read II Corinthians 6:11-18; II Corinthians 7:1 and Psalms 1:1 and made comments. Bro. Loyd Jones led the congregation in singing with Sister Bronwyn Jones at the piano. Songs were *Standing on the Promises*, *Won't It Be Wonderful There?* and *I Feel Like Traveling On*.

A special song entitled *Satisfied* was rendered by Elder Glen Faulkner and Sister Geneva Faulkner.

Elder Mark Casey brought the introductory message using as a theme, "United Effort, A Common Cause." Scripture was read from Numbers 32:1, 4, 5-7; Luke 22:32; Romans 12:11; Acts 10:42; I Corinthians 14:12; Romans 14:13; John 3:17; I Corinthians 10:24; II Corinthians 5:15; Galations 6:2; John 13:34; Numbers 32:8, 23; James 4:17; I Corinthians 15:58; and Numbers 20:22. Service opened with prayer by Elder Tommy Day. Elder Cecil Garrison led the congregation in singing with Sister Shirley Sizemore at the piano. Songs were *That's Why I Love Him So*, *The Glory Land Way* and *Amazing Grace*. The moderator, Elder Bradshaw read scripture found in Joshua 14:6-13. Reading of the Rules of Order were read by the moderator. Letters from the churches were received. Delegates were seated by a word of prayer led by Elder Paul Payne. The Committee on Committees was dismissed for their meeting.

Radio report was given by Elder Noel Easterling, and it was accepted as read. Elder Noel Easterling was re-elected as radio pastor. Sister Hazel Easterling re-elected as secretary-treasurer for the radio program.

Motion made and carried that the report of the Committee on Committees be received.

Quarterly Council meeting report given by Sister Shirley Sizemore, and it was accepted as read.

Motion made and carried to delete Resolution #6 printed on page 23 of the 1988 Association minutes since this is covered in Resolution #11 on page 24 of these minutes.

Discussion about possibly rearranging the Association sanctuary; no decision made at this time.

Business session dismissed until 1:00 p.m. this date.

FRIDAY MORNING SERVICE

Congregational singing conducted by Elder Eldon Bagwell with Sister Shirley Sizemore at the piano. Songs were *I'll Live in Glory* and *I'll Have a New Life*.

Special singing by Sister Geneva Faulkner entitled *I Am His and He is Mine*.

Assistant Moderator Elder Paul Payne made comments and then introduced Elder Randy Burris, who brought the message, reading from Jude 1-7, emphasizing verses 3 and 4. Theme of the message was "Contend for the Faith," using three parts: What to contend for; Why contend for it; and How to contend for it. Scripture from I Peter 3:18 was also used.

The congregation sang *Where Could I go?* and several met at the altar for prayer.

Elder Dale Kester dismissed in prayer.

FRIDAY AFTERNOON BUSINESS SESSION

Elder Gordon Bradshaw called the session to order. Elder Noel Easterling led in prayer.

Further discussion as to rearranging the sanctuary, and it was suggested that the Board of Trustees look into this matter and present ideas at a future meeting.

Home Mission Board Report given by Elder Paul Payne and report accepted. Elder John Ballard was elected to the Home Mission Board for a term of five years. Motion was made and passed to contribute \$1,000.00 from the Home Mission Board to the Dan Huddleston family, who will be going to the Ivory Coast mission field. The Huddlestons are members of Westside Freewill Baptist Church.

Youth Camp Report given by Bro. Carl Johnson and accepted as read. Bro. Randy Bradley was elected to the Youth Camp Board for a term of five years. Bro. Carl Johnson gave a report on the electrical work and installing of doors at the Association Building.

It was suggested that a list of the responsibilities of the Board of Trustees be outlined. The Moderator and Executive Board are to make this list which will be printed in the minutes.

Bro. Carl Johnson was elected to the Board of Trustees for a term of five years.

Christian Education Board report given by Bro. Loyd Jones and accepted as read.

Bro. Dwayne Bagwell was elected to the Christian Education Board for a term of five years. Bro. Bagwell had not served a full five year term on this board, therefore Amendment No. 1 to Article 5 of the Constitution was waived.

A partial report from the Resolution Committee was given by Elder Loy Counts.

Divine Service Committee report was given by Elder Arthur Lee Galloway and accepted as read.

Finance Committee report given by Bro. Carl Johnson and accepted as read.

Obituary report read by Sister Linda Grimes and accepted as read.

Motion made that meeting adjourn until 9:30 a.m. Saturday morning. Motion passed. Elder Norman Cline dismissed in prayer.

FRIDAY NIGHT SERVICE

Meeting was opened with prayer by Bro. Tom Lathrop. Elder Eldon Bagwell led the congregational singing with Sister Shirley Sizemore at the piano. Songs were *Down on My Knees* and *The Old Rugged Cross*.

Assistant Moderator Elder Paul Payne expressed thanks to the Faith Freewill Baptist Church for taking care of the preparation for the Communion service.

Elder Cecil Case led in prayer, and while an offering was being

taken, the congregation sang *Come Unto Me*. The offering was \$88.25.

Elder Dennis Artman brought the message using for a theme, "The Basin and the Towel." Scriptures were read from the following passages: John 13:1-6; John 13:15; Phillipians 2:8; Phillipians 2:5; Proverbs 15:33; James 4:6; Matthew 20:28; John 6:38; John 15:8; John 13:8-10; Exodus 29:4; Exodus 30:19-20 and Revelations 1:5. An invitation was extended to any who would like to come and pray before entering into the Communion and Feet Washing service.

Moderator Elder Bradshaw conducted the Communion Service. Elder Cecil Case led in prayer asking the blessing on the breaking of the bread, and Elder Loy Counts led in prayer asking the blessing on the cup. There were 16 ministers and 7 deacons assisting in the serving of Communion.

After the Communion service was completed, the feet washing service was conducted with 16 women and 23 men participating in this service.

Service was dismissed with an old fashioned handshake, while singing *If We Never Meet Again*.

SATURDAY MORNING SESSION

Service was opened with prayer by Elder Claude Hendrix. Scripture was read from Joshua 3:1-5 by the Moderator.

Elder Greig Caswell gave report of needs for the Youth Camp this year, announcing a workshop for teachers and workers to be June 1, 1989, at 7 p.m. and the work nights for clean-up and preparation for camp are June 6 and 15, 1989.

Divine Service Committee of 1988 was dismissed.

Home Mission Conference to be held at the Victory Free Will Baptist Church on June 23 and 24, 1989.

Motion carried to order 1,000 minutes printed, 50 of these to be sent to the Union Association and 50 to the Northwest Association of Free Will Baptists.

The Pea Ridge Free Will Baptist Church is to be responsible for the Communion Service in 1990.

Motion carried to send as delegates to the State Association at Conway Sisters Mary Johnson, Hazel Easterling, Bonnie Phillips, Mary Reeves and Bro. Alton Reeves; Sister Judy Payne, alternate.

Motion carried to elect as delegates to the Old Union Association of United Baptists Bro. Roy Edgmon, Elders Norman Cline and John Ballard. Elder Gordon Bradshaw, alternate.

Bro. Carl Johnson, Sister Linda Grimes and Elder Ricky Grimes are to direct the registration of deacons, delegates and ministers on Thursday, May 3, 1990, and Friday, May 4, 1990. It is requested that they arrive early.

Motion carried to accept final report of the Resolution Committee by Elder Loy Counts. Committee dismissed.

Elder Eldon Bagwell gave oral report of the Executive Board. Report accepted. Elder Gordon Bradshaw was elected for a five year term on the Executive Board.

Elder James Spears, pastor at Southside Free Will Baptist Church at Fort Smith and from Unity Association, was welcomed.

Motion carried to accept report from Non-represented Church Committee by Elder Claude Hendrix. Committee dismissed.

Motion made and carried to have clerk order additional plastic holders for name tags that are used during the Association.

A motion made and carried that we set up a reserve fund to be used for National and Foreign Mission work. Churches are asked to contribute to this quarterly as they do the radio program, newsletter, etc. This fund will be held in reserve to help those missionaries appearing in our area that may have a financial need. This fund will be set up by the Association Clerk, and disbursements will be made upon the approval of the associational body.

Motion made and carried that all boards that schedule activities meet and make plans for the following year, trying to avoid conflict of dates and scheduling more than one activity on the same date.

Motion made and carried that we take the offering on Thursday nights rather than on Friday night of the Associational meeting.

All business having been taken care of, motion carried to adjourn until May 3, 1990, at 7:30 p.m.

Assistant Moderator Elder Paul Payne stepped to the platform and requested Elder Gordon Bradshaw stand at the front and the congregation would be given the opportunity to come around and express appreciation for a job well done during his tenure as moderator. Elder Tommy Day led in singing *We'll Work Till Jesus Comes*. Sister Shirley Sizemore played the piano.

Elder Ernest Johnson dismissed in prayer.

MEMORIAL SERVICE

Service was opened with congregational singing led by Elder Eldon Bagwell and Sister Shirley Sizemore at the piano. Songs were *Safe in the Arms of Jesus*, *We Are Going Down the Valley* and *Amazing Grace*.

Elder Cecil Garrison led in prayer.

Sister Geneva Faulkner and Elder Glen Faulkner sang two songs, *When I've Gone The Last Mile of the Way* and *I Want Us to Be Together in Heaven*.

Elder Glen Faulkner brought the morning message for the Memorial Service. Scriptures were read from I Thessalonians 4:13-18; I Corinthians 15:1-6; and Revelations 20:10-15. Elder Faulkner brought his message to a close by leading in prayer.

QUARTERLY COUNCIL MEETING REPORT

Saturday, August 6, 1988

Motion carried to change our meeting time to begin at 9:00 a.m., using the same order of service, and ending at 12:00 p.m. with lunch. Motion carried for Old. Mt. Zion District Clerk to send church letters to local church clerks one week prior to quarterly meeting. Local church clerks would return church letter and money back to district clerk before scheduled meeting. Motion carried to accept Bro. Dale Kester into our Association in lieu of a letter of recommendation which will follow. Motion carried to accept Bro. John Ballard into our Association after hearing a letter of recommendation from South Grand River Association. Motion carried to dispense reading of the minutes until further notice. Motion carried to elect Bro. Dale Kester to fill the position on Home Mission Board vacated by Bro. Russel Payne. Discussed bids on the rewiring of associational buildings.

There were 14 pastors, 40 delegates, 15 ministers, 10 deacons, and 11 visitors present, making a total of 90 registered.

Saturday, November 5, 1988

Motion carried to recommend Bro. Russel Payne to Drumright Church. Quarterly Council Meeting officers for the 1988-89 year were elected as follows: Elder Ernest Johnson, Moderator; Elder Jim Spurlock, Assistant Moderator; Shirley Sizemore, Secretary; and Ann Johnson, Assistant Secretary.

There were 13 pastors, 33 delegates, 6 ministers, and 9 deacons registered, along with late arrivals, making a total of 104 present.

Saturday, January 28, 1989

All boards met to complete calendar of events for the coming year.

Saturday, February 18, 1989

DISTRICT WOMAN'S AUXILIARY REPORT 1988-89

The Old Mt. Zion Free Will Baptist Woman's Auxiliary consists of nine local auxiliaries: Berryville, Fayetteville First, Huntsville, New Sulphur, Pilgrim's Rest, Rogers, Victory, West Ridge and West Side with 154 members.

During the 1988-89 associational year, through offerings and special projects, the District Auxiliary disbursed the following: Membership Dues, \$308.00; WNAC Minutes, \$9.00; WNAC Representative and Entertainment Fees, \$40.00; WNAC Emphasis Offering, \$40.00; Home Missions Offering, \$296.90; Missionary Accounts - Patsy Vanhook, \$1,165.72, Stanley Bunch, \$30.00, Norman and Laura McFall, \$275.00; State Project, \$135.61; National Project, \$20.00; FWB Children's Home, \$225.00; Student Loan Fund, \$146.50; Co-Laborer Fund, \$20.00; Patsy Vanhook's Newsletters, \$400.00; and District Woman's Auxiliary Expenses, \$291.09, totaling \$3,555.32.

We had two fund raising projects this year. The first was our Walk-a-thon for Missions, which was held on April 23, at the Pea Ridge Battlefield Park, where we covered seven miles of beautiful, paved country road. The projects benefitting from this walk were: Postage for Sister Patsy Vanhook (\$275.00); The McFall Account (\$275.00); the Foreign and Home Mission General Accounts (\$137.50 each) and Patsy Vanhook's General Account (\$275.00), totaling \$1,100.00 that was raised on this walk. The second project was a knife sale which has brought in to date \$374.10, and this was forwarded to Patsy Vanhook's account to help her cover her expenses for her trip home at Christmas. This seems to be an on going project because funds keep coming in from sales of more knives. Our thanks go out to all the Auxiliaries for the work they have put into these projects to help make them successful.

The 15th annual Woman's Auxiliary Retreat was held September 23 and 24 at Mt. Sequoyah in Fayetteville, Arkansas, with 48 ladies attending representing nine churches. Our theme was "God Can Do Anything." Our guest speaker for the Friday evening program was

Sister Mary Kelton who spoke on the theme topic; and on Saturday morning we had three prayer groups led by Karen Weeks, Dorothy Lathrop and Nancy Webb. Our Vesper Service on Friday evening was led by Dixie Payne, and everyone who attended it was moved by the prayer and testimony given by each lady present. We all felt the closeness of Christian fellowship with one another and with the Lord. It was a blessing to all of us.

RESOLUTION COMMITTEE REPORT

We, the Resolution Committee, submit the following report:

Resolution No. 1: Be it resolved that any event, function, or activity to take place on the Association properties be supported by one of our Free Will Baptist Churches, being a member in good standing with our Old Mt. Zion Association, or Associational committees, and be approved by the Board of Trustees.

RESOLUTIONS: (Permanently Printed)

Resolution No. 1: Be it resolved that the Association set aside Saturday night of the conference each year for the youth of our churches to make their reports concerning their work and to be in charge of the worship service for that night, with privilege of selecting a speaker or speakers for the service.

Resolution No. 2: That attention be called to Article 3 of the Constitution of this Association, as terms of receiving members into the local church as, namely: (1) profession of faith; (2) by letter of recommendation; (3) by restoration; (4) by denominational choice.

Resolution No. 3: That Article 1, Membership, be amended to read: All regularly ordained ministers and deacons of this Association becoming properly credentialed and in full fellowship and good standing in the church of which they are members shall be entitled to seats as a delegate, by virtue of their office.

Resolution No. 4: Be it resolved that we give adequate support and approval to Home Mission work in the bounds of the Old Mt. Zion Association such as assisting in organizing and establishing new churches. Said work to be under the supervision of the Home Mission Board (amended August, 1979), consisting of five ordained ministers or deacons in good standing.

Resolution No. 5: Be it resolved that the churches of Old Mt. Zion Association go on record as denouncing the modern doctrine of a second work of grace (following regeneration and calling it the Baptism of the Holy Ghost), as heresy, and unsound doctrine. We warn any church (endorsing such, or having members in their church advocating such) to purge out such or stand risk of losing their place in this Association.

Resolution No. 6: Be it resolved, "Any church desiring a resolution to be voted on at setting of Association, send a copy of proposed resolution to each church of Old Mt. Zion Association before Association convenes; that is, if possible."

Resolution No. 7: (amended) In view of the fact that our Youth Camp has become a reality, we recommend that "all churches" support both the Youth Camp and the Home Mission Board.

Resolution No. 8: Be it resolved that the moderator appoint three persons to direct the registration on Thursday night and Friday morning and that they arrive early.

Resolution No. 9: That it be recorded in the minutes which church will be responsible for the Communion Service. They shall be responsible for the juice, bread and cleaning of supplies. If said church cannot serve, they must contact the moderator in time to get another.

Resolution No. 10: Be it resolved, "Any Free Will Baptist minister coming from a sister Association must present a letter of good standing from the Association from which he is coming.

Resolution No. 11: (Resolution No. 4 of 1977 Minutes) Be it resolved that the Old Mt. Zion Council Meeting be changed to a quarterly meeting convening on the first Saturday in November, February and May with three (3) elected delegates from each church attending to conduct any business necessary between annual sessions of the Association in August. (Annual Association now meets in May, therefore, quarterly meetings fall on the first Saturday in August, November and February.) Services to begin at 9 a.m.

Resolution No. 12: We believe that Sunday School plays a very important part in the training of our people. Our churches need dedicated teachers who will follow II Timothy 2:15, and we recommend that our churches, who use literature, use Freewill Baptist literature.

CHURCH COVENANT

Having been brought, as we believe, by the divine grace to accept the Lord Jesus Christ as our Saviour and Preserver, we do now solemnly and joyfully covenant and agree by God's help to walk together in brotherly love.

We, therefore, enter into covenant as members of this church, and as Christians, that we will watch over each other in love, sharing together each other's joys and sorrows; that we will not forsake the assembling of ourselves together, nor omit the great duty of prayer for ourselves and others; that by Divine assistance we will endeavor to bring up those under our care in the nurture and admonition of the Lord; that in all things we will strive to exemplify our profession by a corresponding practice, to abstain from all sinful conformity to the world, to be just in our dealings, faithful in our agreements, and exemplary in all our deportment; that we will abstain from the sale and use of intoxicating liquor as beverage; that we will contribute cheerfully according to our ability, to support of the ministry, the expense of the church, the relief of the poor and the general spread of the Gospel.

In keeping this solemn covenant, may we ever enjoy the blessings and presence of the Great Head of the church, which is Jesus Christ the Saviour.

RULES OF ORDER

1. At every sitting of the Association, business shall be opened and concluded by prayer by the Moderator or whomsoever he may request.

2. Ministers, deacons and delegates of Old Mt. Zion Association, when present, are invited to seats, allowed to take part in debates on all subjects, and to vote. Visiting ministers, deacons and delegates are invited to seats, allowed to take part in debates on all subjects, but not to vote.

3. Those who speak shall arise and address the Moderator. Personal reflections shall be avoided in all debates.

4. No motion shall be discussed without a second.

5. When a motion has been made and seconded, and a member opposes its discussion, the Moderator shall put the question, "Shall it be discussed?" If negative, the question shall be dismissed.

6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member, and the vote taken separately.

7. Motions made and lost shall not be recorded.

8. No one shall speak more than twice on the same subject without special leave of the Moderator.

9. All questions shall be decided by a majority vote of all members voting.

10. No member shall absent himself without special leave of the Moderator.

11. Minutes shall be leisurely read and corrected if necessary before the close of the Association.

12. At all future sessions of the Association, arrangements shall be made to insure two sermons, or other devotional exercises equivalent thereto, during each day of the session, and the chair shall announce just before adjournment, who shall preach.

13. These Rules of Order shall be distinctly read from the chair immediately after the organization of the Association.

14. Alterations may be made in these rules at any regular session of the Association.

CONSTITUTION

From long experience, we, the members of the Church of God (denominated Free Will Baptists) being regularly baptized upon profession of our faith in our Lord Jesus Christ, and being convinced of the necessity of a combination of churches to perpetuate a union among us, and to preserve and maintain correspondence with each other, do therefore, ordain this Constitution for our better Church government.

Article 1. Membership--This Association shall be composed of members chosen by the different churches of our union, not exceeding three messengers from each church, and upon producing letters, they

shall be entitled to seats. All regularly ordained ministers and deacons of this Association becoming properly credentialed and in full fellowship and good standing in the church of which they are members, shall be entitled to seats as a delegate, when present, by virtue of their office.

Article 2. Name--The members thus chosen and assembled with the ministers and deacons, to be denominated the Old Mt. Zion Association of Free Will Baptists being composed of the several churches of our union, the Association having no power over the churches reserving the right of withdrawing from any church becoming disorderly.

Article 3. Letters--Letters from the different churches representing are to express their number in fellowship including the names and addresses of ordained and licensed ministers, the number of members received upon profession of faith, by letter of recommendation, by restoration or denominational choice; the number of members dismissed by letter, excluded, and those having died since last Association. Churches, in sending their letters, may send obituaries of anyone who died during the year, that we may keep up the memorial to our dead.

Article 4. Dismissing Members--Our churches, upon granting letters of dismission to any of its members, shall require a notice from the church receiving said letter that it has been received.

Article 5: Officers--The Association to have a Moderator and an Assistant Moderator, Clerk-Treasurer, and an Assistant Clerk-Treasurer, elected annually for a term of one year by the suffrage, and an executive committee of five, one member chosen each year for a term of five years, and that each member be an Ordained Minister in good standing of the Old Mt. Zion Association, who shall have the authority to transact any business transactions of the Association between sessions of the Association and make a report to the Association annually.

Amendment No. 1 to Article 5

Be it resolved that we amend Article 5 to read that no person can serve two consecutive terms on any standing board.

Amendment No. 2 to Article 5

Be it resolved that current Officers of the Association be retained through the present Association and any new Officers assume responsibilities immediately thereafter.

Article 6. New Churches--Newly organized churches may be admitted to the Association, which are to petition by letter and delegates, and if, upon examination, they are found to be orthodox and orderly, they may be received into the Association, the Moderator giving the right hand of fellowship.

Article 7. Questions--No resolution from any church shall come

under consideration of the Association unless it has been first considered in its own church and, if possible, a copy be sent to each church before the Association.

Article 8. Motions--Every motion made and seconded shall come under the consideration of the Association except it be withdrawn by the member who made it.

Article 9. Minutes--The Association is to endeavor to furnish the churches the minutes of the Association in proportion to the amount paid by each church, the distribution to be made at the discretion of the Association.

Article 10. Clerk--It shall be the duty of the Clerk to keep a regular file of the minutes of the Association in a book to be kept by the Association for that purpose.

Article 11. Signatures--The minutes of the Association shall be read and corrected, if needed, and signed by the Moderator and Clerk before the close of the Association.

Article 12. Amendments--Amendments of this Constitution may be made, when necessary, by a two-thirds vote of the members present at any regular session.

Article 13. Non-Attendance--The Association, in case of failure of any church to attend, shall inquire into the case.

Amendment No. 1 to Article 13

Be it resolved that churches that fail to be represented by delegation, or letter, for two consecutive years, be notified they will be dropped from our Association.

Article 14. Ordination of Ministers--Old Mt. Zion Association of Free Will Baptists accepts the wording of Epistles I Timothy 3:1-7, and Titus 1:6-9 as authoritative for guidelines to Ordaining Ministers.

Amendment No. 1 to Article 14

Be it therefore resolved that we amend Article 14 of our Constitution in compliance of our State Constitution. That Old Mt. Zion Association of Free Will Baptists accept the wording of the Epistles to Timothy and Titus as authoritative, namely the interpretation of the phrase, "the husband of one wife," to mean that divorced personnel should not be ordained. (I Timothy 3:2, 12; Titus 1:6)

Amendment No. 3 to Article 14

Be it further resolved that no woman be ordained as a minister or a deaconness.

Amendment No. 4 to Article 14

Be it further resolved that we recommend to the Executive Board of this Association in their examination of candidates for ordination, to observe greater caution, and in agreement with the instructions of the apostles, "To lay hands suddenly on no man." (I Timothy 4:22)

When a Church member acknowledges their call to the Ministry,

they should be licensed by the Church of which they are a member for the period of one year prior to Ordination; or, until they have proved themselves to the Church. When the member has proven himself, the Church should call for his Ordination.

That all Churches of Old Mt. Zion Association, in all Ordination services of Ministers, comply strictly with the rules and regulations laid down by the Free Will Baptist denominations. Said procedure to be conducted by the Local Church.

Amendment No. 5 to Article 14

If any ordained minister of the Old Mt. Zion Association of Free Will Baptists at anytime be found guilty of misconduct, or disregard of any rule or ordinance set forth and practiced by the Constitution of the Old Mt. Zion Association, the said party shall be dealt with according to "Article 14" of the Constitution of the Old Mt. Zion Association as follows:

1. After the local church has made a full and complete investigation as to the misconduct or other charges and the evidence proves to be true--he shall surrender his credentials to the local church or association until said misconduct or other charges have been investigated by the local church or Executive Board. (The local church clerk or associational clerk to hold said credentials.)

2. If after the period of not more than one year after the surrender of his credentials, the said party shall be contacted by the local church of which he is a member or by the Executive Board to try and make restitution. If the local church fails to deal with the charges, then the Executive Board will have the authority to deal with the charges. The Executive Board shall make this report to the regular session of the associational body which will vote on the report as whether to revoke or return the credentials to said party.

Amendment No. 6 to Article 14

Be it resolved that no minister be ordained without written approval of the Executive Board.

Amendment No. 7 to Article 14

Be it resolved that the Association instruct the Executive Board not to approve any minister for ordination who uses tobacco in any form.

"ARTICLES OF FAITH"

1. **God**--We believe in one true and living Triune God; composed of the Father, Son and Holy Spirit, equal in divine Essence, Purpose, Power and Glory. St. John 1:1; I Cor. 8:6; St. John 10:30; I John 5:7.

2. **Christ**--We believe that Jesus Christ is the divine Son of God, was with the Father and the Holy Spirit at the time of creation, left the Courts of Heaven and came to earth, took upon Himself the form of humanity, sin excepted, by being born of the Virgin Mary, manifested His power, was crucified, placed in Joseph's tomb, rose again the third day, completed the great plan of salvation, walked and talked with his disciples, publicly ascended to Heaven, and that He will

descend again to gather His jewels home.--Isaiah 9:6; St. John 1:14; Luke 1:26-28; Matt. 14:13-21; Mark 16:9-19; Luke 24:50-53; Acts 1:9-12; Mark 15:22-41.

3. Holy Spirit--We believe that the Holy Spirit has visited true believers in all ages, and especially since the ascension of the Son back to the Father, and his coming on the day of Pentecost. Has taken up His office work among all nations of people, as a Divine Reprover, Comforter and Guide.--Judges 6:34; 11:29; St. John 16:8-14; Isaiah 63:10-12; Ephesians 4:30; Acts 8:17-20.

4. The Bible--We believe the Bible, which is composed of the Scriptures of the Old and New Testaments was given by inspiration of God, is our way-bill from earth to heaven, and the only infallible rule of faith and practice.--II Peter 1:19-21; II Tim. 3:14-17; Daniel 10:21; Acts 1:16-17; Matt. 21:42.

5. The Fall of Man--We believe that God created man good, gave a just law by which he should be governed, with the promise of reward for faithfulness and with penalties of punishment for disobedience. Gave man power of free moral agency to choose the right and reject the wrong. But our first parents heeded the voice of the great enemy of souls, voluntarily transgressed the law of God, fell with their posterity under the just penalty of the same, and were unable of their own power to extricate or save themselves from the great dilemma into which they had fallen. God gave them the hope of salvation through the coming of Christ.--Gen. 1:27, 2:16-17; Rom. 11:11-35; Rom. 5:18; Pslams 37:23-24.

6. Redemption, Salvation, Adoption--We believe that Jesus Christ by His birth, death, burial, resurrection and ascension paid the purchase price for the redemption of the whole human race, arranged a pardon for all who came upon Gospel terms; and a law of adoption into the Kingdom of Heaven and eternal inheritance into the glorified Kingdom above.--Heb. 9:12; Gal. 3:13, 4:4-5; Titus 2:14; Heb. 1:4; St. John 3:16; Isaiah 45:22.

7. Conditions of Salvation--We believe that all persons dying in infancy and all idiots are saved by the Atoning merits of the Son of God without any act on their part, that persons coming to the years of accountability, transgressing the law of God, must upon their part, exercise faith in Jesus Christ through repentance toward God, at the completion of which pardon takes place in the mind of the Father and by the Holy Spirit they pass through the ordeal of regeneration, are washed in the blood of the Lamb and are planted in the Kingdom of Christ.--John 3; Matt. 19:13-22; II Cor. 7:10; Luke 18:17; St. John 4:11-16; Psalms 98:3.

8. Salvation Free--We believe that God desires the salvation of all; Christ died for all; the Gospel invites all; the Holy Spirit strives for all; and whosoever will may come and be saved on the terms of the Gospel.--Rev. 22:17; I Peter 1:9-13; I Peter 2:9-24; Rom. 3:24.

9. Baptism--We believe that Christian baptism is the immersion of believers in water, in the name of the Father, the Son, and the Holy Ghost, in which are represented the burial and resurrection of Christ; also represents our death to sin, and only those who have come under the presbytery of the elders are qualified to administer the same.--Matt. 3:14-16, 3:5-6; I Peter 3:21; St. John 3:23; Acts 10:47; Matt. 28:19.

10. Communion and Feet Washing--We believe that the Lord's Supper and the washing of the saints' feet are ordinances of the Gospel of Christ; The Lord's Supper was instituted by our Savior to commemorate His broken body and shed blood for the sins of the world and to show our remembrance of Him till He comes.

All Christians have a right to the Lord's Supper and should be invited. "Let a man examine himself and so let him eat."

The washing of feet was instituted by our Lord at the same time that Supper was instituted as an act of humility to show our love for each other, and both ordinances should be perpetuated by all Christians until His second coming.--Luke 22:19-20; I Cor. 11:20-29; St. John 13:1-18; Matt. 26:26-29.

11. The Sabbath--We believe that the Christian Sabbath should be observed as a day of rest and for the worship of God; that we should abstain from all sinful amusements and secular employments, works of mercy and piety excepted.--Exodus 20:11, 31:12-18; Deut. 5:12-15; Ezek. 20:12; Matt. 28:1; Luke 23:56; Acts 13:42-48; Mark 2:27.

12. Call to the Ministry--We believe in a Divine call of the ministry; that God in His goodness and power of grace, impresses His ministers with the burden of lost souls to the extent that the call becomes irresistible with personal contentment; that when they yield to the call and exercise the native gifts according to the Scriptures, with full reliance upon Him, He accompanies them in person of the Holy Spirit to guide them in the way of truth and to bless their labors according to His purposes.--Jonah 1:1; Jer. 1:5; Mark 3:14; Acts 1:22-26; Matt. 28:19.

13. The Invisible Church--We believe that the Invisible or Spiritual Church is the redeemed in the aggregate, is the family of God, is composed of all true Christians of every congregation from righteous Abel to the restitution of all things from every kindred, nation, tongue and people.--Eph. 3:16-21; Heb. 12:22-23; I Peter 2:5; Eph. 2:20-22; Acts 2:47; Matt. 16:18.

14. The Visible Church--We believe that a visible church of Christ is a congregation of faithful men and women, having obtained fellowship with the Lord and with each other, agreeing to keep up a good discipline and doctrine according to the rules of the Gospel.--II Thess. 1:1; Acts 16:5; III John 1:10; Matt. 18:17; Acts 20:28; Rev. 1:4, 11, 20.

15. Perseverance. We believe that all true believers in Christ should persevere in divine graces, and in the knowledge of the truth and that God's grace is sufficient to help them to overcome all the obstacles of life and that all the combined forces of the great enemy of souls on earth and in Hell (or in his eternal abode) are not able to pluck them from his hand so long as they walk in the path of duty; but those who sidestep and willfully refuse or neglect to perform their duty, they would backslide and if persistently continued, would be eternally lost.--II Cor. 9:10; II Peter 1:4-8; II Peter 1:12; I Peter 2:2; Rom. 8:35-39, Apostasy; II Peter 1:8-9; I Cor. 10:1-13; Heb. 12:15-17; I John 5:16; Heb. 6:1-6; I Tim. 4:1-2; Heb. 3:12; St. John 15:1-7; Matt. 12:31-32.

16. Christ the Head of the Church--We believe that Christ is the Great Head of the Church and that the government of the local church is with the body.--Col. 1:18-19; Matt. 16:18; Heb. 12:23; Matt. 21:42; Eph. 1:22; Acts. 16:4-5.

17. Sanctification--Sanctification is work of God's grace, by which the soul is cleansed from all sins and wholly consecrated to Christ. It takes place in regeneration, and the Christian can and should abide in this state to the end of life constantly growing in the grace the knowledge of our Lord Jesus Christ.--I Cor. 6:11; II Thess. 2:13; Heb. 12:14; Phil. 3:21; St. John 17:17-19; II Tim. 2:20; I Thess. 5:19-23.

18. The Resurrection--We believe in the resurrection of the dead, both of the righteous and the wicked. When the resurrection shall take place, the soul and body shall be reunited, the righteous shall be received into everlasting happiness to reign with God forever, but the wicked shall go away into everlasting punishment.--Matt. 28:6; St. John 5:28-29; I Cor. 15:51-58.

19. The Soul--The soul is endless, hence does not die with the body, but immediately after death enters into a conscious state of happiness or misery, according to spiritual character here possessed.--Phil. 1:23; Luke 23:43; Rev. 6:9; Luke 16:19-25; Matt. 10:28.

20. Judgment--We believe that there will be a general, universal judgment, when all men shall be judged according to their works whether they be good or bad, and that immediately thereafter, the wicked shall enter into everlasting punishment and the righteous into eternal happiness.--II Thess. 1:4-9; Rev. 14:9-13; Luke 16:23; Rev. 21:8; II Cor. 5:10; Matt. 12:36-37; Rev. 20:12-13; Acts 17:31.
