PROCEEDINGS OF THE 154TH ANNUAL SESSION OF THE OLD MOUNT ZION ASSOCIATION

“RETURNING TO OUR ROOTS”

The 154th annual session of the Old Mount Zion Association of Free Will Baptists convened on Thursday, May 4, 1995. The meeting was called to order at 7:30 p.m. by Moderator Eldon Bagwell. He asked Loyd and Browyn Jones to lead the congregational singing. The songs were “Come and Dine” and “Leaning on the Everlasting Arms.” Opening prayer was by Elder John Redfearn, pastor of Hope Church.

Bro. Bagwell read Jeremiah 6:16 setting the theme for this year’s session as “Returning To Our Roots.”

Elder Paul Payne led in prayer.

Elder Clark Snow led the congregation in singing “There is Power in the Blood.” Elder Eddie Davis sang a special, “The King is Coming.”

The introductory message was delivered by Elder Randy Burris. Using Acts 4:31-33 as his text, he spoke on “Your Place.” He began by saying God’s people need to fall in love afresh with Jesus, their church and their calling. We need to find the place where God wants us to serve Him. This should be a place of purpose, to win souls; a place of praying, brings great power from God; and a place of preaching. When God calls someone to preach, He gives them the power to do it. Bro. Burris continued saying God doesn’t require results, He requires faithfulness.

Loyd and Browyn Jones led the song of invitation, “Just As I Am,” as many gathered at the altar for a time of prayer.

In the business session the Committee on Committees was chosen. The church letters were read and the delegates were seated with a right hand of fellowship.

Bro. and Sister Jones led the song, “I’ll Be Satisfied,” as an offering of \$142.25 was received.

The session was dismissed until 9:30 a.m. Friday, May 5. Bro. Tommy Day led the prayer of dismissal.

FRIDAY MORNING BUSINESS SESSION

The morning business session began with the congregation singing “The Way of the Cross Leads Home,” and “Beautiful.” Elder John Redfearn was song leader, and Vona Campbell the pianist.

Elder Eldon Bagwell read Matthew 28:18-20, he reminded the gathering that God has a job for all of us to do; teach His commandments and observe. Bro. Bagwell continued by saying, “If you belong to a Free Will Baptist Church, you need to know why; what do we believe in? We need to let people know who we are.”

Opening prayer was by Elder Doug Harris, Moderator of the Northwest Association and pastor of Moore FWB Church.

Delegates who were not seated Thursday night were seated. Delegates from the Union Association of United Baptists, Bill and May Neal, and

Mable Burris were seated. Ruby Head was a visitor from Union Association.

The Rules of Order were read by the Moderator.

Permanent Officers were elected.

Elder Eddie and Sister LaRhonda Bowerman spoke on their call as missionaries to Panama. They will be going to minister to the Cuna Tribe, a totally unreached people.

Elder Doug Harris spoke as a volunteer of the Mission Support Task Force. He shared information about changes in providing support for Missionaries from Arkansas.

A letter was read from the Home Mission church at Maumelle asking for help. A motion was made and approved to take the matter of support for this church to the local churches.

George "Robby" Rutledge was recommended to the Social Band Association. Motion made and approved to send letter of recommendation.

The business session was dismissed until 1:00 p.m. Prayer was by Elder Claude Hendrix.

FRIDAY MORNING WORSHIP SERVICE

The morning worship service began with Elder John Redfearn and Sister Vona Campbell leading the congregation singing "Press Along To Gloryland." Elder Norman Cline led in prayer. The congregation then sang, "I'll Have a New Life" and "When We All Get to Heaven."

Special songs were presented by Elder Glen Faulkner, who sang "Last Mile of the Way," Tom and Dorothy Lathrop singing "This is What Heaven Means to Me," and Elder Cecil Garrison, who sang his special song, "There's a Better Home."

Bro. Bagwell asked for prayers for the many needs of Brothers and Sisters in the Association. Many gathered together in an altar of prayer.

The message was given by Elder Eddie Davis. Using John 8:28-32 as his text, Bro. Davis spoke on how the world needs the teachings of Jesus. He told how the truth of the Bible takes our eyes from the here and now to the Eternal. Man tends to focus on the concerns of the world. He urged the church to be about its business, teaching Jesus. Bro. Davis went on to challenge Christians to love others as God loves them.

At the end of the message, Elder John Redfearn led the song of invitation, "I Need Thee."

AFTERNOON BUSINESS SESSION

The afternoon session opened with Elder John Redfearn leading the song, "Standing on the Promises," with Vona Campbell at the piano.

Prayer was led by Bro. Jim Harris.

Speaking on the theme, "Returning to Our Roots," the moderator read I Timothy 4:11, II Timothy 3:12-17, and verses from Titus stressing the need to teach the truth and speak sound doctrine.

The Committee on Committees' report was read and approved.

Old Mount Zion Newsletter report was read and approved. Sister Gayla Haywood was re-elected editor.

The radio program report was read and approved. Motion made and passed to continue program. Elder Eldon Bagwell was re-elected radio pastor.

Youth Camp Board report read and approved. Mike Gabbard was elected to a five year term.

Christian Education Board report read and approved. Fletcher Williams was elected to a one year term replacing Elder Kenneth Holder. Steve Ash was elected to a five year term.

The Home Missions Board report was read and approved. Sister Dorothy Lathrop was retained as treasurer. Motion was made and passed to give \$300.00 from the account to the account of Ed and LaRhonda Bowerman.

The report from the Board of Trustees was read and approved. Elder Lester Harp was elected to fill a five-year term.

The Executive Board report was read and approved. Elder Randy Burris was elected to a five-year term.

The Westside Church will be in charge of the Communion and Feet Washing Service at the 1996 meeting.

Registration for the 1996 annual session will be handled by Rogers Church.

FRIDAY EVENING SERVICE (Communion and Footwashing)

The service was opened by Moderator Eldon Bagwell. Elder Eddie and Sister Sharon Bowerman led the congregation singing. "There is a Fountain" and "Jesus is the World to Me." Many gathered at the altar for a time of prayer.

Sharon Bowerman sang a special "I've Got More to Go to Heaven For." A quartet from Durham Gospel Lighthouse sang "Sweet Hour of Prayer."

Elder Cecil Garrison brought the message from I Corinthians 11:1-34. Stating that we are redeemed from the bondage of sin by the blood of the lamb.

As the Communion Service began the Moderator called all ordained ministers to come forward as the blessing was asked. Ordained deacons served the bread and fruit of the vine to all who wished to partake of the Lord's Supper.

After the Communion Service, twenty-seven men and twenty-six women took part in the Feet Washing Service.

Many gathered at the altar to pray for a brother who was unable to wash feet because of a physical condition.

An offering was received and the congregation sang a hymn as they went out.

SATURDAY MORNING BUSINESS SESSION

The morning session opened with Steve and LaWanda Ash leading the song, "I Feel Like Traveling On." Elder Arthur Lee Galloway. "I'll Fly Away," was sung by the congregation.

The moderator read from the second chapter of Titus showing how wrong teaching can destroy homes. He went on to say God's people should be eager to do the Lord's work including rebuking wrong teaching and wrong living.

The Finance Committee's report was given and approved as read.

The Divine Service Committee report was given and approved.

The Obituary Committee report was read and accepted. A motion was made and passed to include all names submitted "by request" in the Minutes.

The report of the Committee on Non-Represented Churches was read and approved. An amendment to the motion was made to pay the fees of Midway Church, who did not report, if they failed to pay at a later date.

The Resolution Committee report was read and approved. The four resolutions submitted were voted on individually and were passed (see Committee report for resolutions).

Bro. Melvin Martin was chosen as a delegate to the State Association. Other delegates will be chosen at the Quarterly Council meeting in August.

Elder Cecil Garrison, Elder Norman Cline and Bro. Roy Edgemon were selected as delegates to the Union Association of United Baptists annual session in September.

Delegates to the Northwest Association's annual session will be Bro. Tom and Sister Dorothy Lathrop and Elder Eddie and Sister LaRhonda Bowerman.

Discussion was held to select delegates for the National Association. Sister Sherry Mitchell was selected as one delegate. A suggestion was made to allow qualified persons who were able to attend to represent Old Mount Zion at the National Association.

A motion was made and passed to use money from the offerings received to buy 100 chairs at a cost of approximately \$4.50 each.

After a brief break, a suggestion was made that in future Saturday session snacks and coffee be served mid-morning. Phillips Chapel Church volunteered to bring donuts next year.

The Executive Board met and voted to receive Elder John Redfearn into the Association pending a letter from the Saline Association.

The next annual session of the Old Mount Zion Association will be May 2, 3, 4, 1996. Motion was made and passed to dismiss until 7:30 p.m. May 2, 1996. Closing prayer by Elder Gorden Bradshaw.

MEMORIAL SERVICE

The Memorial Service opened with Bro. Steve and Sister LaWanda Ash leading the congregation singing "Heaven's Jubilee" and "That Glad Reunion Day."

Prayer was by Elder Dennis Artman.

Elder Eldon Bagwell read the names of all the deceased submitted by the churches.

Bro. Tom and Sister Dorothy Lathrop sang a special, "This is What Heaven Means to Me."

The message was brought by Elder Tommy Day, who spoke on the mystery of the Resurrection "The Great Reunion." He used I Corinthians 15:12-18, 50-52, and 54B-58 as his text. He reminded those gathered that the resurrection is real. There is always hope in spite of life's tragedies; and that in spite of those unbelievers who try to hinder that hope, there will be a great homecoming—the great reunion with those who died in Christ. We won't lose a thing if we fall "asleep" (die) in Jesus. He ended the message with a word of prayer.

Elder Cecil Garrison read a poem titled "Safely Home."

The service was dismissed with prayer by Bro. Elmer Martin.

SATURDAY NIGHT SERVICE

B. Ordained ministers coming from another denomination wishing to unite with Free Will Baptist must first unite with a local Free Will Baptist Church of the Old Mount Zion Association; and will be subject to the same examination by the Executive Board, and if found willing to accept the Free Will Baptist denomination's constitution, will be accepted into full fellowship of the Old Mount Zion Association.

The Resolution Committee asks that it be resolved to delete Resolution #10 from the minutes.

We, the Resolution Committee, recommend that each church of the Old Mount Zion Association contribute to buying 125 copies of the Heavenly Highway hymn books for the Association Building.

We, the Resolution Committee, move that we give a rising vote of thanks to the ladies for the very fine meal at the noon hour.

RESOLUTIONS: (Permanently Printed)

Resolution No. 1: Be it resolved that the Association set aside Saturday night of the conference each year for the youth of our churches to make their reports concerning their work and to be in charge of the worship service for that night, with privilege of selecting a speaker or speakers for the service.

Resolution No. 2: That attention be called to Article 3 of the Constitution of this Association, as terms of receiving members into the

local church as, namely: (1) profession of faith; (2) by letter of recommendation; (3) by restoration; (4) by denominational choice.

Resolution No. 3: That Article 1, Membership, be amended to read: All regularly ordained ministers and deacons of this Association becoming properly credentialed and in full fellowship and good standing in the church of which they are members shall be entitled to seats as a delegate, by virtue of their office.

Resolution No. 4: Be it resolved that we give adequate support and approval to Home Mission work in the bounds of the Old Mt. Zion Association such as assisting in organizing and establishing new churches. Said work to be under the supervision of the Home Mission Board (amended August, 1979) consisting of five ordained ministers or deacons in good standing.

Resolution No. 5: (Amended 1992) Be it resolved that the churches of Old Mt. Zion Association go on record as denouncing the modern day doctrine of speaking in tongues as a part of the doctrine of a second work of grace (following regeneration and calling it the Baptism of the Holy Ghost), as heresy, and unsound doctrine. We warn any church (endorsing such, or having members in their churches advocating such) to purge out such or stand in risk of losing their place in this Association.

Resolution No. 6: Be it resolved, "Any church desiring a resolution to be voted on at setting of Association, send a copy of proposed resolution to each church of Old Mt. Zion Association before Association convenes; that is, if possible."

Resolution No. 7: (amended) In view of the fact that our Youth Camp has become a reality, we recommend that "all churches" support both the Youth Camp and the Home Mission Board.

Resolution No. 8: Be it resolved that the moderator appoint three persons to direct the registration on Thursday night and Friday morning and that they arrive early.

Resolution No. 9: That it be recorded in the minutes which church will be responsible for the Communion Service. They shall be responsible for the juice, bread and cleaning of supplies. If said church cannot serve, they must contact the moderator in time to get another.

Resolution No. 11: (Resolution No. 4 of 1977 Minutes) Be it resolved that the Old Mt. Zion Council Meeting be changed to a quarterly meeting convening on the first Saturday in November, February and May with three (3) elected delegates from each church attending to conduct any business necessary between annual sessions of the Association in August. (Annual Association now meets in May, therefore, quarterly meetings fall on the first Saturday in August, November and February.) Services to begin at 9 a.m.

Resolution No. 12: We believe that Sunday School plays a very important part in the training of our people. Our churches need dedicated teachers

who will follow II Timothy 2:15, and we recommend that our churches, who use literature, use Freewill Baptist literature.

Resolution No. 13: Be it resolved that all church letters in the Annual Association be mailed to the Clerk a week prior to the date of the Association, if possible.

Resolution No. 14: Be it resolved that any event, function, or activity to take place on the Association properties be supported by one of our Free Will Baptist Churches, being a member in good standing with our Old Mt. Zion Association, or Associational committees, and be approved by the Board of Trustees.

Resolution No. 15: Be it resolved that the Divine Service Committee be responsible for the Quarterly Council programs—choosing the speaker, his alternate and special singings for each Quarterly Council meeting.

CHURCH COVENANT

Having been brought, as we believe, by the divine grace to accept the Lord Jesus Christ as our Saviour and Preserver, we do now solemnly and joyfully covenant and agree by God's help to walk together in brotherly love.

We, therefore, enter into covenant as members of this church, and as Christians, that we will watch over each other in love, sharing together each other's joys and sorrows; that we will not forsake the assembling of ourselves together, nor omit the great duty of prayer for ourselves and others; that by Divine assistance we will endeavor to bring up those under our care in the nurture and admonition of the Lord; that in all things we will strive to exemplify our profession by a corresponding practice, to abstain from all sinful conformity to the world, to be just in our dealings, faithful in our agreements, and exemplary in all our deportment; that we will abstain from the sale and use of intoxicating liquor as beverage; that we will contribute cheerfully according to our ability, to support of the ministry, the expense of the church, the relief of the poor and the general spread of the Gospel.

In keeping this solemn covenant, may we ever enjoy the blessings and presence of the Great Head of the church, which is Jesus Christ the Saviour.

RULES OF ORDER

1. At every sitting of the Association, business shall be opened and concluded by prayer by the Moderator or whomsoever he may request.

2. Ordained ministers, deacons, and delegates of Old Mt. Zion Association, when present, are invited to seats, allowed to take part in debates on all subjects, and to vote. Visiting ministers, deacons and delegates are invited to seats, allowed to take part in debates on all subjects, but not to vote.

3. Those who speak shall arise and address the Moderator. Personal reflections shall be avoided in all debates.

4. No motion shall be discussed without a second.

5. When a motion has been made and seconded, and a member opposes its discussion, the Moderator shall put the question, "Shall it be discussed?" If negative, the question shall be dismissed.

6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member, and the vote taken separately.

7. Motions made and lost shall not be recorded.

8. No one shall speak more than twice on the same subject without special leave of the Moderator.

9. All questions shall be decided by a majority vote of all members voting.

10. No member shall absent himself without special leave of the Moderator.

11. Minutes shall be leisurely read and corrected if necessary before the close of the Association.

12. At all future sessions of the Association, arrangements shall be made to insure two sermons, or other devotional exercises equivalent thereto, during each day of the session, and the chair shall announce just before adjournment, who shall preach.

13. These Rules of Order shall be distinctly read from the chair immediately after the organization of the Association.

14. Alterations may be made in these rules at any regular session of the Association.

CONSTITUTION

From long experience, we, the members of the Church of God (denominated Free Will Baptists) being regularly baptized upon profession of our faith in our Lord Jesus Christ, and being convinced of the necessity of a combination of churches to perpetuate a union among us, and to preserve and maintain correspondence with each other, do therefore, ordain this Constitution for our better Church government.

Article 1. Membership--This Association shall be composed of members chosen by the different churches of our union, not exceeding three messengers from each church, and upon producing letters, they shall be entitled to seats. All regularly ordained ministers and deacons of this Association becoming properly credentialed and in full fellowship and good standing in the church of which they are members, shall be entitled to seats as a delegate, when present, by virtue of their office.

Article 2. Name--The members thus chosen and assembled with the ministers and deacons, to be denominated the Old Mt. Zion Association of Free Will Baptists being composed of the several churches of our union, the Association having no power over the churches reserving the right of withdrawing from any church becoming disorderly.

Article 3. Letters--Letters from the different churches representing are to express their number in fellowship including the names and addresses of

ordained and licensed ministers, the number of members received upon profession of faith, by letter of recommendation, by restoration or denominational choice; the number of members dismissed by letter, excluded, and those having died since last Association. Churches, in sending their letters, may send obituaries of anyone who died during the year, that we may keep up the memorial to our dead.

Article 4. Dismissing Members--Our churches, upon granting letters of dismission to any of its members, shall require a notice from the church receiving said letter that it has been received.

Article 5: Officers--The Association to have a Moderator and an Assistant Moderator, Clerk-Treasurer, and an Assistant Clerk-Treasurer, elected annually for a term of one year by the suffrage, and an executive committee of five, one member chosen each year for a term of five years, and that each member be an Ordained Minister in good standing of the Old Mt. Zion Association, who shall have the authority to transact any business transactions of the Association between sessions of the Association and make a report to the Association annually.

Amendment No. 1 to Article 5

Be it resolved that we amend Article 5 to read that no person can serve two consecutive terms on any standing board.

Amendment No. 2 to Article 5

Be it resolved that current Officers of the Association be retained through the present Association and any new Officers assume responsibilities immediately thereafter.

Article 6. New Churches--Newly organized churches may be admitted to the Association, which are to petition by letter and delegates, and if, upon examination, they are found to be orthodox and orderly, they may be received into the Association, the Moderator giving the right hand of fellowship.

Article 7. Questions--No resolution from any church shall come under consideration of the Association unless it has been first considered in its own church and, if possible, a copy be sent to each church before the Association.

Article 8. Motions--Every motion made and seconded shall come under the consideration of the Association except it be withdrawn by the member who made it.

Article 9. Minutes--The Association is to endeavor to furnish the churches the minutes of the Association in proportion to the amount paid by each church, the distribution to be made at the discretion of the Association.

Article 10. Clerk--It shall be the duty of the Clerk to keep a regular file of the minutes of the Association in a book to be kept by the Association for that purpose.

Article 11. Signatures--The minutes of the Association shall be read and corrected, if needed, and signed by the Moderator and Clerk before the close of the Association.

Article 12. Amendments--Amendments of this Constitution may be made, when necessary, by a two-thirds vote of the members present at any regular session.

Article 13. Non-Attendance--The Association, in case of failure of any church to attend, shall inquire into the case.

Amendment No.1 to Article 13

Be it resolved that churches that fail to be represented by delegation, or letter, for two consecutive years, be notified they will be dropped from our Association.

Article 14. Ordination of Ministers--Old Mt.Zion Association of Free Will Baptists accepts the wording of Epistles I Timothy 3:1-7 and Titus 1:6-9 as authoritative for guidelines to Ordaining Ministers.

Amendment No. 1 to Article 14

Be it therefore resolved that we amend Article 14 of our Constitution in compliance of our State Constitution. That Old Mt. Zion Association of Free Will Baptists accept the wording of the Epistles to Timothy and Titus as authoritative, namely the interpretation of the phrase, "the husband of one wife," to mean that divorced personnel should not be ordained. (I Timothy 3:2, 12; Titus 1:6)

Amendment No. 3 to Article 14

Be it further resolved that no woman be ordained as minister or a deaconess.

Amendment No. 4 to Article 14

Be it further resolved that we recommend to the Executive Board of this Association in their examination of candidates for ordination, to observe greater caution, and in agreement with the instructions of the apostles, "To lay hands suddenly on no man." (I Timothy 4:22)

When a Church member acknowledges their call to the Ministry, they should be licensed by the Church of which they are a member for the period of one year prior to Ordination; or until they have proved themselves to the Church. When the member has proven himself, the church shall call for his Ordination.

That all Churches of Old Mt. Zion Association, in all Ordinations services of Ministers, comply strictly with the rules and regulations laid down by the Free Will Baptist denominations. Said procedure to be conducted by the Local Church.

Amendment No. 5 to Article 14

If any ordained minister of the Old Mt. Zion Association of Free Will Baptists at anytime be found guilty of misconduct, or disregard of any rule or ordinance set forth and practiced by the Constitution of the Old Mt. Zion Association, the said party shall be dealt with according to "Article 14" of the Constitution of the Old Mt. Zion Association as follows:

1. After the local church has made a full and complete investigation as to the misconduct or other charges and the evidence proves to be true—he shall surrender his credentials to the local church or association until said misconduct or other charges have been investigated by the local church or Executive Board. (The local church clerk or associational clerk to hold said credentials.)

2. If after the period of not more than one year after the surrender of his credentials, the said party shall be contacted by the local church of which he is a member or by the Executive Board to try and make restitution. If the local church fails to deal with the charges, then the Executive Board will have the authority to deal with the charges. The Executive Board shall make this report to the regular session of the associational body which will vote on the report as whether to revoke or return the credentials to said party.

Amendment No. 6 to Article 14

Be it resolved that no minister be ordained without written approval of the Executive Board. Be it further resolved that all men who acknowledge their call to preach, upon being licensed, immediately report to the Executive Board. The Executive Board to assign them lessons covering the entire treatise of the Free Will Baptist. We recommend that some of our older ministers be used to administer these lessons. The candidate to meet at least once a month with said minister. Upon completion of lessons, candidate must agree fully with Free Will Baptist doctrine to be ordained.

Amendment No. 7 to Article 14

Be it resolved that the Association instruct the Executive Board not to approve any minister for ordination who uses tobacco in any form.

Amendment No. 8 to Article 14

Be it resolved that Free Will Baptist ministers coming from another Free Will Baptist Association present a letter of good standing from the Association from which he is coming to the Executive Board upon examination to be admitted to the full fellowship of the Association.

Ordained ministers coming from another denomination wishing to unite with Free Will Baptists must first unite with a local Free Will Baptist Church of the Old Mount Zion Association; and will be subject to the same examination by the Executive Board, and if found willing to accept the Free Will Baptist denominations' constitution, will be accepted into full fellowship of the Old Mount Zion Association.

“ARTICLES OF FAITH”

1. **God**--We believe in one true and living Triune God; composed of the Father, Son and Holy Spirit, equal in divine Essence, Purpose, Power and Glory. St. John 1:1, I Cor. 8:6, St. John 10:30; I John 5:7.

2. **Christ**--We believe that Jesus Christ is the divine Son of God, was with the Father and the Holy Spirit at the time of creation, left the Courts of Heaven and came to earth, took upon Himself the form of humanity, sin

excepted, by being born of the Virgin Mary, manifested His power, was crucified, placed in Joseph's tomb, rose again the third day, completed the great plan of salvation, walked and talked with his disciples, publicly ascended to Heaven, and that He will descend again to gather His jewels home. Isaiah 9:6; St. John 1:14; Luke 1:26-28; Matt. 14:13-21; Mark 16:9-19; Luke 24:50-53; Acts 1:9-12; Mark 15:22-41.

3. Holy Spirit--We believe that the Holy Spirit has visited true believers in all ages, and especially since the ascension for the Son back to the Father, and his coming on the day of Pentecost. Has taken up His office work among all nations of people, as a Divine Reprover, Comforter and Guide. Judges 6:34; 11:29; St. John 16:8-14; Isaiah 63:10-12; Ephesians 4:30; Acts 8:17-20.

4. The Bible--We believe the Bible, which is composed of the Scriptures of the Old and New Testaments was given by inspiration of God, is our way-bill from earth to heaven, and the only infallible and inerrant rule of faith and practice. II Peter 1:19-21; II Tim. 3:14-17; Daniel 10:21; Acts 1:16-17; Matt. 21-42.

5. The Fall of Man--We believe that God created man good, gave a just law by which he should be governed, with the promise of reward for faithfulness and with penalties of punishment for disobedience. Gave man power of free moral agency to choose the right and reject the wrong. But our first parents heeded the voice of the great enemy of souls, voluntarily transgressed the law of God, fell with their posterity under the just penalty of the same, and were unable of their own power to extricate or save themselves from the great dilemma into which they had fallen. God gave them the hope of salvation through the coming of Christ. Gen. 1:27, 2:16-17; Rom. 11:11-35; Rom. 5:18; Psalms 37:23-24.

6. Redemption, Salvation, Adoption--We believe that Jesus Christ by His birth, death, burial, resurrection and ascension paid the purchase price for the redemption of the whole human race, arranged a pardon for all who came upon Gospel terms; and a law of adoption into the Kingdom of Heaven and eternal inheritance into the glorified Kingdom above. Heb. 9:12; Gal. 3:13, 4:4-5; Titus 2:14; Heb. 1:4; St. John 3:16; Isaiah 45:22.

7. Condition of Salvation--We believe that all persons dying in infancy and all idiots are saved by the atoning merits of the Son of God without any act on their part, that persons coming to the years of accountability, transgressing the law of God, must upon their part, exercise faith in Jesus Christ through repentance toward God, at the completion of which pardon takes place in the mind of the Father and by the Holy Spirit they pass through the ordeal of regeneration, are washed in the blood of the Lamb and are planted in the Kingdom of Christ. John 3; Matt. 19:13-22; II Cor. 7:10; Luke 18:17; St. John 4:11-16; Psalms 98:3.

8. Salvation Free--We believe that God desires the salvation of all; Christ died for all; the Gospel invites all; the Holy spirit strives for all; and

whosoever will may come and be saved on the terms of the Gospel. Rev. 22:17; I Peter 1:9-13; I Peter 2:9-24; Rom. 3:24.

9. Baptism--We believe that Christian baptism is the immersion of believers in water, in the name of the Father, the Son, and the Holy Ghost, in which are represented the burial and resurrection of Christ; also represents our death to sin, and only those who have come under the presbytery of the elders are qualified to administer the same. Matt. 3:14-16, 3:5-6; I Peter 3:21; St. John 3:23; Acts 10:47; Matt. 28:19.

10. Communion and Feet Washing--We believe that the Lord's Supper and the washing of the saints' feet are ordinances of the Gospel of Christ; The Lord's Supper was instituted by our Savior to commemorate His broken body and shed blood for the sins of the world and to show our remembrance of Him till He comes.

All Christians have a right to the Lord's Supper and should be invited. "Let a man examine himself and so let him eat."

The washing of feet was instituted by our Lord at the same time that Supper was instituted as an act of humility to show our love for each other, and both ordinances should be perpetuated by all Christians until His second coming. Luke 22:19-20; I Cor. 11:20-29; St. John 13:1-18; Matt. 26:26-29.

11. The Sabbath--We believe that the Christian Sabbath should be observed as a day of rest and for the worship of God; that we should abstain from all sinful amusements and secular employments, works of mercy and piety excepted. Exodus 20:11, 31:12-18; Deut. 5:12-15; Ezek. 20:12; Matt. 28:1; Luke 23:56; Acts 13:42-48; Mark 2:27.

12. Call to the Ministry--We believe in a Divine call of the ministry; that God in His goodness and power of grace, impresses His ministers with the burden of lost souls to the extent that the call becomes irresistible with personal contentment; that when they yield to the call and exercise the native gifts according to the Scriptures, with full reliance upon Him, He accompanies them in person of the Holy Spirit to guide them in the way of truth and to bless their labors according to His purposes. Jonah 1:1; Jer. 1:5; Mark 3:14; Acts 1:22-26; Matt. 28:19.

13. The Invisible Church--We believe that the Invisible or Spiritual Church is the redeemed in the aggregate, is the family of God, is composed of all true Christians of every congregation from righteous Abel to the restitution of all things from every kindred, nation, tongue and people. Eph. 3:16-21; Heb. 12:22-23; I Peter 2:5; Eph. 2:20-22; Acts 2:47; Matt. 16:18.

14. The Visible Church--We believe that a visible church of Christ is a congregation of faithful men and women, having obtained fellowship with the Lord and with each other, agreeing to keep up a good discipline and doctrine according to the rules of the Gospel. II Thess. 1:1; Acts 16:5; III John 1:10; Matt. 18:17; Acts 20:28; Rev. 1:4, 11, 20.

15. Perseverance--We believe that all true believers in Christ should persevere in divine graces, and in the knowledge of the truth and that God's

grace is sufficient to help them to overcome all the obstacles of life and that all the combined forces of the great enemy of souls on earth and in Hell (or in his eternal abode) are not able to pluck them from his hand so long as they walk in the path of duty; but those who sidestep and willfully refuse or neglect to perform their duty, they would backslide and if persistently continued, would be eternally lost. II Cor. 9:10; II Peter 1:4-8; II Peter 1:12; I Peter 2:2; Rom. 8:35-39, Apostasy; II Peter 1:8-9; I Cor. 10:1-13; Heb. 12:15-17; I John 5:16; Heb. 6:1-6; I Tim. 4:1-2; Heb. 3:12; St. John 15:1-7; Matt. 12:31-32.

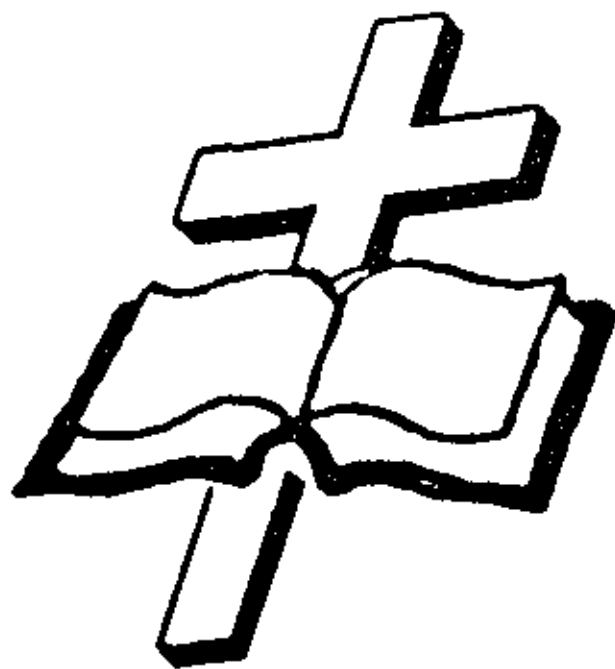
16. Christ the Head of the Church--We believe that Christ is the Great Head of the Church and that the government of the local church is with the body. Col. 1:18-19; Matt. 16:18; Heb. 12:23; Matt. 21:42; Eph. 1:22; Acts. 16:4-5.

17. Sanctification--Sanctification is work of God's grace, by which the soul is cleansed from all sins and wholly consecrated to Christ. It takes place in regeneration, and the Christian can and should abide in this state to the end of life constantly growing in the grace the knowledge of our Lord ..

18. The Resurrection--We believe in the resurrection of the dead, both of the righteous and the wicked. When the resurrection shall take place, the soul and body shall be reunited, the righteous shall be received into everlasting happiness to reign with God forever, but the wicked shall go away into everlasting punishment. Matt. 28:6; St. John 5:28-29; I Cor. 15:51-58.

19. The Soul--The soul is endless, hence does not die with the body, but immediately after death enters into a conscious state of happiness or misery, according to spiritual character here possessed. Phil. 1:23; Luke 23:43; Rev. 6:9; Luke 16:19-25; Matt. 10:28.

20. Judgement--We believe that there will be a general, universal judgment, when all men shall be judged according to their works whether they be good or bad, and that immediately thereafter, the wicked shall enter into everlasting punishment and the righteous into eternal happiness. II Thess. 1:4-9; Rev. 14:9-13; Luke 16:23; Rev. 21:8; II Cor. 5:10; Matt. 12:36-37; Rev. 20:12-13; Acts 17:31.
