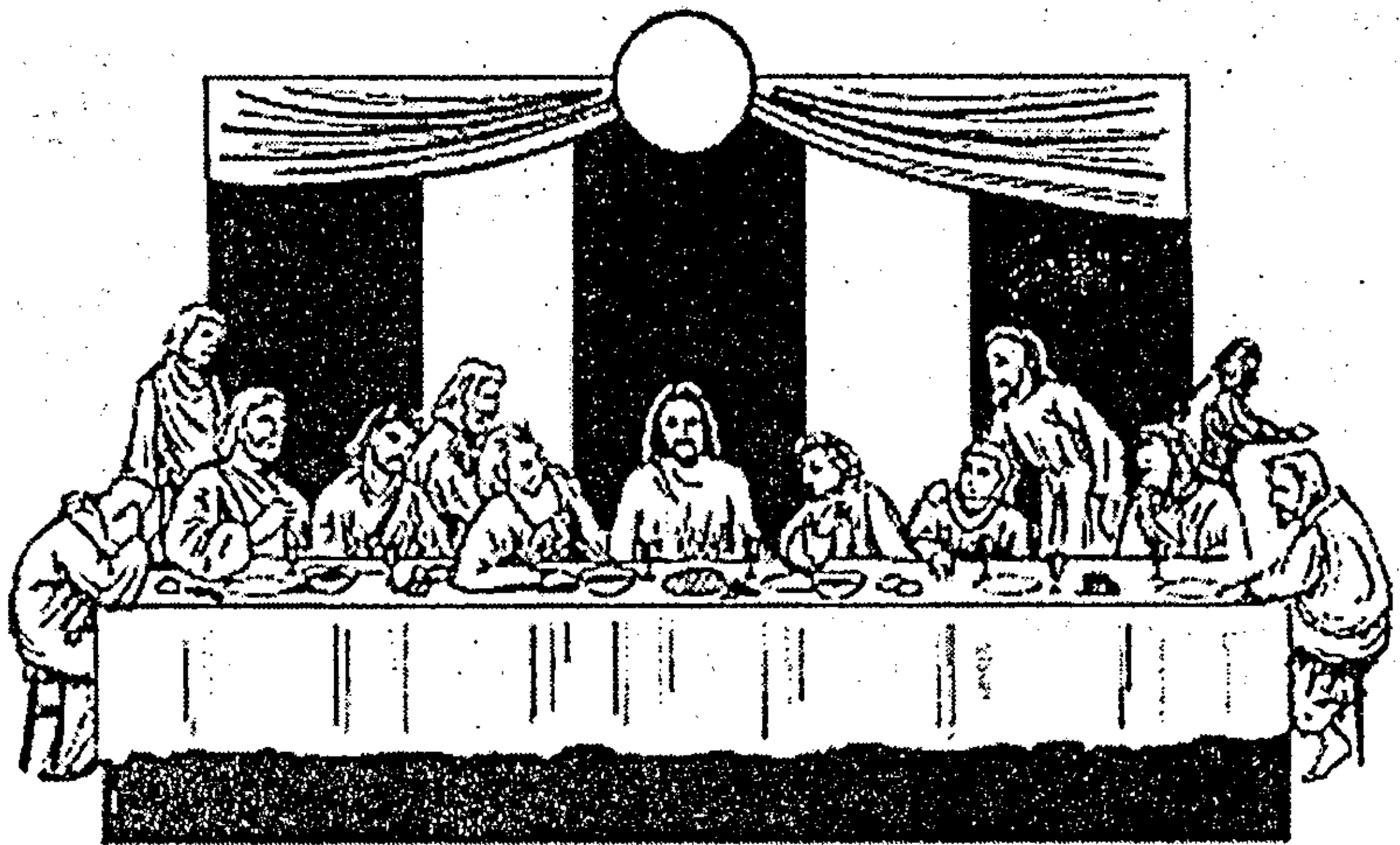

1. Association called to order by the Moderator and in his absence, by the Clerk.
2. Introductory Sermon.

8. Reading of the Rules of Order by the Moderator or Clerk.

10. Reports of committees appointed last Association and other unfinished business.
11. Report of new committees.

13. Reading and adopting minutes.
14. Adjournment.

RULES OF ORDER

1. At every sitting of the Association, business shall be opened and concluded by prayer by the Moderator or whomsoever he may request.

2. Ordained ministers, deacons, church clerks and delegates of Old Mt. Zion Association, when present, are invited to seats, allowed to take part in debates on all subjects, and to vote. Visiting ministers, deacons and delegates are invited to seats, allowed to take part in debates on all subjects, but not to vote.
3. Those who speak shall arise and address the Moderator. Personal reflections shall be avoided in all debates.
4. No motion shall be discussed without a second.
5. When a motion has been made and seconded, and a member opposes its discussion, the Moderator shall put the question, "Shall it be discussed?" If negative, the question shall be dismissed.
6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member, and the vote taken separately.
7. Motions made and lost shall not be recorded.
8. No one shall speak more than twice on the same subject without special leave of the Moderator.
9. All questions shall be decided by a majority vote of all members voting.
10. No member shall absent himself without special leave of the Moderator.
11. Minutes shall be leisurely read and corrected if necessary before the close of the Association.
12. At all future sessions of the Association, arrangements shall be made to insure two sermons, or other devotional exercises equivalent thereto, during each day of the session, and the chair shall announce just before adjournment, who shall preach.
13. These Rules of Order shall be distinctly read from the chair immediately after the organization of the Association.
14. Alterations may be made in these rules at any regular session of the Association.

PROCEEDINGS OF THE 162ND ANNUAL SESSION OF THE OLD MT. ZION ASSOCIATION

The 162nd annual session of the Old Mount Zion Association of Free Will Baptists convened on Thursday, May 1, 2003 at 7:30 p.m. The meeting was called to order by Moderator Loy Counts. Elder Arther Galloway led the opening prayer. Elder Eldon Bagwell led the congregation in singing "Revive Us Again" and "Bring Them In" with Sis. Leona Gurley at the piano. Moderator Loy Counts read I Kings 19:9, I Samuel 3:10 and Acts 9:1 giving the thought "What are we doing?". Special music was rendered by the Elder Calvin Stewart family singing "The Blood That Stained the Old Rugged Cross" and Elder Glen Faulkner singing "Known Only to Him".

The evening message was brought by Elder Cecil Case reading as his text I Corinthians 2: 1-16 and John 15:13. The thought for the message was "Love one another as God loves us". He stated that we need the Spirit of God in our services, but we are afraid of what we need to be full of! He also read from Isaiah 6: 1-8, stating that God wants to use us. The invitation was given with several gathering in the altar for a season of prayer.

Moderator Loy Counts began the business session with the seating of all standing delegates. Assistant Clerk, LaWanda Ash read the list of elected delegates and all delegates present were seated. Moderator Loy Counts appointed the Committee on Committees. Motion was made to adjourn until 9:30 a.m., Friday, May 2, 2003. Elder Jim Spurlock dismissed in prayer.

FRIDAY MORNING, MAY 2, 2003 - 9:30 A.M. SESSION

Moderator Loy Counts called this session to order. Elder Ellis Doyle led the opening prayer. Bro. Steve Ash led the congregation in singing "Press Along to Gloryland" and "I'll Live in Glory", with Sis. Mae Harrison at the piano. Moderator Loy Counts read I Samuel 3:10 for the morning devotion.

Assistant Clerk, LaWanda Ash read the list of delegates. Standing delegates that weren't seated at the Thursday night session were seated at this time. Elected delegates that weren't seated at the Thursday night session were seated at this time. Elder Jason Scott was received as a member of the association pending a letter from his previous association. Motion was made and passed to receive Elder Scott. He was then seated as standing delegate. The associational clerks will send for the letter. Letter from the Old Union Association was read and Elder Jim Sisco was seated as a delegate.

Moderator Loy Counts read the Rules of Order. Discussion concerning the adding of "church clerks as standing delegates" to the Rules of Order. Associational clerks were instructed to add "church clerks" to be permanently printed. Article 1 - Membership will be addressed by the Resolution Committee.

Letters from any newly organized churches were called for and there were none present.

Election of Permanent Officers as follows: Moderator - Elder Paul Payne, Assistant Moderator - Elder Glen Faulkner, Association Clerks - Carla Henson and LaWanda Ash. Report of the Emergency Mission Fund was given by Asst. Clerk LaWanda Ash in the absence of Sis. Dorothy Lathrop. Report was accepted by the delegation. Sis. Dorothy Lathrop also resigned and Sis. Mary Johnson was elected as secretary of the Emergency Mission Fund.

Report of the Board of Trustees was given by Elder Eldon Bagwell and accepted by the delegation. The Board of Trustees will meet to nominate someone to fill the expiring term on the board. Elder Arther Galloway read the report of the Committee on Committees. Report was accepted by the delegation; however, the committee had to meet again and appoint one more person to a committee. Report of the Radio Program was given by Radio Pastor Eldon Bagwell and was accepted by the delegation. Motion was made and passed to give the Radio Pastor full discretion on the radio program and its contents. Elder Eldon Bagwell was elected as Radio Pastor for the coming year. This session was dismissed in prayer by Elder Glen Faulkner.

FRIDAY MORNING WORSHIP SERVICE, 11:00 A.M.

Opening prayer was led by Elder Jason Scott. Bro. Bill and Sis. Mae Harrison led the congregation in singing "Come Unto Me" and "Haven of Rest". Special music was rendered by Bro. Bill and Sis. Mae Harrison singing "Someone to Care". Elder John Starks brought the morning message. He read as his text I Peter 1: 3-9 and Jude 1:20. The thought for the message was "We need to be a people of praise, power and positive persuasion". The invitation was given with Bro. Bill and Sis. Mae Harrison leading the congregation in singing "Must Jesus Bear the Cross Alone". Elder Norman Cline dismissed the service in prayer.

FRIDAY AFTERNOON BUSINESS SESSION, 1:00 P.M.

Moderator Loy Counts called this session to order. Bro. Roy Edgmon led the opening prayer. Elder Glen Faulkner led the congregation in singing "Take My Hand, Precious Lord" and "Down On My Knees" with Sis. Leona Gurley at the piano.

Elder Paul Payne and Elder Ramon Zuniga gave the report of the Executive Board. Elder Paul Payne resigned from the Executive Board. Elder Randy Burris was elected to fill the remaining term of 1 year. Elder Jim Spurlock was elected to the 5 year term on the Executive Board. Report was accepted by the delegation. Report of the Home Missions Board was read by Elder Norman Cline and accepted by the delegation. Report of the Youth Camp Board was given by Bro. Kevin Bowerman and accepted by the delegation. Elder Brad Easter was elected to fill the 5 year term on the Youth Camp Board. Motion was made and accepted to replace the 2 year term of Aaron Kettner. This term will be replaced at the Saturday session pending checking with someone.

Bro. Luverl Day was elected to fill the 5 year term on the Board of Trustees. The Newsletter Report was given by Sis. Shirley Spurlock and accepted by the delegation. Sis Shirley was re-elected as newsletter editor.

Motion was made and passed to give Radio Pastor Eldon Bagwell \$250.00 for travel expenses. This amount to be taken out of the Radio program account. Motion was also made to continue the radio program and motion passed.

Report of the Divine Service Committee was given by Elder Eldon Bagwell and was accepted by the delegation. Motion made and passed to dismiss the Divine Service Committee of 2002. Current committee was retained.

A partial report of the Resolution Committee was given by Elder Jim Spurlock. The partial report was accepted by the delegation. Motion was made to add the words "and church clerks" to the Constitution and Rules of Order as stated. Majority vote taken for the change with no objecting votes.

Obituary Committee Report was given by Sis. Naomi George and was accepted by the delegation. Motion was made and accepted to print 9 obituaries that were turned in as "by request" in minutes. Motion made and accepted to discharge the Obituary Committee. This session was dismissed in prayer by Elder Jim Sisco.

FRIDAY EVENING COMMUNION AND FEET WASHING SERVICE

The 7:30 p.m. service was opened by Asst. Moderator David Watson with the opening prayer led by Elder Earl Dean Morris. Bro. Steve and Sis. LaWanda Ash led the congregation in singing "Come and Dine" and "There Is a Fountain". Asst. Moderator David Watson read I Corinthians 11:26 with the thought "Remembering what Christ did for us". Special music was rendered by Morgan Hull singing "Whiter Than Snow", Bro. Steve and Sis. LaWanda Ash singing "I Got It That Way" and Sis. Thelma Burton singing "I'll Be Waiting on the Far Side Banks of Jordan". Elder Eldon Bagwell led in prayer. Elder Lester Harp brought the evening message reading John 13:1-17 as the text and reminded us of the "Lost Ordinances: Communion and Feet Washing". He also read I Corinthians 11:19-26. He stated that our young people need to see a picture of what Jesus means to you and I.

Asst. Moderator David Watson took charge of the Communion Service with 10 ministers and 4 deacons to serve. Elder Kenneth Lynch blessed the bread and Elder Arther Galloway blessed the fruit of the vine.

There were a total of 36 participants in the feet washing service (16 men and 20 women).

SATURDAY MORNING BUSINESS SESSION, MAY 3, 2003 9:30 A.M.

Asst. Moderator David Watson called the session to order. Elder Bruce Coyle led the opening prayer. Elder Eldon Bagwell led the congregation in singing "I'd Rather Have Jesus" and "Take the Name of Jesus with You" with Sis. Leona Gurley at the piano. Asst. Moderator David Watson read John 13:34 for devotion with the thought "Loving One Another". Standing delegates that had not been previously seated were seated at this time and any elected delegates that had not been seated previously were seated at this time by the delegation.

Christian Education Board Report was read by Asst. Clerk LaWanda Ash in the absence of the board members. The report was accepted as read by the delegation. Motion was made and accepted to replace the 1 year remaining term of Elder Greig Caswell who has taken a church at Vilonia, Arkansas. Bro. Stephen O'Neill was elected by the delegation to fill this term. Bro. Raymond Day was elected to fill the 5 year term.

Non-Represented Churches report was given by Elder Ellis Doyle. As of this date all churches have reported. The report was accepted by the delegation and this committee was discharged.

Finance Committee Report was given by Sis. Mary L. Reeves. The report was accepted by the delegation and this committee was discharged.

Quarterly Council Report was given by Asst. Clerk LaWanda Ash and accepted by the delegation. Motion was made to print 600 minutes and clerks were asked to use their discretion if this needs to be changed. Motion was accepted by the delegation.

Elder David Watson gave report about the state work - Christian Bookstore and also on the Acts 1:8 Program, stating that Home Missionaries have now been added as well as the Foreign Missionaries. Bro. David Joslin is now the representative for this district for Families and Children's Ministries.

Bro. Don Terry was elected by the delegation to fill the 5 year term on the Home Mission Board. Bro. Jimmy Baker was elected by the delegation to fill the 2 year term on the Youth Camp Board.

Announcement was made by the clerks for all new board members to see them before going home to give phone numbers and names.

Motion was made and passed by the delegation to change the time on Thursday night and Friday night to 7:00 p.m. instead of 7:30 p.m. Elder Eldon Bagwell addressed the delegation concerning the basement leaking and possible repairs. He also announced that Bro. James Hamilton will be doing the mowing this year and the mower is now being repaired. Announced that Youth Camp work day will be May 31, 2003.

Question concerning the printing of the time of the Saturday night youth service was discussed and the delegation decided to print "to be announced".

Delegates to the Arkansas State Association on August 5th and 6th were elected as follows: Sis. Mae Harrison and Sis. Judy Payne. Delegates to the National Association of Free Will Baptists in Tampa, Florida were elected as follows: Sis. Ede Zuniga. Delegates to the Old Union Association at Mossville United Baptist Church on September 19, 2003 were elected as follows: Elder Cecil Case, Bro. Roy Edgmon, and Elder Norman Cline. Elder Paul Payne reminded the delegation to pray and help financially with the Hispanic Work in Springdale.

Motion was made and passed to adjourn until the 163rd Session to begin Thursday night, April 29, 2004 at 7:00 p.m.. Elder Jim Spurlock dismissed in prayer.

SATURDAY MORNING MEMORIAL SERVICE, 11:00 A.M.

The Memorial Service was opened with prayer by Elder Lester Harp. Elder Glen Faulkner led the congregation in singing "Amazing Grace" with Sis. LaWanda Ash at the piano. Balance as of February 1, 2003 was \$6,208.09. Interest accrued was \$8.87 for the past 3 months making a balance of \$6,216.96. The board received \$719.21 in receipts for this quarterly bringing the balance to \$6,936.17.

REPORT OF CHRISTIAN EDUCATION BOARD

The Christian Education Board met on Tuesday, February 18 and Friday, March 21, 2003. The meetings were opened in prayer. Items discussed at the meeting were as follows: 1) Went over the final letter to be mailed out in regard to District Competition and made any changes that needed to be made 2) Discussed judges we had contacted and made list of additional judges we could contact before district. 3) Discussed alternative ways to possibly present the awards for district and decided to present the awards and plaques at the District Competition 4) Got the addresses for judges in order to send them a confirmation letter in March confirming them as a judge for our district on April 5, 2003 at Huntsville. RESOLUTIONS:

(Permanently Printed)

Resolution #1: Be it resolved that the Association set aside Saturday night of the conference each year for the youth of our churches to make their reports concerning their work and to be in charge of the worship service for that night, with privilege of selecting a speaker or speakers for the service.

Resolution #2: That attention be called to Article 3 of the Constitution of this Association, as terms of receiving members into the local church as, namely: (1)profession of faith; (2)by letter of recommendation; (3)by restoration; (4)by denominational choice.

Resolution #3: That Article 1, Membership, be amended to read: All regularly ordained ministers and deacons of this Association becoming properly credentialed and in full fellowship and good standing in the church of which they are members shall be entitled to seats as a delegate, by virtue of their office.

Resolution #4: Be it resolved that we give adequate support and approval to Home Mission work in the bounds of the Old Mt. Zion Association such as assisting in organizing and establishing new churches. Said work to be under the supervision of the Home Mission Board (amended August, 1979) consisting of five ordained ministers or deacons in good standing.

Resolution #5: (amended 1992) Be it resolved that the churches of Old Mt. Zion go on record as denouncing the modern day doctrine of speaking in tongues as a part of the doctrine of a second work of grace (following regeneration and calling it the Baptism of the Holy Ghost), as heresy, and unsound doctrine. We warn any church (endorsing such, or having members in their churches advocating such) to purge out such or stand in risk of losing their place in this Association.

Resolution #6: Be it resolved, "Any church desiring a resolution to be voted on at setting of Association, send a copy of proposed resolution to each church of Old Mt. Zion before Association convenes; that is, if possible."

Resolution #15: Be it resolved that the churches of the Old Mt. Zion Association give support and prayer to the work being done in the Hispanic community in Northwest Arkansas.

CHURCH COVENANT

Having been brought, as we believe, by the divine grace to accept the Lord Jesus Christ as our Saviour and Preserver, we do now solemnly and joyfully covenant and agree by God's help to walk together in brotherly love.

We, therefore, enter into covenant as members of this church, and as Christians, that we will watch over each other in love, sharing together each other's joys and sorrows; that we will not forsake the assembling of ourselves together, nor omit the great duty of prayer for ourselves and others; that by Divine assistance we will endeavor to bring up those under our care in the nurture and admonition of the Lord; that in all things we will strive to exemplify our profession by a corresponding practice, to abstain from all sinful conformity to the world, to be just in our dealings, faithful in our agreements, and exemplary in all our deportment; that we will abstain from the sale and use of intoxicating liquor as beverage; that we will contribute cheerfully according to our ability, to support of the ministry, the expense of the church, the relief of the poor and the

general spread of the Gospel.

In keeping this solemn covenant, may we ever enjoy the blessings and presence of the Great Head of the church, which is Jesus Christ the Saviour.

CONSTITUTION

From long experience, we, the members of the Church of God (denominated Free Will Baptists) being regularly baptized upon profession of our faith in our Lord Jesus Christ, and being convinced of the necessity of a combination of churches to perpetuate a union among us, and to preserve and maintain correspondence with each other, do therefore, ordain this Constitution for our better Church government.

Article 1. Membership-This Association shall be composed of members chosen by the different churches of our union, not exceeding three messengers from each church, and upon producing letter, they shall be entitled to seats. All regularly ordained ministers, deacons, and church clerks of this Association becoming properly credentialed and in full fellowship and good standing in the church of which they are members, shall be entitled to seats as a delegate, when present, by virtue of their office.

Article 2. Name-The members thus chosen and assembled with the ministers and deacons, to be denominated the Old Mt. Zion Association of Free Will Baptists being composed of the several churches of our union, the Association having no power over the churches reserving the right of withdrawing from any church becoming disorderly.

Article 3. Letters-Letters from the different churches representing are to express their number in fellowship including the names and addresses of ordained and licensed ministers, the number of members received upon profession of faith, by letter of recommendation, by restoration or denominational choice; the number of members dismissed by letter, excluded, and those having died since last Association. Churches, in sending their letters, may send obituaries of anyone who died during the year, that we may keep up the memorial to our dead.

Article 4. Dismissing Members-Our churches, upon granting letters of dismissal to any of its members, shall require a notice from the church receiving said letter that it has been received.

Article 5. Officers-The Association to have a Moderator and an Assistant Moderator, Clerk-Treasurer, and an Assistant Clerk-Treasurer, elected annually for a term of one year by the suffrage, and an executive committee of five, one member chosen each year for a term of five years, and that each member be an Ordained Minister in good standing of the Old Mt. Zion Association, who shall have the authority to transact any business transactions of the Association between sessions of the Association and make report to the Association annually.

Amendment #1 to Article 5

Be it resolved that we amend Article 5 to read that no person can serve two consecutive terms on any standing board.

Amendment #2 to Article 5

Be it resolved that current Officers of the Association be retained through the present Association and any new Officers assume responsibilities immediately thereafter.

Amendment #3 to Article 5

Be it resolved that we reorganize our leadership structure to elect a Moderator, Assistant Moderator, Clerk, and Assistant Clerk who will serve this body by presiding over the associational meetings at the annual session and the three quarterly meetings.

Article 6. New Churches-Newly organized churches may be admitted to the Association, which are to petition by letter and delegates, and if, upon examination, they

are found to be orthodox and orderly, they may be received into the Association, the Moderator giving the right hand of fellowship.

Article 7. Questions-No resolution from any church shall come under consideration of the Association unless it has been first considered in its own church and, if possible, a copy be sent to each church before the Association.

Article 8. Motions-Every motion made and seconded shall come under the consideration of the Association except it be withdrawn by the member who made it.

Article 9. Minutes-The Association is to endeavor to furnish the churches the minutes of the Association in proportion to the amount paid by each church, the distribution to be made at the discretion of the Association.

Article 10. Clerk-It shall be the duty of the Clerk to keep a regular file of the minutes of the Association in a book to be kept by the Association for that purpose.

Article 11. Signature-The minutes of the Association shall be read and corrected, if needed, and signed by the Moderator and Clerk before the close of the Association.

Article 12. Amendments-Amendments of this Constitution may be made, when necessary, by a two-thirds vote of the members present at any regular session.

Article 13. Non-attendance-The Association, in case of failure of any church to attend, shall inquire into the case.

Amendment #1 to Article 13

Be it resolved that churches that fail to be represented by delegation, or letter, for two consecutive years, be notified they will be dropped from our Association.

Article 14. Ordination of Ministers-Old Mt. Zion Association of Free Will Baptists accepts the wording of Epistles 1 Timothy 3:1-7 and Titus 1:6-9 as authoritative for guidelines to Ordaining Ministers.

Amendment #1 to Article 14

Be it therefore resolved that we amend Article 14 of our Constitution in compliance of our State Constitution. That Old Mt. Zion Association of Free Will Baptists accept the wording of the Epistles to Timothy and Titus as authoritative, namely the interpretation of the phrase, "the husband of one wife", to mean that divorced personnel should not be ordained. (1 Timothy 3:2, 12; Titus 1:6)

Amendment #3 to Article 14

Be it further resolved that no woman be ordained as minister or a deaconess.

Amendment #4 to Article 14

Be it further resolved that we recommend to the Executive Board of this Association in their examination of candidates for ordination, to observe greater caution, and in agreement with the instructions of the apostles, "To lay hands suddenly on no man." (1 Timothy 4:22)

When a Church member acknowledges their call to the Ministry, they should be licensed by the Church of which they are a member for the period of one year prior to Ordination; or until they have proved themselves to the Church. When the member has proved himself, the church shall call for his Ordination.

That all Churches of Old Mt. Zion Association, in all Ordinations services of Ministers, comply strictly with the rules and regulations laid down by the Free Will Baptist denominations. Said procedure to be conducted by the Local Church.

Amendment #5 to Article 14

If any ordained minister of the Old Mt. Zion Association of Free Will Baptists at anytime be found guilty of misconduct, or disregard of any rule or ordinance set forth and practiced by the Constitution of the Old Mt. Zion Association, the said party shall be dealt with according to "Article 14" of the Constitution of the Old Mt. Zion Association as follows:

1. After the local church has made a full and complete investigation as to the misconduct or other charges and the evidence proves to be true-he shall surrender his credentials to the local church or association until said misconduct or other charges have been investigated by the local church or Executive Board. (The local church clerk or associational clerk to hold said credentials.)

2. If after the period of not more than one year after the surrender of his credentials, the said party shall be contacted by the local church of which he is a member or by the Executive Board to try and make restitution. If the local church fails to deal with the charges, then the Executive Board will have the authority to deal with the charges. The Executive Board shall make this report to the regular session of the Associational body which will vote on the report as whether to revoke or return the credentials to said party.

Amendment #6 to Article 14

Be it resolved that no minister be ordained without written approval of the Executive Board. Be it further resolved that all men who acknowledge their call to preach, upon being licensed, immediately report to the Executive Board. The Executive Board to assign them lessons covering the entire treatise of the Free Will Baptist. We recommend that some of our older ministers be used to administer these lessons. The candidate to meet at least once a month with said minister. Upon completion of lessons, candidate must agree fully with Free Will Baptist doctrine to be ordained.

Amendment #7 to Article 14

Be it resolved that the Association instruct the Executive Board not to approve any minister for ordination who uses tobacco in any form.

Amendment #8 to Article 14

Be it resolved that Free Will Baptist ministers coming from another Free Will Baptist Association present a letter of good standing from the Association from which he is coming to the Executive Board upon examination to be admitted to the full fellowship of the Association.

Ordained ministers coming from another denomination wishing to unite with Free Will Baptists must first unite with a local Free Will Baptist Church of the Old Mt. Zion Association; and will be subject to the same examination by the Executive Board, and if found willing to accept the Free Will Baptist denominations' constitution, will be accepted into full fellowship of the Old Mt. Zion Association.

“ARTICLES OF FAITH”

1. **God**-We believe in one true and living Triune God; composed of the Father, Son, and Holy Spirit, equal in divine Essence, Purpose, Power and Glory. (St. John 1:1; 1 Cor. 8:6; St. John 10:30; 1 John 5:7.)

2. **Christ**-We believe that Jesus Christ is the divine Son of God, was with the Father and the Holy Spirit at the time of creation, left the Courts of Heaven and came to earth, took upon Himself the form of humanity, sin excepted, by being born of the Virgin Mary, manifested His power, was crucified, placed in Joseph's tomb, rose again the third day, completed the great plan of salvation, walked and talked with his disciples, publicly ascended to Heaven, and that He will descend again to gather His jewels home. (Isaiah 9:6; St. John 1:14; Luke 1:26-28; Matt. 14:13-21; Mark 16:9-19; Luke 24:50-53; Acts 1:9-12; Mark 15:22-41.)

3. **Holy Spirit**-We believe that the Holy Spirit has visited true believers in all ages, and especially since the ascension for the Son back to the Father, and his coming on the day of Pentecost. Has taken up His office work among all nations of people, as a Divine Reprover, Comforter and Guide. (Judges 6:34, 11:29; St. John 16:8-14; Isaiah 63:10-12;

Ephesians 4:30; Acts 8:17-20.)

4. The Bible-We believe the Bible, which is composed of the Scriptures of the Old and New Testaments was given by inspiration of God, is our way-bill from earth to heaven, and the only infallible and inerrant rule of faith and practice. (2 Peter 1:19-21; 2 Tim. 3:14-17; Daniel 10:21; Acts 1:16-17; Matt. 21:42.)

5. The Fall of Man-We believe that God created man good, gave a just law by which he should be governed, with the promise of reward for faithfulness and with penalties of punishment for disobedience. Gave man power of free moral agency to choose the right and reject the wrong. But our first parents heeded the voice of the great enemy of souls, voluntarily transgressed the law of God, fell with their posterity under the just penalty of the same, and were unable of their own power to extricate or save themselves from the great dilemma into which they had fallen. God gave them the hope of salvation through the coming of Christ. (Gen. 1:27, 2:16-17; Rom. 11:11-35; Rom. 5:18; Psalms 37:23-24.)

6. Redemption, Salvation, Adoption-We believe that Jesus Christ by His birth, death, burial, resurrection and ascension paid the purchase price for the redemption of the whole human race, arranged a pardon for all who came upon Gospel terms; and a law of adoption into the Kingdom of Heaven and eternal inheritance into the glorified Kingdom above. (Heb. 9:12; Gal. 3:13, 4:4-5; Titus 2:14; Heb. 1:4; St. John 3:16; Isaiah 45:22.)

7. Condition of Salvation-We believe that all persons dying in infancy and all idiots are saved by the atoning merits of the Son of God without any act on their part, that persons coming to the years of accountability, transgressing the law of God, must upon their part, exercise faith in Jesus Christ through repentance toward God, at the completion of which pardon takes place in the mind of the Father and by the Holy Spirit they pass through the ordeal of regeneration, are washed in the blood of the Lamb and are planted in the Kingdom of Christ. (John 3; Matt. 19:13-22; 2 Cor. 7:10; Luke 18:17; St. John 4:11-16; Psalms 98:3.)

8. Salvation Free-We believe that God desires the salvation of all; Christ died for all; the Gospel invites all; the Holy Spirit strives for all; and whosoever will may come and be saved on the terms of the Gospel. (Rev. 22:17; 1 Peter 1:9-13; 1 Peter 2:9-24; Rom. 3:24.)

9. Baptism-We believe that Christian baptism is the immersion of believers in water, in the name of the Father, the Son, and the Holy Ghost, in which are represented the burial and resurrection of Christ; also represents our death to sin, and only those who have come under the presbytery of the elders are qualified to administer the same. (Matt. 3:14-16, 3:5-6; 1 Peter 3:21; St. John 3:23; Acts 10:47; Matt. 28:19.)

10. Communion and Feet Washing-We believe that the Lord's Supper and the washing of the saints' feet are ordinances of the Gospel of Christ; The Lord's Supper was instituted by our Savior to commemorate His broken body and shed blood for the sins of the world and to show our remembrance of Him till He comes.

All Christians have a right to the Lord's Supper and should be invited. "Let a man examine himself and so let him eat."

The washing of feet was instituted by our Lord at the same time that Supper was instituted as an act of humility to show our love for each other, and both ordinances should be perpetuated by all Christians until His second coming. (Luke 22:19-20; 1 Cor. 11:20-29; St. John 13:1-18; Matt. 26:26-29.)

11. The Sabbath-We believe that the Christian Sabbath should be observed as a day of rest and for the worship of God; that we should abstain from all sinful amusements and secular employments, works of mercy and piety excepted. (Exodus 20:11, 31:12-18; Deut. 5:12-15; Ezek. 20:21; Matt. 28:1; Luke 23:56; Acts 13:42-48; Mark 2:27.)

12. Call to the Ministry-We believe in a Divine call of the ministry; that God in His goodness and power of grace, impresses His ministers with the burden of lost souls to the extent that the call becomes irresistible with personal contentment; that when they yield to the call and exercise the native gifts according to the Scriptures, with full reliance upon Him. He accompanies them i person of the Holy Spirit to guide them in the way of truth and to bless their labors according to His purposes. (Jonah 1:1; Jer. 1:5; Mark 3:14; Acts 1:22-26; Matt. 28:19.)

13. The Invisible Church-We believe that the Invisible or Spiritual Church is the redeemed in the aggregate, is the family of God, is composed of all true Christians of every congregation from righteous Able to the restitution of all things form every kindred, nation, tongue and people. (Eph. 3:16-21; Heb. 12:22-23; 1 Peter 2:5; Eph. 2:20-22; Acts 2:47; Matt. 16:18.)

14. The Visible Church-We believe that a visible church of Christ is a congregation of faithful men and women, having obtained fellowship with the Lord and with each other, agreeing to keep up a good discipline and doctrine according to the rules of the Gospel. (2 Thess. 1:1; Acts 16:5; 3 John 1:10; Matt. 18:17; Acts 20: 28; Rev. 1:4, 11, 20.)

15. Perseverance-We believe that all true believers in Christ should persevere in divine graces, and in the knowledge of truth and that God's grace is sufficient to help them to overcome all the obstacles of life and that all the combined forces of the great enemy of souls on earth and in Hell (or in his eternal abode) are not able to pluck them from his hand so long as they walk in the path of duty; but those who sidestep and willfully refuse or neglect to perform their duty, they would backslide and if persistently continued would be eternally lost. (2 Cor. 9:10; 2 Peter 1:4-8, 12; 1 Peter 2:2; Rom. 8:35-39 Apostasy 2 Peter 1:8-9; 1 Cor. 10:1-13; Heb. 12:15-17; 1 John 5:16; Heb. 6:1-6; 1 Tim. 4:1-2; Heb. 3:12; St. John 15:1-7; Matt. 12: 31-32.)

16. Christ the Head of the Church-We believe that Christ is the Great Head of the Church and that the government of the local church is with the body. (Col. 1:18-19; Matt. 16:18; Heb. 12:23; Matt. 21:42; Eph. 1:22; Acts 16:4-5.)

17. Sanctification-Sanctification is work of God's grace, by which the soul is cleansed from all sins and wholly consecrated to Christ. It takes place in regeneration, and the Christian can and should abide in this state to the end of life constantly growing in the grace the knowledge of our Lord. (1 Cor. 6:11; 2 Thess. 2:13; Heb. 12: 14; Phil. 3:21; St. John 17:17-19; 2 Tim 2:20; 1 Thess. 5:19-23.)

18. The Resurrection-We believe in the resurrection of the dead, both of the righteous and the wicked. When the resurrection shall take place, the soul and body shall be reunited, the righteous shall be received into everlasting happiness to reign with God forever, but the wicked shall go away into everlasting punishment. (Matt. 28:6; St. John 5:28-29; 1 Cor. 15:51-58.)

19. The Soul-The soul is endless, hence does not die with the body, but immediately after death enters into a conscious state of happiness or misery, according to spiritual character here possessed. (Phil. 1:23; Luke 23:43; Rev. 6:9; Luke 16:19-25; Matt. 10:28.)

20. Judgment-We believe that there will be a general, universal judgment, when all men shall be judged according to their works whether they be good or bad, and that immediately thereafter, the wicked shall enter into everlasting punishment and the righteous into eternal happiness. (2 Thess. 1:4-9; Rev. 14:9-13; Luke 16:23; Rev. 21:8; 2 Cor. 5:10; Matt. 12:36-37; Rev. 20:12-13; Acts 17:31.)

OLD MT. ZION ASSOC. BOARD DUTIES AND RESPONSIBILITIES

EXECUTIVE BOARD

Responsibilities and duties are set forth in the Constitution Article 5 and Article 14: (1) examination of candidates for ordination to the ministry. (2) assist the local church in dealing with any ordained minister guilty of misconduct. (3) request credentials of any minister not complying.

HOME MISSION BOARD

Responsibilities and duties as set forth in Resolution #4: "Be it resolved that we give adequate support and approval to Home Mission work in the bounds of the Old Mt. Zion Association such as assisting in organizing and establishing new churches. Said work to be under the supervision of the Home Mission Board consisting of five ordained ministers or deacons in good standing."

YOUTH CAMP BOARD

Responsibilities: (1) set dates for youth camp, skating, lock ins, fun days, youth services, workers banquets, and other youth related activities. (2) organizes all speakers for activities listed above. (3) facilitates, regulates, and delegates authority for all above activities. (4) makes sure grounds are in order for camp (light hot water heaters, check gas tank, dorms, bathrooms, playground equip.) (5) answers to the Executive Board and the delegates association.

CHRISTIAN EDUCATION BOARD

Purpose and Responsibilities: The Christian Education (CE) Board was formed and is held responsible for the organizing and sponsoring of the District CTS Competition. In addition all funds designed for the CE Board are to be used for funding the District CTS Competition. The first Saturday in April is to be set aside for the District CTS Competition.

TRUSTEES OF THE ASSOCIATION PROPERTY

Defined the roll of the Board of Trustees as: (1) overseers of the property and the maintenance of building and grounds of the Association Youth Camp grounds. (2) must approve the functions which take place on the Youth Camp grounds.

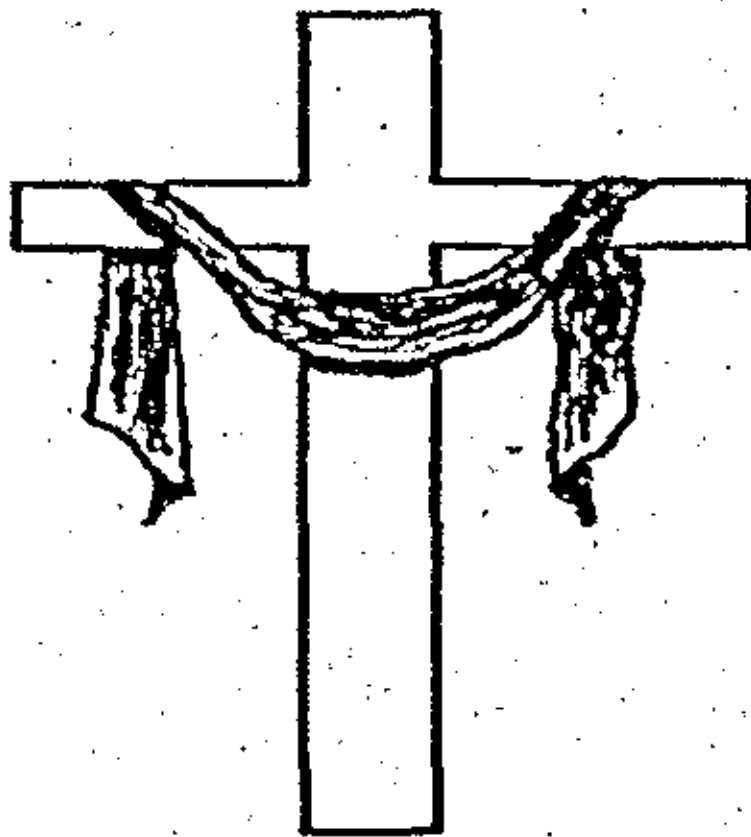
