RULES OF ORDER

1. At every sitting of the Association, business shall be opened and concluded by prayer by the Moderator or whomsoever he may request.
2. Ordained ministers, deacons, church clerks and delegates of Old Mt. Zion Association, when present, are invited to seats, allowed to take part in debates on all subjects, and to vote. Visiting ministers, deacons and delegates are invited to seats, allowed to take part in debates on all subjects, but not to vote.
3. Those who speak shall arise and address the Moderator. Personal reflections shall be avoided in all debates.
4. No motion shall be discussed without a second.
5. When a motion has been made and seconded, and a member opposes its discussion, the Moderator shall put the question, "Shall it be discussed?" If negative, the question shall be dismissed.
6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member, and the vote taken separately.
7. Motions made and lost shall not be recorded.
8. No one shall speak more than twice on the same subject without special leave of the Moderator.
9. All questions shall be decided by a majority vote of all members voting.
10. No member shall absent himself without special leave of the Moderator.
11. Minutes shall be leisurely read and corrected if necessary before the close of the Association.
12. At all future sessions of the Association, arrangements shall be made to insure two sermons, or other devotional exercises equivalent thereto, during each day of the session, and the chair shall announce just before adjournment, who shall preach.
13. These Rules of Order shall be distinctly read from the chair immediately after the organization of the Association.
14. Alterations may be made in these rules at any regular session of the Association.

PROCEEDINGS OF THE 164TH ANNUAL SESSION OF THE OLD MT. ZION ASSOCIATION

The 164th annual session of the Old Mt. Zion Association of Free Will Baptists convened on Thursday, May 5, 2005, at 7:00 p.m. The meeting was called to order by Moderator Paul Payne. Elder Bruce Coyle led the opening prayer. Bro. Bill and Sister Mae Harrison led the opening songs "This World Is Not My Home" and "In the Shadow of the Cross." Bro. Bill and Sis. Mae Harrison also sang "I Can't Even Walk Without You Holding My Hand". Elder Eddie Davis brought the evening message from 1 Corinthians 2:9-13, and brought out the point that "If the Spirit of God is in us, that Spirit will minister to people around us through us." "Take My Hand, Precious Lord" was the song of invitation.

Moderator Paul Payne called the business session to order, and seated all standing delegates. Clerk Carla Henson read the names of the elected delegates from each church and they were seated. The appointment of the Committee on Committees were as follows: Chairman, Elder Jim Spurlock, Elder Randy Burris, Elder Eldon Bagwell, Elder Earl Dean Morris, and Elder Glen Faulkner. This session of business was adjourned and dismissed in prayer by Elder Eldon Bagwell.

FRIDAY MORNING, MAY 6, 2005- 9:30 SESSION

Moderator Paul Payne called the session to order. Elder Clark Snow led the opening prayer. Bro. Steve Ash led the congregation in singing "We'll Work Till Jesus Comes" and "Press Along to Glory Land" with Sis. LaWanda Ash at the piano. Moderator Paul Payne read Proverbs 15:1 for the morning devotion.

Assistant Clerk LaWanda Ash read the list of delegates. Standing delegates that weren't seated Thursday night session were seated at this time. Elected delegates that weren't seated at the Thursday night session were seated. The letter petitioning to become a part of the Association was read and was received by the body. The letter from the Union Association of United Baptists was read accepted with no delegates present.

Assistant Clerk, LaWanda Ash read the Rules Of Order. The Committee on Committees Report was given by Elder Jim Spurlock. Election of Permanent Officers as follows: Moderator- Paul Payne, Assistant Moderator- Glen Faulkner, Clerks-Carla Henson and LaWanda Ash. The Radio Program was given by Moderator Paul Payne in the absence of Elder Eddie Davis, and was accepted by the body. The body also elected Elder Eddie Davis as radio pastor. The District Women's Auxiliary report was read by Assistant Clerk, LaWanda Ash, and accepted by the body. The Mission Emergency Report was given by Elder Ernest Johnson. They also re-elected Sis. Mary Johnson to serve as secretary of the Mission Emergency Fund. A brief oral report of the Board of Trustees was given by Elder Eldon

Bagwell. The Newsletter report was given by Elder Jim Spurlock and accepted by the body. Sis. Shirley Spurlock was elected to serve as editor. Elder Leon Hodge dismissed this session in prayer.

FRIDAY MORNING WORSHIP SERVICE, 11:00 A.M.

The worship service was opened with singing, "That's Why I Love Him So" led by Elder Eldon Bagwell with Sis. LaWanda Ash at the piano. The special was by Sis. Patsy Coyle. Elder Jerry Henshaw brought the morning message using as his text Romans 12:1,2, and read from Psalm 37:3-5. He spoke about surrendering our entire being to God. He said he is thankful to God for the one's in the past and present that have committed themselves to God and made the Association what it is today. Elder Noel Easterling led in prayer after the message and Bro. Frank Bush dismissed in prayer for lunch.

FRIDAY AFTERNOON BUSINESS SESSION, 1:00 P.M.

Moderator Paul Payne called this session to order. Bro. Steve Ash led the congregation in singing "I'll Live In Glory" with Sis. LaWanda Ash at the piano. Elder Earl Dean Morris led the opening prayer.

The Executive Board Report was given by Elder Jim Spurlock and was accepted by the body. Elder Jim Spurlock resigned from the board. Home Mission Board Report was given by Elder Norman Cline and accepted by the body. The body elected Elder Jason Scott to serve in the 5 year term. The Christian Education Board Report was given by Assistant Clerk, LaWanda Ash, and accepted. The body also made a motion to Table the filling of the 5-year term on the Christian Education until Saturday. The Youth Camp Board report was given by LuVerl Day in absence of board members, and it was accepted. The term of Bro. Jimmy Baker expired and the board recommended putting him back on the 5-year term. Elder Dusty Rhodes resigned, and the board recommended Bro. Wade Graham to complete his term. The body voted to accept these recommendations. Elder Eldon Bagwell gave a little more report on the Trustee Board and recommended Bro. Randy James to fill the 5-year term. The body voted to accept the recommendation. The Clerk Report was given by Assistant Clerk, LaWanda Ash, and accepted by the body. She also recommended adding to page 23, Resolution #6, "and Associational Clerks" and to page 25, Article 7, "and Associational Clerk". The body accepted the recommendation and the change will be made in the next minutes. The Executive Report was given by Elder Ernest Johnson. He recommended Elder Calvin Stewart to the 3-year term replacing Elder Jim Spurlock. The body accepted the recommendation and also elected Elder Dewayne Lane to serve on the 5-year term. The Resolution Committee Report was given by Elder Lowell Bradley. They suggested a resolution for resolution #5 to be replaced with pages 18 and 19 of the Treatise of the Faith and Practices of the National Association of Free Will Baptists, Inc. They also gave the ladies a standing vote of thanks for lunch and gave the officers of the Association a rising vote of thanks for a job well done. The report was accepted by the body and voted to accept recommendation of Resolution Board for changes to Resolution #5. The Finance Committee report was given by Bro. Steve Ash and was received by the body. There was also a standing vote of thanks to officers of the Association. The Divine Service report was given by Elder Bruce Coyle and was accepted by the body. The 2004 Divine Service Committee was dismissed and the 2005 was retained. The 2004 Resolution Committee was dismissed and the 2005 committee was retained. The 2005 Finance Committee was dismissed.

Elder Kenneth Lynch dismissed this business session in prayer until 9:30 a.m. Saturday, May 7.

FRIDAY EVENING COMMUNION AND FEET WASHING SERVICE

The 7:00 p.m. service was opened by Assistant Moderator, Glen Faulkner. Bro. Steve Ash and Sis. LaWanda Ash led the congregation in singing "I Feel Like Traveling On" and "Come and Dine". Elder Glen Faulkner spoke about our worship with God, and talked about Jesus meeting with the Samaritan woman. Elder Arther Galloway led in prayer. The specials were by Elder Glenn Faulkner, and Bro. Jimmy Whittle. The evening message was brought by Elder Anthony Lane from Matthew 26:26-30, Revelation 19:5-9, John 17:21-24 and Exodus 10:8,9. He entitled his message "Soon the Marriage Supper". He talked about Christ's love and how God left a way of transportation. Several gathered in the altar for a time of prayer. After the invitation Assistant Moderator Glenn Faulkner began the Communion Service with 9 ministers and 3 deacons. Elder Ernest Johnson blessed the bread and Elder Randy Burris blessed the juice. There were a total of 29 who participated in Communion and 25 in feet washing (15 men and 10 women).

SATURDAY MORNING BUSINESS SESSION, MAY 7, 2005, 9:30 A.M.

Moderator Paul Payne called the session to order. Delegates not already seated were seated. The spot on the Christian Education Board was filled with Quentin Snoderly. The Association can also no longer send Delegates to the National.

The Obituary Committee Report was given by Elder Kenneth Lynch. The Report was received and the committee discharged. Elder Paul Parks, a visiting minister led in prayer. The Non-Represented Churches Committee was given by Elder Leon Hodge. The Greenland Church was contacted and they will be sending their letter and dues. The report was accepted and the committee was discharged. Sis. Mae Harrison and Sis. Judy Payne were elected as Delegates to the Arkansas State Association on August 2nd and 3rd. Elder Norman Cline, Elder Eldon Bagwell and Elder Mark Casey were elected as delegates to the Union Association on September 15th.

The Trustee Board Financial report was given by Bro. Brian Ennis and accepted. Elder Paul Parks from California Free Will Baptist Korean Ministries spoke. He is the 1st Korean Free Will Baptist Preacher. He has established 11 Korean Free Will Baptist Churches in America and 16 in Korea. He was saved in Korea by and American Missionary. He read Matthew 9:35. He said only Jesus can change the hearts of people. We need to have the compassion of Jesus, and we must present the gospel and be busy about this. A motion was made to give \$800.00 from the Mission Emergency Fund to Cross Cultural Ministry for Elder Paul Parks. The motion was accepted.

A video was shone dedicated in honor of the ministers of Old Mount Zion that have already gone home. A motion was made to dismiss until May 4, 2006 at 7:00 p.m. Elder Bruce Coyle dismissed this session in prayer.

SATURDAY MORNING MEMORIAL SERVICE, 11:00 A.M.

REPORT OF HOME MISSION BOARD

Balance as of February 5, 2005 was \$9,745.82 and received \$688.78 bringing the balance to \$10,434.60. On February 9, 2005 Bro. Jerry Woods gave a check replacing the money he had received in the amount of \$8,000.00 making a balance of \$18,434.60. Interest accrued was \$20.43 making a balance of \$18,455.03. We recognized 5 entries from our association that will be going straight to National Competition to be held in Louisville, KY in July. Recognition was also given to our youth involved in the NYC activities this summer, including Seth Lombard, Ashley Bradley, Amy Graham, Lauren Reeves, who will be attending the Truth and Peace Leadership Conference and Jason Bradley and Taylor Desans, who are members of this year's E-team and will be taking a mission trip this summer.

The Board would like to thank Huntsville FWBC for hosting the District Competition for us this year, and all the quizmaster, judges, CTS Directors, coaches and most of all our youth, for making this year's District Competition a great success.

CHURCH COVENANT

Having been brought, as we believe, by the divine grace to accept the Lord Jesus Christ as our Saviour and Preserver, we do now solemnly and joyfully covenant and agree by God's help to walk together in brotherly love.

We, therefore, enter into covenant as members of this church, and as Christians, that we will watch over each other in love, sharing together each other's joys and sorrows; that we will not forsake the assembling of ourselves together, nor omit the great duty of prayer for ourselves and others; that by Divine assistance we will endeavor to bring up those under our care in the nurture and admonition of the Lord; that in all things we will strive to exemplify our profession by a corresponding practice, to abstain from all sinful conformity to the world, to be just in our dealings, faithful in our agreements, and exemplary in all our deportment; that we will abstain from the sale and use of intoxicating liquor as beverage; that we will contribute cheerfully according to our ability, to support of the ministry, the expense of the church, the relief of the poor and the general spread of the Gospel.

In keeping this solemn covenant, may we ever enjoy the blessings and presence of the Great Head of the church, which is Jesus Christ the Saviour.

CONSTITUTION

From long experience, we, the members of the Church of God (denominated Free Will Baptists) being regularly baptized upon profession of our faith in our Lord Jesus Christ, and being convinced of the necessity of a combination of churches to perpetuate a union among us, and to preserve and maintain correspondence with each other, do therefore, ordain this Constitution for our better Church government.

Article 1. Membership-This Association shall be composed of members chosen by the different churches of our union, not exceeding three messengers from each church, and upon producing letter, they shall be entitled to seats. All regularly ordained ministers, deacons, and church clerks of this Association becoming properly credentialed and in full fellowship and good standing in the church of which they are members, shall

be entitled to seats as a delegate, when present, by virtue of their office.

Article 2. Name-The members thus chosen and assembled with the ministers and deacons, to be denominated the Old Mt. Zion Association of Free Will Baptists being composed of the several churches of our union, the Association having no power over the churches reserving the right of withdrawing from any church becoming disorderly.

Article 3. Letters-Letters from the different churches representing are to express their number in fellowship including the names and addresses of ordained and licensed ministers, the number of members received upon profession of faith, by letter of recommendation, by restoration or denominational choice; the number of members dismissed by letter, excluded, and those having died since last Association. Churches, in sending their letters, may send obituaries of anyone who died during the year, that we may keep up the memorial to our dead.

Article 4. Dismissing Members-Our churches, upon granting letters of dismissal to any of its members, shall require a notice from the church receiving said letter that it has been received.

Article 5. Officers-The Association to have a Moderator and an Assistant Moderator, Clerk-Treasurer, and an Assistant Clerk-Treasurer, elected annually for a term of one year by the suffrage, and an executive committee of five, one member chosen each year for a term of five years, and that each member be an Ordained Minister in good standing of the Old Mt. Zion Association, who shall have the authority to transact any business transactions of the Association between sessions of the Association and make report to the Association annually.

Amendment #1 to Article 5

Be it resolved that we amend Article 5 to read that no person can serve two consecutive terms on any standing board.

Amendment #2 to Article 5

Be it resolved that current Officers of the Association be retained through the present Association and any new Officers assume responsibilities immediately thereafter.

Amendment #3 to Article 5

Be it resolved that we reorganize our leadership structure to elect a Moderator, Assistant Moderator, Clerk, and Assistant Clerk who will serve this body by presiding over the associational meetings at the annual session and the three quarterly meetings.

Article 6. New Churches-Newly organized churches may be admitted to the Association, which are to petition by letter and delegates, and if, upon examination, they are found to be orthodox and orderly, they may be received into the Association, the Moderator giving the right hand of fellowship.

Article 7. Questions-No resolution from any church shall come under consideration of the Association unless it has been first considered in its own church and, if possible, a copy be sent to each church and the association clerk before the Association.

Article 8. Motions-Every motion made and seconded shall come under the consideration of the Association except it be withdrawn by the member who made it.

Article 9. Minutes-The Association is to endeavor to furnish the churches the minutes of the Association in proportion to the amount paid by each church, the distribution to be made at the discretion of the Association.

Article 10. Clerk-It shall be the duty of the Clerk to keep a regular file of the minutes of the Association in a book to be kept by the Association for that purpose.

Article 11. Signature-The minutes of the Association shall be read and corrected, if needed, and signed by the Moderator and Clerk before the close of the Association.

Article 12. Amendments-Amendments of this Constitution may be made, when necessary,

by a two-thirds vote of the members present at any regular session.

Article 13. Non-attendance-The Association, in case of failure of any church to attend, shall inquire into the case.

Amendment #1 to Article 13

Be it resolved that churches that fail to be represented by delegation, or letter, for two consecutive years, be notified they will be dropped from our Association.

Article 14. Ordination of Ministers-Old Mt. Zion Association of Free Will Baptists accepts the wording of Epistles 1 Timothy 3:1-7 and Titus 1:6-9 as authoritative for guidelines to Ordaining Ministers.

Amendment #1 to Article 14

Be it therefore resolved that we amend Article 14 of our Constitution in compliance of our State Constitution. That Old Mt. Zion Association of Free Will Baptists accept the wording of the Epistles to Timothy and Titus as authoritative, namely the interpretation of the phrase, "the husband of one wife", to mean that divorced personnel should not be ordained. (1 Timothy 3:2, 12; Titus 1:6)

Amendment #3 to Article 14

Be it further resolved that no woman be ordained as minister or a deaconess.

Amendment #4 to Article 14

Be it further resolved that we recommend to the Executive Board of this Association in their examination of candidates for ordination, to observe greater caution, and in agreement with the instructions of the apostles, "To lay hands suddenly on no man." (1 Timothy 4:22)

When a Church member acknowledges their call to the Ministry, they should be licensed by the Church of which they are a member for the period of one year prior to Ordination; or until they have proved themselves to the Church. When the member has proved himself, the church shall call for his Ordination.

That all Churches of Old Mt. Zion Association, in all Ordinations services of Ministers, comply strictly with the rules and regulations laid down by the Free Will Baptist denominations. Said procedure to be conducted by the Local Church.

Amendment #5 to Article 14

If any ordained minister of the Old Mt. Zion Association of Free Will Baptists at anytime be found guilty of misconduct, or disregard of any rule or ordinance set forth and practiced by the Constitution of the Old Mt. Zion Association, the said party shall be dealt with according to "Article 14" of the Constitution of the Old Mt. Zion Association as follows:

1. After the local church has made a full and complete investigation as to the misconduct or other charges and the evidence proves to be true-he shall surrender his credentials and Old Mt. Zion ministers card to the local church or association until said misconduct or other charges have been investigated by the local church or Executive Board. (The local church clerk or associational clerk to hold said credentials and Old Mt. Zion ministers card.)

2. If after the period of not more than one year after the surrender of his credentials and Old Mt. Zion ministers card, the said party shall be contacted by the local church of which he is a member or by the Executive Board to try and make restitution. If the local church fails to deal with the charges, then the Executive Board will have the authority to deal with the charges. The Executive Board shall make this report to the regular session of the Associational body which will vote on the report as whether to revoke or return the

credentials and Old Mt. Zion ministers card to said party.

Amendment #6 to Article 14

Be it resolved that no minister be ordained without written approval of the Executive Board. Be it further resolved that all men who acknowledge their call to preach, upon being licensed, immediately report to the Executive Board. The Executive Board to assign them lessons covering the entire treatise of the Free Will Baptist. We recommend that some of our older ministers be used to administer these lessons. The candidate to meet at least once a month with said minister. Upon completion of lessons, candidate must agree fully with Free Will Baptist doctrine to be ordained.

Amendment #7 to Article 14

Be it resolved that the Association instruct the Executive Board not to approve any minister for ordination who uses tobacco in any form.

Amendment #8 to Article 14

Be it resolved that Free Will Baptist ministers coming from another Free Will Baptist Association present a letter of good standing from the Association from which he is coming to the Executive Board upon examination to be admitted to the full fellowship of the Association.

Ordained ministers coming from another denomination wishing to unite with Free Will Baptists must first unite with a local Free Will Baptist Church of the Old Mt. Zion Association; and will be subject to the same examination by the Executive Board, and if found willing to accept the Free Will Baptist denominations' constitution, will be accepted into full fellowship of the Old Mt. Zion Association.

RESOLUTIONS:

(Permanently Printed)

Resolution #1: Be it resolved that the Association set aside Saturday night of the conference each year for the youth of our churches to make their reports concerning their work and to be in charge of the worship service for that night, with privilege of selecting a speaker or speakers for the service.

Resolution #2: That attention be called to Article 3 of the Constitution of this Association, as terms of receiving members into the local church as, namely: (1)profession of faith; (2)by letter of recommendation; (3)by restoration; (4)by denominational choice.

Resolution #3: That Article 1, Membership, be amended to read: All regularly ordained ministers and deacons and church clerks of this Association becoming properly credentialed and in full fellowship and good standing in the church of which they are members shall be entitled to seats as a delegate, by virtue of their office.

Resolution #4: Be it resolved that we give adequate support and approval to Home Mission work in the bounds of the Old Mt. Zion Association such as assisting in organizing and establishing new churches. Said work to be under the supervision of the Home Mission Board (amended August, 1979) consisting of five ordained ministers or deacons in good standing.

Resolution #5: (amended May, 2005) "Free Will Baptists understand the Bible teaches the following facts: On the day of Pentecost believers spoke with distinct foreign languages which were readily understood by the nationalities present. Tongues were given as a special gift to the early church as only one sign which confirms the witness of the gospel to unbelievers.

While tongues were bestowed by the sovereign will of God on some believers, all did not speak with tongues. When this gift was abused, it became a source of disturbance in the

congregational meetings. To eliminate confusion and correct the error, Paul set particular guidelines for the Christian church to follow. The gift of tongues was neither an evidence of the baptism of the Holy Spirit is an erroneous doctrine to be rejected. Any implication of a "second work of grace" has never been tolerated in our fellowship of churches, and will not be permitted.

We teach and preach the fullness of the Holy Spirit and heed the scriptural admonition, "Be ye filled with the Spirit; Speaking to yourselves in psalms and hymns and spiritual songs, singing and making melody in your heart to the Lord; Giving thanks for all things unto God and the Father in the name of our Lord Jesus Christ."

Resolution #6: Be it resolved, "Any church desiring a resolution to be voted on at setting of Association, send a copy of proposed resolution to each church and association clerk of Old Mt. Zion before Association convenes; that is, if possible."

Resolution #7: (amended) In view of the fact that our Youth Camp has become a reality, we recommend that "all churches" support both the Youth Camp and the Home Mission Board.

Resolution #8: Be it resolved that the moderator appoint three persons to direct the registration on Thursday night and Friday morning and that they arrive early.

Resolution #9: That it be recorded in the minutes which church will be responsible for the Communion Service. They shall be responsible for the juice, bread and cleaning of supplies. If said church cannot serve, they must contact the moderator in time to get another.

Resolution #10: (Resolution #4 of 1977 Minutes) Be it resolved that the Old Mt. Zion Council Meeting be changed to a quarterly meeting convening on the first Saturday in November, February and May with three (3) elected delegates from each church attending to conduct any business necessary between annual sessions of the Association in August. (Annual Association now meets in May, therefore, quarterly meetings fall on the first Saturday in August, November, and February.) Services to begin at 9 a.m.

Resolution #11: We believe that Sunday School plays a very important part of the training of our people. Our churches need dedicated teachers who will follow 2 Timothy 2:15, and we recommend that our churches, who use literature, use Free Will Baptist literature.

Resolution #12: Be it resolved that all church letters in the Annual Association be mailed to the Clerk a week prior to the date of the Association, if possible.

Resolution #13: Be it resolved that any event, function, or activity to take place on the Association properties be supported by one of our Free Will Baptist Churches, being a member in good standing with our Old Mt. Zion Association, or Associational committees, and be approved by the Board of Trustees.

Resolution #14: Be it resolved that the Divine Service Committee be responsible for the Quarterly Council programs-choosing the speaker, his alternate and special singings for each Quarterly Council meeting.

Resolution #15: Be it resolved that the churches of the Old Mt. Zion Association give support and prayer to the work being done in the Hispanic community in Northwest Arkansas.

"ARTICLES OF FAITH"

1. God-We believe in one true and living Triune God; composed of the Father, Son, and Holy Spirit, equal in divine Essence, Purpose, Power and Glory. (St. John 1:1; 1 Cor.

8:6; St. John 10:30; 1 John 5:7.)

2. Christ-We believe that Jesus Christ is the divine Son of God, was with the Father and the Holy Spirit at the time of creation, left the Courts of Heaven and came to earth, took upon Himself the form of humanity, sin excepted, by being born of the Virgin Mary, manifested His power, was crucified, placed in Joseph's tomb, rose again the third day, completed the great plan of salvation, walked and talked with his disciples, publicly ascended to Heaven, and that He will descend again to gather His jewels home. (Isaiah 9:6; St. John 1:14; Luke 1:26-28; Matt. 14:13-21; Mark 16:9-19; Luke 24:50-53; Acts 1:9-12; Mark 15:22-41.)

3. Holy Spirit-We believe that the Holy Spirit has visited true believers in all ages, and especially since the ascension for the Son back to the Father, and his coming on the day of Pentecost. Has taken up His office work among all nations of people, as a Divine Reprover, Comforter and Guide. (Judges 6:34, 11:29; St. John 16:8-14; Isaiah 63:10-12; Ephesians 4:30; Acts 8:17-20.)

4. The Bible-We believe the Bible, which is composed of the Scriptures of the Old and New Testaments was given by inspiration of God, is our way-bill from earth to heaven, and the only infallible and inerrant rule of faith and practice. (2 Peter 1:19-21; 2 Tim. 3:14-17; Daniel 10:21; Acts 1:16-17; Matt. 21:42.)

5. The Fall of Man-We believe that God created man good, gave a just law by which he should be governed, with the promise of reward for faithfulness and with penalties of punishment for disobedience. Gave man power of free moral agency to choose the right and reject the wrong. But our first parents heeded the voice of the great enemy of souls, voluntarily transgressed the law of God, fell with their posterity under the just penalty of the same, and were unable of their own power to extricate or save themselves from the great dilemma into which they had fallen. God gave them the hope of salvation through the coming of Christ. (Gen. 1:27, 2:16-17; Rom. 11:11-35; Rom. 5:18; Psalms 37:23-24.)

6. Redemption, Salvation, Adoption-We believe that Jesus Christ by His birth, death, burial, resurrection and ascension paid the purchase price for the redemption of the whole human race, arranged a pardon for all who came upon Gospel terms; and a law of adoption into the Kingdom of Heaven and eternal inheritance into the glorified Kingdom above. (Heb. 9:12; Gal. 3:13, 4:4-5; Titus 2:14; Heb. 1:4; St. John 3:16; Isaiah 45:22.)

7. Condition of Salvation-We believe that all persons dying in infancy and all idiots are saved by the atoning merits of the Son of God without any act on their part, that persons coming to the years of accountability, transgressing the law of God, must upon their part, exercise faith in Jesus Christ through repentance toward God, at the completion of which pardon takes place in the mind of the Father and by the Holy Spirit they pass through the ordeal of regeneration, are washed in the blood of the Lamb and are planted in the Kingdom of Christ. (John 3; Matt. 19:13-22; 2 Cor. 7:10; Luke 18:17; St. John 4:11-16; Psalms 98:3.)

8. Salvation Free-We believe that God desires the salvation of all; Christ died for all; the Gospel invites all; the Holy Spirit strives for all; and whosoever will may come and be saved on the terms of the Gospel. (Rev. 22:17; 1 Peter 1:9-13; 1 Peter 2:9-24; Rom. 3:24.)

9. Baptism-We believe that Christian baptism is the immersion of believers in water, in the name of the Father, the Son, and the Holy Ghost, in which are represented the burial and resurrection of Christ; also represents our death to sin, and only those who have come under the presbytery of the elders are qualified to administer the same. (Matt. 3:14-16, 3:5-6; 1 Peter 3:21; St. John 3:23; Acts 10:47; Matt. 28:19.)

10. Communion and Feet Washing-We believe that the Lord's Supper and the washing of the saints' feet are ordinances of the Gospel of Christ; The Lord's Supper was instituted by

our Savior to commemorate His broken body and shed blood for the sins of the world and to show our remembrance of Him till He comes.

All Christians have a right to the Lord's Supper and should be invited. "Let a man examine himself and so let him eat."

The washing of feet was instituted by our Lord at the same time that Supper was instituted as an act of humility to show our love for each other, and both ordinances should be perpetuated by all Christians until His second coming. (Luke 22:19-20; 1 Cor. 11:20-29; St. John 13:1-18; Matt. 26:26-29.)

11. The Sabbath-We believe that the Christian Sabbath should be observed as a day of rest and for the worship of God; that we should abstain from all sinful amusements and secular employments, works of mercy and piety excepted. (Exodus 20:11, 31:12-18; Deut. 5:12-15; Ezek. 20:21; Matt. 28:1; Luke 23:56; Acts 13:42-48; Mark 2:27.)

12. Call to the Ministry-We believe in a Divine call of the ministry; that God in His goodness and power of grace, impresses His ministers with the burden of lost souls to the extent that the call becomes irresistible with personal contentment; that when they yield to the call and exercise the native gifts according to the Scriptures, with full reliance upon Him. He accompanies them in person of the Holy Spirit to guide them in the way of truth and to bless their labors according to His purposes. (Jonah 1:1; Jer. 1:5; Mark 3:14; Acts 1:22-26; Matt. 28:19.)

13. The Invisible Church-We believe that the Invisible or Spiritual Church is the redeemed in the aggregate, is the family of God, is composed of all true Christians of every congregation from righteous Able to the restitution of all things from every kindred, nation, tongue and people. (Eph. 3:16-21; Heb. 12:22-23; 1 Peter 2:5; Eph. 2:20-22; Acts 2:47; Matt. 16:18.)

14. The Visible Church-We believe that a visible church of Christ is a congregation of faithful men and women, having obtained fellowship with the Lord and with each other, agreeing to keep up a good discipline and doctrine according to the rules of the Gospel. (2 Thess. 1:1; Acts 16:5; 3 John 1:10; Matt. 18:17; Acts 20: 28; Rev. 1:4, 11, 20.)

15. Perseverance-We believe that all true believers in Christ should persevere in divine graces, and in the knowledge of truth and that God's grace is sufficient to help them to overcome all the obstacles of life and that all the combined forces of the great enemy of souls on earth and in Hell (or in his eternal abode) are not able to pluck them from his hand so long as they walk in the path of duty; but those who sidestep and willfully refuse or neglect to perform their duty, they would backslide and if persistently continued would be eternally lost. (2 Cor. 9:10; 2 Peter 1:4-8, 12; 1 Peter 2:2; Rom. 8:35-39 Apostasy 2 Peter 1:8-9; 1 Cor. 10:1-13; Heb. 12:15-17; 1 John 5:16; Heb. 6:1-6; 1 Tim. 4:1-2; Heb. 3:12; St. John 15:1-7; Matt. 12: 31-32.)

16. Christ the Head of the Church-We believe that Christ is the Great Head of the Church and that the government of the local church is with the body. (Col. 1:18-19; Matt. 16:18; Heb. 12:23; Matt. 21:42; Eph. 1:22; Acts 16:4-5.)

17. Sanctification-Sanctification is work of God's grace, by which the soul is cleansed from all sins and wholly consecrated to Christ. It takes place in regeneration, and the Christian can and should abide in this state to the end of life constantly growing in the grace the knowledge of our Lord. (1 Cor. 6:11; 2 Thess. 2:13; Heb. 12: 14; Phil. 3:21; St. John 17:17-19; 2 Tim 2:20; 1 Thess. 5:19-23.)

18. The Resurrection-We believe in the resurrection of the dead, both of the

righteous and the wicked. When the resurrection shall take place, the soul and body shall be reunited, the righteous shall be received into everlasting happiness to reign with God forever, but the wicked shall go away into everlasting punishment. (Matt. 28:6; St. John 5:28-29; 1 Cor. 15:51-58.)

19. The Soul-The soul is endless, hence does not die with the body, but immediately after death enters into a conscious state of happiness or misery, according to spiritual character here possessed. (Phil. 1:23; Luke 23:43; Rev. 6:9; Luke 16:19-25; Matt. 10:28.)

20. Judgment-We believe that there will be a general, universal judgment, when all men shall be judged according to their works whether they be good or bad, and that immediately thereafter, the wicked shall enter into everlasting punishment and the righteous into eternal happiness. (2 Thess. 1:4-9; Rev. 14:9-13; Luke 16:23; Rev. 21:8; 2 Cor. 5:10; Matt. 12:36-37; Rev. 20:12-13; Acts 17:31.)

OLD MT. ZION ASSOC. BOARD DUTIES AND RESPONSIBILITIES

EXECUTIVE BOARD

Responsibilities and duties are set forth in the Constitution Article 5 and Article 14: (1) examination of candidates for ordination to the ministry. (2)assist the local church in dealing with any ordained minister guilty of misconduct. (3)request credentials and Old Mt. Zion ministers card of any minister not complying.-

HOME MISSION BOARD

Responsibilities and duties as set forth in Resolution #4: "Be it resolved that we give adequate support and approval to Home Mission work in the bounds of the Old Mt. Zion Association such as assisting in organizing and establishing new churches. Said work to be under the supervision of the Home Mission Board consisting of five ordained ministers or deacons in good standing."

YOUTH CAMP BOARD

Responsibilities: (1)set dates for youth camp, skating, lock ins, fun days, youth services, workers banquets, and other youth related activities. (2)organizes all speakers for activities listed above. (3)facilitates, regulates, and delegates authority for all above activities. (4)makes sure grounds are in order for camp (light hot water heaters, check gas tank, dorms, bathrooms, playground equip.) (5)answers to the Executive Board and the delegates association.

CHRISTIAN EDUCATION BOARD

Purpose and Responsibilities: The Christian Education (CE) Board was formed and is held responsible for the organizing and sponsoring of the District CTS Competition. In addition all funds designed for the CE Board are to be used for funding the District CTS Competition. The first Saturday in April is to be set aside for the District CTS Competition.

TRUSTEES OF THE ASSOCIATION PROPERTY

Defined the roll of the Board of Trustees as: (1)overseers of the property and the maintenance of building and grounds of the Association Youth Camp grounds. (2)must approve the functions which take place on the Youth Camp grounds.
