## COSTITUTION

- Article 1. This association shall be called the Piedmont Association of (original) Free Will Baptists.
- Article 2. This association shall be composed of delegates elected annually by the Free Will Baptist churches cooperating with this association and ministers who are members of this association.
- Article 3. The officers of this association shall be a moderator, vice-moderator, clerk and treasurer.
- Article 4. Each church shall be entitled to three delegates, and one additional delegate for every fifty members over one hundred.
- Article 5. The churches cooperating with this association shall send by the hands of their delegates a full account of all work done by them during the year and all such statistics and information as will be interesting and helpful.
- Article 6. This association shall meet once a year at such time and place as may be agreed upon by the preceding session or by its executive board.
- Article 7. The executive board shall consist of three members elected by the association, one for one year, one for two years and one for three years. The associational officials are members ex-officio of the executive board. The executive board shall have interim authority.
- Article 8. Ministers in good standing in our sister associations may be invited to a seat and take part in the deliberations and his name enrolled in our minutes.
- Article 9. The association may withdraw from any church that becomes disorderly or refuses to represent by letter or delegate.
- Article 10. This association shall encourage a sound ministry such as presents Christ as an all sufficient Saviour, having salvation possible to every human being on the terms of the gospel which is freely offered to all.
- Article 11. This association assumes no higher authority than an advisory council.
- Article 12. This constitution may be amended at any annual meeting of the association by a two-thirds vote of the delegates attending, providing that a notice of such change shall have been given during the first setting of said meeting after permanent organization.

#### RULES AND REGULATIONS OF THE PIEDMONT ASSOCIATION

(Revised to include all new rules passed upon by the association)

- 1. Associational officers are to be elected by ballot system.
- 2. The clerk is to be elected at the beginning of the session.
- 3. The moderator, vice-moderator and treasurer are to be elected at the close of the session.
- 4. The ordaining council is to be elected by the association. The number of this council is to be six members elected to serve rotating terms, To wit:

Two for three-year terms, two for two-year terms and two for one-year terms. The council is to have interim authority to ordain ministers and has charge of the investigation of ministers. They shall report their work annually to the association. The secretary of the council is to send the report of their work to the clerk of the association not later than one week before the association convenes.

- 5. The executive board is to make an annual report to the association.
- 6. The treatise of the faith and practices of the original Free Will Baptists of North Carolina is to be used.
- 7. The body sponsors the following denominational activities: The Ministers' Conference, the Sunday School Convention, the Woman's Auxiliary Convention, the F. W. B. League Convention.
  - 8. The seven-point program of the state convention approved.
  - 9. The indefinite pastor call approved.
  - 10. When a church calls the ordaining council, it is to pay its expenses.
- 11. The executive board has charge of the association's educational program.
- 12. The chairman of each board or committee is treasurer of its funds. (Exception: the executive board, the treasurer of the association is treasurer of its funds.)
- 13. A member of this association may serve on as many boards or committees as he is duly elected to serve with the exception of the executive board and ordaining council. No member may serve on these two at the same time.
- 14. The churches sending ministers and delegates to the association are to pay for their board. The host church will provide all sleeping quarters they can and arrange for rooms that may be rented.
- 15. The minute fund has been changed to general fund and all churches are required to send twenty cents per member to the association with their report. This must be done in order for their delegates to be seated.
- 16. The moderator is authorized to appoint from the floor the nominating committee, consisting of five men, who shall nominate candidates for the office of moderator, vice-moderator, treasurer, executive board, ordaining council and other boards and committees deemed necessary to carry on the work of the association. The body may place nominations from the floor for each office.

#### ORDINATION QUALIFICATIONS

- 1. A minister must serve under a license for one year before he can be ordained.
- 2. The candidate for ordination must have had a Bible course satisfactory to the ordaining council.
  - 3. The state questionnaire is to be used as a guide for the council.
- 4. If a minister cannot meet the standard but shows satisfactory fruits in his ministry, he may be ordained at the discretion of the council.
  - 5. A minister must be a tither in order to be ordained.

## RECORD OF PROCEEDINGS

FRIDAY MORNING, AUGUST 2, 1957

The Piedmont Association of the Original Free Will Baptist Church of North Carolina convened for its fourteenth annual session with the Independence Square Church, Kannapolis, North Carolina, August 2, 1957.

The session opened with the congregation singing "Face to Face," led by D. D. Hunsucker.

Rev. George Bullard led the devotional, reading from the 133rd Psalm and leading in prayer.

The clerk declared the association to be in session and welcomed all delegates and visitors. He introduced the moderator, Rev. R. J. Reynolds, to the body.

The moderator welcomed the body and urged that we conduct our business in a spirit of unity and love.

Worship in song, "Showers of Blessings," led by Brother Hunsucker.

Rev. Howard Taylor brought the morning message, "Letting God Be First," taking his text from Jonah 3:1, 2. He brought an inspiring message in which God wonderfully blessed His children.

After the morning message the moderator declared the house open for business. The following business was transacted:

The moderator recognized the following visitors: Rev. Paul Jenkins, Western Conference; Rev. Ernest Strickland, Blue Ridge Association; Rev. R. H. Jackson, Eastern Conference; Rev. Sherman Branch, Beaver Creek, South Carolina.

Moved and seconded that we seat these visitors as council. Motion carried.

Moved and seconded that we adopt the printed program. Motion carried.

A partial report of the credentials committee was received and adopted.

Moved and seconded that all delegates and alternates from churches that have paid their minute fees be seated. Motion carried.

Amended to include all who will guarantee to pay this fee before the association adjourns.

A letter was read to the body by the clerk from the Westover Church of Kannapolis, North Carolina, in which it advised the body that it had withdrawn from the Piedmont Association.

Moved and seconded that this letter be referred to the executive board to take action after the association adjourns. Motion carried.

Rev. S. A. Smith of the Free Will Baptist Children's Home gave a report of the home. Moved and seconded that we receive this report as information and that an offering be taken for the home. An offering was taken amounting to \$55.48.

The executive board report was called for and given at this time. Moved

and seconded that we receive this report and vote upon it item by item. Motion carried. This report was adopted with the exception of Item 1. This item requested that the association formulate a policy concerning as to whether we will license or ordain ministers who have two living wives. After some discussion the body adopted this item and voted to take this matter into consideration at the beginning of the afternoon session.

Moved and seconded to adjourn until the afternoon session. Motion carried.

#### FRIDAY AFTERNOON SESSION

The afternoon session opened with the congregation singing "Everybody Will Be Happy Over There," led by Rev. Robert Hagler.

Devotions and prayer by Brother Staten.

The moderator declared the house open for business.

Moved and seconded that a committee be appointed to write a resolution concerning Item 1 of the executive board report. The following men were appointed: Rev. Roy Rikard, Rev. Ralph Staten and Rev. Norman Perkins.

Moved and seconded that the minute fund be raised to twenty cents per member.

The body discussed the possibility of purchasing a site for a camp ground. Several churches expressed interest in this project. The body decided to raise funds by receiving pledges for this purpose.

The following ministers made pledges either individually or for their churches to be paid within six months: Ernest Strickland, personal \$25.00; Sherman Branch, personal \$25.00; Ralph Staten, Goshen \$50.00; R. J. Reynolds, Mt. Zion \$50.00; J. W. Wooten, Catawba \$25.00; M. T. Sparks, East Belmont \$10.00.

Rev. M. T. Sparks was elected treasurer of this fund. All that are interested in this project are urged to send all donations or pledges to Brother Sparks. His address is 719 E. Catawba Street, Belmont, North Carolina.

The report of the ordaining council was called for and adopted.

Moved and seconded that the reports of the executive board and ordaining council be mimeographed and distributed among the congregation at each annual association. Motion carried.

Moved and seconded that the report of the ordaining council be sent to the clerk of the association not later than one week before the association convenes. Motion carried.

The committee appointed to prepare a resolution pertaining to Item 1 of the executive board report brought a resolution concerning this matter before the body.

Moved and seconded that this resolution be tabled for twelve months. Motion carried.

Moved and seconded that the future status of a minister be left to the

ordaining council and that they continue to ordain ministers at their discretion. Motion carried.

#### FRIDAY EVENING SERVICE

Rev. Burkette Raper brought the message for the evening worship service.

#### SATURDAY MORNING, AUGUST 3, 1957

Opened with the congregation singing "I'm Going that Way," led by Brother Hunsucker.

Devotions by Rev. J. W. Wooten, reading the 142nd Psalm. Followed with prayer.

The house was declared open for business by the moderator.

The nominating committee, Walter Carter, Billy Yawn and J. C. Calvert, gave its report which was received.

After calling for nominations from the floor, the body proceeded to elect the officers which appear in the directory of this minute.

Rev. Burkette Raper of Mount Olive College brought greetings from the college. Moved and seconded that we receive this report as information. Motion carried.

The following delegates were elected to the state and national conventions: State Convention: Mrs. George Bullard, Mrs. M. T. Sparks, Mrs. Wade Calvert and Mrs. Ralph Staten. National Association: Mrs. Wade Calvert, Mrs. William Calvert, Mrs. Ernest Lewis and Mrs. M. T. Sparks.

The body voted to convene with the Lowell Free Will Baptist Church at the next session on Friday and Saturday before the first Sunday in August. The church is located on highway 7, at Lowell, North Carolina.

Moved and seconded to adjourn. Motion carried.

#### CONSTITUTION OF MINISTERS' CONFERENCE

Article 1: This conference shall be called the Picdmont Ministers' Conference of Original Free Will Baptists.

Article 2: This conference shall be composed of ministers who are members of this conference.

Article 3: The officers of this conference shall be a moderator, vice-moderator, clerk and treasurer.

Article 4: All officers of this conference must have been affiliated with said conference for at least two years in good standing. Should a minister be proven guilty of immoral conduct, he shall forfeit his office. He must be faithful to his local church and by all means a tither.

Article 5: The state questionnaire shall be used as a guide for the qualification of ordination.

Article 6: The Robert's Rule of Order shall be the rules to govern us in our deliberations.

#### **AMENDMENTS**

This constitution and these bylaws shall not be changed or altered except

by two-thirds vote of members present in a regular session. All amendments shall lie upon the table not less than three hours prior to adoption and shall, during that time, be read not less than twice in open convention.
