



RULES OF DECORUM

- 1. The clerk, assistant clerk, or senior minister in years may call the meeting to order and shall have charge until the moderator assumes his place.
- 2. This association shall be opened and closed with suitable devotions providing a quorum of nine Members are present.
- 3. This body shall decide all questions by majority of the members present.
- 4. There shall be no conversation by members, one with another, so as to interupt bussiness while in session.
- 5. Every person wishing to speak, shall first rise and address the moderator, and be recognized before speaking.
 - 6. No person shall interupt another while he is speaking.
- 7. All motions made and second shall be opened for discussion, but debate may be shut off any time by a majority of the members present.
- 8. No one shall speak more than twice on the same subject without special leave from the body, and personal reflections shall be avoided.
- 9. No member shall be allowed to speak more than ten minutes on the same subject, unless body gives permission.
- 10. No member shall absent himself from the body without the permission of the moderator.
- 11. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and the vote taken separately.
- 12. Motions made and lost shall not be recorded in the minutes unless so ordered at the time.
- 13. The moderator shall have the same priviledge to speak as any other member, provided the chair is filled.
- 14. By a two-thirds vote any decision of the moderator may be overruled.
- 15. Visiting brethern shall be entitled to a seat to discuss subjects, but not to vote.
 - 16. No motion shall be discussed without a second.

- 17. Unlawful absence from body denies a party voting priviledges.
- 18. Members breaking any of these rules, moderator admonishes.
- 19. Alterations may be made in these rules at any regular meeting of the association.

THE CONSTITUTION

- Article 1. This association shall be called the Piedmont Association of (Original) Free Will Baptists.
- Article 2. This association shall be composed of delegates elected annually by the Free Will Baptist Churches co-operating with this association, all active ordained deacons of said churches and all ministers who are members of this association.
- Article 3. The officers of this association shall be a moderator, vice-moderator, recording clerk, reading clerk, treasurer and promotional Secretary.
- Article 4. Each church shall be entitled to three delegates, and one additional delegate for every fifty members over one hundred.
- Article 5. The churches co-operating with this association send by the hands of their delegates, a full account of all work done by them during the year and all statistics and information as will be interesting and helpful.
- Article 6. This association shall meet once a year at such time, and place, as agreed upon by the preceding session or Executive board.
- Article 7. The executive board shall consist of three members elected by the association, one for one year, one for two years, and one for three years. The associational officers are members ex-officio of the executive board. The executive board shall have interim authority.
- Article 8. Ministers in good standing in our sister association may be invited to a seat and take part in the deliberations and his name enrolled in our minutes.
- Article 9. The association may withdraw from any church that becomes disorderly or refuses to represent by letter or person.
- Article 10. This association shall encourage a sound ministery such as presents Christ as an all sufficient Saviour, having salvation possible to every human being on the terms of the gospel which is freely offered to all.
- Article 11. This association assumes no higher authority than an advisory council.

Article 12. This constitution may be amended at any annual meeting of the association by a two-third vote of the delegates attending, providing that a notice of such change shall have been at any regular annual session of said meeting after permanent organization.

RULES AND REGULATIONS OF THE PIEDMONT ASSOCIATION

- 1. Associatioal officers are to be elected by the ballot system.
- 2. The clerk is to be elected at the beginning of the session (both)
- 3. The Moderator, vice-moderator, treasurer, promotional secretary are to be elected at the close of the session.
- 4. Ordaining Council is to be elected by the Association the number of this council is to be six members elected in two year terms rotating; Two for two years; two for three years term; and two for one year terms; Under this system two members are elected annually for three year terms. The council shall elect their own chairman and secretary and shall have authority to ordain, investigate ministers, subject to the approval of the Association in regular or special session. They shall keep a record of their work and their secretary shall send a record of that to the clerk of the Association not later than one week before the annual Association convenes. The expense of the council is to be paid from a fund of \$100.00 set aside by the Association for this purpose, and each church who calls the council is requested to receive a Free Will offering and send same to the Treasurer of the Association for this purpose. The Council shall receive from the Treasurer expenses of 6 cents per mile per car plus meals.
- 5. The Executive board shall have charge of the promotional work, and Educational work of the Association and shall have the authority to act for the Association in it's business between sessions. The Board shall report it's work annually to the Association and it's work is subject to the approval of the Association. The expense of the Board shall be paid in the same manner as the Ordaining Council.
- 6. The Piedmont Association is affiliated with the N. C. Association of Free Will Baptist's and the National Association of Free Will Baptist The Treatise of The Faith and Practices of The National Association is to be used.
- 7. The Piedmont Association believes and practices "Congregational" Church Government and assumes no higher authority than in that capacity The highest authority that the Association has over the Churches within her fellowship is the power to withdraw fellowship from a Church.

- 8. The Association approves and urges our Churches to support our denominational programs of our State and National Association.
- 9. The Association approves and urges the indefinite pastoral call.
- 10. The Chairman of each board and committee is treasurer of it's funds. (Exception: Association treasurer is treasurer of Executive Board.)
- 11. A member in good standing in the Association may serve on as many boards and committees as he or she is elected. (Exception: No member may serve on the Executive Board and Ordaining Council at the same time.)
- 12. Each Church shall send thirty (30) cents per member with their report to the annual Association, or have someone stand good for this amount, in order that their delegates may be seated. This money is to be used for the printing of the minutes and Associational expense.
- 13. A Nominating Committee will be appointed at the close of each annual session to serve for the year, Their duty will be to present nominations for all officers, Boards and committees necessary to carry on the work of the Association. The body shall have the priviledge to nominate from the floor, when this committee gives it's report.
- 14. Each church shall record the following information on church letters (in addition to required information): The names and the addresses of every minister belonging to their church, and whether or not, each Minister is a consistant tither. The clerk of the Association is to take special note of this information and to include the same in the minutes. The clerk shall make a list of the ministers who are non-tithers and report the same to the ordaining council.

REPORT FROM THE FREE WILL BAPTIST WITNESS

PROGRESS:

There have been ten issues of the WITNESS and the eleventh one is now in the hands of the printer. As we close out the first year of the operation of the magazine we can see that God has been with us. A year ago the North Carolina Association of Original Free Will Baptists had no statewide publication to present the views of its some 20,000 members. Today we have a monthly periodical that voices our program throughout the United States and into foreign countries. The circulation of the WITNESS is nearly 1850. This was achieved by hard work and tremendous sacrifice on the part of some.

THE FUTURE OUTLOOK:

Now that Free Will Baptists in North Carolina have a magazine they cannot be content with the status quo. There must be a united effort to make this one of the best religious periodicals in the United States. We feel we already have a fine-quality magazine but we are not blind to the possibility of improvement. After hearing others in our state express their views, we can sense that you have the same goals as we.

Some have said they wanted to see the magazine become independent of outside financial support. Others have expressed a desire to have the WITNESS enlarged and to have it published more often. No one can dispute that these opinions are progressive and ideal. All of them would make the ministry of the WITNESS more effective. But between these goals and their fulfillment is the element of reality. Whether we like it or not, there are some facts to face if we expect to develop the potential of this magazine.

THE PRESENT SITUATION:

The WITNESS secures financial support from its subscribers and friends. This is our only source of income. Increased support from these two areas is imperative if we are to move forward.

The number of subscribers to the WITNESS is increasing daily. The Booster campaign is a tremendous help. Already it has helped increase the circulation of the magazine by over 1300. Some of the ministers and laymen have been faithful during the campaign. You Western brethren are doing a good job as reflected in the fact that four of the top five boosters come from this section of the state. However, the original goal of the Booster Campaign is far from being reached. That goal was to sign up 80 boosters. These boosters were to work until circulation reached 4000 and the WITNESS became self-supporting. At present there are 77 boosters. Quick mathematics tell us that we are within reach of this goal if everyone would do his part.

Until we reach the place where we become independent we must work harder. We would like to leave this meeting today and that we had 2000 subscribers to the WITNESS. This would mean that we need 150 more people to sign up today. If you already have a WITNESS why not buy one for a friend or relative. Won't you can help reach that 2000 milestone today?

THE LOYALTY LIST

Until we reach the magic number of 4000 we are compelled to depend on subsidies from local churches. This is where the Loyalty List comes in. At present there are only about a half dozen churches on this list. Why not put the WITNESS in your church budget. It would not have to be a large amount necessarily if each church would respond. There is nothing more strengthening than a systematic income from the Churches. Take the initiative in making sure your church supports the WITNESS.

THE PRESENT CRISIS:

So we can see that the bridge between our mutual goals and their realization is continued hard work and sacrifices. The situation with the WITNESS will become more critical as we are paying off the year-end bills. Also the first one-year subscription are running out and we must retain all our subscribers. We now have a full-time worker and his salary has to be met each week. As of now we are unable to pay off the printing bill for the July issue.

As Free Will Baptist we can not let this crisis darken our dreams. The WITNESS has a place in God's program for this age. God forbid that it should loose its significance because of our shortcomings.
