





Eldridge FWB Children's Home: Bro. Carroll Smith - House Parent. Gave a brief review of where the children come from. Gave specifics concerning what the needs of the Home were at the present time. Also stated that it is taking over \$200.00 per child to clothe them for school. Plans are in the making to tear down the old Big House. A company will be coming in to do the job, and will be paid by materials they can get out of the building. There are also plans to build another cottage for the younger girls. Gave a report of the total number of staff members and how they try to meet the needs of each child. The Home had a dedication service for the Multi-purpose building on July 22, 2000. The building was named the Carlton Lambert Building.

 That we renew Kevin Hester's license to preach the gospel.
 That the Progressive Assoc. have it's next meeting at the Sulphur Springs FWB Church in February 2001.

All the above items were accepted by the body.

The service continued with a special song entitled "He Grew the Tree". Our special speaker for the day was Bro. Dennis Havgood. pastor of the South Huntsville FWB Church. Bro. Haygood stated that the Acts 1:8 program had been a tremendous help to him as a missionary. He has run into some opposition and complacency people. Stated that most people are not looking for Bible believing, Bible teaching churches. Moved in November into the new building in the Jones Valley Area. At present time, the church does not have adequate classroom space. Because of this problem, the church has lost some families. Have overcome some problems to get some space. Still have some restriction problems. Have a building being built at present time, but waiting on paperwork to get building moved onto property. Bro. Dennis gave a story of a family he has been working on for 2 years. She just recently accepted the Lord, but the husband has not. She was raised Espocipal, and he is a Catholic/atheist. Asked that we pray for this family because of problems.

His text was taken from I Sam. 25:36-39. This is the story of the last days of a man. He was a drunk, heart is stone cold, has no feelings, and he dies. David is soon to be king, but he is running for his life from King Saul. Nabal was a rich and prosperous man. He was out sheering sheep for the wool and was having a great feast. David sent men to Nabal during this time to ask for provisions. The men gave great praise and tribute to this man, but became very outraged when asked for provisions. The sin of Nabal was ingratitude. Did not show gratitude, was unthankful, and unholy towards God.

Even though we may give our 10% to God, we may be very selfish with the other 90%. We are blessed to be a blessing to others. God does not give that we may sit down and say look what I have. Nabal became so selfish he claimed the bread, water, and so on. The Bible also shows that this man was evil in all his ways. Today's world is just the same. He was described by servants as the son of Belial.

After his wife heard of how he had reacted, she gathered up the items and took them to David. Abigail wanted to spare the lives of workers so that David would not commit great sin and slay innocent blood. Wife states he is like his name "a fool". Because of the intercession of Abigail, David stated he would let God judge. David had a right to be angry, but he listened to the woman God sent to stand in the way. CONSTITUTION

ARTICLE 1: This association shall be known as the Progressive Association of the Free Will Baptist of Alabama and bordering states.

ARTICLE 2: This association shall be composed of ministers, deacons, and delegates of different churches forming the same.

ARTICLE 3: This association shall adopt as its Articles of Faith, The Treatise of Faith and Practice of the National Association of Free Will Baptist.

ARTICLE 4: All ministers and churches wishing to become members of this body must willing submit to the Articles of Faith, Constitution, and all rules of the same.

ARTICLE 5: Each church in this association shall be entitled to three delegates for the first hundred members and one delegate for each additional fifty members or fraction thereof.

ARTICLE 6: Item 1: This association shall have an Executive Committee composed of a moderator, assistant moderator, clerk, treasurer, and three (3) elected members, elected for terms of 1,2,and 3 years each whose duties shall be to act in behalf of the Progressive Association when said Association is not in regular session. Minimum of four (4) members must be present to constitute a quorum. The Executive Committee shall be allowed to examine pastors, associates, and deacons that need to be ordained when the Association is not in session.

Item 2: This Association shall elect a Credentials Committee composed of five (5) members, three (3) ordained ministers, and two (2) deacons, who shall eb elected to start with as 1 for 5 year term, 1 for 4 year term, 1 for 3 year term, 1 for 2 year term, and 1 for 1 year term. Then hereafter elected one each year. Their duty shall be to approve all church letters and applications for membership of both churches and ministers. Examining, ordaining, or approving the ordination of all ministers or deacons and make a report of the same to the body.

Item 3: This Association shall elect a Board of Christian Education. This board shall be composed of five (5) members to serve on a rotating basis with the term of one member to expire each year. A chairman shall be elected each year by this board immediately after the Annual Association meeting. This board shall have full responsibility for the TNT Rally. It shall arrange and conduct any other meetings which are deemed necessary to accomplish its purpose.

Item 4: The activities of this board shall be financed by an entrance fee or offerings as determined needed by the board.

Item 5: No person or persons shall be allowed to participate in activities provided by this board unless or until the church they represent has paid their entry fee and must meet the dress code of the National Association CTS.

Item 6: This board shall report annually to the Progressive Association of Free Will Baptist.

ARTICLE 7: Item 1: The Officers of this Association shall be a Moderator, Assistant Moderator, Clerk, Treasurer, who shall be elected by the body.

Item 2: The above officers shall serve for all Progressive Association meetings.

Item 3: The salary of the clerk shall be \$100.00 per meeting. The salary of the moderator shall be \$50.00 per meeting.

ARTICLE 8: Item 1: The Association's annual meeting will be on the third Saturday of August.

Item 2: The Progressive Association shall meet on the third Saturday in February.

ARTICLE 9: The Association shall determine at the annual association meeting where the meetings will convene for the next year. This shall be determined by a majority of the votes cast. Only those churches that request a meeting at their church will be considered.

Item 1: The meetings of the Association will be held as follows: one in the Northern section, and one in the Southern section.

ARTICLE 10: Item 1: Any changes made to the Constitution and or by-laws of the association shall be brought before the Executive Committee prior to the annual session, and the Executive Committee bring the recommendation before the body.

Item 2: Any changes must have a two-thirds majority vote.

ARTICLE 11: Item 1: That each church send 50 cents for each active member for the association expenses at the annual meeting.

Item 2: Each church send \$99.00 to the February meeting.

Item 3: Each church shall send the church letter to the clerk two weeks before each meeting.

ARTICLE 12: This Association may exclude from its body any minister who teaches heresy, or any church that countenances his in said teaching or that may be disloyal to the tenants of faith as held by this association and expressed in our articles of faith. The same discipline shall apply to any church excluded by the ordaining council.

CHURCH COVENANT

Having given ourselves to God, by faith in Jesus Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the Will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to provide things honest in the sight of all men.

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship, and by self-denial, faith, and good works endeavor to grow in grace and in the knowledge of our Lord and Savior, Jesus Christ.

We will not forsake the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to the careful of one another's happiness and reputation and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able to promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in heaven. To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may God sanctify each of us wholly, and preserve us blameless unto the coming or cur Lord Jesus Christ.

SUGGESTED GUIDELINES FOR THE OPERATION OF THE LOCAL CHURCH

1. We agree as members of the Progressive Association of Free Will Baptist to co-operate in every move for betterment of our denomination extension of God's kingdom throughout the world.

2. We agree to meet in conference quarterly or oftener if necessary to transact the business of the church.

3. The moderator shall be chosen by the suffrage of the church in the absence of the pastor. The Moderator shall observe good order and explain all questions before he takes the voice of the church on them, and shall have the liberty of speech as any other, but not vote unless there is a tie, we he shall give the deciding vote.

4. It shall be the duty of all members to fill their seats during conference and bear their part of the expenses.

5. No member shall leave their seat during the conference without permission from the moderator.

6. No member shall arraign another before the church for any grievance without first taking gospel steps. See Matt. 18:15-17.

7. All business brought before the church by motion and second in gospel like order shall be attended to by the church unless withdrawn by the mover.

8. Any person wishing to speak shall arise and address the moderator and if two arise at the same time, the moderator shall decide who shall speak first and no member while speaking shall cast any reflection on any person but shall adhere strictly to the subject under consideration.

9. No member shall speak more than twice on any subject without permission from the church and not more than five minutes at a time.

10. It shall be the duty of all church members to be present at all church meetings to vote on all questions that come before the church when called on by the moderator or any member of the church who desires to obtain the mind of the whole church.

11. If any member shall remain silent during the transaction of business of the church and afterward complain of what was done the same shall be deemed disorderly and the member so offending shall be dealt with accordingly.

12. We agree to do all business by a majority of the members present at any regular or called conference provided a quorum is present, said quorum being seven members or more.

13. These rules shall be read if considered necessary bu the moderator, at the opening of each conference, and strictly enforced by the moderator.

14. Any member who willfully absents his or herself for a period of six months and fails to discharge their duty according to the Church Covenant shall be deemed as inactive and shall not be reinstated into full fellowship of the church until they have made restitution.

15. Any member desiring to move his membership from one church to another in the association must haave a letter. Failing to do so, he is taken under the watch care of the church until he presents the letter.

16. That all-inactive members of our churches be dropped from the roll after one year if they have been contacted and given an opportunity to prove themselves worthy to remain on the roll. If they show no interest in and have not attended or supported the church in one year we have right to drop them from the roll according to our National Treatise.

17. The Pastor is ex-officio member of all boards and committees.

RULES FOR PREACHERS AND DEACONS

1. All ministers wishing to become members of the Progressive Association must be recommended by the church of which they are members and will be called upon to present their credentials for examination and answer satisfactorily such questions as may be asked them. This must be done by the next Association or quarterly meeting, after calling the pastor. Their church must recommend them for license or ordination where they have not received such.

2. All preachers shall attend all business meetings unless providentially hindered.

3. Any minister who behaves himself unbecomingly to his high and exalted calling shall be reported by the Credentials Committee to the Association, who shall deal with him.

4. All ministers will be required to strictly adhere to the teachings of the Free Will Baptist according to the Articles of Faith.

5. No minister shall speak slanderously or cast personal reflections upon another minister that will hurt his influence or ministerial standing.

6. All ministers shall be required to support and stand by all boards and committees appointed by the Association and do their utmost to make them a success.

7. An aspirant to the ministry must be recommended to the Credentials Committee by his church for license. The Credentials Committee shall examine him as to his life, doctrine, reputation, and his convictions and abilities regarding the work of the ministry. Upon completion of such an examination, if he is found worthy, he shall be recommended to be licensed for a period of one year. He must have his license renewal annually and kept in force until ordination.

8. An applicant for ordination must have carried a license for at least one year immediately preceding his application. (Any exception for the requirement for carrying a license for one year must pass by a two-thirds majority vote of his Quarterly meeting or Association.) He must be recommended by the church of which he is a member. He must be examined by the Credentials Committee and have a call to pastor a church or be engaged in full time Christian service of such nature as to merit ordination. After examination, if he is worthy and sound in faith, he shall be recommended by the Credentials Committee for ordination.

9. That each preacher of this Association, with recommendations from their church, be given a renewal of their card of good standing each year. This request is to be in writing on the annual church letter.

10. That no man be licensed or ordained that uses tobacco in any form.

11. We use the ordination questionnaire as passed in the Association's 1963 session.

12. No person shall be ordained to the ministry nor shall the credentials of any minister be ratified until he is qualified to meet the conditions stated in the third chapter of I Timothy. The term, "husband of one wife: means he shall not have more than one living wife (that is, he shall not be married to one wife at the present time and there be a wife still living from a previous marriage.) The same shall apply to the wife, she shall have only one living husband.

13. Concerning the ordination of deacons: (a) He must be elected by the church of which he is a member. (b) He must be approved for the work of the church by the Credentials Committee. (c) Any local church in good standing in the association, if it so desires, may ordain deacons who are approved by the Credentials Committee and Moderator of the Association. (d) Be it resolved that no church recommend men who use tobacco in any form to be ordained as deacons or ministers. (e) Each deacon of this Association, with recommendation from their church, be given a card of good standing each year. This request is to be in writing on the annual church letter. (f) That no deacon be ordained who has more than one living wife, as defined in "rules for preachers", No.12, or whose wife has more than one living husband. 14. Anyone desiring to be ordained (a) must send in a completed questionnaire with the church letter to the clerk two weeks before the Associational meeting.
