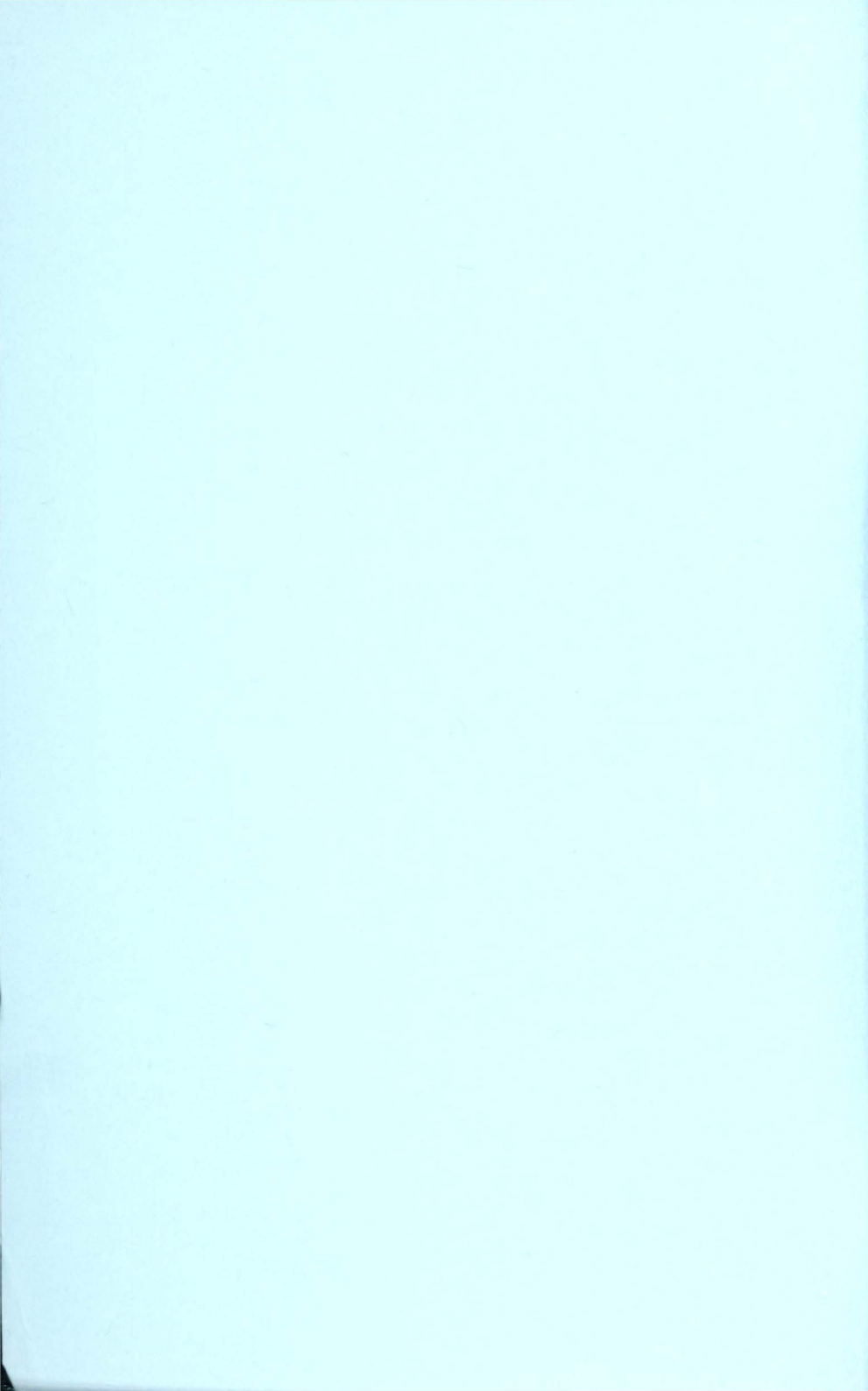

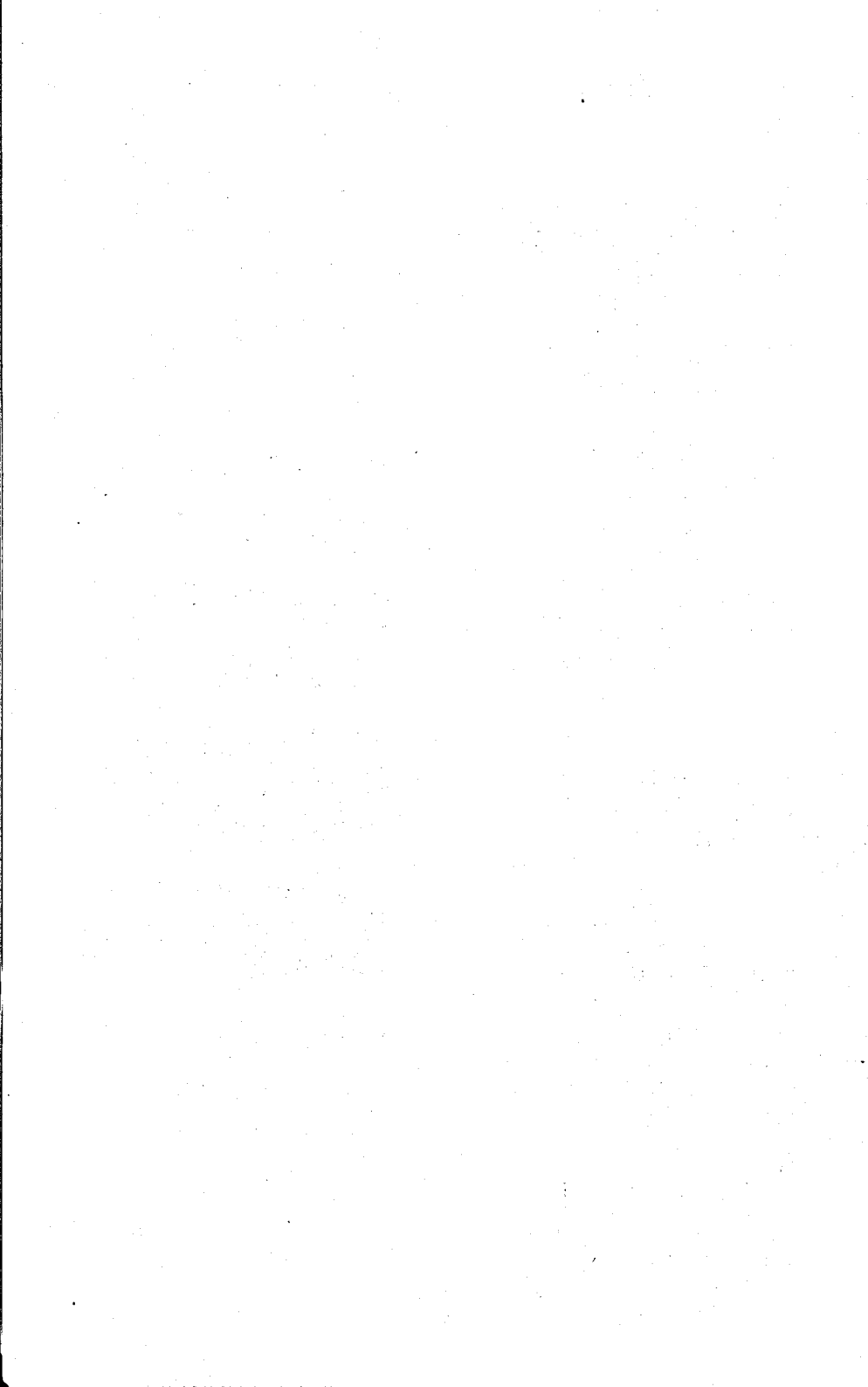

Bro. Doug Henderson opened the meeting by leading the congregation in singing "Since Jesus Came Into My Heart". The Moderator, Bro. Jakie Creech, then recognized the host pastor Bro. Larry Stevens, who extended a warm welcome to the Association and extended directions to the church's facilities. The Moderator also extended his welcome to the Association's Pastors, Ministers, Delegates and Guests. The offering was then received with the offeratory prayer being led by Bro. Lee Thomas. The Moderator then appointed the Finance Committee consisting of Rev. Ricky Tippetts, Bro. Melvin Love and Rev. Troy Daniel. The congregation, led by Bro. Henderson, then joined in another hymn, "He Keeps Me Singing". Special music was provided by Mrs. Connie Chadwick from the West Calvary Free Will Baptist Church.

The Moderator then recognized and introduced the speaker for the evening, Bro. Nathan Eason, pastor of the Tippetts Chapel Free Will Baptist Church, Clayton, North Carolina. Bro. Eason took his text from Revelation 2:24-25 and stressed the importance of believers to hold fast to God; to live close to the Lord in order to be the effective workers they are meant to be. He also challenged the pastors to be more than a deep theological teacher to his people but also to be one who helps his people gather understandings of basic doctrinal truths and to be able and willing to try to understand his peoples' problems and to relate to them. The worship service was closed by singing "The Old Rugged Cross."

The business meeting was then opened by presenting the recommendations from the Executive Committee which reads as follows:

THE EXECUTIVE COMMITTEE

The meeting was opened with the congregation singing "At The Cross." Following the opening song Bro. Troy Daniel led in prayer. The host pastor, Rev. Ronnie Byrd then offered words of welcome and introduced the quartet from his church which provided special music. After the special music the offering was received with the Moderator leading the offeratory prayer.

The Moderator then reconized and introduced the speaker for the evening, Rev. Hubert Mangum, pastor of the Haven Mission Free Will Baptist Church. Bro. Mangum took his text from Mark 14:51 and emphasized the need and necessity of following our Lord Jesus Christ; of working for the cause of Christ until the Lord calls us home; of remaining clean and pure for the cause of Christ.

The Moderator opened the business meeting with the seating of the Delegates. Bro. Creech then presented the Executive Committee's Recommendation concerning the Mission Board which reads:

THE EXECUTIVE COMMITTEE RECOMMENDS

That we adopt the suggestion of the Mission Board to disband this board and that each local church be responsible for its own mission promotion and participation, and that the Constitution be amended to delete Article VI, Section 3 that deals with the Mission Board. Motion was made to accept the recommendation, seconded, and carried.

Bro. Creech then introduced another Executive Committee recommendation concerning Local, State and National Associational fees which reads:

THE EXECUTIVE COMMITTEE RECOMMENDS

That each local church send an offering of \$15.00 per Associational meeting which would amount to \$60.00 per church per year. From this \$60.00 would come \$35.00 for State and National representational fees for each church and would leave \$25.00 per church for Randall Association needs and expenses.

Motion made to accept the recommendation, seconded, carried.

Bro. Dickie Barnes then presented the Youth Board report highlighting the year in Youth activities and stressing The Annual Youth Banquet. Bro. Sam Truett spoke concerning the youth camps that would be held during the weeks of June 14-19 and June 21-26. He asked support from the churches, for campers, for workers and for financial support. The Youth Board Report was received as information.

Mrs. Luther Sanders then presented the following;

THE WOMAN'S AUXILIARY REPORT

The District Woman's Auxiliary of the Randall Association is composed of 13 auxiliaries and 208 members. We meet twice a year, 1st Saturday of April and the 1st Saturday of October.

The Auxiliary exists as the arm of the church through which the women work and serve. The purpose of the Auxiliary is to promote and support Missions and this past year our District gave over \$1,000.00 to the State Auxiliary Mission Project, which was to The Jerry Gibbs (Missionaries in France) account and for furnishings for the Patton building at the Free Will Baptist Bible College in Nashville, Tenn.

This year our goal is to give \$950.00 (At Least) toward the Larry Inscoes' (Missionaries to Panama) account and for Video equipment for the Bible College in Nashville, Tenn. which is the State Woman's Auxiliary project. Last year our State Auxiliary gave \$2000.00 to the John Murrays' (Missionaries in France) account and at this time we are

endeavoring to buy tickets back to their field in Africa for the Clint Morgans.

We ask for your prayers and co-operation as we try to serve the Lord through Missions.

The Report was received as information.

Rev. Sam Truett extended invitation to The Randall Association to meet with the West Calvary Church in Smithfield, North Carolina, August 6; 1982.

The Moderator then expressed need for our Association to send delegates to the State Association meeting at The West Calvary Church in Smithfield, June 7, 8, 1982. Bros. Don Worrells, L. B. Holland, and Jack Forlines were appointed and approved to serve as our Delegates.

The Moderator then recognized our Minister-At-Large, The Rev. Tom Lilly who spoke briefly concerning the work of his department.
