The meeting was opened with Bro. Doug Henderson leading the congregation in singing "When We All Get To Heaven." Following the song the presiding officer, Assistant Moderator Bro. Bobby Bazen offered words of welcome to those attending the meeting. Bro. Richard Barnes then led in prayer. The congregation again led by Bro. Doug Henderson sang the hymn, "Standing On The Promises." The offering was then received with the offeratory prayer led by Bro. Adam Scott. Following the offering Bro. Latham Phillips of the host church presented special music.

The speaker for the evening, Bro. Ronnie Byrd, pastor of the Vandora Springs Free Will Baptist Church in Garner was introduced. Bro. Ronnie Byrd took his text from the book of Revelation 22:8-12. The Moderator and host pastor, Bro. Jakie Creech, led the congregation in the opening hymn, "He Keeps Me Singing." The opening song was followed by prayer led by Bro. Joe Wallis. Bro. Creech gave warm words of welcome to the Association and recognized Bro. David Watkins, missionary to Alaska, who gave a brief testimony and description of his work. The moderator noting that Bro. Watkins was in the process of raising support for his work and would be available for services. Bro. Creech then led another congregational hymn, "Are You Washed In The Blood." The offering was then received and the moderator led in prayer. Special music was then offered by Mr. & Mrs. John Allen from the host church.

The moderator then recognized and introduced the speaker for the evening, Rev. Troy Daniel, pastor of Friendship Free Will Baptist Church in Coats, North Carolina. THE SPIRIT OF COMPROMISE IN THE CHURCH was the title of Bro. Daniel's sermon, taking as his text II Timothy 4:1-5. Bro. The opening hymn, "Love Lifted Me", was led by the host pastor, Rev. Billy Keith. Rev. A. B. Brown then led in the opening prayer. Bro. Keith then offered words of welcome to Association. The Moderator, Rev. Jakie Creech then recognized the visitors and offered words of welcome. The choir of the host church presented special music singing "The King Is Coming" and "Resurrection Morning".

Bro. Creech recognized the newly appointed missionary to the Ivory Coast and a product of the Randall Association out of the Unity Church in Smithfield, Bro. Robert West. Bro. West gave words of testimony and spoke of his call to the mission field. He asked the Association for their prayer and financial support. Bro. West gave a target date of January, 1984 for leaving for the Ivory Coast and made himself available to the Association churches for services.

The offering was received with the moderator leading the offeratory prayer. The host pastor then led in another congregational hymn, "Leaning On The Everlasting Arms". Bro. Creech introduced the speaker for the evening, Rev. Joe Hailey, Pastor of the Friendship Free Will Baptist Church, Roxboro, North Carolina

Bro. Hailey took his text from I Samuel 17:26 and offered as his sermon title, The Big God And The Little Giant. Bro. Hailey used the story of David and Goliath to picture the church and the Christian in their battle against the devil. He spoke of the various giants that the Christian must continually guard against.

Bro. Hailey used David's question from I Samuel 17:26, "Is there not cost?" and made it applicable to preachers and lay people today asking, "Isn't Jesus worth fighting for?" Bro. Hailey concluded his message with prayer.

The moderator opened the business session, recognizing Bro. A. B. Brown from the Commission Of Theological Liberalism. Bro. Brown presented several booklets by denominational leaders. The moderator recognized Rev. John Goss who gave a brief report on the mission work in Siler City.

Mrs. Luther Sanders gave the following Woman's Auxiliary Report:

The Woman's Auxiliary of the Randall Association reports a total of 13 Auxiliaries with a membership of 218.

This past year we gave gifts totaling \$3,927.85 to various denominational causes. We gave \$248.00 to State Missions toward the purchase of a mobile unit (Our State Convention Gave \$2400.00) for this project. We also gave \$1,002.63 for the Larry Inscoe account, our Missionaries to Panama and to the Free Will Baptist Bible College. This was our State project last year.
