We sincerely request all our ministering brethren to give strict and frequent lectures against intemper ance for its demoralizing effect is too often apparant to us.

We recommend that this delegation amend the constitution of this Association and make it against the rules of the church for any member or minister of the church to participate in dram drinking of intoxicating drinks to any degree whatever. Any member of the

church found guilty of the above offence must make acknowledgement to the church of which he is a mem-

ber or be expelled therefrom.

Any minister found guilty of violating this amendment shall make his acknowledgement to the church of which he is a member and also to the next Association following.

From long experience, we the members of the Church of God (denominated Free Will Baptists) being regularly baptized upon a profession of our faith in Jesus Christ and being convinced of the necessity of a combination of churches to perpetuate a union and communion among us and to preserve and maintain a correspondence with each other, do therefore adopt this constitution for our better church government.

# CONSTITUTION. Organization, Etc.

#### ARTICLE I.

SECTION 1. This Association shall be known and designated The McGee-Roberts Association of the Church of God (denominated Free Will Baptist) and composed of members chosen from the respective churches residing within its boundarys as hereinafter described not exceeding three members from each church whom on producing letters may be entitled to seats.

SEC. 2. The officers of this Association shall consist of a moderator, assistant moderator, clerk and treasurer to be chosen by the suffrage of members present. Other assistant officers may be appointed by the moderator when deemed necessary.

#### ARTICLE II. Boundary

The boundary of this Association shall include all of Latimer and Leflore counties, excepting that part of Leflore county lying north of the Brazil and James-Fork creek and south of the Winding Stair mountains.

#### ARTICLE III.

#### Admission of New Churches

SEC. 1. Newly constituted churches may be admitted into this Association who petition by letter and delegates if upon examination they are found otherdox and orderly, the moderator extending the right hand of fellowship.

#### Form of Letters

SEC. 2. Letters from the different churches desiring representation in this Association shall express the number in fellowship, the number received since the last Association, by experience and baptism, letter of recommendation and restoration, the members dis-

missed by letter, excluded and those who have died, together with such other statistics and information as would be of interest to the Association.

## ARTICLE IV.

Power of the Association.

This Association shall have no power to Lord it over God's heritage, nor any eclesiastical power over the churches, but will withdraw from any church becoming disorderly.

#### ARTICLE V.

Refered Questions.

No question from any church shall come under the consideration of the Association unless it has been discussed in the church from which it was refered.

# ARTICLE VI. DUTY OF OFFICERS.

Duty of Moderator

SEC. 1. It shall be the duty of the Moderator to preside over the Association, preserve order appoint all necessary committees and perform such other duties as usually belong to a presiding officer.

Duty of Assistant Moderator.

SEC. 2. It shall be the duty of the Assistant Moderator to aid and assist the Moderator in the performance of his several duties and to preside over the body in the absence of the Moderator.

Duty of Clerk

SEC. 3. It shall be the duty of the Clerk to keep a regular file of the minutes of the Association on a book to be kept by the Association for this purpose and to read the same when called upon by the Association.

Duty of Treasurer.

SEC. 4. It shall be the duty of the Treasurer to receive and receipt for all money due the Association and to pay out the same only, by order of the Moderator and Clerk of the Association.

# ARTICLE VII.

# Adoption of Minutes.

SEC. 1. The minutes shall be read and corrected if needed and signed by the Moderator and Clerk before the close of the Association.

# Distribution of Minutes

SEC. 2. The Association shall endeavor to furnish the churches with minutes of the Association in proportion to the number of members in each church the distribution being at the discretion of the Association.

# ARTICLE VIII. Intoxicants-Use of Forbidden

It shall hereafter be distinctly understood that the use of intoxicating liquors as a beverage is expressly in violation of the Constitution and rules of this Association, and any church member violating the same shall be dealt with by the church of which he is a member and any minister being found guilty of the same shall first make acknowledgement to the church of which he is a member and must also make acknowledgements to the Association, or be expelled therefrom.

#### ARTICLE IX.

# Amendment to the Constitution

This Constitution may be amended when necessary by a majority of members present.

## Rules of Order.

- 1. At every sitting business shall be opened and concluded by prayer by the Moderator, or whomsoever he may request.
  - 2. Ministers present, invited to seats, are allowed to take part in debate on all subjects, but not to vote.
  - 3. Those who speak shall arise and address the Moderator. Personal reflections must be avoided in all dehates.
    - Every motion made and seconded shall come

under the consideration of the body, unless it be withdrawn by the maker, but no motion shall be discussed without being seconded.

- 5. When a motion has been made and seconded and a member opposes its discussion, the Moderator shall put the question: Shall it be discussed? If negative the question shall be dismissed.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.
- 7. Motions made and lost shall not be recorded, unless so ordered by the Association.
- 8. No one shall speak more than twice on the same subject without special leave of the Moderator.
- 9. All questions shall be decided by a majority of the members present.
- 10. No member shall absent himself from the Association without special leave of the Moderator.
- 11. In the future sessions of the Association arrangements must be made so as to insure two or more sermons (or other equivalent exercises) each day.
- 12. The rules of order shall be distinctly read from the chair immediately after the organization of the Association.
- 13. Alterations may be made in these rules at any regular session of the Association.

# ARTICLES OF FAITH

1. We believe in one true and living God, Father Son and Holy Spirit and these three are one in Divine Essence, power and glory.—Rom. 1: 20; St. John 1: 1

2. We believe the Scriptures of the Old and New Testament are of divine origin and the only infalible rule of faith and practice.—II Tim. 3: 16. II Peter 1: 21

- 3. We believe that God created man good and gave him holy commandments whereby he shall live holy; but man voluntarily disobeyed the commandments of God, transgressed the law and fell under the just condemnation of the same, and that man is unable to save himself with his own power; but we see Jesus for the suffering of death crowned with glory and honor that he by the grace of God tasted death for ever man.—Gen. 1:31. Heb. 2:9.
  - 4. We believe that Christ by his death and suffering and resurrection purchased our pardon and offers it freely upon the principle of repentance towards God and faith in our Lord Jesus Christ.—St. John 3: 16. Acts 20:21.
    - 5. We believe that adult persons must be regenerated or born again, if they inherit eternal life.—Jonn 3: 3, 5.
    - 6. We believe that infants are in a saved condition, and we must be like them in innocency if we are ever saved.—Luke 18: 16. Matt. 18: 13
    - 7. We believe that all regenerated persons must persevere in faith and be faithful to the end if they gain an entrance into the City of God.—Rev. 22:14. Matt. 10: 23.
    - 8. We believe that baptism by immersion in water is the apostolic mode, even the burial of the believer in water, and Christ obeyed it thus, and bids us to follow him.—John 3: 22. Matt. 3: 16. Rom. 6: 3, 4. Matt. 28:19.
    - 9. We believe that God iu his goodness displays his power of grace in a greater degree in calling and qualifying his servants by the teaching of the Holy Spirit

and by the instruction of his word to go forth and proclaim life and salvation without price. - John 14: 16. II Tim. 2: 15.

10. We believe that remission of sins and eternal life are free to all who will accept them. -3:16. Peter 3:9.

- 11. We believe that baptism, the Lord's Supper and washing the saints' feet are divine ordinances and must be observed by the people of God. - Matt. 26: 26, 28 and 28: 19. John 13: 4-15.
- 12. We believe that none have a right to baptism only those who have obtained a living hope in the Lord Jesus Christ and none are authorized to offciate in the ordinance of baptism, only those who are called of God. and have been ordained by the laying on of hands .-Acts 8: 37 first clause 38: 30.
- 13. We believe that each church should have a pastor, deacons and clerk so as to keep house for the Lord orderly. - Acts 6: 1-6. Acts 20: 28.
- 14. We believe that in dealing with dis orderly members that reference should be had to the 18th chapter of Matt. and other Scripture relative to dealing with disorderly members.
- 15. We believe that it is the duty of each church to assemble together as often as Providence will permit and in commemorating the Lord's death and washing the saints' feet, a man should examine himself and so let him eat.—Heb. 10:25. I Cor. 11: 23.

16. We believe that the Lord's Supper should be

observed at night and at night only.

17. We believe in the resurrection of the dead of both the just and the unjust. The resurrection of the just to everlasting life and glory and immortality in the presence of God; and the resurrection of the unjust to everlasting shame and banishment from the presence of God.—Matt. 25: 31. I Cor. 15: 42-45. II Thess. 1: 7-9.
