- 1. At every session business shall be opened and concluded by prayer by the Modrator or whomsoever he may request.
- 2. Those who speak shall rise and address the Moderator.
- 3 Personal reflections must be avoided in all debates.
- 4. Every motion made and seconded shall come under consideration of the body unless it be withdrawn by the maker, but no motion shall be discussed without being seconded.
- 5. When a motion has been made and seconded and a member opposes its discussion the Moderator shall put the question. Shall it be discussed? If negative, the question shall be dismissed.
- 6. Visiting members shall take part in debate and shall have all the privileges of other members except to vote.
- 7. If any proposition or motion under debate contains two or more points it shall be divided at the request of any member and a vote taken.
- 8. Motion made and lost shall not be recorded unless so ordered by the Association.
- 9. No one shall speak more than twice on the same subject without special leave of the Moderator.
- 10. All questions shall be decided by a majority of the members present.
- 1. No member shall absent himself from the As sociation without special leave of the Moderator.
- 12. In the future sessions of this Association arrangements must be made so as to insure two or more sermons (or other equivalent exercises) each day.
- 13. The rules of order shall be distinctly read from the chair immediately after the organization of the Association.

A letter from the associational clerk of last years (Sister Beulah Piercefield), was read. She reported Ten Dollar balance carried over from last year minute fund and the above amount accompanied the report, which was applied to the minute fund for this year.

REPORTS OF COMMITTEES

Bill Of Arrangments:—We your committee on Bill of Arrangments, report as follows: Taking into consideration the surrounding cir-

cumstances, and seeing the necesity of a rule governing the ministry, therefore be it resolved, that the association forbids its ministers of the several districts of the asociation speaking disrespectfully of one another, and any one found guilty of suh conduct shall be liable to charges and dealt with as may be deemed necessary.

Be it resolved, that we recomend that our ministers do not vary from the regular custom of the Free Will Baptist in regard to receiving and dismissing members. We furthur advise that the moderators of the churches impress upon the churches the great necesity of observing all the rules of the association.

Be it further resolved, that any elder taking up evvangelestic work it shall be the duty of each church to assist him in the work, and this association shall empower the moderator and clerk with authority to furnish the evangelist with recommendations if he be found worthy.

Resolved, that we forbid the members of our churches from going to, or participating in play parties or dances, and any found guilty of such an offense shall be considered by that body as a stranger, as this evil causes many of our young people to forsake the right way and go off in sin.

Be it further resolved, that we forbid any of our ministers or members of our churches from preaching sanstification or holiness as a second work of grace, separate and apart from regeneration or conversion.

Be it resolved that every member of all our respective churches comprising the Roberts-McGee Association be requested to obey the commandments of God as recorded in 1 Cor. 16:2; 2Cor. 6:7; to lay in store as God has prospered them upon the first day of the week in their nomes or churches, so as to be prepared to help the ministers in preaching the gospel and to help the widows and the worthy poor.

Resolved that each ordained minister should preach at least two sermons each month if not providentially hindered, and that we require every ordained minister to report each year to the association either by letter or in person.

Be it resolved, that every church that calls a minister to her pastoral care should administer to his support as God has prospered them.

Be it resolved, that our articles of faith stand as they are in our old printed minutes.

Be it resolved, that this association reccomend that no church ordain a minister until he has proven himself worthy for a space of twelve months.

Be it resolved, that we ask the association to help us earnestly pray that the divine power of God help us to adopt a more firm basis of finance.

Be it resolved, that the pastor read the constitution and rulings of the association as often as once a year to the church.

Be it resolved, that this association forbids

any of its ministers or members tolerating the so-called doctrine of tongues, or unknown tongues, in any way. Any one found guilty of such shall be deemed guilty of heresy and shall be due acknowledgment or stand suspended from this body.

CONSTITTION

PREAMBLE

From long experience, we the members of the Church of God (denominated Free Will Baptists) being regularly baptized upon a profession of our faith in Jesus Christ and being convinced of the necessity of v combination of churches, to perpetuate a union and communion among us and to preserve and maintain a correspondence with each other, do therefore adopt this constitution for our better associational government.

ARTICLE I. ORGANIZATION

Section 1. This Association shall be known and designated the McGee-Roberts Association of the Church of God (denominated Free Will Baptist) and composed of members chosen from the respective churches residing within its boundaries as hereinafter described not exceeding three members from each church whom on producing letters may be entitled to seats.

Section 2. The officers of this Association shall consist of a moderator, assistant moderator, clerk and treasurer to be chosen by the suffrage of members present. Other assistant officers may be appointed by the moderator when deemed necessary.

ARTICLE II BOUNDARY

The boundary of this Association shall include all of Latimer and LeFlore counties, excepting that part of LeFlor county lying north of the Brazil and James Fork creek and south of the Winding Stair mountains ARTICLE III. ADMISSION OF NEW CHURCHES

Section 1. Any new churches may be admitted into this Association who petition by letter and delegater if upon examination they are found orthodox and orderly, the moderator extending the right hand of fellowship.

Section 2. Letters from the differnt churches desiring representation in this Association shall express the number in fellowship, the number received since the last Association, by experience and baptism leter of recommendation and restoration, the members dismissed by letter, excluded and those who havidied, together with such other statistics and information as would be of interest to the association.

ARTICLE IV. POWER OF ASSOCIATION

This Association shall have no power to Lord it over God's heritage, nor any ecclesiastical power over the churches, but will withdraw from any church becoming disorderly.

ARTICLE V. REFERRED QESTIONS

No question from any church shall come under the consideration of the Association unless it has been discussed in the church from which it was referred.

ARTICLE VI. DUTY OF OFFICERS

Section 1. It shall be the duty of the moderator to preside over the Association, preserve order, appoint all necessary committees and perform such other duties as usually belong to a presiding officer.

Section 2. It shall be the duty of the assistant moderator to aid and assist the moderator in the performance of his serveral duties and to preside over the body in the absence of the moderator.

Section 3. It shall be the duty of the clerk to keep a regular file of the minutes of the Association on a book to be kept by the Association for this purpose and to read the same when called upon by the Association.

Section 4. It shall be the duty of the treasurer to receive and receipt for all money due the Association and to pay out the same only by order of the moderator and clerk of the Association.

... ARTICLE VII. ADOPTION OF MINUTES

Section 1. The minutes shall be read and corrected if needed and signed by the moderator and clerk before the close of the Association.

Section 2. The Association shall endeavor to furnish the churches with minutes of the Association in proportion to the number of members in each church the distribution being at the discretion of the Association.

ARTICLE VIII. INTOXICANTS FORBIDDEN

It shall be distinctly understood that the use of intoxicanting liquors as a beverage is expressly in violation of the Constitution and rules of this Association, and any church member violating the same shall be dealt with by the church of which he is a member and any minister being found giulty of the same shall first make acknowledgment to the church of which he is a member and must also make acknowledgment to the Association, or be expelled therefrom.

ARTICLE IX. AMENDMENT TO CONSTITUTION

This constitution may be amended when necessary by a majority of members present,

ARTICLES OF FAITH

- 1. We believe in one true and living God, Son and Holy Spirit, and these three are one in divine essense, powr and glory.—Rom. 1:20; St. John 1:1.
- 2. We believe the Scriptures of the Old and New Testament are of divine origin and the only infallible rule of faith and practice.—II Tim. 3:16; II Peter 1:21.
- 3. We believe that God created man good and gave him holy commandments whereby he shall live holy; but man voluntarily disobeyed the commandments of God, transgressed the law and fell under the just condemnation of the same, and that man is unable to save himself with his own power; but we see Jesus for the suffering of death crowned with glory and honor that He by the grace of God tasted death for every man.—Gen. 1:31.
- 4. We believe that Christ, by His death and suffering and resurrection purchased our pardon and offers it freely upon the principal of repentance toward God and faith in our Lord Jesus Christ.—St. John 3:15; Acts 20:21.
- 5. We believe that adult persons must be regenerated or born again, if they inherit eternal life.—John 3:3, 5.
- 6. We believe that infants are in a saved condition, and we must be like them in innocency if we are ever saved.—Luke 18:16; Matt. 18:13.
- 7. We believe that all regenerated persons must persevere in faith and be faithful to the end if they gain an entrance into the City of God.—Rev. 22:14; Matt. 10-23.
- 8. We believe that baptism by immersion in water is the apostolic mode, even the burial of the believer in water, and Christ obeyed it thus, and bids us to follow Him.—John 3:22; Matt. 3:16; Rom. 6:3, 4. Matt. 28:19.

- 9. We believe that God in His goodness displays His power of grace in a greater degree in calling and qualifying His servants by the teaching of the Holy Spirit and by the instruction of His Word to go forth and proclaim life and salvation without price.—John 14:16; II Tim. 2:15.
- 10. We believe that remission of sins and eternal life are free to all who will accept them.—3:15; Peter 3:9.
- 11. We believe that baptism, the Lord's supper and washing the Saints' feet are divine ordinances and must be observed by the people of God.—Matt. 26:26, 28 and 28:19; John 13:4, 15.
- 12. We believe that none have a right to baptism only those who have abtained a living hope in the Lord Jesus Christ and none are authorized to officiate in the ordinances of baptism, only those who are called of God, and have been ordained by the laying on of hands.

 —Acts 8:37 first clause 38:30.
- 13. We believe that in dealing with disorderly members that reference should be had to the 8th chapter of Matt. and other scripture relative to dealing with disorderly members.
- 14. We believe that it is the duty of each church to assemble together as often as Providence will permit and in commemorating the Lord's death and washing the Saint's feet, a man should examine himself and so let him eat.—Heb. 10:25; 1 Cor. 11:28.
- 15. We believe that the Lord's Supper should be observed at night, and at night only.
- 16. We believe in the resurrection of the dead of both the just and the unjust. The resurrection of the just to everlasting life and glory and immortality in the presence of God; and the resurrection of the unjust to everlasting shame and banishment from the presents of God.—Matt. 25:31; I Cor. 15:42-45; II Thess. 1:7, 9.
