It was moved, seconded and carried that the Minutes of the 1965 Association be dedicated to the Memory of Rev. I. O. Cook, who passed to his reward September 15, 1965.

Bro. Robert Cloud was elected as Trustee of the Children's Home and to pick up commodities for the Home.

Called for Report of Finance by Marvin Chapel Church (see report).

It was moved, seconded and carried that the Association Letters have a place for Church Extension Report.

Rev. Harvey Ross requested that the Ordaining Council meet with Holly Grove Church to ordain a Deacon.

It was moved, seconded and carried that a Committee of Five be appointed consisting of three ministers and two laymen to review the Constitution and by-laws. Appointed were Rev. C. H. Pelt, Rev. H. D. Shuemaker, Rev. W. L. Eldridge and Bros. C. L. Cook and Earl Hill.

Called for Report of Nominating Committee by Malone Church (see report).

It was moved, seconded and carried to appoint delegates to Sister Associations. Appointed were Rev. M. L. Taylor, Rev. Harvey Ross and Rev. W. W. Hill to State Line Association; and Bro. C. L. Cook, Bro. & Sister Collis Weeks and Rev. J. C. Watson to the Liberty Association. Rev. and Mrs. J. E. Nichols were appointed to Martin Association.

At this time an offering was taken for Sister J. T. Sullivan and \$27.00 was received.

It was moved, seconded and carried to give Holly Grove Church a rising vote of thanks for their hospitality.

So ended the 70th Session of the Salem Association.

Having recognized the fact that our Association has never had a church extension board to help finance small churches, and to help build new ones; furthermore since the need for education is becoming more and more necessary, and this Association has no established method whereby it may assist one attending school;

Therefore, be it resolved:

That the Constitution and by laws be amended to provide for:

First, a Board of Church Extension consisting of five men (the first to serve five years, the second four years, the third three years, and etc.) to be elected at this session and that the members be charged with formulating the regulations for the operation of the Board to be presented to this body for adoption at the next regular quarterly meeting.

Second, a Board of Christian Education and Scholarship consisting of five men to be elected on the same order of the Board of Church Extension. Moreover, may they also be elected at this session and charged with formulating the regulations for the operation of this Board to be presented to this body for adoption at the next regular quarterly meeting.

There shall be a Board of Church Extension composed of five men. They shall serve for a period of five years each. After the fifth year, one will be elected each year. The purpose of this Board is to appropriate and disburse funds for the purpose of helping church building.

There shall be a Scholarship and Education Board composed of five men. They shall serve five years. After the fifth year, one will be elected each year. The purpose of the Board is to appropriate funds and offer scholarship to those of our Association desiring to further their education.

It was moved and seconded to give Malone Church a rising vote of thanks for their hospitality.

## SECOND QUARTER

The second quarterly meeting met with Salem Free Will Baptist Church April 3, 1965.

After song service, Rev. Arnold Woodleif brought the devotional, his subject being "We Need More Laborers In The Field," Math. 9:35:38. Response was by Rev. Billie Buster.

The Moderator called for partial report of Credential Committee. The committee reported 11 churches, 9 deacons and 9 ministers.

The eleven o'clock message was brought by Rev. W. W. Hall, using as his Scripture Matthew 24:12.

At this time offerings were taken for the Home Missions, with \$18.80 being received.

The morning session was adjourned for lunch which was served by the host church.

The afternoon session song service was led by Rev. W. E. George. The devotional was by Rev. J. C. Watson, his Scripture being First Peter, Chapter 1.

The Moderator called for final report of Credential Committee. They reported 18 churches, 32 delegates. There was a move made and seconded that the Association have a theme and program for each session of the 1966 session.

It was moved and seconded to give a vote of thanks to Salem Church.

### THIRD QUARTER

On July 3, 1965, the third quarterly meeting of the Salem Association met with Marvin Chapel church. Song service was led by Rev. H. D. Shuemaker. Prayer was led by Rev. W. E. George.

The Vice-Moderator present and acting, called Rev. Billy Buster to give the devotional, his scripture being Proverbs 30:24. Welcome was given by Sister Mary Eiland. The Response was by Rev. J. C. Watson.

The Moderator asked for the report of the Credential Committee. They reported 12 churches, 19 delegates and 12 visitors. A motion was made and second and carried to seat churches and delegates.

The Children's Home offering was taken at this time and \$12.50 was received.

The eleven o'clock message was brought by Rev. Jim Pelt, his Scripture being Matthew 18:20.

The morning session was dismissed for lunch which was served by the host church.

The afternoon song service was led by Rev. John M. Rich and prayer was led by Rev. H. D. Shuemaker. The devotional was given by Bro. J. T. Toole, his scripture being First Corinthians 3:9.

The Moderator called for the final report of Credential Committee.

A rising vote of thanks was given to Marvin Chapel Church.

### CONSTITUTION AND BY-LAWS OF THE SALEM ASSOCIATION OF FREE WILL BAPTIST

ARTICLE I. NAME AND COMPOSITION. This Association shall be known as the SALEM FREE WILL BAPTIST ASSOCIATION OF WEST FLORIDA, and shall be composed of the following churches: Abes Springs, Cedar Grove, Christian Home, Cottdale, Cypress Creek, Damascus, First Church of Blountstown, First Church of Malone, Hickory Grove, Pine Grove, Rocky Grove, Holly Grove, Lovewood, Marvin Chapel, Midway, New Hope, Oak Grove, Salem Traveler's Rest and any other duly organized Free Will Baptist Church that may wish to unite with this Association.

ARTICLE II. REPRESENTATION. The sessions of this Association shall consist of delegates from the Churches of which it is composed, each Church being entitled to one (1) delegate for every twenty-five (25) members or fraction thereof.

All ordained ministers and deacons who are members and in good standing with the Association and the Churches to which they belong, shall be standing delegates. Ministers from sister Associations who are serving Churches in this Association shall have full delegative powers so long as they are in good standing with this body.

ARTICLE III. OFFICERS., BOARDS AND COMMITTEES. The officers of this Association shall be a Moderator, Vice-Moderator and Clerk-Treasurer, who shall be elected every two (2) years.

The Standing Committees of this Association shall be: Executive, Finance, Obituary, Temperance, Stewardship, Auxiliaries, Resolutions and Nominations, who shall make annual reports to the Association. Other committees shall be appointed as the need may arise.

The Executive Committee shall be composed of three (3) members elected for two (2) year terms and the Moderator of this Clerk of the Association shall act as standing members of this Committee.

The Ordaining Council shall consist of three (3) members to be elected for two (2) year terms.

All elections shall take place on the odd years, except elections to fill vacancies.

ARTICLE IV. SESSIONS AND FINANCE. The sessions of this Association shall be held quarterly. These sessions will convene on Saturday 10:00 AM, before the first Sunday in each quarter with the exception of the fourth (4) quarter. The fourth session in each year will meet on Friday and Saturday before the first (1st) Sunday in October. This particular session shall be known as the annual meeting of the Association, and all annual letters, reports and matters affecting the year's work shall be received in this session.

The general expense of the Association shall be provided by each Church according to the number of its delegates.

Each Church is urged to send at least ten percent (10%) of its income to the Treasurer of the Association quarterly for the Florida State Cooperative Program.

The Moderator and clerk shall each receive twenty-five (\$25) dollars annually for their services.

ARTICLE V. DISCIPLINE. This Association shall have the power to discipline the Churches of which it is composed and to exclude them for disorderly conduct and for doctrine or practices, which are contrary to accepted FREE WILL BAPTIST belief and custom.

ARTICLE VI. AMENDMENTS. This Constitution may be altered or amended by a majority vote of the Association at any regular annual session, provided the suggested amendment is received by the Clerk in writing one day before the vote is taken.

#### BY-LAWS

1. It shall be the duty of the Moderator to preserve order and submit all actions to the body. He shall have the same right of speech as any other member, but he must appoint someone else as Chairman while he speaks. He shall not have the right to vote except in the case of a tie.

(A) The Moderator shall be the Chairman of the Executive Committee.

(B) He shall see that all action taken by this body is carried out, unless otherwise designated by the Association.

2. The Vice-Moderator shall assume the duties, rights and privileges of the Moderator in his absence.

3. The delegates shall be enrolled by the clerk before they are seated in this body.

4. All business shall be brought before the body by a move and second and shall be disposed of according to Parliamentary usage. No person shall be allowed to speak more than three (3) times on the same subject, and not more than ten (10) minutes each time without special permission from the Moderator.

5. Only one person shall be allowed to speak at a time and he must rise to his feet and be recognized by the Moderator. No person is to be disturbed while speaking so long as he keeps to the point in debate except by the Moderator, and then only to call him to order, unless he is willing to yield the floor to some one else temporarily.

6. It shall be the duty of the Executive Committee to act officially for the Association while it is not in session.

7. It shall be the duty of the Ordaining Council to ordain all candidates for the ministry in the Association. Application for all ordination must be made to and approved by the Association. Said applications must come from the Church to which the persons involved belong.

8. No minister or deacon shall be considered in good standing with this body who drinks intoxicating beverages or fails to pay, or make proper satisfaction of his just and honest debts and no minister shall preach to our Churches who cannot bring a clear record from his home Church.

9. Any minister who voluntarily gives up his calling shall immediately turn his credentials over to the Ordaining Council of the Association.

10. No Church shall be recognized in this body who does not commune and wash feet at least once annually. The pastor's salary, number of conferences and the number of communion services shall be contained in the associational letter.

11. No Church shall be considered in order in this body that holds fellowship with a minister or deacon who does not conform with number eight (8) of these by-laws.

12. It shall be the duty of each minister who belongs to, or serves, Churches in this Association to attend all of its sessions. A roll call of the ministers shall be made in all sessions, and the minutes shall carry a list of those present and of those absent. If any minister is absent for two consecutive sessions, his Church, or Churches, shall be notified of said absences, in writing by the Clerk of the Association.

13. This body will not retain fellowship with any church in this Association who retains a pastor or Deacon who has more than one living wife or any pastor who is married to a woman with two living husbands.

14. All ministers must serve Churches as licentiates for a period of two (2) years or do equivalent Church work under the supervision of a duly ordained pastor of the Association appointed by the Ordaining Council, before they are eligible for ordination.

15. Since a call to the ministry and preparation for the same are inseparable, one who is not willing to prepare himself shall not be ordained.

Creator,<sup>1</sup> Preserver,<sup>2</sup> and Governor<sup>3</sup> of the universe; the Redeemer,<sup>4</sup> Savior,<sup>5</sup> Sanctifier,<sup>6</sup> and Judge<sup>7</sup> of men; and the only proper object of worship.<sup>8</sup>

The mode of His existence, however, is a subject far above the understanding of man<sup>9</sup>—finite beings cannot comprehend Him.<sup>10</sup> There is nothing in the universe that can justly represent Him, for there is none like him.<sup>11</sup> He is the fountain of all perfection and happiness. He is glorified by the whole inanimate creation, and is worthy to be loved and served by all intelligence.<sup>1</sup>

## CHAPTER III.

2. God has endowed man with power of free choice, and governs him by moral laws and motives; and this power of free choice is the exact measure of his responsibility.<sup>1</sup>

3. All events are present with God from everlasting to everlasting; but His knowledge of them does not in any sense cause them, nor does He decree all events which He knows will occur.<sup>2</sup>

## CHAPTER IV

### Creation, Primitive State of Man, and His Fall

#### Section I.—Creation

1. **Of the World.** God created the world, and all things that it contains, for His own pleasure and glory and the enjoyment of His creatures.<sup>3</sup>

2. **Of the Angels.** The angels were created by God<sup>1</sup> to glorify Him<sup>2</sup> and obey His commandments.<sup>3</sup> Those who have kept their first estate He employs in ministering blessings to the heirs of salvation<sup>4</sup> and in executing His judgments upon the world.<sup>5</sup>

3. **Of Man.** God created man, consisting of a material body and a thinking, rational soul.<sup>6</sup> He was made in the image of God, to glorify his Maker.<sup>7</sup>

## Section II.—Primitive Man, and His Fall

Our first parents, in their original state of probation, were upright. They naturally preferred and desired to obey their Creator, and had no preference or desire to transgress His will<sup>1</sup> until they were influenced and inclined by the tempter to disobey God's commands. Previously to this, the only tendency of their nature was to do righteousness. In consequence of the first transgression, the state under which the posterity of Adam came into the world is so different from that of Adam that they have not that righteousness and purity which Adam had before the fall; they are not willing to obey God, but are inclined to evil.<sup>2</sup> Hence none, by virtue of any natural goodness and mere work of their own, can become the children of God;<sup>3</sup> but they are all dependent for salvation

upon the redemption effected through the blood of Christ, and upon being created anew unto obedience through the operation of the Spirit;<sup>1</sup> both of which are freely provided for every descendant of Adam.<sup>2</sup>

## CHAPTER V

### Of Christ

#### Section I.

Jesus Christ, the Son of God, possesses all divine perfections. As He and the Father are one, He in His divine nature, filled all the offices and performed the works of God to His creatures that have been the subjects of revelations to us. As man, He performed all the duties toward God that we are required to perform, repentance of sin excepted.

His divinity is proved from His titles, His attributes, and His works.

God, and the everlasting Father.<sup>1</sup>

**2. His Attributes.** He is eternal,<sup>2</sup> unchangeable,<sup>3</sup> omnipresent,<sup>4</sup> omniscient,<sup>5</sup> omnipotent,<sup>6</sup> holy,<sup>7</sup> and is entitled to divine worship.<sup>8</sup>

**3. His Works.** By Christ the world was created,<sup>1</sup> He preserves<sup>2</sup> and governs<sup>3</sup> it; He has provided redemption for all men<sup>4</sup> and He will be their final Judge.<sup>5</sup>

## Section II—The Incarnation of Christ

The Word, which in the beginning was with God and which was God, by whom all things were made, condescended to a state of humiliation in being united with human nature and becoming like us, pollution and sin excepted.<sup>6</sup> In this state, as a subject of the law, He was

liable to the infirmities of our nature;<sup>1</sup> was tempted as we are,<sup>2</sup> but lived our example,<sup>3</sup> and rendered perfect obedience to the divine requirements.<sup>4</sup> As Christ was made of the seed of David according to the flesh, He is called "the Son of man";<sup>5</sup> and as the divine existence is the fountain from which He proceeded, and was the only agency by which He was begotten<sup>6</sup> He is called "the Son of God",<sup>7</sup> being the only begotten of the Father,<sup>8</sup> and the only incarnation of the Divine Being.

## CHAPTER VI

### The Holy Spirit

1. The Scriptures ascribe to the Holy Spirit the acts and attributes of an intelligent being. He is said to guide,<sup>1</sup> to know,<sup>2</sup> to move,<sup>3</sup> to give information,<sup>4</sup> to command,<sup>5</sup> to forbid,<sup>6</sup> to send forth,<sup>7</sup> to reprove,<sup>8</sup> and be sinned against.<sup>9</sup>

1 John 16:13, Howbeit, when he, the Spirit of truth, is come, he will guide you into all truth.

2 1 Cor. 2:11, Even so the things of God knoweth no man, but the Spirit of God.

3 Gen. 1:2, And the Spirit of God moved upon the face of the waters. Acts 8:39.

4 Acts 10:19, While Peter thought on the vision, the Spirit said unto him, Behold, three men seek thee. 1Cor. 2:13; Acts 21:11; John 14:26.

2. The attributes of God are ascribed to the Holy Spirit; such as eternity,<sup>1</sup> omnipresence,<sup>2</sup> omniscience,<sup>3</sup> goodness,<sup>4</sup> truth.<sup>5</sup>

3. The works of God are ascribed to the Holy Spirit; creation,<sup>6</sup> inspiration,<sup>7</sup> giving of life,<sup>8</sup> and sanctification.<sup>9</sup>

1 Heb. 9:14, Who through the eternal Spirit offered himself without spot to God.

2 Psa. 139:7, Whither shall I go from thy Spirit? or whither shall I flee from thy presence?

3 1 Cor. 2:10, The Spirit searcheth all things yea, the deep things of God.

4. The same acts which in one part of the Bible are attributed to the Holy Spirit are in other parts said to be performed by God.<sup>1</sup>

5. The apostles assert that the Holy Spirit is Lord and God.<sup>2</sup>

From the foregoing the conclusion is that the Holy Spirit is in reality God, and one with the Father in all divine perfections. It has also been shown that Jesus Christ is God—one with the Father. Then these three, the Father, Son, and Holy Spirit, are one God.

The truth of this doctrine is also proven from the fact that the Father, the Son, and the Holy Ghost are united in the authority by which believers are baptized and in the benedictions pronounced by the apostles,<sup>3</sup> which are acts of the highest religious worship.

## CHAPTER VII

### The Atonement and Mediation of Christ

1. **The Atonement.** As sin cannot be pardoned without a sacrifice, and the blood of beasts could never wash away sin, Christ gave Himself a sacrifice for the sins of the world,<sup>1</sup> and thus made salvation possible for all men.<sup>2</sup> He died for us, suffering in our stead, to make known the righteousness of God, that He might be just in justifying sinners who believe in His Son.<sup>3</sup> Though the redemption effected by Christ, salvation is actually enjoyed in this world, and will be enjoyed in the next by all who do not in this life refuse obedience to the known re-

quirements of God.<sup>1</sup> The atonement of sin was necessary,<sup>2</sup> For present and future obedience can no more blot out our past sins than past obedience can remove the guilt of present and future sins. Had God pardoned the sins of men without satisfaction for the violation of His law, it would follow that transgression might go on with impunity; government would be abrogated, and the obligation of obedience to God would be, in effect, removed.

**2. Mediation of Christ.** Our Lord not only died for our sins, but He arose for our justification,<sup>3</sup> and ascended up to heaven,<sup>4</sup> where, as Mediator between God and man, He will make intercession for men until the final Judgment.<sup>5</sup>

## CHAPTER VIII

### The Gospel Call

The call of the Gospel is co-extensive with the atonement to all men,<sup>1</sup> both by the word and strivings of the Spirit;<sup>2</sup> so that salvation is rendered equally possible to all;<sup>3</sup> and, if any fail of eternal life, the fault is wholly his own.<sup>4</sup>

## CHAPTER IX

### Repentance

The repentance which the Gospel requires includes a deep conviction, a penitential sorrow, an open confession, a decided hatred and an entire forsaking of all sin.<sup>1</sup> This repentance God has enjoined on all men; and without it in this life the sinner must perish eternally.<sup>2</sup>

## CHAPTER X

### Faith

Saving faith is an assent of the mind to the fundamental truths of revelation,<sup>2</sup> an acceptance of the Gospel,

through the influence of the Holy Spirit;<sup>1</sup> and a firm confidence and trust in Christ.<sup>2</sup> The fruit of faith is obedience to the Gospel.<sup>3</sup> The power to believe is the gift of God;<sup>4</sup> but believing is an act of the creature, which is required as a condition of pardon, and without which the sinner cannot obtain salvation.<sup>5</sup> All men are required to believe in Christ; and those who yield obedience to this requirement become the children of God by faith.<sup>6</sup>

## CHAPTER XI

### Regeneration

As man is a fallen and sinful being, he must be regenerated, in order to obtain salvation.<sup>1</sup> This change is an instantaneous renewal of the heart by the Holy Spirit,<sup>2</sup> whereby the penitent sinner receives new life, becomes a child of God,<sup>3</sup> and disposed to serve Him.<sup>4</sup> This is called in Scripture being born again—born of the Spirit,<sup>5</sup> being quickened,<sup>6</sup> passing from death unto life,<sup>1</sup> and a partaking of the divine nature.<sup>2</sup>

## CHAPTER XII

### Justification and Sanctification

1. **Justification.** Personal justification implies that the person justified has been guilty before God; and, in consideration of the atonement of Christ, accepted by faith, the sinner is pardoned and absolved from the guilt of sin and restored to the divine favor.<sup>3</sup> Through Christ's atonement is the foundation of the sinner's redemption, yet, without repentance and faith, it can never give him justification and peace with God.<sup>4</sup>

2. **Sanctification** is a work of God's grace, by which the soul is cleansed from all sin and wholly consecrated to Christ. It commences at regeneration, and the Christian can and should abide in this state to the end of life, constantly growing in grace and in the knowledge of our Lord Jesus Christ.<sup>2</sup>

## CHAPTER XIII

### Perseverance of the Saints

There are strong grounds to hope that truly regenerate will persevere unto the end, and be saved, through the

## CHAPTER XIV

### The Sabbath

This is one day in seven, which from the creation of the world God has set apart for sacred rest and holy

service.<sup>1</sup> Under the former dispensation, the seventh day of the week, as commemorative of the work of creation, was set apart for the Sabbath.<sup>2</sup> Under the Gospel, the first day of the week, in commemoration of the resurrection of Christ, and by authority of the apostles, is observed as the Christian Sabbath.<sup>3</sup> On this day all men are

required to refrain from secular labor, and devote themselves to the worship and service of God.<sup>1</sup>

## CHAPTER XV

### The Church

A Christian Church is an organized body of believers in Christ, who statedly assemble to worship God, and who sustain the ordinances of the Gospel according to the Scriptures.<sup>2</sup> Believers in Christ are admitted to this church on giving evidence of faith in Christ, obtaining consent of the body, being baptized, and receiving the right hand of fellowship.<sup>3</sup>

The Church of God, or members of the body of Christians throughout the whole world, and none but the regenerate are its members.<sup>1</sup>

## CHAPTER XVI

### Tithing

Both the Old<sup>2</sup> and New Scriptures<sup>3</sup> teach Tithing as God's financial plan for the support of His work.

## CHAPTER XVII

### The Gospel Ministry

1. **Qualification of Ministers.** They must possess good natural and acquired abilities,<sup>1</sup> deep and ardent piety,<sup>2</sup> be especially called of God to the work,<sup>3</sup> and ordained by the laying on of hands.<sup>4</sup>

2. **Duties of Ministers.** These are to preach the Word,<sup>5</sup> administer the ordinances of the Gospel,<sup>6</sup> visit their people

and otherwise perform the work of faithful pastors.'

## CHAPTER XVIII

### Ordinances of the Gospel

1. **Christian Baptism.** This is the immersion of believers in water, in the name of the Father, the Son, and the Holy Spirit,<sup>2</sup> in which are represented the burial and resurrection of Christ, the death of Christians to the

world, the washing of their souls from the pollution of sin, their rising to newness of life, their engagement to serve God, and their resurrection at the last day.'

2. **The Lord's Supper.** This is a commemoration of the death of Christ for our sins, in the use of bread which He made the emblem of His broken body, and the cup, the emblem of His shed blood,<sup>2</sup> and by it the believer expresses his love for Christ, his faith and hope in Him, and pledges to Him perpetual fidelity.<sup>3</sup>

It is the privilege and duty of all who have spiritual union with Christ to commemorate His death; and no man has a right to forbid these tokens to the least of His disciples.<sup>1</sup>

**3. Washing the Saint's Feet.**—This is a sacred ordinance, which teaches humility, and reminds the believer of the necessity of a daily cleansing from all sin. It was instituted by the Lord Jesus Christ, and called an "example" on the night of His betrayal, and in connection with the institution of the Lord's Supper. It is the duty and happy prerogative of every believer to observe this sacred ordinance.<sup>2</sup>

## CHAPTER XIX

### Death, and the Intermediate State

**1. Death.** As a result of sin, all mankind, are subject to the death of the body.<sup>3</sup>

**2. The Intermediate State.** The soul does not die with the body; but immediately after death enters into a conscious state of happiness or misery, according to the moral character here possessed.<sup>1</sup>

## CHAPTER XX

### Second Coming of Christ

The Lord Jesus, who ascended on high, and sits at the right hand of God, will come again, to close the Gospel dispensation, glorify His saints, and judge the world.<sup>2</sup>

## CHAPTER XXI

### The Resurrection

The Scriptures teach the resurrection of the bodies of all men at the last day, each in its own order; they that have done good will come forth to the resurrection of life, and they that have done evil to the resurrection of damnation.<sup>1</sup>

## CHAPTER XXII

### The General Judgment and Future Retribution

1. **The General Judgment.** There will be a general judgment, when time and man's probation will close forever.<sup>2</sup> Then all men will be judged according to their works.<sup>3</sup>
