FIRST QUARTERLY SESSION Damascus Free Will Baptist Church January 12, 1991

The meeting convened at 10:00 a.m. with the congregation singing "When The Roll is Called Up Yonder" led by Bro. Frank Chatwood with Bro. Wayne Hill accompanying at the piano. Rev. Carlie Lloyd led the congregation in an opening prayer. A warm welcome was extended to everyone by the pastor, Rev. David Young. The morning devotion was brought by Rev. Jerry Whitworth, pastor of Chrsitian Home. His topic was "The Greatest Love Letter Ever Written". He challenged each of us to allow God to speak to us through His love letter. Greetings were given to all from our moderator, Rev. Bill George, as he called this session to order. He asked that all standing delegates stand and seat the church delegates. MSC. A partial report of the Credentials Committee was given with a total of 87 present. The moderator passed out the Annual Ministerial Certificates to all pastors of our association present. Terry Vickery. MSC. Announcements were made. There being no further business, MSC to adjourn. Bro. Olan Rehberg dismissed in prayer.

THIRD QUARTERLY SESSION Holly Grove Free Will Baptist Church July 13, 1991

Services began at 10:00 a.m. with the congregation singing "When We All Get To Heaven". Rev. James Elmore led in prayer. The new pastor of Holly Grove, Rev. Ron Ivey, extended a warm welcome to all. Two more congregational songs, "Heaven's Jubilee" and "I Am Resolved" were sung. Rev. Bill George, Moderator, took the floor, extended a welcome to all and introduced Rev. Jerry Whitworth, who brought the morning devotion. He spoke on the fundamentals of the foundation of our Faith. The session was then called to order by Rev. George by asking the standing delegates to stand. They in turn moved to seat the church delegates. MSC. The moderator called for any old business or committee reports. Rev. Carlie Lloyd gave a report on Youth Camp and also mentioned a motion concerning the dress code at camp that the body would be allowed to entertain at the afternoon session. A partial report of the Credentials Committee was given with a total of 68 present. MSC. Rev. Jerry Whitworth also gave a report on Youth Camp. Rev. D. W. Poole dismissed for the morning recess.

After a short recess the session resumed with the congregation singing "Joy Unspeakable". An offeratory prayer was given by Bro. Aaron Jolley and the morning offering of \$56.09 was received. The congregation joined in singing "What A Day That Will Be". A special in song "How Great Thou Art" was presented by Rev. Jim Pelt.

Rev. Ron Ivey preached the morning message, "To be in fellowship with Christians. He encouraged us to help each other in the furtherance of the Gospel. Directions were given for the noon meal and the blessing prayed by Bro. Glen Watson.

The afternoon session convened with the congregation singing "Jesus Hold My Hand". Bro. Richard Rehberg led in prayer. Rev. Carlie Lloyd was called on to bring the afternoon devotion. The title was "Finding God's Way in Dark Days".

A final report of the Credentials Committee was given with a total of 69 present, MSC. The Finance Report was given by Sis. Margaret Lloyd. MSC. Rev. Carlie Lloyd presented a motion concerning the membership of the Camp Board that was presented in the January meeting for consideration. His motion was that the Salem Association not adopt the proposed Camp Board Constitutional change that was intended to make all pastors standing Camp Board members with voting privileges. There was discussion from Rev. Jerry Whitworth, Rev. David Young, Bro. Richard Rehberg and Rev. Carlie Lloyd. A vote was taken; 16 Opposed - 15 for. Motion denied. Rev. Whitworth suggested that the body consider Camp Mt. Pleasant in their budget for 1992. After some discussion, Bro. Richard Rehberg made a motion that the association send the Camp an offering of \$2,000.00 at this time to help with some work that needs to be done. This would come from the General Fund. MSC. Discussion was also made concerning the need for funds at the Children's Home in Eldridge, Alabama. Motion was made by Rev. David Young that the association also send \$2,000.00 to the Children's Home from the General Fund. MSC. Rev. Carlie Lloyd made a motion that the Salem Association send a letter to the Camp Mt. Pleasant Camp Board requesting that:

- 1. All lady counselors, camp workers, and kitchen workers who help with both teen and junior weeks of youth camp set a good example for the campers by wearing modest and at least knee-length dresses, skirts, or culottes (with proper fullness). No walking shorts, slacks, or gaucho pants, please.
- 2. The dress code for campers during our Free Will Baptist Youth Weeks be included on the camper application as follows:

Girls: Modest, knee-length dresses, skirts, or culottes at all classes and services. No shorts, halter tops, or sundresses. Culottes are preferred for activities, and should be at least knee-length with proper fullness. One piece swimsuits only.

Boys: Shirts and long pants at all times. No shorts or tank tops.

Following some discussion, MSC. 19 for; 8 Against. A rising vote of thanks was given to the host church for their hospitality. MSC for dismissal. Rev. D. W. Poole dismissed the session with prayer.

ANNUAL SESSION Marvin Chapel FWB Church October 11 & 12, 1991

The 96th session of the Salem Association of Free Will Baptist convened with the congregation singing "There's Power in the Blood." Rev. Ron Ivey led in prayer. Another congregational song, "Take the Name of Jesus With You" was sung. Pastor, Rev. Tim McDonald, extended a warm welcome to all present. Moderator, Rev. Bill George called the session to order. The Standing Delegates were recognized and then they moved to seat the elected church delegates. MSC. During the next congregational song, everyone was encouraged to turn around and fellowship with the people around them. Special Music, a violin solo, was presented by Paige Baggett. Rev. McDonald introduced Rev. David Womack, speaker for the evening message. He preached a timely message on the importance of unity in the church, home and government. An invitation was given. to Wisconsin, \$1,000.00 to Dennis Owen Account, Foreign Missionary to Uruguay and also to send one fourth of the mission account quarterly receipts to each of the following: Dennis Owen, Dave Franks, Jr. and Odis Whitehead. The remaining one fourth would remain in the Missions account. This will be reviewed next year. Various comments and discussion was made concerning funds in the Mission Board account and how they should be used. Committee on Committees Report was given by New Hope. MSC. After much discussion concerning our current boards and resolutions previously presented, a motion was made that a committee be enacted to examine our existing committees as to their function and worth. This committee would make recommendations to the Association as to how these committees may better serve our churches through re-structuring, merging and guidelines. This committee would serve a temporary purpose, being dissolved at its completion. MSC. Nominating Committee report was made by Marvin Chapel. MSC. Rev. David Young was nominated from the floor to be the representative from the Salem Association to the State Executive Board, to fill vacancy created by Rev. Carlie Lloyd, who recently left our association to become a home missionary. MSC. The following were appointed to be the committee for the motion made earlier concerning evaluation of current committees: Rev. Tim McDonald, Rev. David Womack, Rev. David Young and Rev. STEWARDSHIP REPORT

(Sneads Church)

All of us are perplexed occasionally as to what to do next because of time limitations. Seldom does anyone say, "What will I do to kill some time?" If and when he does, he shows that he is a poor manager of life.

The prodigal son had an answer for the way in which he wanted to spend his time and money -- and soon they were both gone. Then he came to his senses and returned to his father.

To the christian, wise use of time includes worship. CONSTITUTION AND BY-LAWS OF THE SALEM ASSOCIATION OF FREE WILL BAPTISTS OF FLORIDA

PREAMBLE

We, the believers in Christ according to the doctrine of the Free Will Baptist Denomination, having been baptized unto a like profession of faith in Jesus Christ and properly organized into churches, realizing the necessity of a bond of union and fellowship among us for preservation of the "Faith once Delivered Unto the Saints," and the spreading of the gospel of Christ upon earth, do therefore ordain and establish this constitution.

ARTICLE I — NAME

This organization shall be known as the Salem Association of Free Will Baptists of Florida.

ARTICLE II — PURPOSE

The purpose of the organization shall be to unify the work of the churches composing this association by devising and executing such measures as will best spread the gospel of Christ as we interpret it.

ARTICLE III — MEMBERSHIP

Any regularly organized and well disciplined Free Will Baptist Church conforming to the usages of the Free Will Baptist denomination as set forth in the Treatise of the Faith and practices of the Free Will Baptists of the National Association, may upon proper application, and a vote of the association, become a member of this association.

ARTICLE IV — COMPOSITION

The sessions of this association shall consist of delegates appointed or elected by the churches of which this association is composed. All ordained ministers, and deacons who are members and in good standing with the association and the churches to which they belong, shall be standing delegates. Ministers from Sister Associations who are serving churches in this association shall have the right to make suggestions but the voting right shall be reserved for the delegates of the Salem Association. All officers of the Association will be standing delegates.

ARTICLE V — REPRESENTATION

Each church in this association shall be entitled to one delegate for every 25 members or fraction thereof.

ARTICLE VI — OFFICERS, BOARDS AND COMMITTEES

The officers of this association shall be a moderator, vice moderator, and clerk-treasurer, who shall be elected every two (2) years, on the odd year, except to fill vacancies.

The standing committees of this Association shall be: Executive, Finance, Obituary, Temperance, Stewardship, Auxiliaries, Resolutions and Nominations, who shall make annual reports to the Association. Other committees shall be appointed as the need may arise.

(1) The Executive Committee shall be composed of three (3) members, who shall be elected for three (3) year terms on a rotating basis, so that one new member shall be elected yearly.

The Moderator and Clerk of this Association shall act as standing members of the Committee.

(2) The Ordaining Council shall be composed of three (3) ministers of this association and shall be elected for three (3) year terms on a rotating basis, so that one new member shall be elected yearly.

No person shall hold more than one office in this association.

ARTICLE VII — BOARDS

The standing boards of this association shall be: Home Missions, Church Extension, and Youth Board.

(1) The Home Mission-Church Extension Board shall be composed of five (5) members.

(2) The Youth Board shall be composed of three (3) members. All standing members shall be elected alternately for the number of years in accordance with the number of members composing their board, so that one new member might be elected yearly. Other boards may be elected as the need may arise.

ARTICLE VIII — SESSIONS

The sessions of this Association shall be held quarterly. These sessions will convene on Saturday, 10:00 a.m. on the second (2) Saturday in each quarter with the exception of the fourth (4th) quarter. This fourth session in each year will meet on Friday night (before the 2nd Saturday) at 7:00 p.m. and the second (2nd) Saturday in October. This particular session shall be known as the Annual Session of the Association, and all annual letters, reports, and matters affecting the year's work shall be received in this session.

ARTICLE IX — FINANCE

Section 1. All churches represented in the body are asked to pay fees quarterly. The amount of this fee shall be determined by the body while in session, and may be changed by a two-third vote in any session.

Section 2. Each church is to send five dollars (\$5) per delegate with a minimum of five dollars (\$5) per church.

Section 3. Each church is asked to send at least ten percent (10%) of its income for the cooperative plan of support.

Section 4. All cooperative funds coming into this body shall be spent under a budget plan. This budget must be approved by the body while in session.

Section 5. The Moderator and Clerk shall each receive fifty dollars (\$50) annually for their services.

ARTICLE X — DISCIPLINE

This association shall have the power to discipline the Churches of which it is composed, and to withdraw fellowship from a church as a whole when it's action is inconsistent with the doctrine and usages of the Free Will Baptist church, if labor with it is unsuccessful. But in no case can it reverse a decision of a church.

ARTICLE XI — MINISTERS

Section 1. The pastor of every church in the association should be a member of a church under his care.

Section 2. When a church desires that one of its members be licensed or ordained to preach the gospel, it should request the association through it's ordained Council to examine such member, and should agree to abide by the recommendation of the ordaining council.

Section 3. A minister of this association who is subject to discipline for doctrine or practices contrary to the Treatise of the Free Will Baptist denomination shall be brought to trial by the church of which he is a member. However, the ordaining council must sit in the church conference in an advisory capacity.

Section 4. Cards will be given at the annual session of this association to those ministers of good standing.

ARTICLE XII — AMENDMENTS

This Constitution may be altered or amended by a majority of the Association at any regular annual session, provided the suggested amendment is received by the Clerk in writing one day before the vote is taken.

BY-LAWS

- 1. Each session of this association shall be called to order by the Moderator and opened with prayer. Each session shall be closed with prayer.
- 2. It shall be the duty of the Moderator to preserve order and submit all actions to the body. He shall have the same right of speech as any other member, but he must appoint someone else as Chairman while he speaks. He shall not have the right to vote except in the case of a tie.

(A.) The Moderator shall be the Chairman of the Executive Committee.

(B.) He shall see that all the action taken by this body is carried out, unless otherwise delegated by the Association.

3. The Vice Moderator shall assume the duties, rights and privileges of the Moderator in his absence.

before proceeding. A member may second a motion without rising and addressing the Moderator.

4. The delegates shall be enrolled by the Clerk before they are seated in this body.

5. All business shall be brought before the body by a move and second and shall be disposed of according to Parliamentary usage.

6. A member wishing to make a motion or to speak in conference shall first rise, address the Moderator, and be recognized by him
