#### **MINUTES**

Pursuant to adjournment, a goodly number of the Deacons, Ministers and Messengers composing that part of the Church of God known as Social Band Association of Freewill Baptist met with Stony Point church, Elevenpoint, Ark., on August 14, 1926. The annual sermon was preached by Eld. D. M. Holder.

- 1. Regular associational clerk not being present G. W. Million was selected to act as clerk pro tem.
- 2. Called for letters, received 9: Liberty, Pirtle, Hopewell, Clear Lake, Lone Oak, Stony Point, Eureka, White Oak and Union.
- 3. Called for petitionary letters, received one: Plain View church.
- 4. Proceeded to regular organization by electing moderator and clerk. Elds. D. M. Holder, D. C. Jones and E. W. Tucker were put in nomination and duly voted upon. Eld. D. M. Holder was elected and Bro. Mack Johnson was elected clerk.
  - 5. Proceeded to appoint the several committees.

- 12. Moved to turn over what money Bro. Million had and what we had in our treasury to the educational fund of the Freewill Baptist College at Tecumseh, Okla.
- 13. Moved to ask each member of the local churches to contribute 5c each to be put in the disabled ministers fund.
- 14. Moved to elect a district financial board and following were elected; Eld., G. W. Million and Eld D. C. Jones for 3 years; Eld. E. W. Tucker and Bro. Mack Johnson for 2 years; Bro. E. McElyea and E. Rhodes for 1 year. Committee on Divine Service reported that the stand be filled Saturday night by Eld. D. C. Jones.

#### Constitution

. . . ·

- 1. This association, when properly organized, shall, consist of a moderator and a clerk, who shall be chosen by the suffrage of the members present. The duty of the moderator shall be to keep the Association in order, state questions fairly and take the vote thereon; to have the liberty of speech as other members, providing his seat be filled, to have no vote unless the association be equally divided in which case he shall have the deciding. The duty of the clerk shall be to keep a fair record of the proceedings of the association.
- 2. This association shall be composed of ordained ministers, deacons and licentiates, together with messengers duly chosen by the several churches in our union and sent to represent them in this association, said messengers being members of some church within this association, whom the members judge best qualified for that purpose, who, on producing letters certifying to their appointment, shall be entitled to seats.
- 3. In the letters from the several churches shall be expressed their respective number of members in fellowship, and the number received, dismissed, excluded or died since the sitting of the last association and day of church meeting. The state of the same

- 4. No query shall be received by the association from any church unless it has been acted on in said church and cannot be settled, in which case the association shall take up same and act upon it.
- 5. Every church in the association shall be entitled to a representation of messengers not exceeding three.
- 6. Every motion made and seconded shall be acted upon unless withdrawn by the mover.
- 7. The association shall not have the power to lord it over God's heritage so as to infringe on any of the internal rights of the churches; nevertheless we agree that the churches composing the association shall stand in the same relation to each other in this association that individuals do to each other in this association; that is to say, if a church trespass against a sister church, the church injured shall try to reclaim them by Gospel steps; if they cannot be reclaimed they shall be dropped from our union.
- 8. We agree to do all business by a majority of the members present.
- 9. Any church may be admitted into this association by letter and messenger. If upon proper examination it is found to be orthodox and orderly such admission shall be manifested by the moderator giving the right hand of fellowship to the messengers thereof.
- 10. This association shall have power to sit as an advisory council, to give churches all necessary advice in matters of difficulty; to inquire into the cause why churches neglect to represent themselves in this association; to appoint any members, by and with his or her consent to transact any business they may deem necessary; to invite brethren in the ministry to a seat with the association; to adjourn the association at any time and place that may be thought necessary; to exclude from his seat any member who shall not conform to the Rules of Decorum, and shall report his or their conduct to the churches from which he or they were messengers.
- 11. This association possesses appellate jurisdiction in all cases of difficulty that may arise in the churches.
- 12. The Lord's Supper shall be administered at each annual association.
- 13. Each annual association shall be held on the 3rd Sunday in August.

## Articles of Faith

- 1. We believe in one true and living God—the Father, the Son and Holy Ghost—and these three equal in divine essence, power and glory. John 1:1; 1 John 5:7; 1 Cor. 8:6; John 10:30.
  - 2. We believe that the Scriptures in the Old and New Testa-

ments are the words of God, and the only infallible rule of faith and practice. 2 Tim. 4:2; 2 Tim. 3:16.

- 3. We believe that God created man good and gave him holy commandments, whereby he should live holy, but man voluntarily disobeyed the commandments of God, transgressed the law and fell who and make the just condemnation of the same, whereby all men are single ners, not by constraint, but by choice, being partakers of the sinful nature attained by the fall. But we see Jesus, who was made a little lower than the angels for the suffering of death, crowned with glory and honor; then He by the grace of God should taste death for every man. Gen. 1:27; Gen. 2:16-17; Gen. 3:6; John 3:16-17; Heb. 2:9.
- 4. We believe that Christ, by His death, burial and resurrection purchased our pardon and offers it freely to all men upon the conditions of repentance toward God and faith in the Lord Jesus Christ. He now commands all men everywhere to repent, therefore look unto me and be ye saved all the ends of the earth, for I am God, and beside me there is none else. Rom. 5:6-21; Matt. 4:17; Isiah 45:22; Heb. 11:16.
- 5. We believe that all adult persons must be regenerated and born of the spirit of God if they inherit eternal life. John 1:6-14; Titus 3:5; John 3:1-13; Rom. 8:9.
- 6. We believe that regeneration is an instantaneous renewal of the heart by the Holy Ghost whereby the penitent sinier receives a new life, becomes a child of God and is disposed to serve Him. As babies require constant food for bodily development, the new born babe in Christ requires spiritual food that he may develop by a gradual growth into full stature of Christian manhood, John 3:5; Ez. 36:26-27; Titus, 3:5; Gal. 5:1-21; Eph. 2:10; Rcm. 8:18; John, 1:12-13; Matt. 13:21; Mark 4:26; 1 Peter 2:2.
- 7. We believe that the doctrine of Sanctification or Holiness as taught in the Bible applies to the soul or inner man; and to it alone, and that the sanctification of the body will not take place until the resurrection of the dead, when this mortal shall put on immortality and this incorruptible shall put on incorruption. 1 Cor. 6:11; Rom. 7:17-25; Phil. 3:21; 1 Cor. 35:54.
- 8. We believe that all Christians should persevere in grace, and be faithful to the end if they inherit eternal life, for blessed are they that do His Commandments that they have a right to the tree of life and enter through the gates of the city. Cor. 10:12-13; Rev. 22:14; Rom. 11:20-2:; Heb. 10:26; John 15:2-6.
- 9. We believe in the justification of infants by the imputed righteousness of Jesus Christ in a passive state, thereby adopting them heirs to His Kingdom. Matt. 19:13-14: 8:10.
- 10. We believe that the visible Church of Christ is a congregation of faithful followers who have obtained fellowship with each

other and have given themselves to the Lord and one another, having agreed to keep up good discipline according to the rules of the Gospel. Matt. 18:15-20.

- 11. We believe that the church is the family of God, the redeemed in the aggregate of Adam's race from righteous Abel to the restitution of all things of every nation, kindred, tongue and people. Matt. 16:18; Acts 2:47; Heb. 12:23; Eph. 1:22-23; Rom. 12:5; 10:17.
- 12. We believe that Jesus Christ is the great head of the church and the government is with the body. Eph. 5:23; Col. 1:18-21; Matt. 18:17-18.
- 13. We believe that baptism by immersion is the apostolic mode, even the burial of a believer in water, and that Christ, who is our life, showed this humble example to His children and bade them walk therein. Matt. 3:55-16; Matt. 28:19-20; Mark 1:8-11; Acts 8:28; Rom. 6:16.
- 14. We believe that Baptism, the Lord's Supper, and the washing of the Saints' feet are ordinances of the Gospel of Jesus Christ and to be continued until His second coming. Matt. 28:19; Luke 22:19-20; John 13:5.
- 15. We believe that only those who have obtained a living hope in the Lord Jesus Christ, have a right to baptism, and those only who have been called to God and have come under the Presbytery of Elders have a right to administer the same. Titus 1:1-16; Mark 16:16; Matt. 3:8-9; Acts 10:47; 1 Tim. 4:14-16.
- 16. The soul is immortal, hence does not die with the body, but immediately after death enters into a conscious state of happiness or misery, according to the spiritual character here possessed. Phil. 1:23; Luke 23:43; Rev. 6:9.
- 17. We believe that there will be a general universal judgment when all men shall be judged according to the deeds done in the body, whether good or bad, and that immediately thereafter the wicked shall enter into everlasting punishment, and the righteous into eternal happiness. Eccl. 3:17; 11-9; Matt. 12:36-37; 2 Thes. 1:8-9; Rev. 6:12-17; 20:12; 21:8; 14:11; Luke 16:23; 2 Cor. 5:10.
- 18. We believe that God in His goodness displays power of grace in a great degree in calling and qualifying His servants by the teaching of the Holy Ghost and by the instruction of His blessed words to go forth and proclaim life and salvation without price. He bids us freely to come and nothing prevents the salvation of any but their own stubborn rebellion and sinful refusal to come. Acts 9:15; 1 Tim. 4:16; 1 Cor. 1:23; 1 Tim. 1:15-16.
- 19. We believe in a divine call to the ministry, that the minister should heed the admonition of Paul to Timothy to study the Scrip-

tures, that the church donate of their substance as the Lord prospers them to support of their pastors, and that ministers may have better opportunities to store their minds with that spiritual food so necessary to Christian development. To this end we recommend that each church have a finance committee of three to consist of two deacons and a clerk to collect and store such funds. 2 Tim. 2:15; 1 Cor. 16:1-2.

# Rules of Decorum

- 1. The association, when convened shall be opened and closed by singing and prayer.
- 2. Only one person shall speak at a time, who shall rise to his feet and address the moderator.
- 3. Each person thus speaking shall not be interrupted in speech, except by the moderator, until he gets through; nor shall the moderator interrupt him unless he breaks order.
- 4. The person speaking shall adhere to the question and shall in no wise cast any reflections on any person who may have spoken before him.
- 5. No person shall speak more than three times on the same subject without leave of the Association.
  - 6. No member shall laugh or whisper in time of public speech.
- 7. Members shall address each other by the appellations of brother or brethren and sisters.
- 8. No member of this association shall absent himself when the association is sitting in conference without leave of the moderator.
- 9. The names of the members of the Association shall be enrolled and called over as often as the Association thinks necessary.
- 10. No member shall speak longer than fifteen minutes at any one time without leave of the Association.

Be it resolved, That each church in Social Band Association take a firm stand against the teachings of Evolution and Russellism.
