#### PROCEEDINGS

#### 1956 STATE ASSOCIATION-

The fourteenth session of the State Association of Free Will Baptist convened with the Little Bethel Church in the Central Conference Nov. 15, 1956. Rev. Hoyt Powell conducted the morning devotions after the singing of a hymn led by Rev. Carroll Alexander, the song leader for this association. Rev. J. A. Hucks led in prayer. The subject of the devotion was "To Whom Shall We Go?"

The moderator, Rev. W. L. Jernigan, called this association to order. The welcome address was given by Rev. L. P. Brown and the response by Rev. Carl Shook. The resignation of the clerk, Mr. Bass Hanna, was accepted by the body. Rev. Rufus Coffey was in turn elected to serve for this conference.

The moderator's message was delivered. (cf Appendix I)

The visitors were recognized and a motion was sustained to give a seat and voice and all privileges except that of voting.

A motion was adopted that the chair appoint the various committees necessary. The committee on committees was appointed as follows: Rev. Julius Vause, Rev. J. A. Hucks, Rev. Carl Shook. A finance committee was appointed as follows: Mr. Marion Todd, Mr. Roy Brown, Mr. Ollie Mims.

The conference letters were called for and the delegates were enrolled.

A motion to lay on the table certain constitutional amendments and alterations until Friday's session was adopted. Another motion was adopted to list all ministers and liscenuates in the minutes, and their addresses. A further constitutional amendment was proposed and laid on the table for a 24 hour waiting period before disposal. A Home Mission Committee report was read and by motion it was laid on the table until the afternoon business session. The Committee on committees made their report and it was adopted in its' entirety.

#### MORNING WORSHIP

A hymn was sung and Rev. L. A. Holliday led in prayer. Rev. James Miller the representative from the Bible College was introduced and brought a most inspiring message from I Cor. 15:1-20, on "The Power of the Gospel." As the manner and message of Paul's preaching was presented, our souls were stimulated. The conference adjourned for lunch after the message.

#### THURSDAY AFTERNOON

A hymn was sung and Rev. Carl Shook spoke from Mark 16:15 emphasizing in his devotional message the responsibility and power of the gospel to transform lives. Rev. Pickett Kirby led in prayer.

A report of the Bible College in general and the building program in particular was given by Rev. James Miller. Blank checks were distributed to make contributions from each local church.

Mr. Dan Eaddy rendered special music with a vocal solo.

The report of the National Superannuation work was given by the Promotional Secretary, Rev. K. V. Shutes.

In the business session a motion to adopt the Home Mission Committee report was sustained by a majority vote after discussion and amendments. (Appendix II.)

The report of the Mt. Olive Education Committee was given as information. The Temperance committee reported on their work for the past year and was given by Ronald Creech. cf appendix III).

The Children's Home printed report was distributed by the Superintendent, Rev. Eddie Corn. (cf appendix IV) The Promotional Secretary, Rev. Carl Shook, made his report. (cf Appendix V).

The conference adjourned until 9:30 Friday morning at Little Star Church. We were dismissed by prayer.

#### THURSDAY NIGHT

The worship service was conducted by Rev. K. V. Shutes, National Promotional Secretary of Superannuation. He spoke from II Tim. 4:2 on the subject "Preach the Word." This time of worship and prayer was very inspiring and proved a blessing to those who attended.

#### FRIDAY MORNING

The Conference opened at the Little Star Church with singing "At The Cross". Rev. M. S. Todd led in prayer. The devotional was conducted by Rev. Monroe Harrell. His message centered around the woman at the well taken from John, Chapter 4.

The committee appointments were reread. The visitors were recognized and a motion was adopted that they be seated and given every privilege except for voting. Rev. Jackson was present from the Assembly of God church, and our missionaries, Miss Volena Wilson, India, and Miss Lucy Wisehart, Cuba.

The report of Christian Education was adopted. (cf Appendix VI).

The minutes of the Conference on Thursday were read and adopted.

The late churches were requested to report. A motion was sustained to have the Beaver Creek and South Carolina Conference Letters mailed to the clerk. The South Carolina Conference turned in its' dues of twenty dollars.

A verbal report of Foreign Missions was given by Rev. Ronald Creech. He informed the conference we had over subscribed our quota by more than \$600 in ten months.

Special music was given in the form of a record being played of our missionary Carlisle Hanna singing. Miss Volent Wilson led in prayer, asking God's blessings upon him and our other missionaries.

The report of the resolution committee was adopted. (cf. App. **VII**).

Motion was adopted to take from the table the proposed recommendation of the Thursday morning session. These recommendations and constitutioal changes were adopted item by item after due discussion. (cf. appendix VIII).

The League committee report, was adopted. (cf Appendix IX.) The Conference recessed for the morning worship period.

The morning worship consisted of a Mission program. The missionaries present participated and Rev. Raymond Riggs, National Foreign Mission Secretary, brought a most challenging message on missions. His subject was taken from Ecc. 11:1 "Cast they bread upon the waters". A special mission offering was taken before we dismissed for lunch.

#### FRIDAY AFTERNOON

We began the afternoon meeting by singing "Bringing in the Sheaves". Rev. Pickett Kirby conducted the Memorial Service, in memory of all the deceased brethern during the past year. Special tribute was paid to Rev. Willie Johnson of Turbeville. (cf. Appendix X).

The report of the Woman's Auxiliary was received by proper motion. A motion was sustained to print the Woman's State Auxiliary Minutes in the State Association Minutes. (cf. Appendix XVII.) The Publicity Committee report was adopted by proper motion. (cf. Appendix XI).

An offering was taken to defray the expenses of Rev. K. V. Shutes who visited our association.

The report of the State Superannuation Director was adopted. (cf. Appendix XII). The committee was named as requested. (cf Directory).

The report of the State Home Mission Director was adopted. (cf. Appendix XIII).

The Publicity Committee as requested by motion, was appointed. The Sunday School and Literature Committee report was adopted. (cf. Appendix XIV).

The Finance Committee gave their report and upon motion they were released. (cf. Appendix XV).

A verbal statement was given by Rev. Edison Kirby concerning the Treasurer's report. The treasurer was absent but his report was to be mailed to the clerk. (cf. Appendix XVI).

The delegates to the National Association were elected. A motion was adopted to impower the state president or the General Board member to assemble the delegates at the National Association next July.

A committee was appointed to define the duties of the Promotional Secretary after such motion was adopted. (cf. Directory)

The Nominating Committee reported and it was adopted as amended. (cf. Directory).

A Board of Education was elected. (cf. Directory).

A Sunday School State Director and Advisory Board was elected. (cf. Directory).

Rev. Ronald Creech was elected to the General Board of the National Association to represent the state. He will succeed Rev. Fred Powers next July.

A motion was adopted to stand in appreciation for the hospitality of the host churches.

The next State Association will meet in the Eastern Conference. The clerk was to be notified which church would entertain.

The minutes of Thursday's session was read and adopted.

Miss Volena Wilson was given time to speak concerning the work in India and bring to the conference special greetings from the Carlisle Hanna's. Miss Lucy Wisehart sang a beautiful solo.

The Conference adjourned upon motion and all shook hands as we sang "God Be With You Till We Meet Again."

# APPENDICES APPENDIX I PRESIDENT'S MESSAGE

Forward - Genesis 14:15

Dear brethern, sisters, and esteemed friends, it has pleased the Lord to spare us once again to gather in the South Carolina Association, to transact such business as may pertain to the Kingdom of God, and it's advancement, in as much as the Association being human may enter into such a noble work.

As your moderator I shall endeavor to do my best to serve you as I would like that you serve me if I were in your place and you were in mine. I believe in fairness to all and special privileges to none. If we should get into a long discussion on some trivial matter that can easily be observed as insignificant, and of no importance, I shall feel free to call a halt to such discussion. Please lets observe this simple rule if you wish to make a motion then wait until it has been duly seconded before you start discussing it. To second a motion you may remain seated unless you are too far away from the chair to receive proper recognition. Now you be nice to me, and I will be nice to you.

If you are put on a committee, you will please do the work assigned to you just as early as possible, and have it ready to hand in when called for, otherwise we might bypass you.

If you are a minister, officer or delegate to this association, you are supposed to stay in this house during the entire session unless you are excused by the moderator.

Let's remember this is the Lord's business, and it should claim our very best attention. So let's keep our heads cool and our feet on the floor, and be led by the Spirit in all that we do and say.

Now I call your attention to three thoughts:

The forward look.

The forward march.

The forward reception.

It is from these points that I want to briefly speak in connection with the different phases of our work. First, let's think in terms of the local church, second, the Quarterly Conference, and third, the Annual District Conferences, all of which constitute the State Association.

The local congregation must be concerned in the work in general in order to stimulate the minds of it's parishoners. Then in the Quarterly Conference when the brethern come together there is further stimulation because of the communion and fellowship of kindred minds. This inspiration still pressing it's desired effect in the Annual District Conferences. All of which is brought to it's climax in this body, to return in it's power to the local church.

With this spiritual concept we may take the forward look, as it relates to our educational program, our mission program both home and foreign, our Children's Home and our supernnuation program.

The mountains of doubt, dissapointment, misgivings, misunderstanding and fear, even on down to the crossing of the Jordan, and the entrance of the promised land. From the mission fields will come the thousands of converts, who will take up the work in their own native land, and otherwise, doing like the Etheopian Eunich did when Phillip baptized him "going on their way rejoicing" and winning the lost to Jesus.

From our Children's Home will come the well trained and

mannerly children that will rise up some day to call us blessed, as they take their various stations of prominence, and service among us.

From our way worn, brow beaten, tired and weary ministers will come the sweet, pleasant smiles of thankfulness that cheer and fill our hearts to overflowing, as we talk over with them their fond memories of the past and their pleasant thoughts of the future.

Last but by no means least, from our Blessed Lord will come the eternal reward of a well spent life.

May I say in conclusion, since we have been purchased by His blood, and commissioned to fight in His cause ,our song should ever be "Onward Christian soldiers, marching as to war, with the cross of esus going on before." Until at last we come to His presence, and help the innumerable host to crown Him Lord of all.

#### APPENDIX II south carolina state home mission board duties and by-laws

The South Carolina State Home Mission Board is a council of the State Association of Free Will Baptist for the expansion of the Kingdom of God through the Free Will Baptist Denomination in this state.

#### PURPOSE

It shall be the primary purpose of this board to promote evangelism in our churches and state. It shall promote the organization of Free Will Baptist Churches wherever it deems adviseable, revivals; and the re-organization of disorganized congregations.

#### PERSONNEL

The officers of the Home Mission Board shall include a director and an advisory board composed of one representative from each quarterly meeting.

#### PROVISIONS

The State Home Mission Board shall serve as a medium of contact and disbursement of benefits received from the National Home Mission Board. It shall work in accord with the standards, principles and goals of the National Home Mission Board. It shall promote any cause or enterprise for the mutual benefit of all our churches, or would be churches. It shall not have any authority not expressly delegated by the State Association.

#### BY-LAWS

1. The treatise shall be the guiding rule for the board and church organization.

2. This board should give approval to every new church organized before it unites with any Quarterly Meeting.

3. The State Home Mission Director shall investigate every prospect of a new Free Will Baptist Church. After consulting the Advisory Board for their approval, he is authorized to launch a campaign for church organization. He shall call all board meetings and preside. He shall be bonded for \$2500 and the books audited each year.

4. The Advisory Board shall work in full co-operation with the director using sound judgment and divine wisdom in making decisions. Each member shall be elected upon recommendation from his respective Quarterly Conference. The Board shall meet regularly each quarter and it is subject to call anytime by the State Director.

. The Board members shall receive 5c per mile travel expense. The director shall receive personal travel expense plus 5c car mileage. All disbursements from the treasury shall be approved by the board and a written treasury report given each year at the State Associational meeting.

6. The State Home Mission Board shall not have any regulations contrary to the Spirit of the National Home Mission Board. It shall promote the National work and work in conjunction with the recommendation of that body.

7. These duties and regulations as defined herein may be altered or amended by a vote of the State Association.

# **APPENDIX IV**

#### **CHILDREN'S HOME REPORT**

The Free Will Baptist Home for Children was first started at the Sunday School Convention, Sept. 1922, at Bal Branch Free Will Baptist Church, Timmonsville, S. C. After the meeting at Bay Branch Church money began to come in to the convention ear marked for this purpose. The main building was built in the summer of 1949. It was completed by September of the same year. The building was dedicated and opened with four children the first day of October, 1949.

The Home owns approximately 68 acres, having 6.9 acres of tobacco and 4 acres of cotton. Also 4 milch cows, 45 laying hens, a

number of hogs, one tractor, one truck, one Station Wagon and one mule.

The Home has one main building with girls and one dormitory which has boys up stairs and a large dining hall on the ground floor which serves both boys and girls. The boys and girls are trained to do the work in the home and on the farm.

We can adequately care for 20 children but at the present have 22 children under care. The Home employs 4 employees. One Superintendent, one farmer, one dietician and one House Mother.

We wish to express our appreciation to each of you who gave gifts and offerings to our Home during the past year. May God bless you and help you to give more as He seee fit. REMEMBER our CHILDREN are depending on YOU.

We purchased a thirty five acre farm in the month of January for the sum of twelve thousand dollars. We owe three thousand dollars on the loan now. We want to pay off this amount soon. If you have not given on this Loan, please do so now.

#### CONSTITUTION AND BY-LAWS of the south carolina state Association of original free will baptists

**Preamble:** We the officials, ministers and delegates of this the South Carolina State Association of Original Free Will Baptists, while in session at Una Church, Spartanburg, South Carolina, November 13-14, 1946, do accept and adopt the fore going constitution and by-laws.

Article One. This body shall be known Henceforth as the South Carolina State Association of Original Free Will Baptists.

Article Two. It shall be the purpose of this organization to co-operate with the National Association in its efforts to elict, combine, and direct the energies of the Free Will Baptist Church, for the promotion of Home and Foreign Missions, Christian Education, Sunday School, Free Will Baptist leagues, Superannuation, and Woman's Auxiliary work and for the extension of the kingdom of God in general.

#### Article Three.

Section One. This Association shall consist of delegates duly appointed or elected by the church or organizations to represent, and ordain and licensed Free Will Baptist Ministers, who are of good repute in the Original Free Will Baptist Church, and who reside in South Carolina, or hold membership in, or pastor a church in South Carolina.

Section Two. Each Annual Association and Quarterly Conference may represent in this Association on the basis of two delegates for each Association or Quarterly Conference of one thousand members or less, and one delegate for each additional thousand members or fractions thereof.

Section Three. Any local church that desires may send an additional delegate, and each church shall send a contribution of \$10.00 or more.

Article Four. This Association shall have an Executive Committee of five, composed of ordained ministers and lay members in good standing in the Association, one to be elected by this body each year for a five year term, to act officially in the even any case may arise in this Association, when, and only when it is deemed necessary or expedient for the best interest of the cause of the church in general.

Article Five. The officers of this Association shall be a President, First, Second, and Third Vice-President, a corresponding secretary, a recording secretary, and a treasurer and a reading clerk. Said reading Clerk to take the place of the recording secretary in his absence.

These officers shall be elected by the Association to serve a term of two years.

Article Six. All officers of this Association, all members of its committees and boards, all its secretaries, missionaries, and agents appointed by the Association or by any of its boards, shall be members of regular Free Will Baptist Organizations in South Carolina cooperating with this Association.

Article Seven. All missionaries, teachers and Christian workers approved, appointed, or supported by this Association must be fundamental in their views of the Bible and its teachings, and in harmony with the doctrines of the Original Free Will Baptist Church. They must also give evidence of genuine Christian piety, for fervent zeal in the service of Christ, and of ability to do the work for which they are considered.

Article Eight. This Association shall hold its meeting annually on Thursday and Friday of the week between the second and the third Sundays in November, beginning at 10:00 a. m., unless, or until, some change of the time of the year shall be thought best.

Article Nine. Articles may be altered or amended at any regular session of the Association by a vote of two-thirds of the members present providing the change is recommended at least one day before the vote is taken.

#### BY-LAWS OF THE ASSOCIATION

1. A portion of the Scripture shall be read and prayer offered at the beginning of each morning and afternoon session of the Association and prayer shall be offered at the close of each session.

This is to be done by the president or someone appointed by him. 2. The President or Vice-President' shall call the Association to order at the hour designated by the program Committee.

When neither the President nor the Vice-President is present, the recording secretary shall call the Association to order and a President Pro-Tem shall be elected by the body, who shall provide for that session of the Association.

3: It shall be the duty of the Recording Secretary to enroll the delegates of the Association who shall present themselves with proper evidence of their right to seats therein, and those enrolled by

the Secretary shall compose the Association

4. Each organization represented in the Association shall send into the Association as large a contribution as they can from time to time. This money to be used to meet the expenses of the Association and to promote the work it undertakes.

5. On the first day of the Association meeting the President shall appoint a Resolution Committee to consist of three members, all resolutions not connected with the reports of boards and committee shall be referred to this committee, which shall report on all resolutions referred to it, with or without recommendation.

6. The officers of the Association, the departmental Secretaries, the Executive Committee, and all boards shall be elected by the Association. All other committees may be either appointed by the President or elected by the body.

7. In the event of a standing Executive Committee, the Members shell be elected for a term of five years except the first four elected, who shall serve a period of one, two, three, and four years respectively.

8. The duties of the Executive Committee shall be as follows: 1. To act for the Association on matters that demand its consideration between the regular annual sessions of the Association. 2. To have oversight of arrangements for meetings of the Association with authority to change, if necessary, the time and place of meeting. 3. To fill vacancies in the Association that may be caused by death, resignation, etc., between the regular sessions of the Association.

9. It shall be required of all members of the Association to remain throughout the entire session, unless they are excused by a majority vote of the body.

10. Anyone desiring to speak shall rise and address the President, and shall wait until he is recognized before speaking further.

11. The President shall not allow discussions that are unchristian in spirit and that tend to create envy and strife among the brethren, and anyone resenting the ruling of the President in such matters shall be liable to censure of the body.

12. No one shall be allowed to speak more than 15 minutes or more than twice on the same subject without permission of the body.

13. It shall be the duty of the President to have his annual message so prepared and arranged that it can be handed to the Secretary for publication in the minutes of each session of the Association.

14. The officers of this Association, except that of the Board of Trustees and the Executive Committee, shall be for a term of two years.

15. These By-Laws maybe altered at any regular session of the Association by a vote of two-thirds of the members present, providing the change is recommended at least one day before the vote is taken.
