Proceedings of the State Association

THURSDAY MORNING

The ministers, delegates and visitors assembled at the Bethany Church, near Timmonsville, November 15, 1962. The meeting began at 10:00 a. m. with the singing of a hymn. A devotional thought was presented from Luke 24:48 and prayer was offered.

Mr. Carson Welch extended to the body a cordial welcome, and Rev. F. J. Kirby gave the response.

The Moderator, Rev. L.A. Holliday, omitted the usual message. He read Psalm 138 and led in prayer. He then called the association to order.

The following visitors were recognized and extended the right to all privileges except that of voting: Rev. Bruce Barrow, Free Will Baptist Press, Ayden, N. C.; Rev. Frank McQuaig, N. C.; Rev. Lloyd Gore, N. C.; Rev. Fred Powers, N. C.; Rev. Millard Garland, N. C.; Rev. Bobby Bazen, N. C.; Rev. A. B. Bryan, N. C.; Rev. David C. Hansley, N. C.; Mr. Samuel Johnson, Free Will Baptist National League Board.

MSA* that the chair appoint all temporary committees of the association. The following were named: Nominating — Rev. Paul Sheehan, Rev. Hoyt Powell, Rev. Cecil Rose; Resolutions—Rev. Julius Vause, Rev. L. P. Brown, Rev. L. H. Clayton; Finance—Rev. Kenneth Faison, Mr. Tracy Williams, Mrs. Fred Coxe.

The following conference letters were received: Eastern and Central. The S. C. Conference or the Beaver Creek Association did not have their letters.

An opportunity was given to the visiting messengers to speak. Rev. Bruce Barrow spoke in behalf of the Free Will Baptist Press and called attention to the display of literature. Mr. Samuel Johnson spoke in behalf of the National League Program and the new literature which was available from the National office.

The association recessed for the morning service. This service opened with Rev. Fred Powers leading two congregational hymns. Rev. Cecil Rose was the messenger for this hour. He spoke from Heb. 1:1-5 and Romans 10:14-16 on the four conditions that have led to our downfall. He emphasized the absence of a prophetic message, and a powerless, passionless, passive ministry. He pointed out very forcefully the man and message that God uses. It was a very challenging message and inspired our hearts.

The conference recessed for the noon fellowship hour and the host church served a delicious meal.

THURSDAY AFTERNOON

The afternoon session began with singing led by Rev. Fred Powers. A devotional message was given by Rev. L. P. Brown from Matt. 7:7-12.

The Rev. Charles Thigpen was recognized as a visitor. He was given an opportunity to speak in behalf of the National Sunday School Board and present its literature program.

The Christian Education report was given by Rev. Kenneth Faison. MSA (cf. appendix I).

A verbal report on Sunday School was given by Mr. Lavern Hanna. A written report was to be submitted. (cf. appendix II)

The Rev. Tyler Watford gave a report on Superannuation. MSA (cf. appendix III)

The report of Public Morals was given. MSA (cf. appendix IV)

Our State Promotional Secretary, Rev. Reedy Saverance, gave his report. MSA (cf. appendix V)

The State Home Mission report was given verbally by Rev. Julius Vause and a written financial report was submitted. (cf. appendix VI)

The question was raised by Rev. Cecil Rose of the relationship of Rev. Julius Vause to the State Association Home Mission Board and the recently elected S. C. Annual Conference Home Mission Board. MSA to defer this matter to the State Home Mission Board for their consideration and report to the body on Friday.

The Public Relations representative of our Free Will Baptist Bible College, Rev. Paul Ketterman, was recognized. He gave a verbal report of the progress and needs of this institution.

Our National Home Mission Director, Rev. Homer Willis, was recognized. He was given an opportunity to present the challenge and scope of this work. The body was informed of the various projects and fields which the Board promotes.

MSA to give a vote of appreciation to the host church for the gracious hospitality received. A motion was adopted to recess until the morning session.

FRIDAY MORNING

The second days' session of the Association was held at the Bay Branch Church, Timmonsville, S. C. The host pastor, Rev. Dean Dobbs, led the body in singing before the devotional message by Rev. J. A. Hucks. He spoke from Acts 3:1-11.

A report of the state league work was given by Rev. Bennie Turner.

Several late churches turned in their representative fee.

The Woman's State Auxiliary report was read. (cf. appendix XI)

The Treasurer's report was given. MSA (cf. Appendix VII)

The Finance Committee reported \$337 received at this association.

The moderator made a statement to the body that he would not be able to serve as moderator for another term, and requested the nominating committee not to consider him. MSA to stand in appreciation for the long years of service which Bro. Holliday rendered for our state work.

The following delegates to the National Association were nominated: Mr. Wesley McLain, Mr. Dan Eaddy, Mrs. Arthur Lawter, Mrs. Thomas Brown, Mrs. Gladys Williams. MSA to elect these delegates and to authorize the clerk to appoint alternate delegates in the event these persons were not present.

Two more visiting brethren were recognized: Rev. Ronald Creech, Rev. Billy Morris.

The 1963 Association was invited to be held at the First Free Will Baptist Church, 680 Saxon Avenue, Spartanburg, S. C. MSA to accept this invitation.

The Resolutions Committee reported. MSA (cf. appendix VIII)

Rev. Julius Vause submitted his resignation as State Home Mission Director. MSA to accept this resignation and stand in appreciation for his services.

A motion was presented to dissolve the State Home Mission Board and the office of the Field Director. The money from the treasury would be refunded to the various conferences. Discussion ensued. MSA to postpone action until after the State Home Mission Board reported.

The conference recessed before the morning missionary service. The messenger for this special service was Rev. Dan Merkh, returned missionary from the Ivory Coast of Africa. He spoke from Luke 24 on God's program of missions through our churches today. An offering of \$79.59 was received at the close of this stirring message for world missions.

The Conference recessed for the noon meal served by the host church.

FRIDAY AFTERNOON

After congregational singing, the devotion was given by Henry Cremby, one of our young people from the Children's Home. Rev. H. W. Richburg then gave a verbal report of the Home before reading the financial report. MSA to accept the financial report. (cf. appendix IX)

In retrospect to the discussion concerning the Home Mission work during the morning session, the Nominating Committee assumed the responsibility and presented a recommendation. MSA (cf. appendix X). In the light of this recommendation, Rev. Jimmie Aldridge withdrew his preceding motion concerning abolishing the State Home Mission Board.

The Nominating Committee report was read. MSA to elect each officer individually with nominations from the floor. They were elected as indicated by a star in the directory on page two.

The question was raised as to the manner in which Rev. Jack Millwood was elected to the General Board of the National Association of Free Will

Baptist. The national body had elected Bro. Millwood to fill the unexpired term of Rev. Rufus Coffey, who had resigned to accept a position with the National Foreign Mission Board. It was stated that after a called meeting of S. C. ministers and delegates attending the National in Nashville, Rev. Jack Millwood was unanimously recommended to the Nominating Committee. MSA that the State Association endorse the election of Jack Millwood to the General Board as a representative of S. C.

The following motion was made by Rev. Melvin Worthington:

"Realizing the division and dissension that exists in the bounds of the S. C. State Association of Free Will Baptists, and the confusion and unrest that this division promotes in our midst, I move that no representatives of any institution, enterprise, or organization not in fellowship with the National Association of Free Will Baptists to be permitted to present the interests of their organizations."

Heated debate followed the reading of this motion and a second from the floor. In the midst of emotional discussion, a motion to adjourn was made and seconded. This motion being undebatable, the vote was taken. The clerk recorded 35 who voted to adjourn, but before the vote could be taken not to adjourn, the moderator led a tumultuous exit of delegates, ministers and visitors. When order was established, the negative vote was taken of the remaining group. The clerk recorded a vote of 34 not to adjourn. The motion to adjourn, having carried by one vote, the clerk declared the body adjourned. The clerk called the body to prayer, and the dissenting brethren were asked to join in prayer at the altar.
