**THURSDAY MORNING SESSION**

The Thirty-seventh annual session of the South Carolina State Association of Original Free Will Baptists opened with the singing of "Showers of Blessings," led by Rev. Fred Hall, with Bro. David Nobles at the piano. Rev. Bobby Bowers led in prayer.

The Morning Devotion was given by Rev. Johnny Evans of the Eastern Conference. He spoke from Luke 22:31-32, on the subject of "Converted Men." He stated that sin needs to be confessed, and people should stand for God. He used Peter as an example.

The Association was called to order by the Moderator, Rev. Norwood Gibson, after which the host pastor, Rev. Earl Hendrix, gave a warm welcome.

The response was given by the Assistant Moderator, Rev. Paul Clayton.

MSC that the program be approved.

Herman Hersey Board of Pastor's Retirement and Insurance, Mr. Jack Williams editor of Contact, Mr. Lloyd Olson of Master's Men. We had Rev. Paul Kettleman from our Bible College, also.

Rev. Gibson delivered the Moderator's Message. (See Appendix I) He closed the Message with prayer. We then had a short recess.

## MORNING WORSHIP SERVICE

Rev. Fred Hall opened the Morning Worship Service by leading us in "O How I Love Jesus," with Bro. David Nobles at the piano.

The students attending the Inman Church Christian School were recognized. Special music was presented by Rev. Fred Hall. He sang "Follow Me."

Rev. Paul Clayton introduced the speakers for the Morning Message. The speaker for the Morning Message was Rev. Paul Sheehan, from the Beaver Creek Conference, also our Children's Home Superintendent. He spoke from Luke 6:47-48 on the subject "Christianity Is Unchanging and Indestructable." He used the following outline:

- II. Christianity Will Not Change

  - B. We are on God's Foundation
  - C. His Church will not be Destroyed, He is coming For His Church

He closed in prayer.

Rev. Gerald Owens passed out a questionnaire on Abortion to gain information to help him in writing a paper.

Rev. Earl Hendrix Host Pastor gave instructions concerning the meal. We were dismissed in prayer by Rev. L. H. Clayton.

## THURSDAY AFTERNOON SESSION

THE AFTERNOON SESSION WAS OPENED WITH SINGING "Blessed Be The Name of the Lord" led by Rev. Fred Hall, with Bro. David Nobles at the piano. Rev. John Reed led in prayer. Rev. Johnny Johnson of the Central Conference brought the afternoon Devotion, taken from Colossians 1:9-12 on the Subject "The Sacred Fire." He pointed out we need a love for lost souls, and a zeal for God's Work.

The Credentials Committee gave a partial report. (See Appendix III) MSC to accept.

We then elected our delegate to the National Association from the South Carolina Conference. Bro. A. C. Allen was elected.

Rev. Molcom Fry gave a report about the C.T.S. and Sunday School Office being combined. (See Appendix IV) This was accepted as information.

Rev. Paul Kettleman gave a Bible College Report. (See Appendix V) This was accepted as information.

Rev. Fred Hall led us in singing "O Happy Day" with Bro. David Nobles at the Piano.

Rev. Guy Owens, North Carolina Minister At Large gave a Seminar on State Promotional Work. (See Appendix VI) This was accepted as information.

Rev. Fred Hall led us in singing "The Solid Rock" with Bro. David Nobles at the piano.

The Palmetto Conference brought a letter to our State Body asking to unite with us. It was agreed upon to accept them upon receiving the Constitutional changes and By Law changes. MSC to accept this. MSC to lay Constitutional change on the table until Friday.

Item 1 and 2 deals with Constitutional Change and Youth Camp and C.T.S. being joined to State Work. MSC to accept ~~Item 3, about Moderator's expense to Moderator's Meeting in Nashville be paid.~~

## THURSDAY NIGHT SERVICE

Phillip Ayers, with Sister Gwen Hendrix at the piano, with Sister Sue Berry at the organ. Rev. Fred Hall led the congregation in Singing "Send A Great Revival" with above musicians. Bro. A. C. Allen led in prayer. Rev. Norwood Gibson gave a warm welcome to all. Special music was presented by the Choir of First Free Will Baptist Church of Inman. They sang "Rock of Ages," "Standing On The Solid Rock," and "Part of the Family of God." We then had a time of testimonies, and had a good response. Rev. Fred Hall then led us in Singing "Old Time Religion" With above musicians. The Inman Academy Charol Group presented special music. They sang "God is So Good," and "I Have Decided To Follow Jesus." Host Pastor, Rev. Earl Hendrix, took charge of the evening offering.

We then had another presentation of special music. Mrs. Joan Emory Sang "Follow Me." Rev. Guy Owens from the North Carolina State Office brought the Evening Message. He spoke from Psalms 61:1-4 on the Subject "The Overwhelmed Heart." He used the following outline:

GENERAL FUND REPORT  
 TO THE BRETHERN OF THE SOUTH CAROLINA STATE ASSOCIATION  
 FROM FREE WILL BAPTIST BIBLE COLLEGE

Greetings In The Name of Our Lord:

South Carolina State Association is the first of all the State Associations to meet in 1979. The administration at your Free Will Baptist Bible College always looks forward to making reports at state meetings and at the National Associations. It is a privilege to inform our people of the things the Lord is doing.

South Carolina Free Will Baptists are fifth in per capita giving to the General Fund of the Bible College. They averaged \$2.97 per member during 1977-78. They were superceded by Iowa with \$4.76 per member (2 churches); Arizona

with \$4.46 per member (6 churches); Colorado with \$4.35 per member (2 churches); and Mississippi with \$3.75 per member (56 churches). The national average for per capita giving is \$1.60 per member to the College's General Fund.

Thank you for the gifts from your state during the June 1977-May 1978 year. Our records show the General Fund received \$20,416.06 (75%) from churches; ~~\$6,659.00~~ (24%) from individuals; \$167.53 (1%) from associations in gifts. These figures came from the June 1976 - May 1977 report.

Gifts for the past five years from all our people are as follows:

\$257,167.22	\$297,231.15	\$314,667.87	\$349,621.24	\$362,809.85

South Carolina's gifts to the General Fund during the past five years were:

\$18,514.60	\$25,132.56	\$23,415.51	\$23,468.06	\$27,886.64

Names of students from your state are listed in this report along with other vital statistics of interest to you.

South Carolina is being asked for \$29,000.00 in general fund gifts during this fiscal year, June 1978-May 1979. Your state's monthly gifts should be \$2,416.66 in order to meet this amount. You have averaged \$2,718.10 per month through the first seven months, ending December 31. You should go well over your quota.

#### APPENDIX VII

##### REPORT OF THE EXECUTIVE COMMITTEE SOUTH CAROLINA STATE ASSOCIATION OF ORIGINAL FREE WILL BAPTIST February 15-16, 1979

1. We recommend that the body approve the suggested additions and changes to our Constitution and By-Laws to bring them up to date and more accurate in clarification. (See Attached List)

NOTE: These additions and changes do not alter our basic Constitution and By-Laws. These changes are to (1) include in the Constitution things the body has already approved but for some reason were never entered in print. (2) Clarify job title and responsibility. (3) Clarify terms of service.

2. We recommend that the State C.T.S. Convention and the State Youth Camp work be listed in our State Constitution.

(a) To establish a C.T.S. Convention Board to consist of a director and five members.

1) It shall be the duty of this board under the leadership of the director to supervise and promote all of the activities of the C.T.S. Convention.

2) The director is to be elected every two years. He is to be recommended by the C.T.S. Board to the State Association and approved by the body.

3) The board is to consist of five members who are to be recommended to the State Association by the C.T.S. Convention and approved by the body. Each to serve five years with one rotating off each year.

4) The C.T.S. Board shall establish its own treasury and elect by vote of the convention any and all desired officers for the conducting of its programs.

NOTE: It is recommended that — if this board and director are approved — the present C.T.S. president be elected director and all other officers be elected to the board. In the event there is not a sufficient number to fill all positions on the board then allow the present officers to recommend names to fill the needed number.

(b) To establish a Youth Camp Board to consist of a director and a three-man board.

1. It shall be the duty of the Youth Camp Board under the leadership of the director to establish and promote all youth camp schedules and activities.

2. The director is to be elected every two years. He is to be recommended by the Youth Camp Board to the State Association and approved by the body.

3. The board is to consist of three men, each to serve three years with one rotating off each year. Board members are to be recommended to the State Association by the director and board for approval by the body.

4. The director is to serve as treasurer.

NOTE: If this recommendation is approved it is suggested that the present youth camp director be elected by the body and that he be consulted by the nominating committee for suggestions for board members.

(c) The youth camp director shall be elected to serve two years and will be under the jurisdiction of the Youth Camp Board.

(d) The C.T.S. Convention director shall be elected to serve two years and will be under the jurisdiction of the C.T.S. Board.

3. The Executive Committee approved out of session the spending of funds for the Moderator to attend the annual Moderator and Promotional Officers Leadership Conference October 23-26 in Nashville, Tennessee. The amount was approximately \$165.00.

### RECOMMENDED CHANGES AND ADDITIONS TO THE CONSTITUTION

#### Duties of the Assistant Clerk

It shall be the duty of the Assistant Clerk to assume the responsibilities of the Clerk in the event of resignation, sickness, or for any other cause which would render it impossible for the Clerk to discharge his duties.

#### Duties of the Assistant Treasurer

It shall be the duty of the Assistant Treasurer to assume the responsibilities of the Treasurer in the event of resignation, sickness or for any other cause which would render it impossible for the Treasurer to discharge his duties. His signature shall be registered at the bank for the entire period of his tenure for authorization to issue checks. This authority is to be exercised only in the event he must assume the duties of the Treasurer.

### ARTICLE V. COMMITTEES

1. (Present Reading) The Executive Committee, composed of its officers. This committee shall (1) act for the association on matters that demand its consideration between the regular annual sessions of the association; (2) to have oversight of arrangements for meetings of the association with authority to change, if necessary, the time and place of meeting; (3) to fill vacancies in the association that may be caused by death, resignation, etc., between the regular sessions of the association.

1. (Change to Read) The Executive Committee, composed of the Moderator, Assistant Moderator and the Clerk shall (1) Act, for the Association on matters that demand its consideration between the regular annual sessions of the Association; (2) To have oversight of arrangements for meetings of the Association with authority to change, if necessary, the time and place of meeting; (3) To fill vacancies in the Association that may be caused by death, resignation, etc., between the regular sessions of the Association; (4) To have jurisdiction over Promotional Secretary and his office.

2-c (Present Reading) The Nomination Committee, composed of one delegate from each conference or association, shall prayerfully prepare a slate of officers and present them before the body for vote.

2-c (Change to Read) The Nominating Committee composed of one delegate from each conference or association, shall prayerfully prepare a slate of officers, field directors, board members and elected committee members and present them to the body for election. The committee should refer to the director of officers and boards located in the front portion of the minutes for the position and time for election.

5. (Present Reading) The Publicity Committee, composed of one delegate from each conference or association. The members will be responsible for informing the newspapers and other news media of the convening and the events of this association during the session and immediately after.

5. (Change to Read) The Publicity Committee shall be composed of the Executive Committee and the Promotional Secretary. The committee shall be responsible for informing the newspapers and other news media of the convening and the events of the Association during the session and immediately after.

### ARTICLE VI. BOARDS

2. (Present Reading) The Board of Education shall be responsible for examining all applications for loans from the Poston Bagette Memorial Loan Fund. The Christian Education Field Director, elected every two years, shall be under the jurisdiction of this board. This board and director should be alert to help as many worthy students as possible to attend our Christian educational institutions. The Board should encourage our churches to give financially to the Loan Fund. This Board shall be composed of one member from each conference or association, plus one member-at-large.

2. (Change to Read) The Poston-Bagette Loan Fund Board shall be responsible for examining all applications for loans from the Poston-Bagette Memorial Loan Fund. The Poston-Bagette Loan Fund Field Director, elected every two years, shall be the treasurer of the fund and shall be under the jurisdiction of this board. This board and director should be alert to help as many worthy students as possible to attend our Christian educational institutions. The board should encourage our churches to give financially to the loan fund. This board shall be composed of one member from each conference or association, plus one member at large. They are elected to serve 5 years.

To change name of the Board of Education everywhere it appears in the Constitution and By-Laws to the Poston-Bagette Loan Fund Board.

### ARTICLE VII. APPROPRIATIONS

2. (Present Reading) The clerk shall receive fifty dollars a year for services rendered. The Moderator and Treasurer shall receive twenty-five dollars per year. Before bills are incurred, he shall consult the treasurer to find out if money is available to pay said bills.

2. (Change to Read) The clerk shall receive fifty dollars per year for services rendered. The Moderator and Treasurer shall receive twenty-five dollars each per year. Before any bills are incurred, the responsible person must consult the treasurer to be sure money is available to pay said bills.

3. (Present Reading) All board shall pay incurred expenses from their own funds.

3. (Change to Read) All boards shall pay incurred expenses from their own funds, except the Trustee Board. This board and committee expenses shall be paid from the State treasury.

### ARTICLE VIII FIELD DIRECTORS

1. (Present Reading) Promotional Secretary: The Promotional Secretary's duties are 1) to report South Carolina news to our National Association magazines; 2) to arrange missionary schedules for our state when missionaries are visiting in our churches; 3) to edit an occasional newsletter and mail to all pastors informing our people of Free Will Baptist Church news.

1. (Change to Read) The Promotional Secretary's duties are: (1) to report South Carolina news to our National Association magazine; (2) To edit the State

paper "The Informer" bimonthly and mail to all pastors for distribution to his church; (3) to promote the State Association Convention, particularly for attendance by our pastors and other delegates and our people in general; (4) to promote his own office and other state ministries as time and finances will permit; (5) The Promotional Secretary shall be the treasurer for this office. This office shall be under the jurisdiction of the State Executive Committee. He is to be elected to a two-year term.

4. (Present Reading) Home Missions Field Director: His duties are the same as the Foreign Missions Director's above.

4. (Change to Read) The Home Missions Field Reporter: It shall be the duty of this reporter to report to the State Association the activities and progress of all present conference or association home missions works, and all plans for future works.

To change the Home Mission Field Director to Home Missions Field Reporter everywhere it appears in the minutes.

#### BY-LAWS

6. (Present Reading) It shall be the duty of the Moderator to have his annual message so prepared and arranged that it can be published in the minutes.

6. (Change to Read) It shall be the duty of the Moderator to have an arranged outline of his annual message to be presented to the clerk for printing in the minutes.

#### ARTICLE V COMMITTEES

3. Public Morals Committee — (Add To:) They are elected to a 5-year term; one rotating off each year.

4. Credentials Committee — (Add To:) They are elected to a three-year term; one rotating off each year.

#### ARTICLE VI BOARDS

Trustee Board — (Add To:) They are elected to serve a 5-year term; one rotating off each year.

Pastors Retirement and Insurance Board — (Add To:) They are elected to a 5-year term; one rotating off each year.

Children's Home Board — (Add To:) They are elected to serve a 4-year term; one conference or association electees rotating off each year.

#### ARTICLE VIII FIELD DIRECTORS

Add to each officer: He shall be elected to serve a 2-year term.

#### MODERATOR'S QUESTIONNAIRE RESULTS

5. Do you think we as a State should get involved in radio and TV ministries? Yes — 25; No — 8; Somewhat — 1; Not Sure — 5; No Answer — 4

#### APPENDIX VIII

#### SUBJECT: SPECIAL REPORT EXECUTIVE COMMITTEE

#### SOUTH CAROLINA STATE ASSOCIATION OF FREE WILL BAPTIST TO: MEMBERSHIP OF S. C. STATE ASSOCIATION

At the 1978 State convention the Executive Committee was charged with the following responsibility:

(a) To meet with the Executive Committees of the four conferences in the state and discuss reasonable and workable methods of further development and improvement of our present state ministries and for entering into new works. The committee is requested to take into consideration the digest report of the information received by the Moderator's request for information survey which was presented at the 1978 convention.

(b) To supply a written report of recommendations to the 1979 State convention. This report is to be mailed to the pastors and churches of our state at least 30 days prior to the convention.

After reviewing the Moderator's survey report, there was a unanimous feeling by the committee members present that our people would like to improve and expand our present state ministries and to enter into new works. It was also a general feeling that it would be unwise to recommend any suggestive methods to expand our present works because our ministries are now under the leadership of pastors or other men with full-time employment, and these men just do not have time to devote to their particular work beyond which they are now giving. The leaders of our various works are doing a good and faithful job. However, we need to realize that their first obligation is to their pastorates. It was also agreed that it would be unwise to recommend any new works because of the above-mentioned limitations.

It was the general feeling of these committee members that for our state ministries to expand we must have a man on the field with time to devote to correlating and promoting our state work. It was also the general feeling that our state was not ready at this time to undertake the support of a full-time employed person for this work. Because of the aforementioned, concluded facts, the committee makes the following recommendations:

1. That Norwood Gibson be recommended to the nominating committee to be elected to serve as Promotional Secretary for the allotted two year term.
2. That he be charged with the specific responsibility of promoting this office to a full-time position within this two-year period.
3. That the State Executive Committee, who supervises this office, allow Brother Gibson to spend funds at his discretion to hire needed secretarial and other help to accomplish this task.

##### Green Wood Mission:

#### APPENDIX XXI

##### RESOLUTION #1

Whereas the first amendment to the Constitution states that . . . "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof, or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

And whereas the Internal Revenue Service have proposed revenue procedures which violate this provision.

And whereas it is felt that the IRS has implied there intent to implement these procedures without congressional approval therefore, be it resolved that;

1. The clerk be instructed to write all U. S. Senators and Congressmen from S. C. informing them of our opposition to the IRS proposed revenue procedure in its entirety. Also, ask them to contact Rep. Sam Gibbons Sub Committee on oversight, and request that he hold Congressional hearing immediately.

2. The clerk write a letter to the president stating our opposition and requesting him to use his influence to stop this bureaucracy from violating our constitutional protection.

3. That the clerk send a copy of this resolution to the UPI and other major news media and to all pastors within the state.

4. That each pastor be encouraged to solicit each member to write individual letters to the president, senators, and the congressmen in his or her district.

5. That each pastor encourage each member to telephone their district congressional office immediately.

6. That the state Association endorse the starting of christian schools by local churches and or encourage their students to attend Fundamental Christian Schools.

**RESOLUTION #2**

Whereas the U. S. Employment Security Commission in 1976 changed the law thus removing the existion exemption of elementary and secondary schools, including those schools owned and operated by churches, from unemployment compensation.

And whereas the S. C. Employment Security Commission has pressured churches within our state to comply and pay or face the possibility of their churches being sold for taxes.

And whereas nineteen (19) churches, through Christian Viewpoint, have filed a class action suit against the S. C. Employment Security Commission and received a temporary order by the Circuit Court Judge therefore be resolved that:

1. The clerk be instructed to write Orin Briggs, P. O. Box 12026, Columbia, South Carolina 29211, expressing our endorsement of his action.

2. That each pastor encourage each member to contact their individual Congressmen and request that the Congress change the law to exempt Churches and Christian Schools from Unemployment Compensation.

3. That a copy of this resolution be sent to the UPI and other major news media and that it be sent to all pastors within our state.

**RESOLUTION #3**

Be it resolved that we, the State Association of Free Will Baptist, oppose any change in our present Blue Laws and encourage our pastors to speak out and have their people to write letters to their representatives.

**RESOLUTION #4**

Be it resolved that we continue to oppose the radification of the E. R. A. That our clerk send a letter to Governor Riley and Lt. Governor Nancy Stevenson informing them of this action of South Carolina Free Will Baptist.

**RESOLUTION #5**

Be it further resolved that we give a rising vote to the officers of the convention, to the host church and to the Beaver Creek Conference for a fine convention.

Dear Brethren:

Free Will Baptists are alive and well except for a few aches and pains that come with aging. We continue to trudge along steadily with typical family accord. Like most brothers and sisters we have some fusses. Nevertheless, tension subsides whenever we allow reason to prevail. Our oneness in Christ mixed with love in the Spirit is the cement that binds the church of the living God together.

The manner in which you are faithfully supporting the various ministries of our denomination exemplifies an earnest effort to advance God's work. You are to be commended for your stewardship and cooperation in a world-wide outreach. Your venture in cooperation demonstrates the advantage of churches combining their resources and energies into a mutual task of giving an international witness for Christ.

The central purpose of our joining forces in a denominational endeavor is that we can accomplish more by working together than working independently! Mutual cooperation is the foundation of our district, state and national work. It is the keystone that binds us together in a common mission for our Lord. Our common goal is to work together in a program of united action to extend our witness at home and abroad. We rejoice together that God's work is being advanced through 106 churches in your state working in conjunction with each other to accomplish the paramount task of world evangelism.

God's blessings continue to be evident on our national outreach. Hundreds of choice young people are committing their lives to Christ and receiving training in our educational institutions. The surging interest in Christian education is reflected by the increased number of Bible institutes and the growing number of Christian day schools. 2. **CONTACT MAGAZINE.** This 32-page national publication continues to receive enthusiastic support across the denomination. Monthly contents are filled with inspirational articles, discussion of contemporary issues, family oriented articles and denominational news. The magazine is designed to complement the ministry of the local church, strengthen the spiritual life of the families and help develop the spiritual life of believers. Pick up sample copies at the display table or write Jack Williams, Editor, P. O. Box 1088, Nashville, TN 37202, to learn how you can obtain or promote our national publication.

3. **NATIONAL CONVENTION.** Highlighting our denominational year is the convening of representatives from almost 2500 churches in the United States as well as nine foreign countries. This international assembly for which the Executive Office is directly responsible for planning and promoting provides opportunity for fellowship, inspiration and enlarged vision of world missions. Business sessions provide a forum for discussing contemporary issues and establishing policies designed to strengthen our fellowship. This is why every church ought to send its pastor and a lay delegate to the national body which meets July 15-19 in Charlotte, North Carolina. Details of the convention will be published in the May issue of CONTACT.

4. **RECORD KEEPING.** Accurate records are very essential to evaluate our growth and preserve our history. Churches have been very negligent in keeping proper records. We appeal to our pastors and church clerks to keep accurate records and report the same to the district, state and national association.
