#### MINUTES OF THE THIRTY-NINTH ANNUAL SESSION of the SOUTH CAROLINA STATE ASSOCIATION of ORIGINAL FREE WILL BAPTIST

#### MEETING WITH THE EASTERN CONFERENCE at New Prospect Church Pamplico, S. C.

February 12 - 13, 1981

The Superintendent urged the people of the State Association to write our Senators pleading for the Home, that it may remain to be a Private Home. The suggestions were made that the Children's Home Board get a letter written and give to the people in the State Association.

SUBJECT: RIGHTEOUSNESS

SCRIPTURE: Mt. 5:4, 13:16

Introduction: Every movement that has ever been blessed of God and used of God has:

- Believed in righteousness
- Stood for righteousness
- Practiced righteousness
- And in many cases died for righteousness

Illus: Gen. 4 — Cain and Abel

The issue was righteousness — Mt. 23:33-35.

The first murder was a religious killing.

This should tell us something about the kind of world we are living in — a world that has no use for righteousness.

I. RIGHTEOUSNESS IS AN ATTRIBUTE OF GOD!

Psa. 145:17 — Habakkuk 1:13

- This does not mean that God does not see evil.  
He cannot see evil without a reaction — Broken heart; — Holy wrath  
We should have the same reaction
- II. **RIGHTEOUSNESS IS A REQUIREMENT OF GOD!**  
Psa. 11:7 — Acts 17:31 — Rev. 19:7,8 — Rev. 22:27
- III. **RIGHTEOUSNESS IS A PROVISION OF GOD!**  
Contrast first half of Rom. 3 (note v. 10 etc.) with last half (vs. 21,22 etc.)  
I Cor. 1:30
- IV. **RIGHTEOUSNESS IS AN OPPORTUNITY OF MAN!**  
We have emphasized duty and rightly so.  
We need more preaching on duty, obligation, "oughts" etc.  
We also should emphasize the blessed privilege of being righteous.  
Illus: Being free from snake venom after bite  
Illus: Being free from nuclear contamination — Ezek. 18:30
- V. **RIGHTEOUSNESS IS AN OBLIGATION OF MAN!**  
We are saved by grace on God's part and a decision on our part. You cannot separate the decision from the way you live.  
I John 3:10  
Illus: Gen. 4:8 — Noah was saved by grace, but he chose to accept it and it was evidenced in his life — Gen. 4:9; 7:1
- VI. **RIGHTEOUSNESS IS A TARGET OF SATAN!**  
II Tim. 3:1,12  
Seen in philosophy of Humanism in our educational system  
Question — Psa. 11:3  
Answer — II Tim. 3:14; I Cor. 9:27
- VII. **RIGHTEOUSNESS IS A SAFEGUARD OF MAN!**  
True both collectively and individually  
Collectively — Prov. 14:34, 29:2, 16:12  
Will take more than a revival of political conservatism to save America  
— will take a revival of righteousness.  
Individually — Eph. 6:14

Dear Brethren:

The Executive Office staff appreciates your loving and loyal support. Thank you for your correspondence, cooperation, contributions and considerations during 1980. Although the Executive Office is not always visible, it makes a valuable contribution to the Free Will Baptist constituency.

Executive Office ministries are in direct relationship to the ministries of church, district and state associations and national departments. All Executive Office functions are designed to assist these organizations in evangelizing sinners and edifying saints.

#### IT'S START

The Executive Office was born between the fourth (1940) and fifth (1941) ses-

sions of the National Association. Its first report was delivered to the National Convention at the fifth annual session in Drumright, Oklahoma, July 13 - 18, 1941.

During its 40 year history, eight men have served as Executive Secretary — L. R. Ennis (1941-1944); Robert Crawford (1944-1948); Ralph Lightsey (1948-1949); Damon Dodd (1949-1953); W. S. Mooneyham (1953-1959); Billy Melvin (1959-1967); Rufus Coffey (1967-1979); Melvin Worthington (1979-).

The COOPERATIVE PLAN OF SUPPORT is promoted by the Executive Office. This plan serves as an equitable means to undergird the total ministry of the National Association. For those who choose to designate their gifts, we encourage them to include all national departments. COOP receipts totaled \$312,805.58 in 1980.

The annual national convention is planned, programmed and promoted by the Executive Office. The 1981 convention convenes July 19 - 23 in Louisville, Kentucky. Every local church should send its pastor and a lay delegate to this annual gathering.

The Executive Office COORDINATES the work of the National Association. This office is to the national body what a pastor is to a local church. It coordinates the work of the denomination by promoting and presenting impartially the total ministry of all departments. The correlation and interrelation of all the national ministries are shown through general promotion.

#### IT'S SUPPORT

The Executive Office is supported by gifts through the COOPERATIVE PLAN and designated gifts which are sent directly to the office. Every Free Will Baptist church has an obligation to financially support each department of the National Association.

A church's denominational obligation is not met until it has included an equitable gift to each national department. The simplest way to do this is by giving through the COOP PLAN.

Gifts through the COOPERATIVE PLAN equitably undergird all national ministries with the exception of the Sunday School and Church Training Department which is self supporting. If you prefer designating your gifts, remember your obligation to support every national department.

South Carolina gave \$37.87 through the COOP PLAN in 1980. Direct gifts to the Executive Office totaled \$530.44.

### RULES THAT GOVERN THE POSTON-MEMORIAL LOAN FUND OF ORIGINAL FREE WILL BAPTIST STATE ASSOCIATION OF SOUTH CAROLINA

1. The applicant must be a member in good standing in a Free Will Baptist church within our state Association.
2. The applicant must be recommended by his local church for a loan, with a statement from the Applicant that he or she has been unable to secure assistance from any other source, along with a resume by the applicant and character reference from the pastor.
3. The assistance is available to any qualified person entering and attending our Free Will Baptist Bible College for any phase of full-time Christian service with Ministerial students preferable.
4. (a) The loan will be secured by a promissory note signed by the applicant and co-signed by his or her church to guarantee the collection of said note.  
(b) The loan may be issued for a period of six years maximum, and at the option of the board may be extended for a period of one year. If the applicant fails to comply with the rules and regulations, the note will become due within one year from the time of default.  
(c) No interest shall be charged on a loan as long as the applicant is a student; but thereafter at the rate of 7% annually until the loan is paid in full.  
(d) A payment on this loan shall be expected within sixty days after withdrawal or completion from school, and equal monthly payments thereafter until the loan is paid in full.
5. All loans that are approved shall be paid directly to the Free Will Baptist Bible College.
6. The applicant must fill out the questionnaire provided by the Board.
7. Less than a "C" average will render the applicant ineligible for further assistance.
8. An individual can only borrow a maximum of \$1000.00 total at the following break-down:
 

500.00 1st year (of borrowing)
300.00 2nd year (of borrowing)
200.00 3rd year (of borrowing)

9. These rules can be revised or amended by the South Carolina State Association of Free Will Baptist only.

Over the years South Carolina Free Will Baptist churches and individuals have made significant contributions to foreign missions both in terms of missionaries and money.

The missionary families and home office staff need and appreciate your faithful prayers. Pray also for the world at large. The 4.5 billion people who now live on the earth present an unparalleled challenge to the church. "The harvest truly is plenteous, but the laborers are few. Pray ye therefore the Lord of the harvest, that he will send forth laborers into his harvest" (Matthew 9:37b, 38).

## APPENDIX IX

### PRACTICAL HELPS ON EVANGELIST PREACHING

DEFINE: Preaching Bible truth in content and method of delivery that is aimed at awaking sinners to their need and bring them to Christ.

Describe:

1. It ought to be Preaching.

Presentation of truth with a sense of urgency and compassion seeking to get people saved.

2. It ought to be Bible Preaching.

It should not be just a lecture, but it should be based on the Bible, have

great passages of Bible. Ezra used God's law to convict Israel of their sins. God's word is the God used instrument to convict hearts.

3. It ought to be Earnest Preaching.  
Tears, burden, and a broken heart need to be known and felt.
4. It ought to be Informative Preaching.  
It should give out details, content, and convey real truth.
5. It ought to be Interesting Preaching.  
Get peoples attention and give them something to listen to. Put your best in each sermon.
6. It ought to be Illustrated Preaching.  
Illustrations clarifies the truth you have stated and help people to understand.
7. It ought to be Organized Preaching.  
Have points to get across to the people. Don't look for points as you preach, but before you preach. Keep your heart in it.
8. It ought to be De-personalized Preaching.  
The Bible may offend people, but our attitude and actions should not. Be plain in your preaching.
9. It ought to be Chaste Preaching.  
Choose your words carefully. Don't use gutter language. Don't make people desire to do the sins you are preaching against.
10. It ought to be Powerful Preaching.

#### Dangers:

1. Scarcity of sinners in the service. Evangelist ask Pastor about the number of lost people in the service. Give the Word in homes and other areas where lost people are.
2. Humanist teaching. People do not have right and wrong absolutes. People ought to know what sin is, due to Evangelist Preaching.
3. Distractions. Don't let other areas of service replace your job at preaching. Other areas are good and important, but your main job is preaching. Don't get side tracted at feeding the Saints. This needs to be done, but some also need burping.

### I. APPROVED PERSONAL INCOME AND BENEFITS FOR THE PROMOTIONAL SECRETARY.

1. Salary (weekly) ..... \$175.00
2. Housing Allowance (weekly) ..... 75.00
3. Retirement Benefits. 5% of salary to paid to the National FWB retirement plan.
4. Hospitalization Ins. (Presently about \$108.00 monthly)
5. Retain income from four revivals each year. All other revival income will go to the Promotional Office funds.

Please keep in mind that this office went on a full time salaried basis August 1, 1980, without funds on hand to meet the financial needs. It has been a faith venture and the Promotional Office has survived as the Lord has met the needs through you, who have given prayerfully and financially.

### II. SALARY AND BENEFITS RECEIVED BY THE PROMOTIONAL SECRETARY FROM AUGUST 1, 1980 TO JANUARY 15, 1981.

1. A salary and housing allowance was received each week.

- A. 20 weeks salary of \$115.00 each

#### CONSTITUTIONS AND BY-LAWS OF THE SOUTH CAROLINA STATE ASSOCIATION OF ORIGINAL FREE WILL BAPTISTS

#### PREAMBLE

WE, the South Carolina State Association of Original Free Will Baptists, in

order to advance the cause of the Lord Jesus Christ through fellowship and cooperation, do establish and adopt this Constitutions and By-Laws.

#### ARTICLE I NAME

This body shall be known henceforth as the South Carolina State Association of Original Free Will Baptists.

#### ARTICLE II PURPOSE

It shall be the purpose of the organization to cooperate with the National Association of Free Will Baptist in its effort to elect, combine, and direct the energies of the Free Will Baptist Denomination, for the promotion of home and foreign missions, Poston Baggett Loan Fund, Sunday School, Church Training Service, Pastor's Retirement, and Ins. Board, and Woman's Auxiliary work and for the extension of the Kingdom of God in general.

#### ARTICLE III REPRESENTATION TO THE STATE ASSOCIATION

##### SECTION ONE: Delegates

This association shall consist of delegates duly appointed or elected by the local church or conference or association to represent, and ordained and licensed Free Will Baptist Minister's, who are of good repute in their church and the conference or Association of which they are a member, and all members of standing boards and committees.

##### SECTION TWO: Conference Representation

Each annual association and quarterly conference may represent in this association on the basis of two delegates for each association or quarterly conference of one thousand members or less, and one delegate for each additional thousand members of fractions thereof.

##### SECTION THREE: Church Representation

Any local church that is in good standing with the conference or association to which it belongs may send one delegate.

##### SECTION FOUR: Finances

Each member association or quarterly conference shall be requested to send a representative fee of three dollars per church. Each local church shall be requested to send a contribution of \$30.00. This money shall be used to meet the expenses of the association and to promote its work.

#### ARTICLE IV OFFICERS

The officers of the association shall be Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer, and Assistant Treasurer. They shall be elected every year.

##### SECTION ONE: Duties

**Moderator:** It shall be the duty of the Moderator to preside over each session, preserve order, govern the body according to established parliamentary usage, and appoint all temporary committees, unless the organization requests they be elected.

**Assistant Moderator:** It shall be the duty of the Assistant Moderator to serve in the full capacity of the Moderator when he is absent or he requests the Assistant Moderator to serve in this capacity.

**Clerk:** It shall be the duty of the Clerk to record all transactions of the association and prepare them for printing and distribution.

**Duties of the Assistant Clerk:** It shall be the duty of the Assistant Clerk to assume the responsibilities of the Clerk in the event of resignation, sickness, or for any other cause which would render it impossible for the Clerk to discharge his duties.

**Treasurer:** It shall be the duty of the Treasurer to receive all monies that come into the association. He shall be a standing member of the Finance Committee. He shall pay all bills of the association through a checking account in a bank of his convenience. He shall present a financial report to the Finance Committee at each session.

**Duties of the Assistant Treasurer:** It shall be the duty of the Assistant Treasurer to assume the responsibilities of the Treasurer in the event of resignation, sickness or for any other cause which would render it impossible for the Treasurer to discharge his duties. His signature shall be registered at the bank for the entire period of his tenure for authorization to issue checks. This authority is to be exercised only in the event he must assume the duties of the Treasurer.

##### SECTION TWO: Membership and Support

All officers of this association, all members of its committees and boards, all its secretaries, missionaries, and agents plus all missionaries, teachers, and Christian workers approved or supported by this association must be fundamental in their views of the Bible and its teachings, and in harmony with the doctrines and practices of the Original Free Will Baptist Denomination. They must give evidence of genuine Christian piety, possess fervent zeal in the service of Christ and of ability to do the work for which they are considered.

#### ARTICLE V COMMITTEES

1. The Executive Committee, composed of the Moderator, Assistant Moderator and the Clerk shall (1) Act for the Association on matters that demand its consideration between the regular annual sessions of the Association; (2) To have oversight of arrangements for meetings of the Association with authority to change, if necessary, the time and place of meeting; (3) To fill vacancies in the Association that may be caused by death, resignation, etc., between the regular sessions of the Association; (4) To have jurisdiction over Promotional Secretary and his office.

2. The Committee on Committees, appointed at the beginning of the session by the Moderator. They shall present before the body for vote the necessary committees for transaction of business. The recommended Committees are:

a. The Finance Committee, composed of four, whose chairman shall be the treasurer, shall be responsible for receiving and handling the monies received into the association. (The committee shall receive all recommendations for expenditures and then recommend to the body for vote the expenditures.) The Committee shall receive and examine the treasurer's report and then present the financial report to the body.

b. The Resolutions Committee, composed of one delegate from each conference or association, shall be responsible for receiving all resolutions. After careful examination and necessary discussion, possibly with those presenting the resolution, the committee shall present the resolutions before the body.

c. The Nominating Committee composed of one delegate from each conference or association, shall prayerfully prepare a slate of officers, field directors, board members and elected committee members and present them to the

body for election. The committee should refer to the director of officers and boards located in the front portion of the minutes for the position and time for election.

3. The Public Morals Committee, composed of five with one rotating off each year, shall be responsible for evaluating the moral condition of our country and churches. Through resolutions, papers, and messages, they should warn us of the dangers of low morals and encourage us in keeping our standards Scripturally high. They are elected to a five year term, one rotating off each year.

4. The Credentials Committee, composed of three, shall properly register and recommend the seating of all delegates, ministers, and visitors. They shall keep a register of all delegates, ministers, and visitors, and present their report to the body and to the clerk for recording in the minutes. They are elected to a three year term, one rotating off each year.

5. The Publicity Committee shall be composed of the Executive Committee and the Promotional Secretary. The committee shall be responsible for informing the newspapers and other news media of the convening and the events of Association during the session and immediately after.

#### ARTICLE VI BOARDS

The Pastor's retirement and Ins. Board, the Board of Education, and the Children's Home Board shall draw up their own Constitution and By-Laws and present them to the State Association for its approval. They are elected to a five year term, one rotating off each year.

1. The Board of Trustees shall hold title, if any, to all property or equipment owned by the association. This board shall be composed of one member from each conference or association, plus one member-at-large. They are elected to a five year term, one rotating off each year.

2. The Poston-Bagette Loan Fund Board shall be responsible for examining all applications for loans from the Poston-Bagette Memorial Loan Fund. The Poston-Bagette Loan Fund Field Director, elected every two years, shall be the treasurer of the fund and shall be under the jurisdiction of this board. This board and director should be alert to help as many worthy students as possible to attend our Christian educational institutions. The board should encourage our churches to give financially to the loan fund. This board shall be composed of one member from each conference or association. They are elected to serve 5 years.

3. The Pastor's retirement and Ins. Board shall supervise and distribute retirement and other assistance, as approved by the board, to the ministry of this association. The Field Director, elected every two years, will be the treasurer of Pastors' retirement funds. Expenses incurred in connection with Pastor's retirement promotion and board meetings shall be paid from Pastor's retirement funds. The travel allowance will be .20 cents per mile. The travel allowance is to be paid only to the person incurring the expense. This Board shall be composed of one member from each conference or association, plus one member-at-large. They are elected to a five year term, one rotating off each year.

4. General Board Member shall be one person, elected every two years to be recommended to the National Association of Free Will Baptists to represent South Carolina on the General Board of the National Association.

5. The Children's Home Board shall supervise the ministry of the Free Will Baptist Children's Home, Turbeville. They shall be responsible for establishing the rules of the Home, employing the employees, and overseeing the ministry of

the Home. This Board shall consist of two members from each conference or association, except South Carolina, which shall have three. They are elected to a five year term, one conference or association electees rotating off each year.

6. C.T.S. Convention Board shall, under the leadership of the director, supervisor and promote all of the activities of the C.T.S. Convention.

The director is to be elected every two years. He is to be recommended by the C.T.S. Board to the State Association and approved by the body.

The board is to consist of five members who are to be recommended to the State Association by the C.T.S. Convention and approved by the body. Each to serve five years with one rotating off each year.

The C.T.S. Board shall establish its own treasury and elect by vote of the convention any and all desired officers for the conducting of its programs.

7. Youth Camp Board shall, under the leadership of the director, establish and promote all youth camp schedules and activities.

The director is to be elected every two years. He is to be recommended by the Youth Camp Board to the State Association and approved by the body.

The board is to consist of three men, each to serve three years with one rotating off each year. Board members are to be recommended to the State Association by the director and board for approval by the body.

The director is to serve as treasurer.

#### ARTICLE VII APPROPRIATIONS

1. Members of the Executive Committee shall be reimbursed their travel expenses at the rate of 20 cents per mile to and from no more than two committee meetings per year. The travel allowance is to be paid only to the person incurring the expense.

2. The clerk shall receive fifty dollars per year for services rendered. The Moderator and Treasurer shall receive twenty-five dollars each per year. Before any bills are incurred, the responsible person must consult the treasurer to be sure money is available to pay said bills.

3. All boards shall pay incurred expenses from their own funds, except the Trustee Board. This board and committee expenses shall be paid from the State treasury.

4. The Promotional Secretary shall receive fifty dollars per year for supplies.

#### ARTICLE VIII FIELD DIRECTORS

1. The Promotional Secretary's duties are: (1) to report South Carolina news to our National Association magazine; (2) to edit the State paper "The Informer" bimonthly and mail to all pastors for distribution to his church; (3) to promote the State Association Convention, particularly for attendance by our pastors and other delegates and our people in general; (4) to promote his own office and other state ministries as time and finances will permit; (5) The Promotional Secretary shall be the treasurer for this office. This office shall be under the jurisdiction of the State Executive Committee. He is to be elected to a two year term.

2. Pastors' retirement and Ins. Board: The Pastors' retirement and Ins. Field Director shall be under the jurisdiction of the Pastor's retirement and Ins. Board. He is elected to a two year term.

3. Poston Baggett Loan Fund: The Poston Baggett Loan Fund Field Director shall be under the jurisdiction of the Poston Baggett Loan Fund Board. He is elected to a two year term.

4. The Home Missions Field Reporter: It shall be the duty of this reporter to report to the State Association the activities and progress of all present conference or association home missions works, and all plans for future works. He is elected to a two year term.

5. Church Training Service Field Director: His duties are to give a report from the State C.T.S. convention on the activities, and accomplishments of the past year, and the plans of the coming year's activities. He is elected to a two year term.

6. Senator for Master's Men: His duties are to promote the general work of Master's Men in the state.

7. Foreign Mission Field Director: His duties are to make a report of the activities and work carried on in the State during the past year. Give report of planned activities and promotions for the coming year. He is elected to a two year term.

8. The C.T.S. Convention director shall be elected to serve two years and will be under the jurisdiction of the C.T.S. Board.

9. The youth camp director shall be elected to serve two years and will be under the jurisdiction of the Youth Camp Board.

#### ARTICLE IX TIME

This association shall convene annually on Thursday and Friday before the third Saturday in February, beginning at 10 A. M.

#### ARTICLE X AMENDMENTS

Articles may be altered or amended at any regular session of the association by a vote of two-thirds of the members present providing the change is recommended at least one day before the vote is taken.

#### BY-LAWS OF THE ASSOCIATION

1. A portion of the Scripture shall be read and prayer offered at the beginning of each morning and afternoon session of the association and prayer shall be offered at the close of each session.

2. It shall be the duty of all members of the association to remain throughout the entire session unless they are excused by the Moderator.

3. Anyone desiring to speak shall rise and address the Moderator and shall wait until he is recognized before speaking further.

4. The Moderator shall not allow discussions that are unChristian in spirit and that tend to create envy and strife among the brethren. Anyone resenting the ruling of the Moderator in such matters shall be liable to censure of the body.

5. No one shall be allowed to speak more than 15 minutes or more than twice on the same subject without permission of the body.

6. It shall be the duty of the Moderator to have an arranged outline of his annual message to be presented to the clerk for printing in the minutes.

7. These by-laws may be altered at any regular session of the association by a vote of two-thirds of the members present, providing the change is recommended at least one day before the vote is taken.
