Independent Auditor's Report

We have audited the accompanying statement of assets, liabilities and net assets modified cash basis of Free Will Baptist Home for Children as of December 31, 2005, and the related statement of support and other revenue, expenses and changes in net assets modified cash basis for the year then ended. These financial statements are the responsibility of the Organization's management. Our responsibility is to express an opinion on these financial statements based on our audit.

We conducted our audit in accordance with generally accepted auditing standards. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatements. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

As more fully described in Note 1 to the financial statements, the Company has valued property and equipment at a nominal value of one dollar. Also, mortgages payable are not stated as liabilities. In our opinion, property and equipment should be recorded at cost, if purchased, or at fair value, if donated or contributed, to conform with accounting principles generally accepted in the United States of America, and those amounts should be depreciated over the estimated useful lives of the assets. The effects on the financial statements of the preceding practices are not reasonably determinable.

As described in Note 1, these financial statements were prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles.

NOTES TO FINANCIAL STATEMENTS

December 31, 2005

Note 1 - Nature of Organization and Summary of Significant Accounting Policies

Nature of Organization

Free Will Baptist Home for Children is a religious organization whose purpose is to provide regular opportunities for public worship.

Method of Accounting

The financial statements of Free Will Baptist Home for Children have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. Revenues and related assets are recognized when received rather than when earned and certain expenses when paid rather than when the obligation is incurred.

Basis of Presentation

Financial statement presentation follows the recommendations of the Financial Accounting Standards Board in its Statement of Financial Accounting Standards (SFAS) No. 117, Financial Statements of Not-for-Profit Organizations. Under SFAS No. 117, the Organization is required to report information regarding its financial position and activities according to three classes of net assets: Unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

Cash

Cash includes cash on hand and on deposit with financial institutions, certificates of deposit, savings accounts and money market accounts.

Designation of Unrestricted Net Assets

It is the policy of the Church to review its plans for future needs and to designate appropriate sums of unrestricted net assets to assure adequate financing of such needs.

December 31, 2005

Note 1 - Nature of Organization and Summary of Significant Accounting Policies (Cont.)

Income Tax Status

The Church is a not-for-profit organization under Section 501(c)(3) of the Internal Revenue Code and is exempt from federal and state income taxes.

Investments

The Church carries investments in marketable equity securities at cost in the Statement of Assets, Liabilities and Net Assets.

Property and Equipment

In accordance with the cash basis of accounting, acquisition of buildings and equipment are recorded at a normal value of \$1. Mortgages there on are not recorded.

Restricted and Unrestricted Revenue

Contributions received are recorded as increases in unrestricted, temporarily restricted, or permanently restricted net assets depending on the existence and/or nature of any donor restrictions. Temporarily restricted net assets are reclassified to unrestricted net assets upon satisfaction of the donor's restrictions.

MSC that the letter by Rev. James Wilhide containing the admission of his moral failure, including but not limited to his admission to lying, while director of the Children's Home be given to the S C Conference Ordaining Council for them to use in their deliberation regarding the ministerial standing of his credentials.

MSC that the General Board of the S C State Association ask that a letter be penned by the SCFWB Executive Committee and the Children's Home Board and be sent to Pastors of the state providing a brief summary of the actions taken at the Special General Board meeting.

It is also requested that a written apology from Rev. James Wilhide be provided in this Pastor's letter.

The past year has had many low times but because of the Free Will Baptist churches in the state standing behind us we have had a lot of good times as well. Through everything that has happened this year God has blessed us in a great way.

We are happy to report that with your help the Home has been able to pay off all of the outstanding credit card debt totaling \$16,349.34. We also have been able to reduce our indebtedness which was approximately \$392,000.00 down to \$324,061.45, making our total paid this year, toward the outstanding debts, in the amount of \$84,287.89. As of the first of January all of our bills were paid up to date and we had a balance of \$70,892.51 in our bank account. As Bro. Mike would say GLORY!

We have 17 children as I write this report and we served another 18 children during the year, making our total 35. We never know from day to day when we will receive a call of a child in need of our home. Isn't it wonderful to know God's made it possible for these children to have a place that can take care of them and give them the love and care they need.

This past year we have hired two sets of house parents, to replace those that have moved on to other ministries or jobs. God has blessed us with good workers, who came to us because they felt the Lord leading them to this ministry to love and care for our kids.

If we closed out our report right now, you could say it was a good report, but we have saved the best news for last, in the year 2005 we saw 7 of our children accept Jesus as their Lord and Savior. Now that's a great report. We were able to help baptize four of them and plan to baptize the other three soon.

Thank you for caring for the children and staff. The people and churches of South Carolina have accepted Paula and me and for that we would like to say thank you. The most important thing we can ask of you is to remember us always in your prayers. The devil is always working to tear down the Lord's work. Dear SC FWB State: Greetings in the lovely name of Jesus Christ! I shared with the Home Mission Board at our last meeting that this has been a very tough year. My wife had two back surgeries, and my son had a retina detachment surgery. We had three families that left the church due to relocation and other reasons. Yet despite the tough year, God has not ceased to bless us by giving us a slight increase in our attendance and over \$1,000 per month increase in our average monthly giving. Our church gave back \$9,214.09 back to our mission account. At our 2005 South Carolina Free Will Baptist State meeting, I presented a goal of having 200 churches or individuals give \$1,000 each in order to retire our debt. The quicker we retire our debt, the sooner we can go self supporting. On January 1, 2005, the principle balance on our loan was \$179,146.41. Some churches responded and gave \$1,000 toward our goal. Also, individuals and churches who were unable to give \$1,000, gave smaller gifts to help with the debt retirement. We did not meet our goal of having 200 individuals or churches, however what everyone gave was a BIG HELP! On December 31, 2005, the principle balance on our loan was \$143,971.10. God allowed us to pay off \$35,175.31 off the principal of our loan, including gifts from churches, individuals, principal from our regular loan payments, and extra giving from our church in Aiken. If in the next year we can either increase our giving by \$2,500, or pay off our loan, we would be very close to going self supporting. Please pray with us and for us regarding what God might have you to do as a church or individual.

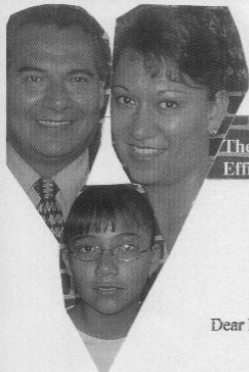
