Tuesday, June 30, 2009

After the State met, there arose an objection to the manner and publishing of that explanation in the minutes. To prevent any further dissension or division with the National Home Missions Department and other states' mission agencies, the SC State Home Missions Board has elected not to publish the explanation as presented. There was also a recommendation given to the SC State Home Mission Board to meet with the National Board and attempt to resolve the issue of the National's decision to not allow Aiken to be a Joint Project. An attempt was made to meet with the National but there were certain stipulations to the SC State Home Mission Board required by the National in order for the state board to meet with them. The SC Board rejected those stipulations and decided to not pursue any further. The Aiken Home Mission work remains a State work and will not be a Joint Project with the National. We commend Bro. Jim Fairchild for the work he is doing in Aiken and are very thankful for God's blessings there. We urge you to continue to support all of our SC State Home Mission works in prayer and financial support.

AIKEN HOME MISSION report to the State Meeting:

We have seen God do wonderful things in Aiken this year. When we moved to the church we had one teen that was attending. 2009 has seen the start of a new teen ministry that seems to be taking off. On the average Sunday we now have from 12 - 15 teens in our service. One of those boys, Stephen, recently moved from California, where he was living with his Mom, to Aiken to live with his Dad. He was forced to move when he was kicked out of school for getting in a fist fight with a teacher. With shaggy hair down to his shoulders and clothing that is quite odd looking, it is obvious that Stephen is no stranger to the "wild life". A couple of months ago, Stephen's best friend, Wesley, was being baptized. (Wesley had recently accepted Christ into his heart after a Sunday Morning Service.) Stephen came to see this event. You could tell that the entire service was something that was foreign to Stephen. About a month-and-a-half after Wesley's baptism, Stephen accepted Christ's forgiveness. It is not uncommon to see this sixteen year old boy walking to church. He lives six to seven miles away. Stephen walked in at the end of our Christmas Eve service thinking that it started at 6:30 instead of 5:30 and the disappointment was apparent on his face. Pray for this young man, God has a lot of work to do in his life.

As I reviewed our monthly attendance for the year, I was glad to see that every month except one, showed a greater attendance than 2008. The one month that did not show a greater attendance was November. I had to go to Mississippi, due to the death of my father-in-law. My absence always affects our attendance adversely. This is something I am working on.

We made some changes to the way we do Bible Study. It is somewhat unorthodox, yet, it has yielded great fruit. We switched our Sunday School around and our attendance has nearly doubled.

2009 saw us reaching further into our community. Through outreaches at the ball park that is almost directly beside the church we picked up 21 people (this number includes a few people we picked up at the end of 2008).

2009 saw the birth of a few new ministries in the church. We started a new program for our children on Sunday Evenings called K.I.C.K. (Kids In Christ's Kingdom). This has helped us pick up three new children whose parents do not yet come to our church. We also started a ministry among our men, where they help perform minor repairs on the houses of older folks. We put a new floor inside and a new porch on the house of a retired minister in our area. What a joy it was to serve.

Thank you for letting me serve as your missionary to Aiken. I pray that the Lord will use this work to make a difference in his kingdom.

FEASIBILITY STUDY COMMITTEE REPORT

At the 2009 South Carolina Free Will Baptist State Association meeting, the following motion was made: "That a feasibility study committee consisting of Chairman: Tim Hackett, Roy Roach, Larry Hawkins, Earl Hendrix, Sherwood Lee, Todd Smith, Cyrus Shoffner, and Bruce Kimbrel be formed to study the feasibility of all the SC ministries involved in children, youth, camps, conferences, etc. be formed to study the best use of finances and facilities."

On Tuesday, September 15, 2009, the Feasibility Study Committee met at the SC FWB State Office. In attendance were the following: Rev. Sherwood Lee (Moderator), Rev. Todd Parrish (Children's Home Director), Rev. Donnie Miles, Rev. Cyrus Shoffner (Youth Ministries Director), Rev. Todd Smith (SC FWB Executive Secretary), Rev. Theron Scott (Home Mission Board), Mr. Larry Hawkins (Children's Home Board), Rev. Bruce Kimbrel (NYC Director), Mrs. Pam Hackett (SC WAC Coordinator), and Rev. Tim Hackett (Children's Home Board Chairman). The meeting was a round table discussion on how we can better serve South Carolina Free Will Baptist through effective ministry. The following recommendations came from the meeting:

- 1) It was recommended that on the third Tuesday of September of each year, that the various South Carolina Free Will Baptist ministry directors, board chairmen, a board representative from each ministry, conference moderators, state moderator, Children's Home Director, and the SC FWB Executive Secretary get together to discuss thoughts and to put forth goals and ideas for the future growth of our South Carolina Free Will Baptist state ministries. The September meeting is a half way point from one state meeting to the next for state leaders to get together to share ideas regarding state ministries.

- 2) Whereas at each state meeting, a Nominating Committee is appointed to serve to appoint positions that need to be filled for that current year, we recommend that beginning with the 2010 state meeting, a Nominating Committee be elected for the following year in order to provide the Nominating Committee ample time to meet and take recommendations, receive resumes, and appoint vacant and expiring positions for the following year. It was also discussed to encourage the involvement of lay leadership on our state boards and committees.

- 3) It was recommended that an advisory committee of lay leaders which may consist of business leaders and mothers from across our state

be formed to assist the Children's Home Board in understanding the needs of the children at the SC FWB Children's Home.

4) It was recommended for the 2010 September Feasibility Study Committee meeting that a 10 year Strategic Plan be compiled for the future growth of the various South Carolina Free Will Baptist ministries.

It was also decided to extend an invitation to other leaders in the state for a January Meeting in order to gain more insight and input.

Feasibility Study Committee met at the SCFWB State Office Conference Room on Monday, January 25, 2010. Present were Tim Hackett, Pam Hackett, Jimmy Sanders, Buddy Seay, Sherwood Lee, Todd Smith, Doug Mathis, Larry Hawkins, Donnie Miles, Marty Cox, Todd Parrish, Bruce Kimbrell, Mike Jones, Danny Stone.

Opening Remark by SCFWB State Moderator Sherwood Lee about the need to make sure any actions taken by this committee meet the requirements of the State Constitution.

Prayer by Todd Parrish. Opening remarks by Feasibility Study Committee Chairman, Tim Hackett including the reading of the minutes of the previous.

After considering the intent of the motion forming the feasibility study committee it was decided to re-direct our observations to the best use of facilities and finances for youth ministry.

Following discussion by the assembled members the following Motion was MSC:

- 1) We recommend that the SCFWB State Association work toward a state youth director who may have shared responsibilities with our State Book Store and Children's Home.
- 2) We also recommend combining the two state youth boards together.

We were thankful for **Brian and Jennifer Coker**, and their daughters, Brianna and Maggie, as they agreed to leave the comforts of their Turbeville home and move into the dorms, acting as temporary dorm parents, until permanent staff could be secured. This fine family did an amazing job during a difficult transition time.

The middle of November saw the arrival of two families who felt led of God to leave their homes and jobs and come "back" to the Children's Home to serve our precious kids. **Dale and Kim Blout** (Mansfield, Ohio) and **Tim and Wendy Snipes** (Lancaster, SC) are familiar to SC Free Will Baptists. Both couples served for several years at our Children's Home in the past and it is a joy to have them back on board. They are doing an amazing job and have a servant's heart for hurting children. We have been blessed with a tremendous Administrative Secretary, **Merry Floyd**, and Dietician, **Sherry Lee**, also. God has truly assembled a winning team that loves the Lord and our children. It is an honor to serve with them.

Praise Items and Prayer Needs

As we closed 2009, we praise the Lord for the 9 precious children that were placed in our care. As many of you know, due to the horrific economic situation in our country in early 2009, we were faced with the difficult task of laying off all staff except the Executive and Assistant Directors and Secretary. In early 2009, we only had 3 children in our care. We praise the Lord that the number tripled toward the end of the year and enabled us to hire staff to meet the increasing needs brought about by the increasing numbers. At the end of the year, we rejoiced as we saw 18 faces gathered around the supper table each evening (Children served, Admin staff, & Dorm Staff families)! We rejoice in how God's hand has moved and is moving mightily in our midst.

Anything done of eternal value and that is blessed of God must be bathed in fervent prayer. We ask that you commit to pray earnestly for us in the following areas:

- That we will sense the leading of the Holy Spirit and that caring for and protecting His precious children will always be our number 1 priority.
- That God will increase our numbers so that we can provide a loving, safe, and Christ-honoring "Home" where hurting children can find refuge.
- That we will make every effort to promote the work of the Home in our churches, among our pastors, and throughout our communities. This should produce an awareness and increase in placements as more and more people realize that we are here to provide a place for children in need.
