New Changes!

NORWOOD GIBSON MINISTER HELP FUND

The Norwood Gibson Minister Help Fund exist for the purpose of helping ministers that are in good standing with the South Carolina Free Will Baptist State Association during a time of crisis or dire need. The fund is named in memory of Reverend Norwood Gibson, the first full time South Carolina Free Will Baptist State Association Promotional Director. Reverend Norwood Gibson served as a friend and co-laborer with men who had accepted the call of God upon their life into ministry. It is in his memory that this fund exist. Below are the guidelines by which this fund shall operate:

- The Norwood Gibson Minister Help (NGMHF named hereafter) will be financed through designated gifts with oversight provided by the South Carolina Free Will Baptist Executive Secretary and Executive Committee.
- 2) The NGMHF exist for the purpose of helping ministers that are in good standing with a conference or association that is in good standing with the South Carolina Free Will Baptist State Association.
- 3) If funds are available, a payout of up to \$400 per occurrence can be paid to a minister that meets the above qualifications, and no more than \$400 can be paid per minister per calendar year except in extreme emergency situations to be determined by the South Carolina Free Will Baptist Executive Secretary and South Carolina Free Will Baptist Executive Committee.
- 4) At time of such crisis or dire need, a request can be made to the South Carolina Free Will Baptist Executive Secretary and the conference moderator of which the minister is a member and will be determined on a case by case basis. Any payouts must be reported to the South Carolina Free Will Baptist Executive Committee on a monthly basis, and an annual report without disclosing the names of the payees shall be reported to the South Carolina Free Will Baptist State Association at its annual meeting.
- 5) These guidelines may be altered by a majority of the South Carolina Free Will Baptist State Association or by the South Carolina Free Will Baptist Executive Committee while the State Association is not in session.
