(3) M/S/C that the Executive Board act as a nominating committee to fill the vacancies in our offices and boards.


The session was then dismissed for a recess.



Congress is now considering a bill (House Bill 41) which would regulate the solicitation of charitable contributions by mail, television and radio, and

Whereas,

Such bill threatens religious freedom in this country and violates the Constitutional requirements of separation of church and state, therefore

Be it resolved:

That the clerk of this association, write a letter to our congressman expressing our oppositions to the bill.

Whereas,

The following resolutions were adopted by the National Association of Free Will Baptists in its 1977 session, therefore

Be it resolved:

That we, the South Georgia Association, go on record as adopting the same, and that the said resolutions be published in our minutes.

I. Capital Punishment

Whereas,

Crime in America has steadily increased; and Whereas.

We believe capital punishment is a deterrent to crime, and Whereas,

We believe the Bible supports capital punishment, therefore, Be it resolved:

That we, the National Association of Free Will Baptists, reaffirm our support of capital punishment for crimes of premeditated murder and rape.

#### II. Homosexuality

Whereas,

The National Association of Free Will Baptists in its 1976 session passed a strong resolution against homosexuality and adultery; and

Whereas,

Homosexuality has come increasingly to the forefront gaining widespread acceptance even among many so-called Christians; therefore,

Be it resolved:

That we reaffirm our belief that according to the Bible homosexuality is sin; its participants are sinners; and the practice and the participant are condemned by God.

#### **III.** Abortion

Whereas,

We believe that the Bible teaches that life begins with conception; and Whereas,

To willfully take human life constitutes a crime in society and sin against God; and



Whereas,

Our society now permits or even encourages such crimes against unborn infants; therefore,

Be it resolved:

That the National Association of Free Will Baptists hereby register our stern condemnation of abortion and any legislation, court rulings, or social pressure which endorse abortion.

IV. Inspiration and Inerrancy of Scriptures

Whereas,

Free Will Baptists have existed in America for the past 250 years as a fundamental Bible-believing denomination, free from doctrinal corruption; and

Whereas,

Many other denominations who once stood true have been corrupted from

within because of the influence of "German Higher criticism;" and Whereas,

Current theological trends cast doubt on or deny the inspiration, infallibility of, and inerrancy of the Scriptures, defining inspiration, even plenary verbal inspiration, to mean less than it has historically meant; and Whereas,

The doctrine of the full inspiration, innerrency and trustworthiness of the Scriptures is the foundation of all Bible truth; and Whereas.

Our own beloved denomination is not immune to this type problem; therefore, Be it resolved:

1. That we reaffirm our belief in the plenary verbal inspiration of the Bible. By plenary we mean "full and complete," that all parts of the Bible are inspired, that inspiration extends to all subjects dealt with. By verbal we mean that inspiration extends to the very words of Scripture, not just to the thoughts and ideas in the minds of the human authors of Scripture. 2. That we reaffirm our belief in the complete infallibility and inerrancy of Scriptures. We believe the Bible is inerrant in all that it intends to teach as truth or fact, in matters of cosmogony, geology, astronomy, anthropology, history, chronology, etc., as well as in matters of faith and practice.

3. That we reaffirm our belief that the human authors of Scripture were the very men to whom the Bible itself attributes the individual books. We reject the theory which says that many of the books were written under a pseudonym.

4. That we accept the Bible, the Word of God, as our final authority and dedicate ourselves to the proclamation of it in its entirety, trusting in God to empower it to fruition.

#### CONSTITUTION SOUTH GEORGIA ASSOCIATION OF FREE WILL BAPTISTS

## Preamble

The object and purpose of this organization shall be to unify the people and strengthen the work of the various churches composing the South Georgia Association of Free Will Baptists and to devise and recommend measures for the extension of the Kingdom of God in association with the various churches which do now and may later comprise this organization.

ARTICLE 1. NAME—This fellowship of churches shall be known as the South Georgia Association of Free Will Baptists of Georgia.

;e ;5 ARTICLE 2. COMPOSITION—This association shall be composed of such regularly organized and well disciplined Free Will Baptist churches as may conveniently embody themselves in this fellowship.

ARTICLE 3. REPRESENTATION—Representation shall be by delegates duly authorized by the local churches comprising the South Georgia Association, and shall be determined on the basis of one (1) delegate for each twenty (20) members or fraction thereof. Standing delegates are all ordained ministers and deacons in good standing with the South Georgia Association: missionaries who hold memberships in a church in the South Georgia in this capacity.

ARTICLE 4. OFFICERS—The officers of this association shall consist of a Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer, each of whom shall be elected at the close of each annual session. No member of this association shall be eligible to serve as Moderator for more than two consecutive years unless no other member be competent to serve.

Section 2. BOARDS AND COMMITTEES—In addition to a Mission Board, other boards may be set up as needed such as Board of Finance, Board of Education, Superannuation Board, Sunday School and Training Service Boards, Presbytery Board (Ordaining Council) etc. The personnel of each of these shall be elected as follows: The first named for a period of five years (or three years if the board numbers less than five members), the second for a term of four years, the third for a term of three years, the fourth for a term of two years, the fifth for a term of one year. Succession to officer thereafter shall be for a period of five years or three as the case may be. Committees, as necessary, shall be appointed by the Moderator unless otherwise provided for and shall hold office until their work is completed or until their successors are named. The Executive Committee shall consist of the standing officers and the chairman of each of the boards of the South Georgia Association.

ARTICLE 5. MEETINGS—The meetings of the South Gerogia Association shall be held quarterly on the fourth Saturday in January, April, July, and October each year. It shall be the duty of the church of this association to represent themselves by letter and delegates and report their standing prospects and statistics; at which time the association shall act upon such questions and topics as may be referred to by its respective member churches and transact other business not repugnant to this constitution, nor the the practices of the denomination as in its judgment may promote the cause of Christ, and the interest of the churches within the limits of this association.

ARTICLE 6. FINANCES—Member churches in this association are requested to observe the following suggestions relative to gifts to be sent with

quarterly reports:

(Compliance with this recommendation is not compulsory for affiliation.

More or less may be sent according to the ability and pleasure of each church).

ARTICLE 7. Section 1. DISCIPLINE—This association shall have power to act only as an advisory council to give churches advice in matter of difficulty, to exclude for disorderly walk and to withdraw the hand of fellowship if labor proves unsuccessful but in no case to reverse their decisions not to interfere with any of their internal regulations.

Section 2. All matters involving discipline shall be handled according to the Treastise of the National Association of Free Will Baptists.

ARTICLE 8. BY-LAWS—This association shall have power to adopt any regulation or by-laws not inconsistent with this constitution, which may be deemed essential to the further regulations of its sessions.

ARTICLE 9. AMENDMENTS—This Constitution may be amended or altered by a two-thirds vote of delegates present at any regular session, notice of intended alteration having been given in writing, and recorded at the previous session.
