1. Be it resolved that the moderator of the Association be given the authority to appoint a Sunday School convention committee for the purpose of carrying on the work for the Sunday School Convention. 2. Be it resolved that the Quarterly Meeting be given authority to place itself by invitation of the churches present.

3. Be it resolved that the Moderator of the Association appoint a committee to make up, or formulate a suitable letter from the church to the Association and have copies mimeographed and sent to each church clerk. The association to pay for paper and stencil.

4. Be it resolved that we recommend that the floor of the Association discuss whether or not to change the time of the Quarterly meeting from Saturday night to Saturday. Rejected.

5. Be it resolved that an educational fund be established in the association for the purpose of helping any one of our members that is called of God and desires to further his or her Christian education or prepare his or herself for a God called vocation, and a committee be appointed to administer it.

6. Be it resolved that all ministers be required to pass a written examination before being ordained and that the list of questions be used that are attached to this resolution. SATURDAY AFTERNOON SESSION

Recommendation of Home Missions Board that the Fifth Sunday meetings be discontinued was rejected by the Body.

Rev. Luther Walley's resignation from Home Mission Board accepted and Bro. Claude Burgess appointed to fill his unexpired term of one year. Bro. Virgil Day appointed to a five year term succeeding Bro. Charles Henderson.

Home Mission Board status as of Sept. 1, 1960: Rev. Virgil Day, 5 years Bro. Hickman McLain 4 years; Bro. Feltus Holifield 3 years; Bro. Lonnie Walley 2 years; Bro. Claude Burgess 1 year.

Bro. W. H. Henderson's resignation as Superintendent of Sunday School conventions accepted and was replaced by a committee appointed by Moderator composed of Rev. Virgil Day, chairman, Mrs. Gatsye Smith and Miss Jarma Lee Jones.

Education Fund Committee: Bro. Carter Brewer, chairman; Rev. Tillis Walley, Rev. A. J. Conway.

The 1st Quarterly Meeting will convene Saturday night before the Fifth Sunday in October with Lee's Chapel Church in Jones Co.

Next session of Association to convene with Pine Grove Church on Friday and Saturday before the first Sunday in September 1961.

Election of Officers: Rev. Truman Freeman, Moderator; Rev. W. H. Henderson, Assistant Moderator; Bro. Dave Palmer, Clerk.

Adjourned until next regular session. Benediction by Rev. Truman Freeman.

CONSTITUTION

Article 1. This Association shall be known as the South Mississippi Free Will Baptist Association of Mississippi, and be composed of delegates from churches composing same. Each church shall be entitled to two delegates to represent her at each session.

Article 2. This body shall be considered an advisory council, but having no authority over local affairs of the church.

Article 3. Each church of this body shall be considered an independent body, and shall control her own affairs in matters of discipline so long as she does not exercise authority over the association or the quarterly meeting.

Article 4. All questions of doctrine and matters of general interest shall be settled by two-thirds vote of the Association, and this vote shall be final.

Article 5. The officers of this Association shall be a moderator, assistant moderator, and treasurer, who shall be chosen by a majority vote annually.

Article 6. This Association shall meet at such time and place as shall be most convenient and shall not adjourn finally until all business is transacted.

Article 7. Churches wishing to become members of this Association must adopt the Articles of Faith and conform to its usage. We agree as churches composing this Association, to use our best influence to promote the interest of all moral and benevolent institutions, such as Temperance Cause, Sunday Schools, Missions, and so on.

Article 8. Any person who feels that he is called to preach shall be recommended to the Quarterly meeting or association by the church to which he belongs to License him. Then, if he is found worthy of Ordination, his church shall recommend him to the Quarterly Meeting or association for Ordination.

Article 9. This Constitution shall be amended at any regular session by two-thirds vote of the members present, provided the change is recommended in writing on the day before the vote is to be taken.

Article 10. Any minister desiring ordination in this Association shall be required to pass a written examination from a list of questions furnished by this Association before being ordained. Also, any candidate for license to the ministry shall be examined in accordance with the treatise as set forth on Page 48 of the Treatise of the Practices of the Freewill Baptist.

RULES OF DECORUM

Article 1. This Association shall be called to order by the former moderator, who presided at the last session; the former clerk also officiates until the body is fully organized.

Article 2. The Moderator and Clerk shall be chosen by nomination at each session; a majority of members present elect by ballot.

Article 3. The names of delegates from the different churches

shall be enrolled and called as often as necessary during the session.

Article 4. A majority of delegates shall rule in a case except in reception of churches into our body, which shall be unanimous.

Article 5. The moderator shall vote in case only when the Association is equally divided, but shall have equal right to speak on any question, provided he puts the assistant in the chair while he is speaking.

Article 6. Only one person shall speak at a time, who shall arise and address the moderator.

Article 7. No brother shall be interrupted while speaking unless he departs from the subject under discussion, or uses words of personal reflection.

Article 8. No person shall be allowed to speak more than 10 minutes at a time, not more than twice on any one subject without the consent of the body.

Article 9. No member shall laugh or talk during the time the discussion is going on.

Article 10. No member shall absent himself from the Association while in session without leave of the moderator.

ARTICLES OF FAITH

1. The Bible, the Scriptures of the Old and New Testament, were given by inspiration of God and are our infallible rule of faith and practice.

2. God. There is one living and true God revealed in nature as the Creator Preserver, and Righteous Governor of the universe, and in the Scriptures as Father, Son, and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore, and obey.

3. Christ. Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The Mediator between God and man, once crucified He is now risen and glorified and is our ever present Savior and Lord.

4. The Holy Spirit. The Scriptures assign to the Holy Spirit all the attributes of God.

5. The Government of God. God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts, not otherwise provided for, as the highest welfare of men requires.

6. The Sinfulness of Man. Man was created innocent but by disobedience fell into a state of sin and condemnation. His posterity therefore, inherit a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God.

7. The Work of Christ. The Son of God by His incarnation, life, sufferings, death and resurrection effected for all a redemption from sin that is full and free and is the ground of salvation by faith.

8. The Terms of Salvation. The conditions of salvation are: 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to love and obey Him in all things.

In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death.

9. Election. God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect.

10. Freedom of the Will. The human will is free and self-controlled, having power to yield to the influence of the truth and the Spirit, or to resist them and perish.

11. Salvation Free. God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of life freely.

12. Perseverance. All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal salvation.

13. Gospel Ordinances. Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel; feet washing, an ordinance teaching humility, of universal obligation, and to be ministered to all true believers.

14. Tithing. God commanded tithes and offerings in the old Testament; Jesus Christ endorsed it in the Gospel (Matt. 23-23) and the Apostle Paul said, "Upon the first day of the week let everyone of you lay by him in store as God hath prospered him." (I Cor. 16-2).

15. The Christian Sabbath. The Divine Law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works and activities and for personal communications with God.

16. Resurrection. Judgment and Final Retribution. The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life and they that have done evil unto the resurrection of damnation; then the wicked will "go away into eternal punishment, but the righteous into eternal life."

CHURCH COVENANT

Having given ourselves to God, by faith in Christ and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith and good works endeavor to "grow in the grace and the knowledge of our Lord and Saviour Jesus Christ."

We will not forsake the assembling of ourselves together for

church conferences; public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church or its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able promote the success of the church and of the Gospel.

We will everywhere hold Christian principles sacred and Christian obligations and enterprise supreme; counting it our chief business in life to extend the influence of Christ in society constantly by praying and toiling that the Kingdom of God may come and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of Missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of Peace sanctify us wholly and preserve us blameless unto the coming of our Lord Jesus Christ.
