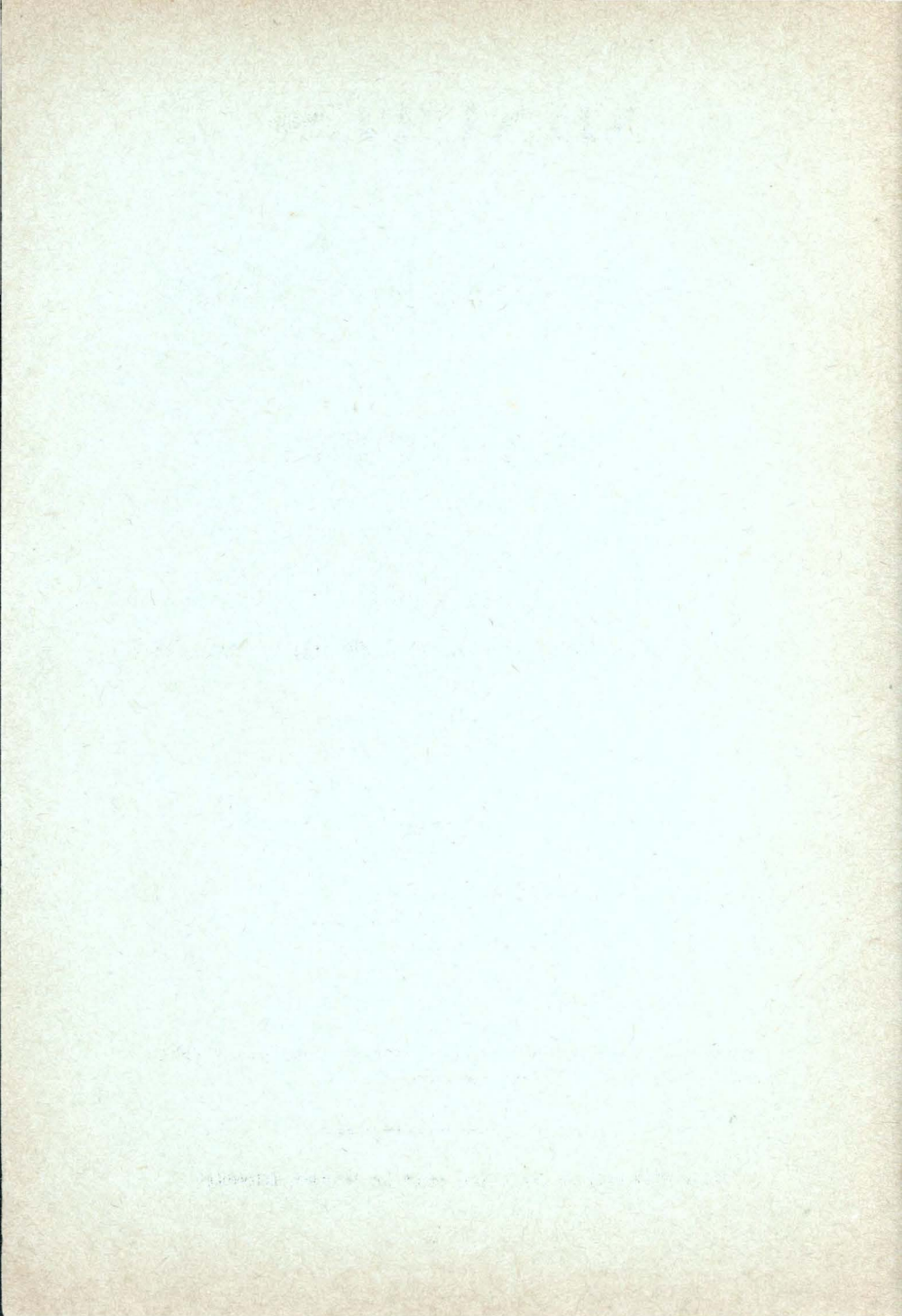

The Southeast Missouri Ministers' Conference met in its fifth annual session, Aug. 21, 22, 1945, at the Third Free Will Baptist Church, 1330 Geyer Ave. St. Louis, Mo.

7:45 P. M.

Service opened with prayer led by Rev. Melvin Bingham.

Welcome Address Wm. Hughes
Response Rev. Wm. Reeves

Song service led by Rev. D. C. Dodd, opened by singing, "At The Cross," "Stand Up For Jesus," and "When I See The Blood." Prayer, Rev. Chas. Moyer.

Rev. Mark Lewis read Isa. 62:10 with appropriate comments on the theme of the program. Special number in song was rendered by Rev and Mrs. D. C. Dodd, "I Know Somebody's Listening."

Sermon, Rev. F. C. Zinn Subject: "Setting up The Standard of Good Christian Character in the Ministry" "Amazing Grace" was sung by the congregation. Rev. Zinn delivered a great message.

President called all the ministers present to the platform, 19 present, and they sang, "I'll Be a Friend to Jesus," led by Brother Cleo Black. Benediction, Rev J. F. Miller

WEDNESDAY MORNING

9:30 A. M. Devotional led by Rev. L. Hampton as follows: opened with singing "I'm Not Ashamed," and "When Morning Comes." Prayer, Rev. J. F. Miller. Hymn, "Some Day." Scripture read: Eph. 6:10-20. Prayer, Rev. Wm. Reeves. Brother Hampton read, "The Preachers Beatitudes" and "The Laymans Beatitudes." Special number in song by F. C. Zinn, "Lift Him Up."

President, Rev. Mark Lewis, took charge at this time and read the constitution and by-laws of the Southeast Missouri Ministers' Conference.

Invitation extended for membership.

Rev. J. Johnson, Rev. J. F. Miller, Rev. O. T. Allred, and Rev. L. Hampton came forward and pledged their acceptance of the constitution and by-laws and were

accepted by vote.

Visiting brethren were seated, at this time among whom were several visiting ministers.

Roll call answered by eight ministers.

Reading of last years minute.

President declared time for election of officers. Led in prayer by Rev. Damon C. Dodd after which the following officers were elected:

Five minute recess declared.

11 o'clock Service

Singing led by Rev. F. C. Zinn "Just Over in the Glory Land." Prayer, Mrs. Melvin Bingham, Hymn, "Beautiful Garden of Prayer." Prayer led by Mrs. J. F. Miller. Special number in song by Mrs. Helen Allred.

Sermon, Rev. Mrs. Thursie Woods. Subject, "Setting Up The Standard of the Ministers Prayer Life." Text, Isa. 62:10. The message challenged us; to ask what ye will and I will do it."

Hymn, "Sweet Hour of Prayer."

Benediction, Bro. John Rogers.

WEDNESDAY AFTERNOON

Service opened by singing "To The Work" led by Rev. F. C. Zinn, also "There'll Be Shouting."

Rev. Lewis read Psa. 37.

Prayer, Rev. Woodrow Matthews. Hymn "Praise Him, Praise Him." Prayer, Rev. J. L. Yancey. Special number in song by Mrs. Helen Allred, "Something Got Hold of Me." A praise service was enjoyed by all with the presence of the Holy Spirit manifested in our midst. Another song by Mrs. Allred, "I'd Like to Talk It Over" Hymn, "You Never Mentioned Him To Me." Prayer and sermon by Rev. J. F. Miller. "Setting Up the Stan-

dard of Preparation for the Ministry." A truly great message was delivered. Business was resumed at this time with the president in charge.

Motion carried that clerk make report to Yearly Meeting. Business suspended.

Friday Aug. 24, 1945

Business resumed.

Rev. Melvin Bingham accepted as a Minister in good standing and into full fellowship of this Conference by a legal vote.

Minute read and approved.

Motion carried to adjourn until the next regular session in 1946.

Moderator declared nominations in order for a Board member. Rev. O. T. Allred elected to the Board for a term of 3 years to expire in 1948.

Report read from Executive Board of Yearly Meeting by Rev. Mark Lewis to the effect that Rev. Melvin Bingham be accepted in full fellowship of the Yearly Meeting. The report was adopted by a standing vote.
