
SOUTHEAST MISSOURI MINISTERS' CONFERENCE & YEARLY MEETING of FREE WILL BAPTISTS 1948

of the

MINISTERS' CONFERENCE

The Southeast Missouri Ministers' Conference met in its eighth annual session on August 17, 18, 1948 with the First F. W. B. Church, Flat River, Mo.

Tuesday Evening 7:30

Services opened by the Vice President, Rev. Wm. Reeves, with singing, conducted by Rev. F. C. Zinn, of hymns No. 56, "Draw Me Nearer", and No. 61, "Make Me a Channel of Blessing".

Prayer by Rev. Damon Dodd followed by hymn No. 54, "Is Your All on the Altar".

The Welcome Address was given by Rev. Albert Tucker.

Response by Rev. Harold Dunlap.

Hymn No. 119, "Heavenly Sunlight".

The Introductory Message was delivered by Rev. Albert Halbrook with the subject: "Paul, a Pattern". Text: I Tim. 1:16 and scripture reading, II Cor. 11:24-33.

Wednesday 9:30 A. M.

The morning devotion was conducted by Rev. Harry Beatty with Rev. Damon Dodd conducting the singing of hymn No. 31, "Stand Up for Jesus", and No. 39, "Trust and Obey".

Scripture reading and Comments from Eph. 4:1-19 by Rev. Harry Beatty.

Prayer by Rev. John Long followed by hymn No. 97, There Shall Be Showers of Blessing.

The speaker of the morning, Rev. Harold Dunlap, was introduced by Rev. Harvey Hill.

Rev .Dunlap read for his scripture, Mk. 13:24-30 and delivered an inspiring message on the subject: "Deception, Satan's Masterpiece of the Age".

Benediction and expression of thanks for the food by Rev. D. C. Dodd.

Item No. 1—We recommend that a committee be appointed for the revising and reconstructing the constitution and By-Laws of the S. E. Yearly Meeting, said committee to submit a complete and final report of any

Item No. 2.—In as much as the Great Commission as given by our Lord involves the Church in a world wide ministry, and whereas we are under obligations to carry on a Home Mission Progsam, and whereas a Home Mission Board of 3 members as elected by St. Francois Quarterly Meeting for the promotion of a Home Mission Program has met with outstanding success and promises to be the present answer to our needs in the Home Mission Dept.:

We, therefore, recommend that this body elect a Home Mission Board consisting of 3 members whose duty it shall be to plan, promote, and co-ordinate the Home Mission cause in the bounds of the Yearly Meeting.

Item No. 3—Pursuant to a resolution adopted by the S. E. Mo. Ministers' Conference and passed on to this body for its official action, we recommend to this S. E. Mo. Yearly Meeting that it forbid the ministers of said Yearly Meeting to knowingly solemnize marriages in which either of the contracting parties have been divorced and have living companions, this ruling to become effective, on and after Sept. 1, 1948.

Item No. 4.—We further recommend that the Secretary of the S. E. Mo. Yearly Meeting be instructed by the body to send each of the ministers in the Yearly, Meeting an official notice of the above action.

Item No. 5.—We recommend that each Quarterly Meeting comprising the Yearly Meeting send the said Yearly Meeting an amount equivalent to \$4.00 per church comprising the Quarterly Meeting said amount to accompany the Quarterly Meeting letter to the Yearly Meeting.

Item No. 6.—Whereas the duties eveolving upon the Clerk of this Yearly Meeting have been increased, and whereas the expenses of carrying on the office are greater, we recommend that the Clerk's honorarium be increased from \$5.00 to \$10.00 per session.

Item No. 7.—Be it resolved that this body extend to the Flat River Free Will Baptist Church and its paster, along with all others who have had any part in assisting the above named church and pastor, a standing vote of thanks for their hospitality and efficient handling of this session of the S. E. Mo. Yearly Meeting, and be it further resolved that all who have rendered special

music or otherwise contributed to the spiritual success of this session be included in the standing vote of thanks.

Denominational Enterprises Committee-

We recomend

Item No. 1A.—That this Yearly Meeting make an offering of \$100.00 to our Free Will Baptist Bible College now. B. That as many as possible of our people adopt our Endorsement check book plan of supporting our school.

Item No. 2A.— That this body adopt the plan recommended to the National Association by the Home Mission Board that a special Tent Fund be raised to purchase and equip a tent to be used in the Home Mission work.

B.—And further recommend that we follow the plan of the National Association as using October for special Home Mission offerings.

C.—Since new missionaries have gone to the Foreign Fields, we recommend the continued, and if possible increased, support to our Foreign Mission work.

Item No. 3.—That we support the National Executive Department financially and all the other phases of our national work.

Item No. 4.—That after the glorious session of our Youth Encampment, which we have just closed, and realizing that the need is so great for completion of our camp, we recommend the whole hearted support of the \$10,000.00 campaign which the children launched while in session.

Item No. 5.—That we support our Gem and State Entertainment Funds, etc.
