





– PROCEEDINGS –

The 60th session of the Southeast Missouri Yearly Meeting of Free Will Baptist convened with the Southside Free Will Baptist Church, St. Louis, Missouri, August 20-22, 1953.

The Thursday evening service began at 7:30 p.m. with singing of Hymn No. 8, "I Am Thine O Lord" led by Rev. Dean Burpo, and the devotional by Rev. Robert Hill. After the hymn the Clerk formally called the house to order and presented the Assistant Moderator Rev. James Barker, who presided in the absence of the Moderator, Rev. Harry Beatty.

The welcome address was given by the host pastor, Rev. James Franklin with response by Avery DeWitt.

A temporary pulpit committee was chosen by the moderator as follows: Bro. Leeman Underwood, Bro. Howard Kennedy. and Bro. Avery DeWitt. This committee chose Rev. James Franklin to deliver the 11:00 o'clock message on Friday.

Hymn No. 20 "He Keeps Me Singing" was sung followed by Scripture reading with comments from Luke 12:6 by Rev. Robert Hill. The congregation sang Hymn No. 15 "Revive Us Again" followed by special number titled "It's Real" by the Swan Sisters. The Moderator presented Rev. Woodrow Matthews who delivered the introductory message. The text was Exodus 14:5 with subject "Go Forward". After the message Hymn No. 111 "I Want To Be A Worker" was sung by the congregation. After announcements the benediction was offered by Rev. Don Ellis.

Friday - 9:30 A.M.

Services called to order by Moderator with Rev. Dean Burpo conducting the singing. Hymn No. 48 "O I Want To See Him" was sung followed by prayer led by Rev. George Hibbitts. Hymn No. 35 "Leaning on the Everlasting Arms" was sung. Scripture reading by Rev. Charles Moyer from Philippians 1:8-11.

The standing delegates were recognized by the Moderator. Rev. Eunice Edwards was appointed as Assistant Clerk. The letters from the Madison County and St. Francois County Quarterly Meetings were read, and absentee delegates replaced by appointments. Motion made and sustained to receive the letters and seat the delegates. Rev. and Mrs. Hiram McAdams were recognized as visiting ministers.

Motion made and sustained that W. T. Newsome be received as a member of the Southeast Missouri Yearly Meeting.

ELECTION OF OFFICERS: Moderator, Rev. James Barker, Assistant Moderator, Rev. Woodrow Matthews; Secretary-Treasurer, Rev. Albert Halbrook and Statistician, Rev. Albert Halbrook.

The Constitution and By-Laws of the Yearly Meeting were read by the Moderator.

While waiting for the report of the Executive Board Hymn No. 126, "When We All Get To Heaven," was sung.

Report of the Executive Board was read including letters of resignation from Rev. Harvey Hill and Rev. Benjamin Scott both who were Board Members. The report of the Executive Board was received by motion. Motion to receive the resignation of Rev. Harvey Hill and Rev. Benjamin Scott who have left the Bounds of the Yearly Meeting to accept pastorates in other states. Rev. John Long led in prayer for their success in their new work.

The following were elected as members of the Executive Board: Rev. James Franklin for 3 years, whose term expires in 1956 and Rev. Rolla Smith for 2 years whose term expires in 1955.

Sis. Lizzie McAdams delivered the charge and offered prayer in behalf of the elected officers.

The Moderator appointed a Committee on Committee as follows: Rev. Leslie Logsdon, Rev. John Long, and Deacon R. L. Sharp. The Business Committee was as follows: Rev. Rolla

Smith, Rev. Willard Darnell. Rev. Woodrow Matthews, Rev. W. T. Newsome and Rev. Robert Hill. Motion made and sustained to adjourn. Benediction. Rev. Rolla Smith.

11:00 O'clock Service

Congregation singing led by Rev. Dean Burpo. Hymn sang No. 145, "Bring Them In" and No. 113, "Trust and Obey". Prayer by Rev. W. T. Newsome followed by Hymn No. 6. "Love Lifted Me." Scripture reading and commented from Philippians 2:1-4 by Rev. Buddy Hill. Rev. James Franklin, pastor of Southside Church was presented by Moderator as the messenger of 11:00 O'clock Service. Rev. Franklin read for his scripture John 13:34-35, and announced "Love" as his subject. At the close of his message Hymn No. 207 "Where He Leads Me" was sung and an invitation was extended to the lost and also to those who felt called for a special service. The congregation was called forward for a consecration service and prayer was offered by Rev. Hiram McAdams.

Benediction and expression of thanks for food of noon hour by Rev. Charles Moyer.

1:30 P.M.

The Program of the Woman's Auxiliary was rendered at this hour.

After the adjournment of the Woman's Auxiliary Program The Moderator assumed charge and called for the reading of the partial report of the Business Committee. Three items were read which were placed on the table for next day's consideration. The report of the Committee on Committee was read and accepted.

Motion made and sustained to adjourn.

Benediction - Rev. Leslie Logsdon.

Saturday - 9:30 A.M.

Services called to order by Moderator with Bro. Harold Baldwin conducting the singing and Rev. W. T. Newsome the devotions. Songs sung No. 164 "More About Jesus" Scripture reading and comments from Hebrews 1:1-2 by Rev. Newsome followed by prayer by Bro. Clifford McGraw.

Elected delegates who were absent the previous day were recognized and seated .

The report of the Obituary Committee was read and in compliance with its recommendation Rev. James Franklin after a moment of silent prayer by the congregation led in audible prayer.

Oral reports from the Madison County Sunday School convention and the Triumphant Sunday School Conventions were given by Bro. Harold Baldwin and Rev. Dean Burpo, presidents of the respective Sunday School Convention. Motion made and sustained to receive the reports as information. Also an oral report of the Southeast Missouri League Convention was given by Rev. Dean Burpo. Motion made and sustained to receive the report as information.

The minutes of the Clerk up to the previous moment were read and received. The Financial report of the Treasurer was read and accepted. The Statistician Report was read and received. The report of the Nominating Committee was read and received as amended.

The partial report of the Business Committee was received for discussion item by item. Item No. 1 adopted (See report,. Item No. 2 adopted. Motion made and sustained that the Yearly Meeting dates be changed to convene Thursday night following the first Sunday in August.

Item No. 4 adopted (see report). Benediction — Rev. Robert Hill.

11:00 O'clock Service

Congregational singing led by Rev. Dean Burpo with singing of hymn No. 91 "Some Day" followed by prayer by Rev. C. B. Dees. Chorus "Praise Ye The Lord" was sung followed by devotions by Rev. Leslie Logsdon, who read for his scripture Romans 15:1-8. and offered prayer.

Rev. Lawrence Thompson was presented by the Moderator as the messenger of the hour. The announced subject was "Hidden Sin" with scripture from Genesis 4. At the close of the message Hymn No. 211 "There is a Fountain" and No. 79 "Victory in Jesus" were sung followed by a testimonial service.

Benediction and expression of thanks for food of noon hour by Rev. Dean Burpo.

1:30 P.M.

Services called to order by Moderator with singing led by Rev. Robert Hill. Hymn No. 329 "Stand Up For Jesus". Prayer by Bro. Harold Baldwin followed by hymn No. 172 "Kneel At the Cross". Devotions led by Rev. Willard Darnell reading the scripture lesson Psalm 129 followed by comments.

The death of Sis. Georgia Hill's grandmother was announc-

ed and prayer was offered by Rev. George Hibbitts in behalf of the bereaved.

The Ministers' reports were read followed by the reading of the Credentials Report which was adopted. (See reports).

The report of the Temperance Committee was read and received. (See reports).

The report of the Denominational Committee was read and received to be adopted item by item. Item No. 1 adopted. (See reports).

For a brief moment for relaxation the congregation stood and sang choruses led by Rev. Robert Hill.

Item No. 2 adopted by vote (see report). Item No. 3 adopted by vote (see report). Item No. 4 adopted by vote (see report). Item No. 5 adopted by vote (see report). Item No. 6 adopted by vote (see report).

Rev. James Franklin was elected to preach the Introductory Message at the next Yearly Meeting with Rev. W. T. Newsome as alternate.

The final report of the Business Committee was read and received to be adopted item by item.

Motion made and sustained that a standing vote of thanks be given to the officers of the Yearly Meeting for their service during this session.

A closing hymn No. 79 "When We All Get To Heaven" was sung and fellowship handshake was enjoyed.

Item No. 9 That this body take a stand against the new Revised Standard Version of the Bible as copyrighted by the National Council of Churches.

CONSTITUTION

This organization shall be known as the Southeast Missouri Yearly Meeting of Free Will Baptists and shall be composed of the St. Francois County Quarterly Meeting and the Madison County Quarterly Meeting.

Article I

When the delegated body shall meet in regular annual session for the transaction of business, the Moderator, or in his absence, the assistant Moderator, shall call the meeting to order and invite all to take part in congregational singing.

After a sufficient number of hymns, the Moderator chall read, or have read, some suitable Scripture, then prayer shall be offered.

Article II

Five or more delegates from one or more churches of each Quarterly Meeting comprising this Yearly Meeting shall constitute a quorum for the transaction of business. However, a lesser number may adjourn from time to time.

Article III

The letters from the Quarterly Meetings to be read, dues received (\$4.00 per Church), the delegates seated. All ordained Ministers and their companions and licensed ministers who are in good standing and full fellowship with some church in the Yearly Meeting, together with ordained deacons. church clerks, and church treasurers, shall, by virtue of their authority, be standing delegates in this Yearly Meeting.

Article IV

When all delegates, both elected and standing, have been seated, the body will then proceed to elect officers as required by rule number one governing the organization. All officers elected shall be instructed in the duties of the offices to which they have been elected. The instruction to be given by the Moderator, or someone qualified to do so.

Article V

The Moderator elected shall at once take charge of the meeting and shall, when present, preside over all meetings. In the absence of the Moderator, the assistant Moderator shall preside over the meeting.

Article VI

The Moderator shall appoint all committees unless otherwise ruled by the Body.

Article VII

The Moderator shall have the privilege to solicit the help of any minister or delegate present in appointing committees.

Article VIII

C. C.L

After the organization has been completed, corresponding messengers and visiting brethren from other religious bodies are invited to a seat in council. Should there be letters of greetings or reports from other bodies they may at this time be read.

Article IX

All items of business coming to this Yearly Meeting. except routine business, must come through the Business Committee or a Committee appointed for that special purpose.

Article X

Before any question can properly be discussed by the delegated body, it must be before the body by a motion properly sustained. All questions are settled by a majority vote of the delegates present. When a question is properly before the body, any regular delegate has a right to speak on the subject. No person shall be allowed to speak more than five (5) minutes on any subject at one time, and not more than twice on the same subject without special permission from the Moderator.

Article XI

The Moderator shall have power to stop all discussions that are leading to confusion.

Article XII

All ordained ministers who are members of this Southeast Missouri Yearly Meeting are required to submit in writing a full and complete report of their ministerial activities to this body while in annual session. These reports shall be examined by a Committee on Credentials and submitted to the body for approval. Failure to make said report forfeits their rights to a Certificate of Ministerial Standing.

Article XIII

Official papers of this Yearly Meeting must be signed by the Moderator of the Yearly Meeting and the Secretary.

Article XIV

Each Quarterly Meeting belonging to the Yearly Meeting shall be entitled to two (2) delegates for the organization and two (2) delegates for each one hundred (100) members or major fraction thereof belonging to the said Quarterly Meeting.

Article XV

Any person who is a delegate to this Yearly Meeting, wishing to speak on any subject properly before the Body, shall arise and address the chair, by saying, "Brother Moderator," or "Brother Chairman" and shall speak no farther until they have been recognized by the Moderator.

Article XVI

This Constitution may be altered or amended at any regular meeting by a two-thirds majority vote, provided that one day's previous notice of proposed change or amendment has been given.



BY-LAWS ADOPTED FOR THE BODY

Known As

The Southeast Missouri Yearly Meeting of the Free Will Baptist Church, and at the present date, composed of the Madison County Quarterly Meeting and St. Francois County Quarterly Meeting of the Free Will Baptist denomination.

No. 1—The officers of this Yearly Meeting shall be a Moderator, Assistant Moderator. and Secretary-Treasurer who shall also serve as Statistician. There shall also be an Executive Board of three or more members who are actively engaged in work of the Free Will Baptist Church in Southeast Missouri.

No. 2—The Moderator and Assistant Moderator shall be elected annually and shall hold office until their successors are elected and quaified.

No. 3—Choice of these officers shall be made by nomination and by legal vote. In case where there is but one nominee the officer shall be elected by acclamation.

No. 4—The Moderator and Assistant Moderator shall not be elected jointly, but shall be elected separately by nomination and by legal vote.

No. 5—The Secretary and Treasurer shall be elected by nomination and by legal vote as the Moderator and Assistant Moderator. He or she will hold the office for one year, and be paid a salary agreed upon by him or her and the body. The Secretary and Treasurer shall be the same person. It shall be the duty of said officer to keep an accurate record of the proceedings in a book or books furnished him or her by the body. The said officer agrees faithfully to discharge all the duties of the office willingly in the interest of the cause of the Free Will Baptists everywhere.

No. 6—The Executive Board shall be elected as other officers but shall serve a term of three years; terms to expire alternately. It shall be the duty of said board between sessions of the Yearly Meeting to be in charge of the work in a general way. They shall act as an advising body for each local body composing this Yearly Meeting. They shall at all times have at heart the cause of Christ and the Free Will Baptist denomination and in all cases act without partiality or respect of persons.

They agree to discharge their duty or duties faithfully, to work according to the leadership of the Holy Spirit and the usages of the Yearly Meeting that they are to serve. Should money or any other property of the Yearly Meeting be entrusted to them they shall handle, hold, convey, and convey said property with the greatest possible care, and will be able at all times to give a full and complete report of all property to the proper authorities.

No. 7—These By-Laws may be altered or amended at any regular meeting by a two-thirds majority vote, provided that one day's previous notice of proposed change or amendment has been given.
