Proceedings

THE SIXTY-SEVENTH SESSION OF THE SOUTHEAST MISSOURI YEARLY MEETING OF THE FREE WILL BAPTISTS WHEN CONVENED WITH THE FAITH CHURCH, 9824 CLYDE ST., ST. LOUIS, MO., AUGUST 11-13, 1960.

The service on Thursday evening, August 11th, came to order by singing of hymn No. 98, "It Won't Be Very Long," led

by Rev. Harry Asher and Eilene Hovis as pianist.

The Clerk, Rev. Albert Halbrook, called the Yearly Meeting into session and presented Rev. Harvey Hill, Assistant Moderator, to moderate in the absence of Rev. Rolla Smith, who had left the Southeast Missouri Yearly Meeting to assume the duties of Director of Foreign Mission, and now resides at Nashville, Tenn.

Welcome Address by Rev. Floyd Arnold, pastor of Faith Church.

Response by Rev. Chesley Hill, pastor of Parkview Church. Following prayer by Rev. R. B. Spurgeon, pastor of St. Louis Third Church, the Moderator presented Rev. John Elliston, director of Nogales Mission of Arizona and New Mexico. Rev. Elliston gave greetings and introduced a student, Fabian Guzman.

Congregational hymn No. 19, "I Would Not Be Denied" was sung, followed by prayer led by Rev. Elmer Turnbough.

Devotions were led by Rev. Bobby Hesselmeyer of Berkeley City Church. Rev. Hesselmeyer read for Scripture lesson Mark 13:34-37, and gave comments. Prayer by Rev. Johnny Land.

The Moderator appointed a temporary Pulpit Committee as follows: Rev. Floyd Arnold, Rev. Chesley Hill, and Mrs. Gussie Hamblen.

Rev. Dale Jones, pastor of the First Free Will Baptist Church of Flat River, was presented by the Moderator to deliver the Introductory Message. Rev. Jones read Psalm 51:1-3 as Scripture lesson and, using "and my sin is ever before thee" as the basis of his message, challenged us to be more diligent in soul-winning. At the close of the message hymn No. 283, "Softly and Tenderly" was sung and an invitation extended to the unsaved.

The Pulpit Committee reported that Rev. Elmer Turnbough, pastor of the Fourth Church, was to lead devotions at 9:30 Friday morning; Rev. Elro Driggers, pastor of Fellowship Church, devotions at 11 o'clock; and Rev. Clarence Burton, pastor of Fredericktown Church, to deliver the 11 o'clock message.

After various announcements, the benediction was pronounced by Rev. John Elliston.

FRIDAY MORNING-9:30 A. M.

Service called to order by the Moderator with prayer offered by Rev. Johnny Vicks, Nashville, Tenn. Congregational singing was led by Rev. Floyd Arnold, pastor of Faith Church, with Sharon Barker as pianist. Hymns No. 37 "Standing On the Promises" and No. 6 "Love Lifted Me" were sung.

Devotional period was led by Rev. Elmer Turnbough, reading and commenting from I Cor. 10:31 and offering prayer.

The Moderator read selected articles of the Yearly Meeting Constitution. The standing delegates were asked to stand.

Rev. James Barker, pastor of First Free Will Baptist Church of Farmington, was elected as Assistant Moderator.

The letters from the Madison Co., St. Francois Co., and St. Louis District Quarterly Meetings were read and also names of delegates from churches. The letters were received by motion. The Assistant Moderator, Rev. James Barker, delivered the charge to the delegates.

Rev. Johnnie Vicks, Nashville, Tenn., expressed greeting to the Yearly Meeting. Also a letter of greetings from Mr. and Mrs. Mark Vandivort, serving as home missionaries in Littleton, N. H., was read.

An oral report from the Executive Board was given by Rev.

Harry Asher and accepted.

A Committee on Committees was appointed as follows: Rev. Roger Reeds, Rev. Dean Burpo, and Rev. John Long. The temporary Pulpit Committee, consisting of Rev. Floyd Arnold, Rev. Chesley Hill, and Mrs. Gussie Hamblen was appointed as Permanent Committee.

The statistical letter and letter to the State Association from the Yearly Meeting were read and accepted. An invitation from the Madison Co., Quarterly Meeting was accepted as the setting for the 1961 session of the Yearly Meeting. Rev. Harry Asher was elected to deliver the Introductory Message for 1961 session with Rev. Harvey Hill as alternate.

Mrs. Eunice Edwards, Executive Secretary of the National Woman's Auxiliary, Nashville, Tenn., expressed words of greet-

ing.

Recess declared with benediction by Mrs. Edwards.

11:00 A. M. SERVICE

Services called to order with singing led by Rev. Clarence Burton and Lois DePriest as pianist. Hymn No. 8, "I Am Thine O Lord" was sung, followed by prayer by Rev. Truman Huffman. The report of Committee on Committees was read and accepted. (See reports.) The Woman's Auxiliary report on names of committees was given by Mrs. Myrtle Reeds.

A solo "Is Your All On The Altar?" was rendered by Rev. Chesley Hill. Devotions were led by Rev. Elro Driggers, pastor of Fellowship Church, reading II Kings 4:1-7, commenting and offering prayer. Hymn No. 133 "Leaning On The Everlasting

Arms" was sung.

Rev. Johnnie Vicks, pastor of New Hope Church, Nashville, Tenn., was presented as speaker for the morning; Rev. Clarence Burton, previously chosen having graciously relinquished the hour to him. Rev. Vicks read Judges 7:21. Prayer was offered by Rev. James Barker. Rev. Vicks announced as subject—text, "They stood every man in his place." Rev. Vicks forcibly urged each individual Christian to stand in his place. At the close of the message he offered prayer. While singing No. 282 "Where He Leads Me," the congregation gave Rev. Vicks their appreciation for the message.

Announcements relative to the services in the afternoon were made. Also Rev. Floyd Arnold, host pastor, made announcements pertaining to noon hour. Mrs. Myrtle Reeds made final announcements on committees for Woman's Auxiliary.

ing with Mrs. Burpo as pianist.

The St. Louis League Convention report and the St. Francois County Sunday School Convention report was read and accepted. The Temperance and Obituary reports were read and accepted. In compliance with the Obituary report, the body bowed in silent prayer, followed by audible prayer led by Rev. Wm. Turnbough.

The minutes of the session to the present hour were read

and accepted.

Upon the presentation of the item by Rev. Barker, the body voted that this Yearly Meeting invite the State Association to convene with the Farmington First Church in its 1961 session.

Rev. John Elliston, director of Nogales Mission, was presented by the Moderator. Rev. Elliston and Fabian Guzman sang "Send the Light" in Spanish. Following the duet, Rev. Elliston delivered a message on the "The Lights Of The World"

and earnestly challenged us to live a more sacrificial life for God. Rev. Barker commented briefly on the message and called for adjournment.

FRIDAY EVENING-7:30 P. M.

The service was called to order by the Moderator with prayer by Rev. John Long. Congregational singing was led by Rev. Roger Reeds, with Mrs. R. B. Spurgeon as pianist. Hymn No. 261 "At The Cross" was sung. Devotions were led by Rev. R. B. Spurgeon, pastor of Third Church of St. Louis, reading Mark 8:34, commenting and offering prayer.

The Moderator asked that visitors and delegates to stand

for their respective Quarterly Meeting.

Rev. John Elliston and Fabian Guzman sang in Spanish

"Where He Leads Me."

The final report of the Pulpit Committee was given as follows: Rev. Willard Darnell, pastor of the Copper Mines Church, to lead devotions at 9:30 a.m., Saturday morning; Rev. R. J. Kennedy, Greenville, N. C., for devotions at 11 o'clock; and Rev. Roger Reeds, pastor of South Side Church, to preach the 11 o'clock message.

The Moderator presented the Free Will Baptist College Quartette of Nashville, Tennessee. The quartette sang "Wonderful Peace" and introduced themselves as Ken Riggs. Nashville, Tenn.; Dwight Riggs, Detroit, Michigan; Jakie Creech, Kenly, North Carolina; and R. J. Kennedy, Greenville, North Carolina. After singing "Peace In The Valley" and "Now I Belong To Jesus," Ken Riggs gave his testimony, followed by the quartette singing "Victory In Jesus." R. J. Kennedy led the congregation in a testimony service. The quartette sang "There's No Friend To Me Like Jesus," and "Go Tell Someone About Jesus," after which Bro. Kennedy gave the congregation opportunity to receive pledge cards in support of the F. W. B. College. The Moderator also received an offering from the congregation for the College.

Whereas the separation of church and state has always been a Baptistic principle, and whereas the Catholic Church has always taken a position to the opposite extreme, and whereas the Catholic Church demands the complete loyalty of its members and whereas the Pope is not only the supreme ruler over the Catholic Church and its membership, but also rules over foreign power, we recommend that Free Will Baptists everywhere and especially those in the Southeast Missouri Yearly Meeting prayerfully consider the person for whom they cast their ballot for presidency this fall.

We have no ill feeling toward the candidate of the Democratic Party, but since he is a Roman Catholic, we fear that his allegiance to the Roman Catholic Church will take precedence over this position as President. Knowing this fact, Free Will Baptists ought to carefully screen all of the other candidates

and select their man from them.

3. We recommend we give \$30.00 to Rev. Elliston for the mission work in Nogales, Arizona.

4. We recommend we given \$50.00 to Rev. and Mrs. Mark Vandivort for the mission work in New Hampshire.

5. We recommend this Yearly Association give the St. Louis Quarterly Meeting and the Faith Free Will Baptist Church a standing vote of thanks for the splendid way in which they have entertained this Association.
