# FIRST QUARTERLY MEETING OF THE SOUTHEASTERN ASSOCIATION OF FREE WILL BAPTIST MEETING WITH UNION GROVE CHURCH ON JANUARY 19, 1991

BRO. MIKE GILLOCK, PASTOR OF NEW ZION, BROUGHT THE EVENING DEVOTION, USING AS SCRIPTURE ROMANS 6:19. HE SPOKE OF THREE AREAS OF THE CHRISTIAN LIFE. ONE, THE GREEN LIGHT. #### BITS AND PIECES OF THE HISTORY OF FREE WILL BAPTIST AND THE SOUTHEASTERN ASSOCIATION OF FREE WILL BAPTIST CHURCHES

#### DID YOU KNOW

THE FIRST FREE WILL BAPTIST CHURCHES WAS FORMED BY PAUL PALMER IN CHOWAN COUNTY, NORTH CAROLINA IN 1727. THIS WAS KNOWN AS THE FREE WILL BAPTIST CHURCHES OF THE SOUTH. FIFTY YEARS LATER BENJAMIN RANDALL FORMED THE FREE WILL BAPTIST CHURCHES OF THE NORTH. THERE WAS A DIFFERENCE IN THE ORDINANCES ON THE PRACTICE OF FEET WASHING BETWEEN THE TWO. THE SOUTH PRACTICED FOOT WASHING, BUT THE NORTH DID NOT. IN THE YEAR OF 1827 THERE WAS THREE CHURCHES IN THE STATE OF SOUTH CAROLINA. THE FREE WILL BAPTIST DENOMINATION MOVED ON TO THE STATE OF GEORGIA IN APPROXIMATELY 1835 AND SETTLED IN THE COLUMBUS, GEORGIA AREA WE BELIEVE THE FREE WILL BAPTIST THEN MOVED ON TO EUFAULA, ALABAMA AREA AS COLUMBUS, GEORGIA AND EUFAULA WAS TRADING POST CENTERS. AS THE PEOPLE MOVED THE FREE WILL BAPTIST DENOMINATION MOVED. THIS TOOK PLACE SOMETIMES BETWEEN 1835 AND THE CIVIL WAR.

IT IS OUR BELIEF THAT THE SOUTHEASTERN ASSOCIATION HAD IT'S BEGINNING ABOUT 1878 FROM INFORMATION WE HAVE GATHERED FROM JOSEPH WHITAKER WHO WAS BORN IN 1865. HE IS BURIED AT HOWARD GROVE FREE WILL BAPTIST CHURCH. WE HAVE OBTAINED THE FOLLOWING INFORMATION FROM HIS RECORDS. IN THE YEAR OF 1879 HOWARD GROVE FREE WILL BAPTIST CHURCH WAS A MEMBER OF THE SOUTHEASTERN ASSOCIATION OF FREE WILL BAPTIST CHURCHES.

IN THE YEAR OF 1886 THE SOUTHEASTERN ASSOCIATION CONVENED AT GOODWATER FREE WILL BAPTIST CHURCH THEN LOCATED IN DALE COUNTY, ALABAMA. IN THE YEAR OF 1886 THE SOUTHEASTERN ASSOCIATION OF FREE WILL BAPTIST CHURCHES PROPOSED TO ABOLISH THE PRACTICE OF FOOT WASHING AS A CHRISTIAN ORDINANCE. HOWARD GROVE LEFT THE SOUTHEASTERN ASSOCIATION, FOLLOWED BY HICKORY, SILVER RUN AND NEW PROSPECT CHURCHES. THEY APPOINTED HOWARD GROVE AS THEIR MEETING PLACE AND FORMED THE STATE LINE ASSOCIATION.

IN THE EARLY CHURCHES PEOPLE WAS OFTEN CALLED UP FOR DOING WRONG. DANCING AND DRINKING WAS TWO OF THE MAIN ACKNOWLEDGMENTS MADE.

FROM THE EARLY MINUTES OF THE UNION GROVE CHURCH ESTABLISHED IN 1877 WE HAVE TAKEN THE FOLLOWING INFORMATION. ON SATURDAY BEFORE THE 5TH SUNDAY IN AUGUST 1890 THERE WAS AN ASSOCIATIONAL MEETING HELD AT MOUNT ZION. THIS WAS TO ESTABLISH OR DISCUSS A NEW CONSTITUTION FOR THE SE ASSOCIATION. ON AUGUST 1, 1891 DELEGATES WAS ELECTED FROM UNION GROVE TO GO TO THE ASSOCIATION. IN 1891 THE UNION GROVE CHURCH PAID 50 CENTS FOR MINUTES AND 50 CENTS FOR ASSOCIATIONAL PURPOSES.

THE ASSOCIATION MEETING WAS HELD AT PLEASANT HILL FWB CHURCH ON THE 3RD SATURDAY IN DECEMBER 1892.

DID YOU KNOW IN APRIL 1894 THE CHURCH OF UNION GROVE APPROVED THE BUYING OF ONE HALF DOZEN HYMN BOOKS?

IN SEPTEMBER 1896 UNION CHURCH ELECTED DELEGATES TO REPRESENT THEM IN THE ASSOCIATIONAL MEETING AND THE CHURCH PAID \$1.00 FOR MINUTES AND 75 CENTS FOR ASSOCIATIONAL PURPOSES.

IN THE YEAR OF 1897 THE ASSOCIATIONAL DUES WAS RAISED TO \$2.00. (TIMES HAVE CHANGED).

IN THE MONTH OF OCTOBER 1898 THE ANNUAL SESSION OF THE SE ASSOCIATION WAS HELD WITH PROSPECT CHURCH IN HENRY COUNTY, ALABAMA. PINEY GROVE, NEW PROSPECT, ANTIOCH AND EVERGREEN WITHDREW FROM THE SE ASSOCIATION WITHOUT ANY AUTHORITY FROM THEIR RESPECTIVE CHURCHES. THEY THEN FORMED AN ASSOCIATION KNOWN AS THE EVERGREEN ASSOCIATION.

ON THE FRIDAY BEFORE THE THIRD SUNDAY IN OCTOBER 1910 THE SOUTH-EASTERN ASSOCIATION OF FWB CONVENED AT NEW PROSPECT CHURCH IN HENRY COUNTY, ALABAMA FOR THE 32ND ANNUAL SESSION. BRO. J. H. GUILFORD WAS MODERATOR AND BRO. C. B. SEARCY CLERK. THE FOLLOWING REPORT WAS BROUGHT BEFORE THE ASSOCIATION ON DOCUMENTS. TEMPERANCE: WE YOUR COMMITTEE SUBMIT THE FOLLOWING REPORT; AS THE LORD HAS COMMANDED HIS CHILDREN TO BE TEMPORATE IN ALL THINGS, WE WILL SUBMIT AND SURRENDER TO BE TEMPORATE IN SUCH ACTS AND DEEDS AND AS GOD'S WORD PRONOUNCES "WOE UNTO HIM THAT GIVETH HIS NEIGHBOR DRINK OR PUTTETH THE BOTTLE TO HIS NEIGHBOR'S LIPS TO MAKE HIM DRUNK" WE WILL NOT ONLY ABSTAIN FROM IT OURSELVES, BUT DO EVERYTHING AGAINST THE SALE OF IT OR THE USE OF IT IN ANY WAY. WE SEE THAT WHISKEY IS A DESTRUCTION OF HUMANITY AND THE CHURCH. WE GIVE BELOW THE ESTIMATE OF WHAT ONE BUSHEL OF CORN WILL MAKE. THE DISTILLER GETS FOUR GALLONS OF WHISKEY WHICH RETAILS AT \$16.00.; THE FARMER GETS ONE DOLLAR FOR HIS CORN, THE GOVERNMENT GETS \$4.40, THE RAILROAD GETS \$1.00 FOR CARRYING, THE MANUFACTURER GETS \$9.85, THE DRAYMAN GET 15 CENTS, THE CONSUMER GETS DRUNK, AND THE WIFE AND CHILDREN GO HALF CLAD IN IGNORANCE AND SHAME.

IN 1910 THE ASSOCIATION PAID \$15.00 FOR THEIR MINUTES AND ON SATURDAY THE PUBLIC COLLECTION WAS \$8.65. A MOTION WAS MADE TO SEND \$10.00 TO THE AYDEN, NORTH CAROLINA SCHOOL. THERE WAS ALSO A MOTION MADE TO PAY THE MODERATOR \$10.00 FOR HIS SERVICES.

ONLY 4 CHURCHES IN THE ASSOCIATION WAS HAVING SUNDAY SCHOOL (SABBATH SCHOOLS). C. A. ARNOLD ASKED THAT THE CHURCHES PUT FORTH SPECIAL EFFORT TO HAVE SABBATH SCHOOLS AS IT WAS A STEPPING STONE TO RELIGION FOR THE BOYS AND GIRLS.

IN 1910 THERE WAS 15 CHURCHES IN THE SE ASSOCIATION. THEY WERE: ANTIOCH, BETHSIADA, CHRISTIAN HOME, EPHESUS, EVERGREEN, GOODWATER, JUDSON, MT. ZION, NEW PROSPECT, PINEY GROVE, PLEASANT HILL, PILGRIM'S REST, SARDIS, UNION GROVE AND ZION.

ON FRIDAY BEFORE THE 3RD SUNDAY IN OCTOBER 1936 THE SE ASSOCIATION CONVENED AT NEW ZION CHURCH FOR THEIR 58TH ANNUAL SESSION. REV. J. H. GUILFORD, MODERATOR; REV. D. F. PELT, VICE MODERATOR; J. S. VICKERS, CLERK AND D. E. SHIRLEY, TREASURER.

THE FOLLOWING REPORT WAS GIVEN ON TEMPERANCE. WE URGE THAT OUR MEMBERS OBEY PAUL'S INSTRUCTION, "BE YE TEMPERATE IN ALL THINGS, ESPECIALLY PERTAINING TO STRONG DRINKS, AND WE RECOMMEND THAT ALL OUR CHURCHES DEAL WITH IT'S MEMBER THAT WALK DISORDERLY IN ANY RESPECT.

SIX CHURCHES WAS REPORTED AS HAVING SUNDAY SCHOOLS. EACH CHURCH WAS URGED TO ORGANIZE A SUNDAY SCHOOL AND TAKE THE WORK TO HEART.

REV. J. T. HUTTO HELD THE CONGREGATION ALMOST SPELLBOUND WITH OLD TIME PREACHING. THIS WAS VERY IMPRESSIVE AND ENJOYED BY ALL.

THE SUNDAY SCHOOL CONVENTION WAS SET TO MEET SATURDAY BEFORE THE SECOND FIFTH SUNDAY IN 1937 AND GOES TO GOODWATER.

THE FOLLOWING MEN WAS GIVEN AS MINISTERS: E. O. SELLERS, BOB BEASLEY, J. H. GUILFORD, C. P. GUILFORD, THOMAS GILLEY, J. M. SHIRLEY, D. F. PELT. THERE WAS 12 CHURCHES IN THE ASSOCIATION IN 1936.

ON FRIDAY BEFORE THE 3RD SUNDAY IN OCTOBER 1938 THE SE ASSOCIATION OF FWB MET AT UNION GROVE CHURCH. REV. J. H. GUILFORD, MODERATOR; REV. D. F. PELT, VICE MODERATOR; J. S. VICKERS, CLERK AND J. L. (LONG) STOKES, TREASURER.

ON FRIDAY REV. T. B. MILETTE PREACHED THE TRUE GOSPEL OF JESUS CHRIST TO A CONGREGATION THAT ENJOYED IT AS WAS TRULY THANKFUL FOR SUCH A MESSAGE. AN INTERMISSION OF ONE HOUR AND FIFTEEN MINUTES WAS GIVEN DURING WHICH A BOUNTIFUL FEAST WAS SPREAD AND ENJOYED BY ALL.

SONG SERVICE WAS LED BY BRO. BOB STOKES. ONLY 5 CHURCHES WAS HAVING SUNDAY SCHOOL IN 1938.

PILGRIM CHURCH GAVE THE FOLLOWING REPORT. FROM THE DAY OF JESUS DOWN TO OUR AGE OR THROUGHOUT THE ENTIRE HISTORY OF THE CHRISTIAN RELIGION, WOMEN HAVE BEEN FOUND AMONG THE MOST LOYAL AND ARDENT FOLLOWERS OF CHRIST. THE LADIES AUXILIARY WORK AFFORDS OPPORTUNITY FOR WOMEN TO LEND A HELPING HAND IN CARRYING OUT JESUS COMMAND "GO YE INTO ALL THE WORLD."

A MOTION WAS MADE TO PAY THE CLERK \$15.00 AND \$10.00 WAS GIVEN TO

D. F. PELT FOR HIS EXPENSES TO THE NATIONAL ASSOCIATION. THERE WAS 12 CHURCHES IN THE ASSOCIATION. EVERGREEN HAD THE LARGEST ATTENDANCE WITH 229 MEMBERS. BRO. G. W. NOBLES WAS PASTOR.

ON THE FRIDAY BEFORE THE 3RD SUNDAY IN OCTOBER THE SOUTHEASTERN ASSOCIATION OF FWB CONVENED AT SARDIS CHURCH FOR THE 68TH ANNUAL SESSION. THIS WAS IN THE YEAR 1946. REV. D. F. PELT WAS MODERATOR. J. L. STOKES WAS TREASURER.

ON SATURDAY MORNING THE SONG SERVICE WAS LED BY BRO. LONG STOKES. BRO. HUMAN HAD THE DEVOTION FOR THE MORNING AND BRO. PELT IN THE AFTER-NOON.

A MOTION WAS CARRIED TO SELL JAMES CHAPEL CHURCH AND TO PROCEEDS TO BE DONATED TO HOLMES NEW CHURCH.

THERE WAS 14 CHURCHES IN THE ASSOCIATION. THEY WERE: CHESTER CHAPEL, EVERGREEN, FRIENDSHIP, GOODWATER, HOLMES, MT. ZION, NEW PROSPECT, NEW ZION, PLEASANT HILL, SARDIS, UNION GROVE, HICKORY GROVE, JUDSON AND PILGRIM REST.

EVERGREEN STILL HAD THE LARGEST MEMBERSHIP 239 MEMBERS.

ON FRIDAY BEFORE THE 3RD SUNDAY IN OCTOBER 1947 THE SE ASSOCIATION OF FWB CONVENED AT UNION GROVE CHURCH FOR THE 69TH ANNUAL SESSION. REV. D. F. PELT, MODERATOR; LUCILLE BODIFORD, CLERK AND J. LONG STOKES, TREASURER. THE THEME FOR THIS SERVICE WAS CHRISTIANITY WILL NEVER END.

THE OFFICERS WERE; MODERATOR, BRO. D. F. PELT; CLERK, LUCILLE BODIFORD; TREASURER, LINNIE J. STOKES. THERE WERE 14 CHURCHES IN THE ASSOCIATION.

THE FINANCIAL REPORT WAS GIVEN BY LINNIE J. STOKES, TREASURER FOR 1948 AND THERE WAS A BALANCE OF \$31.94.

THE FOLLOWING INFORMATION WAS GIVEN ON BRO. J. LONG STOKES.

HUEY P. LONG, MODERATOR; BRO. JOHN GOLDEN, VICE-MODERATOR; EVELYN SUTTON. CLERK AND GENE CARR, TREASURER.

THERE WERE 13 CHURCHES IN THE ASSOCIATION. THE TOTAL MEMBERSHIP WAS 1,147. THERE WERE 4 LEAGUES, 9 SUNDAY SCHOOLS AND 5 LADIES' AUXILIARIES.

THE EIGHTIETH ANNUAL SESSION OF THE SE FWB ASSOCIATION CONVENED WITH UNION GROVE AND NEW ZION CHURCHES FRIDAY AND SATURDAY BEFORE THE THIRD SUNDAY IN OCTOBER 1958. THE OFFICERS WERE; BRO. PAUL MALLORY, MODERATOR; BRO. DURWOOD ADKINSON, VICE-MODERATOR; EVELYN SUTTON, CLERK AND GENE CARR, TREASURER. NEW ZION HAD THE LARGEST MEMBERSHIP WITH 117 IN SUNDAY SCHOOL. REV. PAUL MALLORY WAS THE PASTOR.

DURING THE SESSION THE SPECIAL FINANCE COMMITTEE RECOMMENDED THAT THE MODERATOR BE PAID \$10.00 FOR HIS EXPENSES AND THE CLERK \$35.00 FOR PREPARING THE MANUSCRIPT. THE CHURCHES WERE TO BE RESPONSIBLE FOR ALL EXPENSES IN PREPARING THE PROGRAM.

THE EIGHTY SECOND ANNUAL SESSION OF THE SE FWB ASSOCIATION BEGAN THE 60'S BY MEETING WITH NW PROSPECT CHURCH AND SARDIS CHURCH IN OCTOBER 1960. THE OFFICERS WERE REV. DURWOOD ADKINSON, MODERATOR; REV. W. T. HUTTO, VICE-MODERATOR; EVELYN SUTTON, CLERK AND GENE CARR, TREASURER. NEW ZION HAD THE LARGEST SUNDAY SCHOOL ENROLLMENT WITH 100.

THE EIGHTY NINTH ANNUAL SESSION OF THE SE FWB ASSOCIATION WAS AT HICKORY GROVE AND GOODWATER CHURCHES ON OCTOBER 13 AND 14, 1967. OFFICERS WERE PAUL MALLORY, MODERATOR; DURWOOD ADKINSON, VICE-MODERATOR; KATE PALMER, CLERK AND LOWELL VICKERS, TREASURER.

THE NINETY FIRST ANNUAL SESSION OF THE SE FWB ASSOCIATION MET WITH PLEASANT HILL AND UNION GROVE CHURCHES ON FRIDAY AND SATURDAY BEFORE THE THIRD SUNDAY IN OCTOBER 1969. OFFICERS WERE; BRO. JAMES FRANKLIN, MODERATOR; BRO. THOMAS KIRKLAND, VICE-MODERATOR; ALETHA DEESE, CLERK AND CHESTER CALHOUN, TREASURER.

THE 70'S BEGAN WITH THE NINETY SECOND ANNUAL SESSION OF THE SE FWB ASSOCIATION WITH THE OFFICERS BEING; BRO. FAUL MALLORY, MODERATOR; BRO. THOMAS KIRKLAND, VICE-MODERATOR; MRS. ALETHA DEESE, CLERK AND MR. CHESTER CALHOUN, TREASURER. THERE WERE 14 CHURCHES IN THE ASSOCIATION AT THIS TIME.

THE EXAMINING AND CREDENTIALS COMMITTEE RECOMMENDED THAT THE AS-SOCIATION APPROVE THE REQUEST OF MOUNT ZION FOR THE ORDINATION OF BRO. CLARENCE CULPEPPER. BRO. WILLIAM WALTER BUSH WAS ALSO RECOMMENDED FOR ORDINATION TO THE GOSPEL MINISTRY.

REV. CHARLES CRADDOCK MADE A MOTION AT THE DISTRICT SUNDAY SCHOOL AND CHURCH TRAINING SERVICE WHICH WAS HELD ON MARCH 29, 1970, THAT A YOUNG PEOPLE FELLOWSHIP RALLY BE STARTED. THIS WAS SECONDED AND CARRIED.

PROBABLY THE OLDEST FREE WILL BAPTIST CHURCH IN THIS AREA IS THE NEW HOPE CHURCH WHICH WAS ORGANIZED IN 1860. THE FIRST FREE WILL BAPTIST CHURCH OF DOTHAN (PROSPECT) ORGANIZED IN 1867 IS PROBABLY THE SECOND OLDEST. NEW PROSPECT WAS ORGANIZED IN 1875, PLEASANT HILL IN 1876, UNION GROVE IN 1879, EVERGREEN IN 1889. THE EXACT DATE OF THE ORGANIZATION OF GOODWATER SPRINGS CHURCH IS UNKNOWN, BUT THE DEED TO THE PRESENT SITE OF GOODWATER WAS DATED 1890. SARDIS WAS ORGANIZED ON JUNE 10, 1906 BY W. M. SHIRLEY AND C. C. MARTIN. CHESTER CHAPEL WAS ORGANIZED IN 1915.

IT HAS BEEN A PLEASURE FOR THE GOODWATER FREE WILL BAPTIST CHURCH TO HOST THE 100TH ANNUAL SESSION OF THE SOUTHEASTERN ASSOCIATION OF FWB. IT HAS ALSO BEEN A PLEASURE FOR THE YOUNG PEOPLE OF THE GOODWATER CHURCH TO PRESENT YOU WITH THIS PROGRAM OF MUSIC AND A BIT OF INTEREST OF THINGS THAT HAVE HAPPENED OVER THE PAST 100 YEARS IN OUR ASSOCIATION.

# CONSTITUTION AND BY-LAWS OF THE SOUTHEASTERN ASSOCIATION OF FREE WILL BAFTIST CHURCHES

#### PREAMBLE:

IN ORDER TO ENCOURAGE AND INSPIRE THE CHURCHES OF THE ASSOCIATION TO ENGAGE IN A MORE DEFINITE PLAN OF WORK, TO LABOR TOGETHER IN UNITY AND TO CO-ORDINATE THEIR EFFORTS FOR A GREATER PROGRAM TO CHRIST AND HIS KINGDOM, WE DO HEREBY ADOPT THIS CONSTITUTION AND BY-LAWS.

#### CONSTITUTION:

ARTICLE 1. NAME - THIS ORGANIZATION SHALL BE KNOWN AS THE SOUTH-EASTERN ASSOCIATION OF FREE WILL BAPTIST CHURCHES.

ARTICLE 2. OFFICERS - THE OFFICERS OF THIS ASSOCIATION SHALL BE A MODERATOR, AN ASSISTANT MODERATOR, A CLERK AND A TREASURER AND AN ASSISTANT CLERK AND TREASURER. THE OFFICES OF CLERK AND TREASURER MAY BE COMBINED.

ARTICLE 3. MEMBERSHIP - THIS ASSOCIATION SHALL BE COMPOSED OF CHURCHES IN GOOD STANDING ACCORDING TO THE FAITH AND PRACTICES OF THE TREATISE OF THE NATIONAL ASSOCIATION OF FREE WILL BAPTIST.

SECTION 1. CHURCHES DESIRING MEMBERSHIP IN THIS ASSOCIATION SHALL SEND DELEGATES BEARING A PETITIONARY LETTER. IF THE ABOVE CHURCH(ES), UPON EXAMINATION BY THE CREDENTIALS AND EXAMINING COMMITTEE, ARE FOUND TO BE IN ORDER AND PROPERLY ORGANIZED AS SPECIFIED IN THE TREATISE, THEY SHALL, BY VOTE OF THIS BODY, BE RECEIVED IN FULL FELLOWSHIP.

SECTION 2. ALL CHURCHES OF THIS ASSOCIATION ARE EXPECTED TO REQUIRE THEIR PASTOR TO BE A MEMBER OF THE CHURCH CONGREGATION WHICH HE SERVES, UNLESS HE PASTORS MORE THAN ONE CHURCH, THEN HE MUST BE A MEMBER OF ONE OF THE CHURCHES HE SERVES. ALL CHURCHES ARE EXPECTED TO REQUIRE THEIR PASTOR TO PETITION FOR MEMBERSHIP INTO THIS ASSOCIATION UPON JOINING HIMSELF WITH THE CHURCH HE IS PASTORING IN THIS ASSOCIATION.

SECTION 3. ACCEPTANCE ON MINISTERS INTO THIS ASSOCIATION. NO MINISTER SHALL HAVE ANY VOTE NOR HOLD ANY OFFICE TIL ONE OF THE FOLLOWING AFFLIES.

A. MINISTERS COMING FROM ANOTHER ASSOCIATION MUST RECEIVE A WRITTEN RECOMMENDATION FROM THE ASSOCIATION FROM WHICH HE COMES, IN GOOD STANDING, OR, UPON RECOMMENDATION OF THE CREDENTIALS AND EXAMINING COMMITTEE, BE PUT UNDER THE WATCH CARE OF THE ASSOCIATION FOR A PERIOD OF TIME, (NOT TO EXCEED ONE (1) YEAR). MINISTERS ARE EXPECTED TO REQUEST MEMBERSHIP IN THIS ASSOCIATION ON BECOMING A MEMBER OF THE CHURCH HE IS PASTORING WITH SUCH REQUEST COMING NO LATER THAN THE SECOND MEETING OF THE ASSOCIATION FOLLOWING HIS ACCEPTANCE OF A PASTORATE IN THIS ASSOCIATION. FAILURE BY A MINISTER TO REQUEST MEMBERSHIP IN THIS BODY WILL RESULT IN THE PASTOR BEING OUT OF FELLOWSHIP WITH THIS BODY.

B. MINISTERS COMING FROM AN INDEPENDENT CHURCH OR ANOTHER DENOMINATION MUST UNITE WITH A CHURCH IN THIS ASSOCIATION AND THE CHURCH HE UNITES WITH REQUEST THE ASSOCIATION'S CREDENTIALS AND EXAMINING COMMITTEE TO EXAMINE HIM ACCORDING TO THE HOLY SCRIPTURES AND THE FAITH AND PRACTICES IN THE TREATISE OF THE FREE WILL BAPTIST. THIS COMMITTEE SHALL THEN MAKE THEIR RECOMMENDATION TO THE ASSOCIATION FOR A VOTE OF THE DELEGATES. THE CHURCH INVOLVED IS EXPECTED TO REQUEST SUCH AN EXAMINATION WITHIN THREE (3) MONTHS AFTER THE PASTOR UNITES WITH THE CHURCH.

- C. NO MINISTER OR DEACON SHALL BE A MEMBER OF THIS ASSOCIATION WHOSE MEMBERSHIP IS OUTSIDE THE ASSOCIATION.
- D. MINISTERS OR DEACONS SHALL NOT HAVE MORE THAN ONE LIVING WIFE; LIKE-WISE, A MINISTER OR DEACON'S WIFE MAY NOT HAVE MORE THAN ONE LIVING HUSBAND. MINISTERS AND DEACONS MUST BELIEVE AND PRACTICE FREE WILL BAPTIST DOCTRINE.

ARTICLE 4. REPRESENTATION - EACH CHURCH IS EXPECTED TO BE REPRESENTED AT THE QUARTERLY AND ANNUAL SESSIONS.

SECTION 1. EACH CHURCH SHALL BE REPRESENTED AT THE QUARTERLY AND ANNUAL SESSIONS OF THE ASSOCIATION BY A PROPORTIONATE NUMBER OF DELEGATES, BASED ON THE SIZE OF THE ACTIVE CHURCH MEMBERSHIP. THE FIRST FIFTY (50) MEMBERS ENTITLES A CHURCH TO THREE (3) DELEGATES AND ONE (1) ADDITIONAL DELEGATE FOR EACH TWENTY FIVE (25) MEMBERS OR PART THEREOF: AS GIVEN IN THE MINUTES OF THE PREVIOUS ANNUAL MEETING.

SECTION 2. STANDING DELEGATES - ALL ORDAINED MINISTERS AND ORDAINED DEACONS WHO ARE MEMBERS IN GOOD STANDING IN THE ASSOCIATION SHALL BE A STANDING DELEGATE.

SECTION 3. SEATING OF DELEGATES - IN ORDER FOR DELEGATES TO BE SEATED AT ANY SESSION OF THE ASSOCIATION AS A DELEGATE SUCH MEMBER MUST HAVE BEEN ELECTED BY THEIR HOME CHURCH TO SERVE IN SUCH CAPACITY. DELEGATE NAMES MUST APPEAR ON THE CHURCH LETTER BEING PRESENTED ALONG WITH A LIST OF ALTERNATES WHO MAY SERVE IN THE ABSENCE OF DULY ELECTED DELEGATES. EACH CHURCH SHOULD USE ONE OF TWO METHODS IN SENDING DELEGATES/ALTERNATES.

A. A CHURCH MAY USE THE DIRECT DELEGATE/ALTERNATE METHOD WHEREBY A ALTERNATE IS ELECTED TO SERVE IN THE ABSENCE OF A SPECIFIED DELEGATE; I.E., JOHN SERVES FOR JOE.

B. A LIST OF DELEGATES AND A LIST OF ALTERNATES IS SUBMITTED ON THE CHURCH LETTER AND IN THE ABSENCE OF A DELEGATE THE FIRST ALTERNATE NAME CALLED WOULD MOVE UP TO SERVE AS THAT DELEGATE. EACH TIME A DELEGATE NAME CALLED AND NOT ANSWERED THE ALTERNATE LIST WOULD BE READ UNTIL ANSWERED AND THAT PERSON WOULD MOVE UP TO SERVE. THIS WOULD CONTINUE UNTIL ALL DELEGATES HAD ANSWERED OR AN ALTERNATE HAD MOVED UP TO SERVE OR UNTIL BOTH LIST HAD BEEN EXHAUSTED, IN WHICH CASE THE CHURCH WOULD THEN BE REPRESENTED BY THAT NUMBER ANSWERING THE ROLL CALL OF DELEGATES.

NO PERSON MAY BE APPOINTED BY A PASTOR OR ANOTHER CHURCH MEMBER WHILE AT THE ASSOCIATION. ALL DELEGATES BEING RECOGNIZED AND SEATED MUST HAVE BEEN ELECTED BY THEIR HOME CHURCH AND NAMES MUST PROPERLY APPEAR ON THE CHURCH LETTER BEING PRESENTED.

SECTION 4. REPRESENTATION FEES SHALL BE FIVE DOLLARS (\$5.00) PER DELEGATE FOR THE FIRST, SECOND AND THIRD QUARTERLY SESSIONS AND TEN DOLLARS (\$10.00) PER DELEGATE AT THE ANNUAL SESSION.

SECTION 5. IT IS HEREBY REQUESTED THAT ALL CHURCHES REGULARLY CONTRIBUTE TO EACH SESSION OF THE ASSOCIATION A SUM OF FIFTY CENTS (\$.50) PER ACTIVE MEMBER TO BE USED BY THE ASSOCIATION FOR LOCAL CAUSES AND ANY OTHER NEED THE ASSOCIATION MAY DETERMINE WHILE IT IS CONVENED IN REGULAR SESSION AND ANY MOTION SHALL PROPERLY COME BEFORE THIS BODY. THE ANNUAL SESSION IS CONSIDERED AS ONE.

SECTION 6. FUNDS RECEIVED AS SET FORTH IN SECTION 5 ABOVE SHALL BE RETAINED FOR LOCAL CAUSES AND ARE NOT SUBJECT TO DISTRIBUTION AS OTHER FUNDS AS PROVIDED FOR IN ARTICLE 6, SECTIONS 2 THROUGH 5 OF THE BY-LAWS TO THE CONSTITUTION.

SECTION 7. MEMBER CHURCH ATTENDANCE - ALL OUR SISTER CHURCHES WHO ARE

MEMBERS IN GOOD STANDING WITH THIS ASSOCIATION IS EXPECTED TO BE REPRESENTED BY LETTER AND DELEGATES AT EACH SESSION OF THE ASSOCIATION.

ARTICLE 5. COMMITTEES - ALL COMMITTEES SHALL BE SUBJECT TO THE ASSOCIATION FOR APPROVAL OR DISAFPROVAL VOTE ON THEIR ACTIONS, EXCEPT THE EXECUTIVE COMMITTEE, THE CHRISTIAN BOARD OF EDUCATION UNDER AUTHORITY GRANTED AT SECTION 3 - PARAGRAPH B AND THE CREDENTIALS AND EXAMINING COMMITTEE AT SECTION 2 - PARAGRAPHS E AND F. ALL COMMITTEES SHALL GIVE A REPORT OF THEIR ACTIONS AT EACH ASSOCIATIONAL SESSION. EACH COMMITTEE SHALL HAVE ONE OR MORE OF ITS MEMBERS COMING UP FOR ELECTION OR RE-ELECTION EACH ANNUAL SESSION OF THIS ASSOCIATION; EXCEPT THE EXECUTIVE COMMITTEE.

SECTION 1. EXECUTIVE COMMITTEE - THE EXECUTIVE COMMITTEE SHALL BE COMPOSED OF THE MODERATOR, VICE MODERATOR, CLERK/TREASURER, ALL ORDAINED MINISTERS WHO ARE IN GOOD STANDING WITH THIS BODY AND WHO ARE PASTORING CHURCHES IN THIS ASSOCIATION AND ONE MEMBER ELECTED BY AND FROM EACH CHURCH IN GOOD STANDING IN THE ASSOCIATION. THE DUTIES ARE:

- A. TO ACT FOR THE ASSOCIATION OF CHURCHES WHEN IT IS NOT IN SESSION ON THINGS THAT CANNOT WAIT UNTIL THE ASSOCIATION IS IN REGULAR SESSION.
- B. TO PLAN AND ARRANGE THE YEARS PROGRAM FOR ALL SESSIONS OF THE ASSOC-IATION.
- C. TO ACT AS THE PROMOTIONAL AGENCY FOR THE VARIOUS WORK OF THE ASSOC-
- D. THIS COMMITTEE SHALL BE CALLED INTO SESSION WHEN NECESSARY BY THE MODERATOR. OR IN HIS ABSENCE, THE VICE MODERATOR.

SECTION 2. CREDENTIALS AND EXAMINING COMMITTEE - ALL MEMBERS OF THIS COMMITTEE SHALL BE FROM THE ORDAINED AUTHORITY IN GOOD STANDING WITH THIS ASSOCIATION. THIS BOARD SHALL CONSIST OF SEVEN (7) MEMBERS ELECTED BY THE ASSOCIATION WHILE IN SESSION. MEMBERS SHALL BE ELECTED AS FOLLOWS: ONE FOR FOUR (4) YEARS, TWO (2) FOR THREE (3) YEARS, TWO FOR TWO (2) YEARS AND TWO (2) FOR ONE (1) YEAR. ALL MEMBERS SHALL BE ELECTED AT THE ANNUAL SESSION, HOWEVER, SHOULD THE NEED ARISE FOR A MEMBER TO BE REPLACED FOR ANY REASON THE ASSOCIATION MAY DO SO AT ANY QUARTERLY SESSION. RECOMMENDATION FOR REPLACEMENT MAY COME FROM THE NOMINATING COMMITTEE AND/OR FROM THE DELEGATES ON THE FLOOR. THE DUTIES OF THIS COMMITTEE SHALL BE:

- A. TO EXAMINE ALL CHURCH LETTERS AND PRESENT RECOMMENDATION TO THE ASSOCIATION AS TO ORDER AND SEATING OF THE DELEGATES.
- B. TO EXAMINE ALL CANDIDATES FOR LICENSING TO THE MINISTRY AT THE REQUEST OF THE LOCAL CHURCH, EITHER AT THE ASSOCIATION OR AT THE LOCAL CHURCH BY REQUEST OF THE PASTOR AND CHURCH MEMBERSHIP. IF REQUESTED BY A LOCAL CHURCH TO EXAMINE A CANDIDATE FOR THE MINISTRY WHILE THE ASSOCIATION IS NOT IN SESSION, THIS COMMITTEE MAY, BY A 3/4 MARGIN, (5), MEMBER MAJORITY EXAMINE SUCH CANDIDATE AND MAKES ITS RECOMMENDATION TO THE LOCAL PASTOR AND CHURCH. THIS COMMITTEE SHALL REPORT ANY SUCH ACTION TO THE NEXT ASSOCIATIONAL MEETING.
- C. TO EXAMINE ALL CANDIDATES FOR ORDINATION INTO THE MINISTRY AND OF DEACONSHIP AT THE REQUEST OF THE LOCAL CHURCH. REQUIREMENTS FOR BEING ORDAINED BEING THAT SAID CANDIDATE MUST SHOW AND HAVE SHOWN FRUITS EVIDENCING A BORN AGAIN CHRISTIAN CONDUCT. MINISTERS AND DEACON CANDIDATES SHALL BE GIVEN AN ORAL AND WRITTEN EXAMINATION. THIS EXAMINATION SHALL INCLUDE, BUT NOT LIMITED TO: (A) THE HOLY SCRIPTURES (B) THE FAITH AND PRACTICE OF FREE WILL BAPTIST AND (C) MORAL CHARACTER AND INTEGRITY. THE WRITTEN EXAMINATION FORM SHALL BE FURNISHED BY THIS COMMITTEE.
- D. TO EXAMINE MINISTERS MAKING REQUEST FOR MEMBERSHIP IN THIS ASSOCIATION WHO ARE COMING FROM ANOTHER ASSOCIATION, OTHER DENOMINATIONS, INDEPENDENT CHURCHES OR FROM A LICENSED POSITION TO ORDAINED REQUEST. ALL

SUCH CANDIDATES SHALL BE GIVEN AN ORAL EXAMINATION AND AT THE DISCRETION OF THE CREDENTIALS COMMITTEE A WRITTEN EXAMINATION WILL BE GIVEN.

E. BY A 3/4 MAJORITY, (5), THIS COMMITTEE MAY GRANT A LETTER OF DISMISSAL TO ANY MINISTER LEAVING THIS ASSOCIATION AND GOING TO ANOTHER ASSOCIATION DURING THE TIME THIS ASSOCIATION IS NOT IN SESSION; PROVIDING THERE ARE NO CHARGES FILED AGAINST THE MINISTER BY THE CHURCH HE IS LEAVING, OR THERE IS NO OTHER REASON KNOWN TO THIS COMMITTEE, EITHER SPIRITUAL OR MORAL, THAT THE LETTER WOULD BE GRANTED WERE THIS BODY IN SESSION. ANY SUCH ACTION SHALL BE REPORTED TO THE ASSOCIATION AT THE NEXT REGULAR SCHEDULED MEETING.

SECTION 3. BOARD OF CHRISTIAN EDUCATION - THERE SHALL BE A CHRISTIAN BOARD OF EDUCATION CONSISTING OF THREE (3) MEMBERS ELECTED TO TERMS OF ONE (1) FOR THREE (3) YEARS, ONE (1) FOR TWO (2) YEARS AND ONE (1) FOR ONE (1) YEAR. THE DUTIES ARE:

- A. TO ORGANIZE, PLAN AND SUPERVISE THE YOUTH RALLIES, CTS COMPETITION, SUNDAY SCHOOL PROMOTION AND SUMMER CAMPS FOR THE ASSOCIATION.
- B. THE CHRISTIAN EDUCATION COMMITTEE SHALL RECOMMEND TO THE ASSOCIATION A CAMP DIRECTOR AT THE ANNUAL SESSION TO BE ELECTED BY A VOTE OF THE DELEGATES. THIS COMMITTEE AND THE CAMP DIRECTOR SHALL BE AUTHORIZED TO MAKE COMPLETE ARRANGEMENTS, INCLUDING A PLACE FOR SUMMER CAMP. THIS AUTHORIZATION IS AN EXCEPTION TO ARTICLE FIVE (5) PERTAINING TO A VOTE BY THE ASSOCIATION ON COMMITTEE ACTIONS.
  - · C. TO PROMOTE THE BIBLE COLLEGE AND THE EDUCATION OF OUR PEOPLE.

SECTION 4. MISSIONS COMMITTEE - THERE SHALL BE A MISSIONS COMMITTEE CONSISTENT OF THREE (3) MEMBERS ELECTED TO TERMS OF ONE (1) FOR THREE (3) YEARS, ONE (1) FOR TWO (2) YEARS AND ONE (1) FOR ONE (1) YEAR. THE DUTIES ARE:

- A. TO PROMOTE MISSION WORK IN THIS ASSOCIATION.
- B. TO CO-ORDINATE THE NEEDS OF OUR MISSIONARIES (HOME AND FOREIGN) TO EACH OF OUR CHURCHES IN THIS ASSOCIATION, TO PLAN, ORGANIZE AND SUPERVISE MISSION WORK; (RETREAT, CONFERENCE, AND ETC.), IN THE ASSOCIATION.

SECTION 5. CHILDREN HOME COMMITTEE - THERE SHALL BE A CHILDREN HOME COMMITTEE CONSISTING OF THREE (3) MEMBERS ELECTED TO TERMS OF ONE (1) FOR THREE (3) YEARS, ONE (1) FOR TWO (2) YEARS AND ONE (1) FOR ONE (1) YEAR. THE BOARD MEMBER OF THE CHILDREN HOME SHALL BE ELECTED BY THE ASSOCIATION WHILE IN ANNUAL SESSION. THE DUTIES ARE:

A. TO CO-ORDINATE EFFORTS TO RELIEVE THE STRAIN ON THE CHILDREN HOME AND THE ASSOCIATION INFORMED OF THE HOME.

SECTION 6. FINANCE COMMITTEE - THERE SHALL BE A FINANCE COMMITTEE CONSISTING OF THREE (3) MEMBERS ELECTED TO TERMS OF ONE (1) FOR THREE (3) YEARS, ONE (1) FOR TWO (2) YEARS AND ONE (1) FOR ONE (1) YEAR. THE TREASURER SHALL SIT IN THIS COMMITTEE AT THEIR REQUEST, BUT HAVE NO VOTE ON THIS COMMITTEE. THE DUTIES ARE:

- A. THIS COMMITTEE IS TO WORK WITH THE TREASURER IN WORKING UP A BUDGET FOR THE DISTRIBUTIONS OF THE MONIES FOR THE ASSOCIATION. THE BUDGET WILL BE PRESENTED AT THE ANNUAL SESSION FOR APPROVAL.
- B. RECOMMEND DISTRIBUTION OF THE FLATE OFFERINGS FROM EACH SESSION OF THE ASSOCIATION.

SECTION 7. PLACEMENT COMMITTEE - THERE SHALL BE A PLACEMENT COMMITTEE CONSISTING OF THREE (3) MEMBERS ELECTED TO TERMS OF ONE (1) FOR THREE (3) YEARS, ONE (1) FOR TWO (2) YEARS AND ONE (1) FOR ONE (1) YEAR. THE DUTIES ARE:

A. TO CO-ORDINATE THE PLACES TO HOLD THE QUARTERLY AND ANNUAL SESSIONS OF EACH ASSOCIATIONAL YEAR.

SECTION 8. NOMINATING COMMITTEE - THERE SHALL BE A NOMINATING COMMITTEE CONSISTING OF THREE MEMBERS ELECTED TO TERMS OF ONE (1) FOR THREE (3) YEARS, ONE (1) FOR TWO (2) YEARS AND ONE (1) FOR ONE (1) YEAR. THE DUTIES ARE:

A. TO MAKE NOMINATIONS TO FILL VACANCIES ON THE VARIOUS BOARDS. TO NOMINATE ASSOCIATIONAL OFFICERS AND SUCH OTHER ACTIONS AS MAY COME BEFORE THIS COMMITTEE.

SECTION 9. ANY MEMBER OF THE ABOVE COMMITTEES THAT FAILS TO CO-OPERATE WITH THE COMMITTEE FOR A PERIOD OF ONE YEAR, MAY, UPON THE RECOMMENDATION OF THE COMMITTEE, BE REPLACED BY THE ASSOCIATION.

ARTICLE 6. INDEPENDENCE OF CHURCHES - EACH CHURCH OF THIS ASSOCIATION IS AS DISTINCT AND INDEPENDENT ORGANIZATION WITH FULL AND ABSOLUTE AUTHORITY TO MANAGE ITS OWN INTERNAL AFFAIRS, TO ELECT IT'S PASTOR, OFFICERS AND TO RECEIVE AND DISMISS MEMBERS.

SECTION 1. EACH CHURCH OF THIS ASSOCIATION SHALL HAVE, HOLD AND CONTROL IT'S PROPERTY. REAL AND OTHERWISE.

SECTION 2. THE ASSOCIATION HOLDS NO AUTHORITY OVER OR IN THE MEMBER CHURCHES. IT IS ONLY A VEHICLE THROUGH WHICH MEMBER CHURCHES FELLOWSHIP, WORK AND CO-OFERATE IN ALL THINGS WHICH TEND TO PROMOTE AND ADVANCE THE CAUSE OF CHRIST AND THE FREE WILL BAPTIST FAITH IN GOD'S KINGDOM.

SECTION 3. DISCIPLINE - THIS ASSOCIATION SHALL ACT ONLY IN AN ADVISORY CAPACITY. SHOULD THERE ARISE IN THE LOCAL CHURCH ANY QUESTION IN DOCTRINE, PRACTICES OR DISCIPLINE, THE BIBLE AND THE TREATISE OF THE FAITH AND PRACTICES OF FREE WILL BAPTIST SHALL BE CONSIDERED THE FINAL AUTHORITY. HOWEVER, IF SAID CHURCH(ES) FAIL TO COMPLY WITH SAME, THIS BODY, WHEN IN SESSION, MAY, BY MAJORITY VOTE OF THE DELEGATES PRESENT, WITHDRAW THE HAND OF FELLOWSHIP FROM SAID CHURCH(ES) UNTIL SUCH TIME THAT THEY HAVE SET THEIR HOUSE IN ORDER.

ARTICLE 7. MEETINGS - THE ASSOCIATION SHALL MEET IN QUARTERLY SESSIONS ON SATURDAY BEFORE THE THIRD (3RD.) SUNDAY IN JANUARY, APRIL AND JULY. THE ANNUAL SESSION SHALL MEET ON FRIDAY NIGHT FROM 7:00 PM UNTIL 9:00 PM AND ON SATURDAY BEFORE THE THIRD (3RD) SUNDAY IN OCTOBER.

SECTION 1. ROBERT'S RULES OF ORDER SHALL BE USED AS A GUIDE IN ALL BUSINESS TRANSACTIONS AND PARLIMENTARY USAGES.

ARTICLE 8. QUORUM - THIRTY (30) DELEGATES FROM SIX (6) OR MORE CHURCHES OF THIS ASSOCIATION SHALL CONSTITUTE A QUORUM. A LESSER NUMBER MAY ADJOURN UNTIL SUCH A CUORUM IS PRESENT.

## BY-LAWS TO THE CONSTITUTION OF THE SOUTHEASTERN ASSOCIATION OF FREE WILL BAPTIST

ARTICLE 1. DUTIES OF ASSOCIATION OFFICERS.

SECTION 1. MODERATOR - THE MODERATOR SHALL PRESIDE OVER ALL MEETINGS OF THE ASSOCIATION, APPOINT TEMPORARY COMMITTEES AND CALL THE MEMBERS OF THE EXECUTIVE COMMITTEE TOGETHER WHEN NECESSARY.

SECTION 2. VICE MODERATOR - THE VICE MODERATOR SHALL PRESIDE OVER THE MEETINGS OF THE ASSOCIATION IN THE ABSENCE OF THE MODERATOR. HE SHALL ASSIST THE MODERATOR IN THE GENERAL WORK OF THE ASSOCIATION.

SECTION 3. CLERK - THE CLERK SHALL RECORD THE PROCEEDINGS OF THE QUARTERLY AND ANNUAL SESSIONS OF THE ASSOCIATION AND OF THE EXECUTIVE COMMITTEE AND SHALL HAVE THEM EDITED AND PRINTED INTO ANNUAL MINUTES. CLERK SHALL TURN ALL RECORDS OF THE ASSOCIATION OVER TO HIS/HER SUCCESSOR IN OFFICE. THE CLERK SHALL ALSO MAINTAIN A CURRENT FILE ON ALL THE MINISTERS IN THE ASSOCIATION WHO DESIRE TO SUBMIT THE INFORMATION AS TO THEIR AVAILABILITY FOR PASTOR AND TYPE OF PASTORATE DESIRED, WILLINGNESS TO RELOCATE AND SO FORTH. THIS WILL BE AN INFORMATION FILE ONLY AND SHALL BE STRICTLY CONFIDENTIAL AND THE INFORMATION RELEASED TO OTHER CHURCHES ONLY WITH THE PRIOR APPROVAL OF THE MINISTER SUBMITTING THE INFORMATION. A FORM WILL BE PROVIDED BY THE CLERK TO EACH MINISTER IN THE ASSOCIATION FOR HIS USE AND ALSO THE CLERK WILL REPORT TO EACH MINISTER, UPON HIS REQUEST, ANY CHURCHES SEEKING A PASTOR.

SECTION 4. TREASURER - THE TREASURER SHALL HAVE CHARGE OF ALL ASSOCIATION FUNDS. TREASURER SHALL KEEP A RECORD OF ALL MONIES RECEIVED AND PAID OUT BY THE ASSOCIATION. TREASURER SHALL DISTRIBUTE FUNDS AT THE DIRECTION OF THE ASSOCIATION WHILE IN SESSION OR EXECUTIVE COMMITTEE BY A MAJORITY PRESENT. TREASURER SHALL TURN ALL RECORDS OF THE ASSOCIATION OVER TO HIS/HER SUCCESSOR IN OFFICE.

SECTION 5. PROVISION FOR MODERATOR - IN CASE OF THE ABSENCE OF BOTH THE MODERATOR AND VICE MODERATOR, THE SENIOR MINISTER OF THE STANDING DELEGATES SHALL ACT IN THAT CAPACITY.

ARTICLE 2. REPORTS.

SECTION 1. EACH CHURCH IS EXPECTED TO SEND QUARTERLY AND ANNUAL REPORTS OF PROGRESS ON FORMS FURNISHED BY THE ASSOCIATION.

SECTION 2. THE CLERK OF THE ASSOCIATION SHALL PREPARE AN ASSOCIATIONAL REPORT TO THE ALABAMA STATE ASSOCIATION OF FREE WILL BAPTIST CHURCHES.

ARTICLE 3. STANDING DELEGATES - ALL ORDAINED MINISTERS AND ORDAINED DEACONS WHO ARE MEMBERS IN GOOD STANDING OF CHURCHES AFFILIATED WITH THIS ASSOCIATION SHALL BE STANDING DELEGATES.

ARTICLE 4. OFFICERS - ALL OFFICERS SHALL BE ELECTED ANNUALLY AND NO FERSON SHALL BE DISQUALIFIED FOR RE-ELECTION BECAUSE OF HAVING SERVED IN OFFICE THE PREVIOUS YEAR.

ARTICLE 5. USE OF FUNDS.

SECTION 1. FUNDS OF THIS ASSOCIATION SHALL BE USED TO PAY FOR THE PRINTING OF THE ANNUAL MINUTES AND FOR SUCH PURPOSES AS DESIGNATED IN THE APPROVED BUDGET AND AS OTHERWISE SET FORTH BY THIS BODY WHILE IN SESSION.

SECTION 2. THE ASSOCIATION SHALL SUPPORT HOME AND FOREIGN MISSIONS, THE BIBLE COLLEGE IN NASHVILLE, TN., THE CHILDREN HOME IN ELDRIDGE, AL. AND THE SUPERANNUATION OF OUR OLDER MINISTERS.

SECTION 3. THE ASSOCIATION SHALL OPERATE ACCORDING TO THE BUDGET AS PRESENTED AND APPROVED AT THE ANNUAL SESSION OF THIS BODY.

SECTION 4. ALL PLATE OFFERINGS RECEIVED AT THE QUARTERLY AND ANNUAL SESSIONS SHALL BE DESIGNATED BY THE FINANCIAL COMMITTEE RECOMMENDATIONS AND AFFROVAL BY THIS BODY.

SECTION 5. FUNDS SHALL BE DISBURSED IN THE MANNER AS RECOMMENDED BY THE FINANCIAL COMMITTEE IN ITS ANNUAL REPORT AND AS APPROVED BY THIS BODY.

ARTICLE 6. AMENDMENTS.

SECTION 1. THIS CONSTITUTION AND THESE BY-LAWS SHALL NOT BE CHANGED OR

ALTERED EXCEPT AND ONLY BY A TWO-THIRDS (2/3) MAJORITY VOTE OF DELEGATES PRESENT FROM MEMBER CHURCHES IN ANY SESSION OF THE ASSOCIATION.

SECTION 2. ALL AMENDMENTS TO THE CONSTITUTION AND BY-LAWS SHALL BE PRESENTED IN WRITING TO ANY SESSION OF THE ASSOCIATION AND SHALL BE READ IN THE HEARING OF THOSE ASSEMBLED DELEGATES AND SHALL BE TABLED UNTIL THE NEXT SCHEDULED ASSOCIATIONAL MEETING AND THEN SHALL BE REMOVED FROM THE TABLE, READ AGAIN IN THE HEARING OF THOSE ASSEMBLED, AND THEN ACTED UPON AS DEEMED BEST BY THE ASSOCIATION.

#### RULES OF DECORUM

- 1. THE ASSOCIATION, WHEN CONVENED, SHALL BE OPENED AND CLOSED BY SINGING AND PRAYER.
- 2. ONLY ONE PERSON SHALL SPEAK AT A TIME, AND HE WILL RISE TO HIS FEET AND ADDRESS THE MODERATOR.
- 3. EACH PERSON THUS SPEAKING SHALL NOT BE INTERRUPTED IN SPEECH, EXCEPT BY THE MODERATOR, UNTIL HE GETS THROUGH; NOR SHALL THE MODERATOR INTERRUPT HIM UNLESS HE GETS OUT OF ORDER.
- 4. THE PERSON THUS SPEAKING SHALL ADHERE TO THE QUESTION AND SHALL IN NO WAY CAST REFLECTIONS ON ANY PERSON WHO MAY HAVE SPOKEN BEFORE HIM.
- 5. NO PERSON SHALL SPEAK MORE THAN THREE (3) TIMES ON THE SAME SUBJECT WITHOUT LEAVE OF THE ASSOCIATION.
- 6. NO FERSON SHALL LAUGH OR WHISPER IN TIME OF PUBLIC SPEECH.
- 7. MEMBERS SHALL ADDRESS EACH OTHER BY THE APPELLATION OF BROTHER OR BRETHERN AND SISTER(S).
- 8. NO MEMBERS OF THIS ASSOCIATION SHALL ABSENT HIMSELF WHEN THE ASSOCIATION IS SITTING IN CONFERENCE WITHOUT LEAVE OF THE MODERATOR.

9. THE NAMES OF THE MEMBERS OF THIS ASSOCIATION SHALL BE ENROLLED AND CALLED

- AS OFTEN AS THE ASSOCIATION THINKS IS NECESSARY.
- 10. NO MEMBER SHALL SPEAK LONGER THAN FIVE (5) MINUTES AT ANY ONE TIME WITHOUT LEAVE OF THE MODERATOR.

#### ARTICLES OF FAITH

- 1. THE BIBLE THE SCRIPTURE OF THE OLD AND NEW TESTAMENTS WERE GIVEN BY INSPIRATION OF GOD AND ARE OUR INFALLIBLE RULE OF FAITH AND PRACTICE.
- 2. GOD THERE IS ONE TRUE AND LIVING GOD, REVEALED IN NATURE AS THE CREATOR, PRESERVER AND RIGHTEOUS GOVERNOR OF THE UNIVERSE AND IN SCRIPTURE AS FATHER, SON AND HOLY GHOST, YET AS ONE GOD, INFINITELY WISE AND GOOD, WHOM ALL INTELLIGENT CREATURES ARE SUPREMELY TO LOVE, ADORE AND OBEY.
- G. CHRIST CHRIST IS GOD MANIFEST IN THE FLESH; IN HIS DIVINE NATURE TRULY MAN. THE MEDIATOR BETWEEN GOD AND MAN, ONCE CRUCIFIED, HE IS NOW RISEN AND GLORIFIED, AND IS OUR EVER PRESENT SAVIOUR AND LORD.
- 4. THE HOLY SPIRIT THE SCRIPTURES ASSIGN TO THE HOLY SPIRIT ALL THE ATTRIBUTES OF GOD.
- 5. THE GOVERNMENT OF GOD GOD EXERCISES A WISE AND BENEVOLENT PROVIDENCE OVER ALL THINGS BY MAINTAINING THE CONSTRUCTION AND LAWS OF NATURE. HE ALSO PLATORMS SPECIAL ACTS, NOT OTHERWISE PROVIDED FOR AS THE HIGHEST WELFARE OF MEN REQUIRE.
- 6. THE SINFULNESS OF MAN MAN WAS CREATED INNOCENT, BUT BY DISOBEDIENCE FELL INTO SIN AND CONDEMNATION. HIS POSTERITY THEREFORE INHERIT A FALLEN NATURE OF SUCH TENDENCIES THAT ALL WHO COME TO YEARS OF ACCOUNTABILITY SIN AND BECOME GUILTY BEFORE GOD.
- 7. THE WORK OF CHRIST THE SON OF MAN BY HIS INCARNATION, LIFE AND SUFFERINGS, DEATH AND RESURRECTION EFFECTED FOR ALL A REDEMPTION FROM SIN THAT IS FULL AND FREE AND IS THE GROUND OF SALVATION BY FAITH.
- 8. THE TERMS OF SALVATION THE CONDITIONS OF SALVATION ARE; (1) REPENTANCE

OR SINCERE SORROW FOR SIN AND THE HEARTY RENUNCIATION OF IT. (2) FAITH OR THE RESERVED COMMITTAL OF ONE'S SELF TO CHRIST AS SAVIOUR AND LORD WITH PURPOSE TO LOVE AND OBEY HIM IN ALL THINGS. IN THE EXERCISE OF SAVING FAITH THE SOUL IS RENEWED BY THE HOLY SPIRIT, FREED FROM THE DOMINION OF SIN AND BECOMES A CHILD OF GOD. (3) CONTINUANCE IN FAITH AND OBEDIENCE UNTIL DEATH.

9. ELECTION - GOD DETERMINED FROM THE BEGINNING TO SAVE ALL WHO SHOULD COMPLY WITH THE CONDITIONS OF SALVATION. HENCE BY FAITH MEN BECOME HIS ELECT.

- 10. FREEDOM OF THE WILL THE HUMAN WILL IS FREE AND SELF CONTROLLED, HAVING POWER TO YIELD TO THE INFLUENCE OF THE TRUTH AND THE SPIRIT; OR TO RESIST THEM AND PERISH.
- 11. SALVATION FREE GOD DESIRES THE SALVATION OF ALL, THE GOSPEL INVITES ALL, THE HOLY SPIRIT STRIVES WITH ALL, AND WHOSOEVER WILL MAY COME AND TAKE OF THE WATER OF LIFE FREELY.
- 12. PERSEVERANCE ALL BELIEVERS IN CHRIST, WHO THROUGH GRACE PERSEVERE IN HOLINESS TO THE END OF LIFE, HAVE PROMISE OF ETERNAL SALVATION.
- 13. GOSPEL ORDINANCES BAPTISM THE IMMERSION OF BELIEVERS IN WATER AND THE LORD'S SUPPER ARE ORDINANCES TO BE PERPETUATED UNDER THE GOSPEL. FEET WASHING, AN ORDINANCE TEACHING HUMILITY, OF UNIVERSAL OBLIGATION, AND TO BE MINISTERED TO ALL BELIEVERS.
- 14. TITHING GOD COMMANDED TITHES AND OFFERINGS IN THE OLD TESTAMENT AND JESUS CHRIST ENDORSED IT IN THE GOSPEL (MATT: 23:23), AND THE APOSTLE PAUL SAID "UPON THE FIRST DAY OF THE WEEK LET EVERY ONE OF YOU LAY BY HIM IN STORE AS GOD HATH PROSPERED HIM", (I CORINTHIANS 16:2).
- 15. THE CHRISTIAN SABBATH THE DIVINE LAW REQUIRES THAT ONE DAY IN SEVEN BE SET APART FROM SECULAR EMPLOYMENTS AND AMUSEMENTS FOR THE REST, WORSHIP, HOLY WORKS AND ACTIVITIES AND FOR THE PERSONAL COMMISSION WITH GOD.
- 16. RESURRECTION, JUDGEMENT AND FINAL RETRIBUTION THE SCRIPTURES TEACH THE RESURRECTION OF ALL MEN AT THE LAST DAY, THEY THAT HAVE DONE GOOD WILL COME FORTH TO THE RESURRECTION OF LIFE AND THEY THAT HAVE DONE EVIL UNTO THE RESURRECTION OF DAMNATION; THE WICKED WILL "GO AWAY INTO ETERNAL PUNISHMENT, BUT THE RIGHTEOUS INTO LIFE ETERNAL."

#### CHURCH COVENANT

WE AGREE FAITHFULLY TO DISCHARGE OUR OBLIGATIONS IN REFERENCE TO THE STUDY OF THE SCRIPTURES, SECRET PRAYER, FAMILY DEVOTIONS AND SOCIAL WORSHIP; AND BY SELF DENIAL, FAITH AND GOOD WORKS ENDEAVOR TO "GROW IN THE GRACE AND KNOWLEDGE OF OUR LORD AND SAVIOUR, JESUS CHRIST."

WE WILL NOT FORSAKE THE ASSEMBLING TOGETHER FOR CHURCH CONFERENCE, PUBLIC WORSHIP AND THE OBSERVANCE OF THE ORDINANCES OF THE GOSPEL, NOR FAIL TO PAY ITS POOR AND ALL ITS BENEVOLENT WORK.

WE AGREE TO ACCEPT CHRISTIAN ADMONITION AND REPROOF WITH MEEKNESS, AND TO WATCH OVER ONE ANOTHER IN LOVE, ENDEAVORING TO "KEEP THE UNITY OF THE SPIRIT" IN THE BONDS OF PEACE, TO BE CAREFUL OF ONE ANOTHER'S HAPPINESS AND REPUTATION AND SEEK TO STRENGTHEN THE WEAK, ENCOURAGE THE AFFLICTED, ADMONISH THE ERRING, AND SO FAR AS WE ARE ABLE, PROMOTE THE SUCCESS OF THE CHURCH AND THE GOSPEL.

WE WILL EVERYWHERE HOLD CHRISTIAN PRINCIPLE SACRED AND CHRISTIAN

OBLIGATIONS AND ENTERPRISES SUPREME, COUNTING IT OUR CHIEF BUSINESS IN LIFE TO EXTEND THE INFLUENCE OF CHRIST IN SOCIETY, AND CONSTANTLY PRAYING AND TELLING THAT THE KINGDOM OF GOD MAY COME, AND HIS WILL BE DONE ON EARTH AS IT IS IN HEAVEN.

TO THIS END WE AGREE TO LABOR FOR THE PROMOTION OF EDUCATIONAL AND DENOMINATIONAL ENTERPRISES, THE SUPPORT OF MISSIONS, THE SUCCESS OF SUNDAY SCHOOLS AND THE EVANGELISTIC EFFORTS FOR THE SALVATION OF THE WORLD. AND MAY THE GOD OF PEACE SANCTIFY US WHOLLY AND PERSEVERE US BLAMELESS UNTO THE COMING OF OUR LORD JESUS CHRIST.
