The 36th Annual Ministerial Association of the Free Will Baptists when convened with the Oak Valley Church on June 2, 1955

36TH ANNUAL YEARLY CONFERENCE

The 36th Annual Session of the Free Will Baptist Association of Southern, Illinois when convened with the Oak Valley Church June 3. 1955.

Services were opened by singing "Take the Name of Jesus With You", "Are You Washed in the Blood". Prayer by Rev. C. A. Curry. Song "An Old Account Was Settled." Prayer by Rev. Byford Campbell and Rev. Wm. Buster.

Rev. George W. Waggoner was nominated for moderator by Rev. H. Pierce. Rev. C. A. Curry nominated Rev. Willie Huffman. Rev. Ketteman nominated Rev. Claude Childers. Motion was made by Rev.

Arthur Kern to close nominations. Seconded by Rev. Byford Campbell. Rev. Huffman was elected. Rev. George W. Waggoner was appointed as assistant moderator.

Letters from the various churches were read by clerk.

Motion was made by Rev. Byford Campbell and seconded by James Fite that letters be accepted and delegates seated. Motion Carried.

Rev. Willie Huffman read scripture from John 14 and had prayer. Pulpit committee appointed by the moderator was Bro. Earl Jent, Mrs. Edith Smith, and Bro. Frank Farris.

Business committee appointed by the moderator was Bro. Loy Light, Deacon Harl Hilliard, Rev. Claude Childers.

Auditing committee appointed by the moderator was Bro. Gorden Neal, Mrs. Freda McClaskey, and Earl Jent.

Motion was made by Rev. William Buster and seconded by Rev. Claude Childers that Deacons be allowed to vote. Motion carried.

Sister Dora Jones gave a report of the National Association which was in Spartanburg, S. C., in 1954. Motion was made by Rev. Hosea Smith and seconded by Rev. James Fite that we accept the report.. Motion carried.

Pulpit committee gave report as follows: Rev. Claude Childers to bring message at 11:00 o'clock Friday. Rev. Wallace Malone, Saturday, and Rev. George W. Waggoner, Saturday evening message. Motion was made by Rev. James Fite and seconded by Rev. Herbert Pierce that report be accepted. Motion carried.

Rev. Herbert Pierce was nominated by Rev. Dewey Merritt to bring the introduction message for next year. Motion carried.

Morning Worship

The ministers' reports were read by clerk. Motion made by Rev. George W. Waggoner and seconded by Rev. Byford Campbell that reports be turned over to business committee. Motion carried.

Motion was made by Rev. Byford Campbell and seconded by Rev. Arthur Kern that we elect Freda McClaskey for clerk of the yearly conference. Motion was carried.

We the business committee of the annual conference recommend that since the yearly has the state charter, we feel that the yearly meeting shall make the By-Laws and Constitution to govern our ministers so that if a man or woman, wishing to be ordained may be ordained in any quarterly meeting when they have completed the course laid down by the yearly conference. A substitute motion was made by Rev. Herbert Pierce for the moderator to select a committee, one from each quarterly to oversee the study course to be used by the yearly. Motion carried. Motion made by Rev. Jack Ketteman and seconded by Rev. Leon McBride to adopt the study course and release the business committee. Discussion. Motion carried.

Motion was made to adopt revision of "Article 6" of Constitution by Rev. Leon McBride and seconded by Rev. E. I. Able. Motion lost.

Motion was made by Rev. Dewey Merritt and seconded by Rev. Lester Breeze to have the clerk have 500 minutes printed and the treasurer be authorized to pay for them. Motion carried.

Motion made by Rev. Jack Ketteman and seconded by Rev. Dewey Merritt to accept the business Committee report on Ministers. Motion carried.

Motion was made by Rev. Hoesa Smith and seconded by Gorden Neal to allow \$15.00 each for 5 delegates to go to National. Motion carried.

Treasurer's report was read by Joyce Browning.

Motion was made by Rev. Hoesa Smith to adjourn business until 1:30 this afternoon. Motion carried. Rev. Dewey Merritt prayed the dismissal prayer.

Morning Service

Morning worship was opened by singing "There Shall Be Showers of Blessing," "Kneel At the Cross," and "The Way of the Cross Leads Home". Prayer by Rev. W. R. Burton.

Song—"Mansion Over the Hilltop," by the Rev. Carl Williams.

Morning Message was delivered by Rev. Wallace Malone, using Joshua 14.

Song— "Power In The Blood." Dismissal prayer by Rev. Oran Kersh.

Afternoon Session

Afternoon services were opened by singing "Since Jesus Came Into My Heart." Prayer by Rev. Everett Beaty. Jane Vaughn sang "All I Need Is Jesus." Rev. George W. Waggoner read the Scripture, Col. 16-18.

The pulpit committee reports: Rev. L. E. Abel afternoon service, Rev. Oran Kersh Sunday morning, and Rev. Byford Campbell evening service. Motion made by Rev. John Hiltibidal and seconded by Rev. W. R. Burton that we accept the report and release the committee. Motion carried.

We, The Business Committee, recommend that this yearly meeting appoint a board of three trustees. Motion was made by Rev. W. R. Burton and seconded by Rev. Jack Ketteman. Motion carried.

Rev. Everett Beaty, Rev. O. C. McClerren and Rev. Paul Barnfield were nominated to serve as trustees. Nomination closed each duly elected.

We, The Business Committee, recommend that this yearly meeting discipline any or all ministers even to the extent to call in their papers that allow or permit or support the pulling of our Churches out of our quarterly meeting or denomination. (s) Committee, Rev. W. R. Burton, Deacon Harl Hilliard, Rev. O. C. McClerren.

We, The Business Committee, recommend that this yearly meeting adopt these "Rules and regulations to govern our incoming Ministers":

- I. They must believe and teach our articles of faith.
- II. They must hold to the enterprises of Free Will Baptist.
- III. They must tithe as God prospers them.
- IV. Each minister must be either a pastor or assistant pastor for one (1) year before being ordained.

Rev. Carl Williams made a report from the Sunday School Alliance.

We, The Auditing Committee, have duly examined the treasurer's books and found them correct with \$153.14 on hand.

(s) Committee, Gorden Neal, Freda McClaskey, Earl Jent, Motion was made by Rev. Hosea Smith and seconded by Rev. Wallace Malone that report be accepted and the committee be released. Motion carried.

Bro. Earl Adcock, Bro. Henry Bushkool, Bro. Robert Isaccs, Sister Trecie Adcock, Sister Aileen Waggoner, Ella Mae Hiltibidal, Nellie Williams and Virginia Bushkool were nominated as delegates to the National Association. A motion was made by Rev. Oran Kersh and seconded by Rev. Hosea Smith that nominations cease and proceed to elect by acclamation. Motion carried.

A motion was made by Rev. W. R. Burton and seconded by Rev. L. E. Abel that a standing vote of thanks be given the ladies and people of the various Churches who helped serve the meals during the Yearly Conference. Motion carried and vote of thanks given.

The next yearly conference will meet in the Freedom County quarterly on Wednesday night before the second Sunday in June.

Rev. Leon McBride, Rev. Berlin Scarbrough, and Bro. Reful Jones were nominated to serve on the program committee along with the moderator and clerk to plan the program for the next yearly conference.

A motion was made by Rev. Carl Williams and seconded by Rev. O. C. McClerren that nominations close and proceed to elect by acclamation. Motion carried.

Motion was made by Rev. W. R. Burton and seconded by Rev. Leon McBride that Bro. George W. Waggoner be elected as moderator and Rev. O. C. McClerren, Asst. Nominations closed and both duly elected.

A motion was made by Rev. Eugene Norris that Mrs. Freda Mc-Claskey be re-elected as clerk Nomination closed. Motion carried.

Rev. Wallace Malone nominated Shirley McClerren as treasurer. Motion carried.

Rev. Carl Williams gave a talk on "What is the Free Will Baptist Need of League."

Motion made by Rev. John Hiltibidal and seconded by Rev. Oran Kersh that we adjourn business. Motion carried.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of Missions, the success of Sunday schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
